


Kelli was cited for Best Shooting Form, Ronda was named Best Defensive Player in Division II, and Ralynn was named Best Offensive Player in Division I.



# Your County Agent Says by Alan Day

THRIP PROBLEMS IN COTTON



Thrips have been extremely bad this year. They started about 3 weeks ago and are still in high numbers. Late planted cotton and cotton that is under stress from hail damage could be in trouble.

Thrip damage is easily spotted as leaves will be curled and knarled in apparance. Thrips are rarely enough of a problem to warrant chemical control. Treatment maybe necessary if thrips number 15 or more per plant. If your plants have 4 to 6 good looking true leaves, you are most likely past the thrip damage stage.

There are a lot of beneficial insect running around out in the cotton fields, (lady beatles, minute pirate xugs, big eyed bugs). Their number one food source at this time are the thrips! Make sure your infestation rate is high enough to cause economic damage before spraying. You want to leave your beneficials out there for fleahoppers and bollworms.

If your cotton is approaching the 6 rune leaf stage, start checking for cotton fleahoppers!

#### GRASSHOPPER PROBLEMS

Grasshoppers continue to move from rangeland into cotton and other field crops. The most common grasshopper is the jumbo but other winged forms are present. Toxaphen, Sevin XLR, Seven 4 Oil and Toxaphene bait seem to be giving the best control. Only as a last resort should you use methyl parathion as this will sterilize your cotton field by killing anything that's there including beneficials.

If you are having grasshopper problems, give me a call.



# COMMODITY GRAIN LOAN

Loans are available for all small grains. The basic loan rates for 1981 are: Wheat-\$3.21 per bushel, Barley-\$1.85 per bushel, and Oats-\$1.40 per Bushel. They must be stored in an approved warehouse or in an acceptable place on the far. If you are interested please contact this office for more details.

#### DISASTER

I know most of you have planted your cotton or you have planted and lost part or all of the acreage to the recent hail. June 15th is the final date you are required to plant or replant your cotton, and you have until June 30th to file a prevented planting request. The final planting date for grain sorghum is June 20th and you have until July 5th to file a prevented request for grain sorghum.

All failed acreage regulations remain the same. Do Not make any other use of the acreage until it has been reported and inspected, or if harvested, you must file an application for disaster credit within 15 days after harvest is complete. 1981 Disaster rates are: Wheat-\$1.91 per bushel, Cotton-\$.2362 per pound, Grain Sorghum-\$2.28 per hundred. Nothing different than in prior years except rates have increase.

#### COMPLIANCE

Skip row cotton in prior years must again be skip row or a yield reduction will be considered. A 3 percent standard deduction will be used for crops planted in normal row widths and zero deductions will be used for close sown crops.




