# **Gray County** returns 12 indictments

A Gray County grand jury returned 26 indictments this month against 12 people on charges ranging from child pornography to robbery.

Alex Ray Fox, 30, faces 10 counts of possession with intent to promote child pornography in January. Fox is free on bonds totaling \$150,000.

James Floyd Williams, 47, faces six counts of possession with intent to promote child pornography in September, 2008. Williams is free on bonds totaling \$150,000.

Aemon Troy Layton, 26, was indicted on one count of aggravated robbery for allegedly threatening Ginger Jones during a reported theft in March. Layton is in Gray County jail in lieu of a \$125,000 bond.

Michael Don Burns, 27, was indicted on one count of aggravated robbery for allegedly threatening Ginger Jones during a reported theft in March. Burns is free on \$100,000 bond.

Howard Alexander Santacruz, 24, was indicted on one count of aggravated assault causing serious bodily injury to Linda Ordonez by kicking and punching on New Year's Day. Santacruz is in Gray County jail in lieu of \$20,000 bond.

Texas shoppers can get a break from state and local sales taxes during the state's annual tax holiday set this weekend.

The Texas comptroller's office says the law exempts most clothing and footwear priced under \$100 from sales and use taxes. The tax exemption could save shoppers about \$8 on every \$100 they spend.

The agency says backpacks under \$100 and used by elementary and secondary students are also exempt.

The 2009 Legislature expanded the list of items qualifying for tax

weekend. Texas families get a sales tax break on most school supplies priced at less than \$100 purchased for use by a student in an elementary or secondary school.

Texas Comptroller Susan Combs predicted shoppers will save \$59.3 million in state and local taxes this weekend. The sales tax holiday takes place every year on the third Friday, Saturday and Sunday of August. According to the comptroller's office, the following is an all-inclusive list of qualifying school supplies (if priced less than \$100):

# McLean seeks to fill medical service void

Pampa-based Emergency Medical Services Foundation of Texas will meet with McLean officials later this month to see if something can be worked out to provide the community with medical services.

After emergency medical personnel moved out of McLean earlier this year, that southeast Gray County community had two sophisticated ambulances but no one to operate them.

McLean Mayor Peggy Baer spoke to the Gray County Commission during their mid-month meeting Monday concerning the situation.

The county helps fund the volunteer ambulance service in McLean.

"I am here to tell you we do have a problem," Baer told commissioners.

She said that the ambulance service had recruited one EMT and some personnel have completed their emergency medical training so the situation is not as critical as it was a few days ago, but still something needs to be done.

We need some options," Baer said.

## CTT proposed line extends east

Wednesday's Pampa News reported that the route planned for power lines to take electricity from near Lefors and south into Donley County. That was Route 194, one of the original proposed routes filed in May with the Public Utility Commission.

On July 16, the PUC staff recommended an alternative route, Route 314, that would run in an easterly direction, paralleling existing lines

through Gray County into Wheeler County and turning south-easterly to near Shamrock where it would turn south through Collingsworth County to near Kirkland in Childress County.

Cameron Fredkin, Cross Texas Transmission's director of project development, said that on Aug. 9, all parties in the case, including LINES cont. on page 6

#### Clint Elray Evans, 88


Clint Elray Evans, 88, died August 16, 2010 in Sunray.





## Egg recall grows

ATLANTA (AP) — Hundreds of people have been sickened in a salmonella outbreak linked to eggs in four states and possibly more, health officials said Wednesday as a company dramatically expanded a recall to 380 million eggs.

The Centers for Disease Control and Prevention is working with state health departments to investigate the illnesses. No deaths have been reported.

Initially, 228 million eggs, or the equivalent of 19 million dozen-egg cartons, were recalled by the company Wright County Egg of Galt, Iowa. But that number was increased to nearly 32 million dozen-egg cartons.

Spikes of salmonella cases have been reported in Arizona, California, Colorado, Illinois, Minnesota, Nevada, North Carolina, Texas and Wisconsin.

#### Inmate mistreatment suit tossed

HOUSTON (AP) - A federal court has rejected an appeal from inmates at a federal prison in Beaumont who said in a lawsuit that they were mistreated in the aftermath of Hurricane Rita in 2005.

The 5th U.S. Circuit Court of Appeals, in an opinion issued last month that was revised this week, upholds a lower court ruling.

Inmates at two lower-security federal prisons at the Beaumont Federal Correctional Complex were evacuated as the Category 3 storm approached but 453 prisoners in the maximum-security lockup remained. Several dozen inmates sued, contending they were left without electricity, potable water, food and medical care.

The three-judge appeals court panel determined the warden had the authority to keep them in place.

"We do not minimize or discount the severe hardships that the plaintiffs endured in the aftermath of the storm," the judges wrote. "We simply lack jurisdiction to provide relief."

## Jeffs hearing canceled

SALT LAKE CITY (AP) - A judge has canceled a scheduled hearing on polygamous sect leader Warren Jeffs' request for a speedy trial.

Fifth District Judge James Shumate's order Wednesday canceling the Aug. 23 hearing was in response to a joint request from Washington County prosecutors and defense attorneys.

Jeffs is the 54-year-old head of the Fundamentalist Church of Jesus Christ of Latter Saints, a southern Utahbased church that practices polygamy. His 2007 convictions on two counts of rape as an accomplice were overturned by the Utah Supreme Court last month. Citing faulty jury instructions, the court sent the case back to the district court.


Texas authorities have charged Jeffs with bigamy, aggravated sexual assault and assault based on alleged incidents with underage girls at a church ranch near Eldorado, Texas. Utah Gov. Gary Herbert has signed a warrant for Jeffs extradition to Texas, but Jeffs attorneys have said they will fight extradition. Jeffs remained in the Utah State Prison on Wednesday.

It's unclear when a hearing might be rescheduled.

## NTSB cites 'copter crash causes

WASHINGTON (AP) - A federal report issued Wednesday says the sudden onset of poor visibility and pilot uncertified in instrument flying probably caused a firearm while committing a theft of Cornelius Wendell Morgan, indicted on one count of assault 2008 helicopter crash off Sabine Pass, Texas, that killed all property in March. Jesus Rodriguez 44, was indicted on an enhanced causing serious bodily injury to five aboard. The crash in the Gulf of Mexico, about six miles south of Sabine Pass, killed the pilot and four passengers aboard the air taxi. The chopper was ferrying oil workers to an offshore platform on Dec. 11, 2008, when it went down. The National Transportation Safety Board probable cause report says the airframe "damage was consistent with controlled flight into the water." Thick clouds had formed in the crash area that required instrument flight. While the pilot held a commercial certificate with an instrument rating, the NTSB says he wasn't approved to fly air taxi service by instruments.

### Former D.A. indicted

ALICE (AP) - A south Texas grand jury has indicted a former district attorney on a funds misappropriation charge for funneling drug seizure money to his staff.

The Alice Echo-News reports the special grand jury, convened at the state Attorney General's request, indicted Joe Frank Garza Wednesday. Garza is the former district attorney for Brooks and Jim Wells counties in south Texas. An audit Garza's successor requested found that more than \$1.2 million in forfeiture funds were shifted to two Garza secretaries and his office's head of crime victims service from 2004 to 2008.

According to the audit, the transfers were reportedly for purposes such as car allowances, stipends, reimbursements, advances, audits, travel and contract labor.

Before his indictment, Garza hadn't disputed spending some of the forfeiture money on his staff but denied that he did anything illegal.

## Kidnapped Mexican mayor dead

MONTERREY, Mexico (AP) - The kidnapped mayor of a northern Mexican town has been found dead, extending a rash of deadly attacks on political figures in an area besieged by drug gang battles.

Officials say Santiago Mayor Edelmiro Cavazos' body was found Wednesday near a waterfall outside his town, which is a popular weekend getaway for residents of the industrial city of Monterrey.

Police have not determined a motive, but the assassination bore the hallmarks of drug cartels waging vicious turf battles in northeastern Mexico: Cavazos' hands were bound and his head was wrapped in tape.

## Police find bears guarding pot

VANCOUVER (AP) - A pair of marijuana growers in Western Canada appear to have been using bears to protect their illegal crop, but the well-fed animals proved to be a bit lax in their guard duties, police said on Wednesday.

Officers were dismantling two large outdoor plots of marijuana near Christina Lake, British Columbia, when they realized there were 10 large black bears wandering around the farm property, the Royal Canadian Mounted Police said. Officers were initially worried the bears might be dangerous, but quickly realized the animals were actually very docile and content just to sit around as the marijuana was seized, police said in a news release.

Two people were arrested in connection with the drugs. The bears, which were apparently being fed dog food to keep them on the property, may eventually have to be put down if wildlife officials determine they have become too habituated to humans, police said.



## Today in History

Today is Thursday, Aug. 19, the 231st day of 2010. There are 134 days left in the year.

#### Today's Highlight in History:

On Aug. 19, 1960, a tribunal in Moscow convicted American U2 pilot Francis Gary Powers of espionage, two days after his 31st birthday. (Although sentenced to 10 wears' imprisonment, Powers was returned to the United States in 1962 as part of a prisoner exchange.)

#### On this date:

In 1812, the USS Constitution defeated the British frigate Guerriere off Nova Scotia during the War of 1812

In 1909, the first automobile races were run at the just-opened Indianapolis Motor Speedway.

In 1918, "Yip! Yip! Yaphank," a musical revue by Irving Berlin featuring Army recruits from Camp Upton in Yaphank, N.Y., opened on Broadway.

In 1934, a plebiscite in Germany approved the vesting of sole executive power in Adolf Hitler.

In 1942, during World War II, about 6,000 Canadian and British soldiers launched a disastrous raid against the Germans at Dieppe, France, suffering more than 50-percent casualties.

In 1955, severe flooding in the northeastern U.S. claimed some 200 lives.

In 1976, President Gerald R. Ford won the Republican presidential nomination at the party's convention in Kansas City

In 1980, 301 people aboard a Saudi Arabian L-1011 died as the jetliner made a fiery emergency return to the Riyadh airport.

In 1990, Leonard Bernstein (BURN'-styn) conducted what turned out to be the last concert of his career at Tanglewood in Lenox, Mass. with the Boston Symphony Orchestra; the program ended with Beethoven's Symphony No. 7.

In 1991, Soviet hard-liners announced to a shocked world that President Mikhail S. Gorbachev had been removed from power. (The coup attempt collapsed two days later.)

Ten years ago: Norwegian divers with video equipment went down to the sunken Russian submarine Kursk in a final attempt to find survivors trapped for a week, even though Russian officials said all 118 seamen aboard were probably dead.

Five years ago: A Texas jury found pharmaceutical giant Merck and Co. liable for the death of a man who'd taken the once-popular painkiller Vioxx, awarding his widow \$253.4 million in damages. (Texas caps on punitive damages reduced that figure to about \$26 million; a Texas court overturned the verdict in May 2008.) Attackers firing Katyusha rockets narrowly missed a U.S. amphibious assault ship docked at the Red Sea resort of Aqaba, but killed a Jordanian soldier. Britain's former Northern Ireland chief, Mo Mowlam, died in Canterbury, England; she was 55. One year ago: Suicide bombers struck Iraq's finance and foreign ministries, killing more than 100 people. Four members of an elite Army special operations unit were killed when their helicopter crashed on a Colorado mountain during a training mission. Don Hewitt, the TV news pioneer who created CBS' "60 Minutes," died at his Long Island, N.Y. home at age 86.

For the past few articles, I have been discussing hardware upgrades, software selection, software licensing, and disaster recovery.

Little did I know that my next article would include all of the above.

# Texas faces rising cost of illegal immigrant care

AUSTIN (AP) — The cost of keeping illegal immigrants in prison and providing them with medical care exceeded \$250 million last year in Texas, according to state health and corrections officials.

The testimony before the House State Affairs Committee on Wednesday came as lawmakers faced a projected state budget shortfall of up to \$18 billion.

"We want to focus on what the real costs are for state services," said Rep. Burt Solomons, R-Carrollton, the committee chairman. "There's really not a lot of wholly accurate data."

Jerry McGinty, the Texas Department of Corrections' chief financial officer, said state prisons held 11,766 offenders who are foreign citizens in July.

He said it costs the state about \$171 million per year to hold them, although the federal government reimburses about 10 percent of that total.

Rick Allgeyer, director of research for the Health and Human Services Commission, said illegal immigrant healthcare cost the state nearly \$100 million last year. Allgeyer said that most of those healthcare costs were in emergency care.

Rep. Rene Oliveira, D-Brownsville, said an Arizonatype law allowing police to question anyone they stop about their citizenship status could fill every county jail in Texas.

"It would bust all our counties," said Oliveira. Rep. Pete Gallego, D-Alpine, told fellow committee

members that when making policy, "you always have to be aware of unintended consequences." Gallego said there could be significant effects if law

Gallego said there could be significant effects if law enforcement and other public agencies were asked to reallocate already-sparse resources to check citizenship of people in Texas.

# Unguarded border bridges could be route into U.S. soil

ACALA, Texas (AP) — On each side of a towering West Texas stretch of the \$2.4 billion border fence designed to block people from illegally entering the country, there are two metal footbridges, clear paths into the United States from Mexico.

The footpaths that could easily guide illegal immigrants and smugglers across the Rio Grande without getting wet seem to be there because of what amounts to federal linguistics. While just about anyone would call them bridges, the U.S.-Mexico group that owns them calls them something else.

"Technically speaking it's not a bridge, it's a grade control structure," said Sally Spener, spokeswoman for the International Boundary and Water Commission, which maintains the integrity of the 1,200-mile river border between the U.S. and Mexico. The structures under the spans help prevent the river — and therefore the international border — from shifting.

Spener said the river was straightened years ago to stabilize and prevent a shift during high river flow, Without the structures, which also help slow the flow of water in the river, she said it could erode its banks, wash out the river bed and degrade natural habitats.

Whatever they're called, there are fresh sneaker tracks on the structures — indicating they're being used as passages into the country.

"This is outrageous and yet another example of the federal government failing miserably in its duty to secure the

border from those who wish to do us harm, and they need to take immediate action to address this situation," Katherine Cesinger, spokeswoman for Texas Gov. Rick Perry, said in a Wednesday statement.

The realization that a section of the border fence is sandwiched between two footbridges comes at a time of heightened alarm along the U.S.-Mexico border as the drug war in northern Mexico continues unabated. President Barack Obama ordered thousands of National Guard troops to the border but Perry has railed that the federal government isn't doing enough to keep Americans safe and illegal immigrants out.

The steel fencing that dots about 600 miles of border in Texas, New Mexico, Arizona and California was built under former President George W. Bush's administration amid a national outcry for border security. The steel fencing appears in urban areas, while more rural areas have shorter, concrete vehicle barriers.

"If we are spending so much money on a fence, why not put some into cutting (the bridges) out, eliminating an easy access at a place that is not a port?" said Don Reay, executive director of the Texas Border Sheriff's Coalition.

The footbridges were built in the 1930s as part of a treaty with Mexico, Spener said.

On a recent visit to a bridge west of the fence line near Acala, Border Patrol Special Operations Supervisor Ramiro Cordero spotted an hours-old adult-sized sneaker print in the soft sand at the foot of the bridge facing into the United States. In a border tour with the Hudspeth County Sheriff's Office in March, Associated Press journalists happened upon the bridge moments after a man with a bicycle used the bridge to cross the river from Mexico. The border crosser, who told authorities he was only trying to fish from the north side of the river, was promptly arrested. "If he can do it, so can drug cartels with loads of narcotics of any kind," Hudspeth County Sheriff's Lt. Robert Wilson said. "Even a terrorist could pass here with weapons of mass destruction and be in the United States and up on the interstate and gone in a short time."

It's unclear how often the bridge is used, but it's common to see people on the Mexican side lingering around the crossing or others playing in the river in the area.

## Back-to-School Safety Tips for Kids and Parents!

When parents talk about school safety these days, they're usually referring to the surge in violence at schools. But research shows that school-age children are actually nine times more likely to sustain an unintentional injury-whether on the playground or in school- than to be the victim of violence while at school. In fact, an estimated 2.2 million children over ages 14 and under are injured in school-related accidents each year, according to the National SAFE KIDS Campaign. Accidents can be prevented if parents are on the lookout for potential hazards. To help keep your kids free from harm, here are some safety tips from SAFE KIDS, the Consumer Product Safety Commission, and the American Academy of Pediatrics. • Traveling to and from school. Plan a walking route to school or the bus stop. Choose the most direct way with the

fewest street crossings and, if possible, with intersections that have crossing guards. Walk the route with your children beforehand. Tell him or her to stay away from parks, vacant lots, fields and other places where there aren't many people around. Before crossing the street, stop at the curb, edge of the road, or corner before proceeding. Look left-right-left and, if it's clear, begin crossing, looking over your shoulder for turning vehicles. Continue to check for traffic while crossing. them up as close to the school as possible. Don't leave until they are in schoolyard or building.

• if your child bikes to school make sure he wears a helmet that meets the safety



# Harvesters set for Dons' smashmouth running offense

Last week the Harvesters scrimmaged a spread offense team in Bushland that bassed the ball 90 percent of the time. Friday against former District 3-4A opponent Palo Duro, Pampa will get the opposite in their final scrimmage 7 p.m. at Harvester Field.

Defensive coordinator Stacey Alexander said he expects the Dons to run 90 percent of the time.

Alexander said the difference this week in defending Palo Duro is how many people they bring in the box.

"The more they have down there from fight end to tackle, the more backs they have, we'll add to it (men in the box)," Alexander said. "We spent 90 percent of the practice this week working on what scrimmage at 6 p.m. at Harvester Field.

"It will be interesting to see if we can get off a man jam," Ericson said. "If we don't that's the coverage we're going to get all season.'

Ericson said the offense has more confidence this week after their scrimmage with Bushland

"Just being able to have success with a team like that, that went to state finals last year shows that we can be good this year is motivating us a little bit," Ericson said. "

Thompson said the Dons speed will provide them a challenge defensively.

"They are going to run a lot," Thompson said. "Their backs are ridiculously fast which is going to be pretty difficult."

Alexander said the biggest challenge will be stopping Palo Duro's running backs.

"They got two really good backs this year," Alexander said. "Biggest challenge is going to be execute the gaps on the inside and support a force around the perimeter to the outside."

Alexander said with the season opener against Iowa Park a week away, they are trying to figure out how to practice more efficiently.


"With school starting, with the regular season starting, we are down to a three day practice schedule," Alexander said. "We are trying to figure out what kids can do in the most efficient manner."




