Some of the better freezables are blueberries, melons, rhubarb and strawberries.

They, and many other of summer's fruits, need little preparation before you pack them into Seal-AMeal pouches and seal them for

Seal the pouches. Lay them on their side in single layers in the coldest areas of your freezer (a 0 degrees temperature is a must) for 12 hours. Then stack them in another area of the freezer for storage. Let the summer sun sink into autumn. You have packed its rays away in your freezer.

Now you will discover why home freezing pouches make a fest out of freezing. They are easy to fill, easy to store, 100 percent safe and prevent freezer burn.

Later you will discover more, that pouch-frozen fruits are perfect containers for thawing. Drop them in luke warm water for a few minutes and your fruits and vegetables are ready to eat or add to recipes.

-Vegetables, Too

Freezing vegetables is similarly simple. Pick fresh and tender vegetables, wash them well, lifting them out of the water to leave the dirt behind. Drain well.

Sort the vegetables by size and blanch (a quick precook followed by an icy bath). Fill the pouches, seal and freeze.

When you are ready for field-fresh flavor, drop the sealed, boilable pouches in boiling water or a microwave oven and serve.

# POSSIBLE FEDERAL QUARANTINE

As you all know, a federal quarantine of Texas is looming due to all legislative holdup in the state

congress.

In the event a Federal Brucellosis Quarantine is placed on Texas cattle, the following information should answer most of your questions concerning movement.

The movement of cattle within the State will continue under the present regulations:

1. Steers and spayed heifers can move with no restriction.

2. Officially vaccinated heifers of dairy breeds under twenty (20) months and beef breeds under twenty-four (24) months (as evidenced by the presence of the first pair of permanent incisor teeth) which are not springers or have calved are exempt from test.

3. All other nonexempt cattle changing ownership within the State will follow the present regulations for the Class "C" or "B" areas of Texas:

CHANGE OF OWNERSHIP WITHIN THE CLASS "B" AREA:

1. Nonexempt cattle over eighteen (18) months shall originate from:

a. A certified free herd

(b) Test negative within thirty (30) days prior to sale (c) Consigned to livestock market and tested negative prior to sale

(d) Consigned to slaughter for testing and blood collection

CHANGE OF OWNERSHIP WITHIN THE CLASS "C" AREA:

1. Nonexempt cattle over eighteen (18) months shall originate from:

(a) A certified free herd (b) Test negative within thirty (30) days prior to sale (c) Consigned to livestock market and tested negative unless "S" branded prior (d) Consigned to slaughter for testing and blood

1. Only steers and spayed heifers can move outside the State without test

2. Other cattle moving outside Texas will have to originate from a "qualified herd" since 'certified free" herds will lose their status for out-of-State movement. An extract of the requirements for moving from a Federal quarantine area is attached for your information

Under the Federal quarantine, the following will probably occur:

1. The "B" and "C" area status will be lost.

2. Movement of breeding animals out of the State will probably be curtailed.

3. Texas cattle will have to come from "qualified herds" for shows and fairs within the State if they are to be exhibited with cattle from outside Texas.

In order to maintain a "qualified herd" status, it will take a minimum of one hundred twenty (120) days. This will include two (2) To maintain tests. qualification, the herd will have to be retested not later than every one hundred twenty (120) days. Testing will include nonvaccinated female breeding cattle and bulls six (6) months of age and over, and vaccinates over twelve (12) months of

# "Mineral Resource War" Targets U.S. Industrial Base

The Soviets, operating through a "puppet" terrorist group known as **SWAPO (South West Africa** People's Organization), are trying to seize power in South West Africa-Namibia.

Namibia (South West Africa) is a country generally unknown to Americans despite the important U.S. national defense interests involved there.

Not only does Namibia have the largest uranium mine in the world, and vast resources of copper, diamonds, lead, tungsten, tin, zinc and oil, but its western coast deep-water port can harbor Soviet nuclear submarines in a position to bisect the oil and mineral lifeline from the Persian Gulf to the U.S. and NATO countries of western Europe. More than 28,000 ships a year follow this sea

route around the Cape of Good Hope.

If the Soviets and their SWAPO proxies can drag Namibia behind the "iron curtain", the U.S. loses another ally in the mineral "resource war" and Russia makes a huge gain in its campaign to deprive the U.S. of the strategic minerals in southern Africa.

The Soviet-dominated United Nations General **Assembly provides SWAPO** with about \$100 million a year. And the U.N. supplies millions to other Soviet-sponsored terrorist groups such as the Palestine Liberation Organization (PLO), the Cuban guerrillas in Angola, the Carribbean, and elsewhere in Africa.

The U.S. Congress annually appropriates over \$ 1 billion of hard-earned U.S. taxpayers dollars to the United Nations -- 1/4 of the total U.N. budget.

Few Americans are aware that to the extent they allow the United Nations to use taxpaver American contributions to finance pro-Soviet terrorists, they are helping finance their own destruction. Is it not time for U.S. taxpayers to ask their representatives in Congress to stop this flow of U.S. tax dollars through the U.N. to SWAPO, PLO, Cuban guerrillas and other Soviet-backed terrorist groups?
