Contrary to a rumor that's been circulating around town, financing for the Bennigan's in Pampa has not fallen

through, said franchisee Nimit Patel. 'There has never been an issue with the financing," Patel said.

Ladd Biro of Champion Management in Plano confirmed the rumor is false. Champion is a public relations firm in Plano that represents the Dallas-based restaurant franchise.

A groundbreaking for the new restaurant was held May 14, but construction has still not begun.

Patel, who is new to the restaurant business, said unexpected delays are

not unusual for a big project.

"It's better to do it right the first time than have to go back and fix things," he said. "There is a lot that has to go into effect to have an establishment like this. It is a prototype so a lot has to go into the design."



City's emergency drill helps prepare citizens for disasters

Fred Courtney, Emergency Management coordinator for Pampa, and the rest of the emergency management team held an emergency drill On Tuesday morning in which they trained volunteers to be prepared for what they can do to help out the community in the event of a disaster.

Courtney said it is important to have volunteers who know the roles of city employees so that they are able to jump in and help side by side with them when needed, as these disasters can affect city employees, too.

For this drill, unaffiliated volunteers, or people that who are not obligated to lend a hand, came

6-month extension granted on prairie chicken listing

■ Fish and Wildlife Service seeks additional information from public, scientific community.

A decision by the federal government on the fate of small, reclusive grouse that lives throughout the Great Plains will be postponed for six months. The U.S. Fish and Wildlife

Service announced Monday a six-month extension of the final determination of whether to provide protection under the Endangered Species Act for the lesser

prairie chicken. The USFWS is taking this action to solicit additional scientific information and public comment before making a final listing determination. The final determination will be extended from Sept. 30 to March

30, 2014. H. Wayne Hughes, executive vice president of the Panhandle Producers and Royalty Owners Association (PPROA), said he

was pleased by the news. "This gives us some breathing us an opportunity to inject more science into the mix."

The PPROA is a trade association representing independent petroleum producers, service companies and mineral royalty owners in the Texas Panhandle, western Oklahoma and southwestern Kansas.

Hughes said this gives the PPROA and other parties who oppose the listing more time to make their case that the chicken is not in as much peril as other special interests groups claim.

"We have a well-thought approach that would save the fed-

room," he said Tuesday. "It gives eral government money in a time when they are strapped for cash. I can't imagine the reason why they would not want the respective state agencies to manage the habitats. We want to keep the chicken from being added to the burden of federal oversight."

He added he doesn't want to speak ill of the USFWS, but "our direct concern is the attitude at Fish and Wildlife that it is a foregone conclusion that it will be listed. At every turn we are hitting some kind of bureaucratic road block. Hopefully, we can



One previously selected volunteer moved on to another stage of the drill in which he was staged to find out where he was working and what he would be doing in the event of a disas-

The purpose of the drill was to practice disaster control, something Courtney is not alone in talking about passionately.

Jim Barringer, a safety manager at Cabot Corp., said that many of the Cabot employees volunteer because they feel as members of the community it is their duty to try to give back when they can. Dozens are feared dead in Quebec oil train derailment

Tuesday, three days after a At least five exploded. runaway oil train smashed town and incinerated much of its downtown.

Thirteen people were confirmed dead and nearly 40 others were still missing in a catastrophe that raised questions about the safety of transporting oil by rail instead of pipeline.

Investigators zeroed in on whether a blaze on the train a few hours before the disaster set off the deadly chain of events.

Rescue workers labored to reach the bodies believed to be in the ruins.

"This is a very risky environment. We have to secure the safety of those working there. We have some hotspots on the scene. There is some gas," Quebec Provincial Police Sergeant Benoit Richard

He said recovery efforts had to be halted briefly Monday for health reasons, and some officers had to be removed from the scene. He did not elaborate. The bodies that have been recovered were burned so badly they have yet to be

The same train caught fire hours earlier in a nearby town, and the engine was shut down — standard operating procedure dictated by the train's owners, Nantes Fire Chief Patrick Lambert said.

Edward Burkhardt, president and CEO of the railway's parent company, Rail World Inc., suggested that shutting off the locomotive to put out the fire might have disabled the brakes.

"An hour or so after the locomotive was shut down, the train rolled away," he told the Canadian Broadcasting Corp.

Lambert defended the fire department, saying that the blaze was extinguished within about 45 minutes and that's when firefighters' involvement ended.

"The people from MMA told us, 'That's great — the train is secure, there's no more fire, there's nothing anymore, there's no more danger," Lambert said. "We were given our leave, and we left."

Transportation Board investigator Donald Ross said the locomotive's black box has been recov-

"The extent to which (the fire) played into the sequences of events is a focal point of our investigation," Ross said, but he cautioned that the investigation was still in its early stages.

On Dec. 11, 2012, the USFWS proposed to list the lesser prairie chicken as a threatened species primarily due to habitat loss and fragmentation from the conversion of grasslands to agricultural uses; encroachment by invaenergy development; pemanmade vertical struc-

Officials in Texas and other prairie states insist that landowners and energy producers — not the federal government — are the best stewards of the Plain's vast grasslands, and that can be accomplished through voluntary agreements between private industry and the parks and wildlife agencies from the respective states.

During the initial public comment period, the USF-WS held four public hearings in Woodward, Okla.; Garden City, Kan.; Lub-

bock; and Roswell, N.M. On May 6, the service reopened the public comment period to gather additional public comments on the Dec. 11, 2012 list-

ing proposal. The USFWS also opened a commenting period that closed June 20 for a conservation plan that would allow state wildlife agencies where the bird has known habitats — Texas, Oklahoma, Kansas, Colo-

rado and New Mexico instead of the federal gov-

Thornberry said there are three actions the USF-WS could take: Listing the bird as endangered, which would seriously restrict activity on private property; listing the bird as threatened, which would restrict activity but not as much as endangered; or not listing the bird at all.

Though it is possible the bird could be designated as endangered, Thornberry said an action that drastic is unlikely.

The 30-day comment period, which began Monday, will begin with the publication of this announcement in the Federal Register to ensure the public has full access to, and an opportunity to comment

Most significantly, the Natural Resources Conservation Service's Lesser keeping the bird off the Prairie Chicken Initiative has provided funding and technical assistance to private landowners seeking to improve habitat for the prairie chicken.

Court on BP settlement

(AP) — A federal appeals court is wading into a high-stakes dispute over the terms of multibillion-dollar settlement of claims arising from BP's massive 2010 oil spill in the Gulf of Mexico.

A three-judge panel of the 5th U.S. Circuit Court of Appeals is scheduled to hear arguments Monday by attorneys for the Londonbased oil giant and for Gulf Coast businesses that say the nation's worst offshore oil spill cost them money.

BP asserts that the judge who approved the deal and a court-appointed claims administrator have misinterpreted the settlement, allowing thousands of businesses to secure hundreds of millions of dollars in payments for inflated and fictitious losses.

"The result is that thousands of claimants that suffered no losses are coming forward in ever-increasing numbers, seeking and obtaining outrageous windfalls and making a mockery of what was intended to be a fair and honest court-supervised settlement process," attorneys company wrote in their brief for the hearing.

BP says it could be forced to pay billions more in "capricious awards to uninjured claimants" if the 5th Circuit doesn't overturn rulings on the issue by U.S. District Judge Carl Barbier.

attorneys Plaintiffs' who brokered the deal last year counter that BP undervalued the settlement and underestimated how many claimants would qualify for payments under the terms they negotiated.

Obama embarrassed by Obamacare

Barack Obama assured us that, after his signature legislation Obamacare went into effect, we would surely like it. Now Obama has decided he doesn't want us to find out how it affects us until after the 2014 elections.

ployers of 50 or more full-time employees to provide comprehensive health insurance that includes a mandate to pay for an

abortion-inducing drug. The penalty for non-compliance is a tax of \$2,000 per fulltime employee per year (beyond the first 30), and the Internal Revenue Service was supposed to start collecting the penalties on Jan. 1.

Obama apparently thinks he can conceal the mess he created, which even the Democrats who voted for it now call a "train wreck," by simply postponing the effective date of the employer mandate one year. But the Obamacare law, as upheld by the U.S. Supreme Court, unambiguously states: "EF-FECTIVE DATE ... The amendments made by this section shall apply to months beginning after December 31, 2013."

Obama has no authority to alter the timetable of the law's implementation. Maybe he should actually read the 2,700 pages of text in the Obamacare law and its 20,000 pages of regulations.

Obama doesn't seem to care whether his order to delay Obamacare is lawful or not. He wants to avoid the trouble the destructive employer mandate would cause for Democratic candidates before the next election of the House of Representatives, an election he deems critical to his plan to "fundamentally transform the United States."

The postponement of the employer mandate is not the first setback to the Obamacare timeline. A few months ago, the Obama administration quietly announced that the federally run statelevel exchanges will not offer a choice of plans to employees of small

businesses until after the 2014 elections.

The one-year extension for employers will create havoc in the exchanges where individuals are supposed to buy next year's health insurance. The government admitted July 5 that it won't be able to verify whether applicants qualify for the subsidies that are supposed to make the required coverage "affordable" but plans to give out the subsidies anyway.

Meanwhile, Obamacare's expansion of Medicaid is being rejected by the states. After the Supreme Court's June 2012 decision in NFIB v. Sebelius gave states the OK to reject this expansion, 27 of 50 states did not implement Obamacare's Medicaid

States were wise to reject this very expensive Medicaid expansion.

Obamacare required that anyone with income below 133 percent of the poverty level would be eligible for Medicaid and sought to expand eligibility to able-bodied, non-elderly, childless adults, that is, to people without dependents who were able but perhaps unwilling to support themselves.

In addition to having sections of Obamacare postponed and rejected outright, Obamacare is also failing to fulfill Obama's promise that it would decrease the deficit. The funds that were supposed to pay down the deficit included the money anticipated to flow from the penalty payments made by employers who refused to obey the mandate to provide comprehensive healthcare to their em-

Now that employers will not be required to pay those fines in 2014 for violating the mandate, and indeed will not even be required to report whether they are complying, it is obvious that Obamacare will not produce the promised deficit reduction.

Railroads big part of Southwest's history

The influence of the railroad in Pampa has left its mark since the 1800s. The rail not only brought settlers to Pampa but also business, goods and other necessities for settlers' survival

in the area.

"The story of the Santa Fe Railway is the story of the Southwest. It mirrors the same spirit of the early pioneers who ventured into this developing territory, their wagons and pack mules

loaded down, their dreams of prosperity propelling them forward. The Santa Fe was said "to



start nowhere and go nowhere," but as the nation's second transcontinental rail line, it eventually would connect the growing towns in what are now Kansas, Colorado, Oklahoma and Texas to the Pacific Coast and parts of the Midwest," according to "The History and Legacy of the BNSF Railway".

The Southern Kansas Railway Company of Texas, which was subsidized by Santa Fe Railway and was commonly known as the Santa Fe, constructed a roadbed from Miami to Panhandle City in 1887. The line did not operate trains, except for construction purposes, until Jan. 15, 1888.

"On that date the only thing that resembled a structure of any kind at the station designated as Glasgow (now Pampa) was a boxcar intended to be used as an "open station," according to BNSF. An open station is basically a station that is open for people to come in and take care of their business themselves. In February 1892, the railroad officially named the station Pampa and with that name improvements to the station began.

On May 26, 1898, George Tyng wrote, "The Southern Kansas Railway Company is having loaded here at Pampa, RAILROADS cont. on page 6

I would like to share a story with you about

Coach Woldt and my dad. In 1965, Lubbock Monterey was the district falast year coaching the Har- vorite, as they were nearly every year. They were coached by Bobby Moegle, who recently was inducted to the Texas Sports Hall of Fame. We were considered a good contender for the district title. Our opening games were in Lubbock, at Lubbock High and Mon-

When the Monterey game was about to start, we were short an umpire. Coach Woldt and Coach Moegle were at home plate with the one umpire, trying to decide what to do.

My dad had driven to Lubbock to watch us play and umpired in Pampa for years in every leaugue there was. Coach Woldt

told them that there was one of the best umpires in the Panhandle sitting in the stands, but there was one problem. He had two sons playing in the game. My bother, Gary, was the starting shortstop.

Coach Moegle asked Coach if he was fair, and the reply was "yes." Well, my dad umpired the bases in a key district game with two sons playing, based on the integrity and respect of Coach Woldt.

We lost the game and ended the season 11-3. Monterey was 12-2. We lost district by one game. In those days the second place team did not advance to the playoffs. I'm not much into "what if's," but what if we had won? What if there was a close play on

the bases that could have determined the outcome of the game. Every time I think of this, I think of what a tough spot my Dad was placed. However he was a hard nosed Pampa Oiler and I know he would have done the right thing.

On behalf of a lot of guys who truly admire and respect Coach Woldt, thank you.

By the way, Lubbock Monterey had Coach Moegle, and PHS had Coach Woldt. It's a personal opinion, but I think if Coach Woldt had coached as many years as Coach Moegle, we would have had two coaches in the Texas Sports Hall of Fame!

Problems with meddling overseas

You pay taxes? You contributed to the \$2 billion your government gave

Egypt this year. And last year. And every year 30 years. Most of it went to Egypt's military. How's that worked out?

Now our government will "cautiously" support anti-government rebels in Syria, even though some are openly allied with al-Qaida.

Years before, we paid to arm and train the Mujahedeen, the Islamic holy warriors battling the Russians in Afghanistan. That conflict led to the rise of al-Qaida. One of the Mujahedeen factions went on to become

the Taliban, with whom we now fight.

Advocates of foreign intervention argue that our government must aid friends and fight obvious foes, and that the world would be in worse shape had we not intervened. They say it's important that America send soldiers overseas to acquire "influence" in the world.

I don't buy it.

It's important to defend ourselves. We were right to retaliate after 9/11 and after the Japanese bombed Hawaii. But often politicians think: When in doubt, America must "lead." I wish they thought: When in doubt, stay out.

Political essayist Randolph Bourne famously wrote, "War is the health of the state." He was right. Whenever there is war, government grows in power, as he saw happening in the U.S. during World War I. The public longs to be led to safety. People will tolerate sacrifices and civil liberties violations in wartime that they never would tolerate in peacetime.

Once they acquire political power, even silly leftists embrace military action. After Sept. 11, Sen. Charles Schumer, D-N.Y., declared that the "era of a shrinking federal government is over." In fact, government had never shrunk. For politicians like Schumer, a terrorist attack was another excuse to spend more.

Most Americans didn't object — anything to stop terror. Political and military leaders often exaggerate threats. Adm. Mike Mullen, a chairman of the Joint Chiefs of Staff under both

George W. Bush and Barack Obama, said of the post-9/11 world, "This is the most dangerous time I've seen growing up the last

This the most dangerous time? More than when Soviet nuclear missiles were pointed at us? That's absurd.

four decades."

9/11 was horrible. But it was an unusually successful attack. Even if there were a similar attack every decade, that would kill far fewer Americans than house fires. Or stairs. Or bathtubs even. Of course, our brains are wired to react more strongly to the dramatic attack. But that fear leads us to spend big on things that don't add to our safety.

Some current Egyptian protesters are angry at America — not because they are Islamists who

We need to become like the epileptic boy

Have you ever known anyone with epilepsy? Ever personally witnessed one of their seizures? Did the violence of the seizure frighten you? It

does most folks. The example we look to in this article is that of a young boy who was possessed by an evil spirit that made him mute and inflicted him with violent seizures. His story can be found in Mt 17:14-23; Mk 9:14-32; Lk 9:37-45. A man in the crowd

called out, "Teacher, I

beg you to look at my son, for he is my only child." He approached Jesus and knelt before him. "Lord, have mercy on my son, who is possessed by a spirit that has robbed him of speech," he said. "He has seizures and is suffering greatly. Whenever the spirit seizes him, he suddenly screams; it throws him, to the ground into convulsions. He foams at the mouth, gnashes his teeth and becomes rigid. It scarcely ever leaves him and is destroying him. I brought him and begged your disciples to drive out the spirit, but they could not." "From childhood it has often thrown him into fire or water to kill him.'

How driven would you be if that was your child? If that had been you when you were a young boy or girl, how strongly would you have yearned for help? This boy was no different than you would have been; he craved with all his heart for someone to help

Even though they weren't totally confident, the father and son came

looking for Jesus. Any port in a storm. Since Jesus was on the mountain for the transfiguration, the father cried out for help to the nine disciples left at the foot of the mount. The nine were frustrated; they had cast out demons before, but not so this time. When Jesus arrived and called out for the boy, the demon went NUTZ and threw the boy into a convulsion.

Then suddenly in the midst of the boy's writhing, "Jesus took him by the hand and lifted him to his feet, and he stood up. He was healed from that moment. Jesus gave him back to his father. And they were all amazed at the greatness of God."

a steam engine, boiler and derrick for putting in a well and pumping station upon the success of which, it is said, other improvements will follow.

"In 1905, the Santa Fe Railway built the first real depot in Pampa. The building was said to be 24 by 42 feet. Located near the cattle loading chute, the depot was between West Atchison and the railroad on the west side of Cuyler Street. The depot, which had serviced both the Santa Fe and the Wells Fargo Freight Company, was destroyed by fire in 1914.

In 1908, the Santa Fe rebuilt its entire line to Panhandle and on into Amarillo. The White Deer Land Company had to give additional right of way for the part of the line that crossed the property of the land company. The Santa Fe then abandoned its tap line that had been constructed in 1888 to connect the Santa Fe at Panhandle with the Fort Worth and Denver at Washburn. Between the years 1886

and 1914, the Santa Fe built a fabulous railroad empire in the Panhandle and South Plains of Texas. This was done by purchase, by piecemeal construction of segments of track and by putting together the segments as purchased and constructed. In 1995 Santa Fe merged with Burlington Northern Railroad to form Burlington Northern and Santa Fe Railway.
