Newspapers in Education keeps the classroom current

Through the Newspapers in Education program (NIE), each week newspapers are delivered to the schools in the Pampa Independent School District.

English teachers set up different assignments and activities to familiarize their students with the paper. Some of these activities include scavenger hunts, calendar events and current events. They are able to work in groups or individually to complete these activities, which encourages the students to talk about the events they are reading about. They use the paper to practice parts of speech, editing, persuasion, propaganda techniques and advertising.

The Pampa Junior High School is among the schools in the district that implement the use of local newspapers in the classroom. Sixth grade English teacher Jamie Winborne stresses the importance of utilizing a medium students can relate to and are genuinely interested in.

Plans continue for Fort Hood shooting memorial

KILLEEN (AP) — Funding issues have delayed a Central Texas memorial to victims of the Fort Hood shooting rampage that left 13 people dead and more than 30 wounded

Tuesday was the fourth anniversary of the gunfire blamed on an Army major who in August was convicted and sentenced to death for the attack. Nidal Hasan remains in military custody pending execution.

The Killeen Daily Herald reports the memorial garden and gazebo are planned near the Killeen Civic and Conference Center. The nearly \$403,000 project will include sculptures on granite pedestals representing those who died.

Center spokeswoman Connie Kuehl says the memorial committee has raised about 75 percent of the necessary funds. Kuehl says contributions have slowed in the past couple of years.

beautiful. But at the same time he wants what is now called the Lovett building, a former dormitory for nursing students built in 1959, to look its very best.

"I don't want this to be the eyesore on Hobart Street where PISD is building its new administrative office," he told the Commissioners Court at their regular meeting last week.

With \$5,000 approved by the Commissioners, along with inmate labor from the Jordan Prison Unit, Curfman is taking the lead on a project to renovate the court room and dress up the outside with some tree work.

The City of Pampa has pitched in to help by transporting the inmates back and forth from the prison.

The 50-year-old shag carpeting in the courtroom will be ripped out and replaced with new flooring. Inmates with carpentry skills have built a new judge's bench with a witness stand and a riser. Also, the inmates have carved from wood a large seal for the county justice court system that will be attached to the front of the bench. The county paid for the materials, but all the inmate labor was free, Curfman said.



Kerik's fall from enforcer to drug war critic

Former New York police Commissioner Bernie Kerik handed

President George W. Bush nominated him to be homeland security chief, the 9/11 hero lied to federal investigators. Instead of joining the Bush Cabinet, Kerik pleaded guilty to two counts of tax fraud and six counts of making false statements. He was sentenced to four years in prison.

Free after three years in a minimum-security facility, Kerik went on "Today" to discuss not the injustice of his conviction but the injustice of federal mandatory minimum sentences that can put first-time nonviolent offenders away for decades, even life. "I had no idea that for 5 grams of cocaine, which is what that nickel weighs, 5 grams, you could be sentenced to 10 years in prison," quoth Kerik. Clearly, Kerik is not a details guy. He got everything in that example wrong except the weight of a nickel. When Kerik pleaded guilty, first-time nonviolent offenders found guilty of possessing 5 grams of crack cocaine in federal court faced a mandatory five years. The same mandatory minimum applied for 100 grams of powdered cocaine. In 2010, Congress changed the law so that 28 grams of crack invite a five-year mandatory minimum. But even if wrong on the details, he's right on the big picture. As a cop and then commissioner, Kerik said, he was involved in putting some "really bad people" - violent bad guys — away for decades, even life, for breaking state law

find himself in federal prison, "housed with men that were doing those same sentences that were there for firsttime nonviolent drug offenses." He contin-ued: "I didn't know that could happen. I didn't know that you could be sentenced to 25 years to life for a first-time nonviolent drug conviction.'

Still, he was stunned to

Eric Sterling of the Criminal Justice Policy Foundation observed that it's not unusual for white-collar criminals to emerge from federal prison enraged at not their own situation but the warehousing of nonviolent drug offenders. "It is the massive scale of this that is so moving to people."

In a speech to the American Bar Association in August, Attorney General Eric Holder said, "Too many Americans go to too many prisons for far too long and for no truly good law enforcement reason." Yet the Obama administration has failed to lead the way in reforming federal sentencing. When "Meet the Press" host David Gregory asked Obama adviser David Axelrod about Kerik's bold statement, Axelrod credited Sen. Rand Paul and other Republicans before adding Obama's name. When Axelrod wants to share the credit, that's not a good sign. "Legislators should heed his message because there's nothing in it for Kerik," Julie Stewart of Families Against Mandatory Minimums argued. "He is simply shining a spotlight on a dark hole that policymakers never look into."

Remembering the character of an old 'sole'

Some Pampans recall that they wore Buster Brown shoes when they were children and they remember Buster

Tige (Tiger). But they do not know that the real Buster Brown was four-foot tall Jack Fox who was an early resident of Pampa. John Alexander

Fox, born August 21, 1883 in Tennessee,

was a son of the Reverend William Petway Fox and Nancy J. Fox. In 1885 the Fox family moved to Peaster in Parker County, Texas .

When Jack entered Peaster School, the teacher thought he was in the wrong class because of his small size. He was quick to inform the teacher that he was right where he belonged.

In 1903 Fox came to Pampa as timekeeper for the Santa Fe Railroad. About two years later, his friend, J.E. Whitsell of the First National Bank at Weatherford, brought about an offer from the Brown Shoe Company of St.

Louis. The shoe company, manufacturer of Buster Brown shoes for children, wanted an advertising agent to portray Buster Brown, the famous Outcault cartoon character.

Fox, who had never done any acting, was reluctant to leave the railroad for he had become chief clerk at Pampa. However, persuaded by his banker friend, he changed his career and trooped the nation's movie houses, delighting thousands of children for nearly a quarter-century.

Richard F. Outcault's popular comic strip first appeared in newspapers in 1902. Later the strip made its way into comic books dealing with the devilish mischief of Buster Brown and his companions and including the consequences of their misdeeds and often some sermonizing. The serial was so popular that thousands of baby boys were named Buster and countless canines were given the name of Tige.

The character Buster Brown wore a pageboy hair style and dressed in a Little Lord Fauntleroy suit consisting of knee-length pants and a jacket with a round

collar and loose neck-bow.

About 1930 Fox retired to the Meadowbrook section of Fort Worth in Tarrant County where he was scoutmaster of a troop for several years. Because of his four-foot-height, he was given the title, "Smallest Odd Fellow in the World," by the Independent Order of Odd Fellows where he was a familiar figure. He was a Methodist and a Mason.

Fox died of natural causes on May 14, 1961 in Fort Worth and was buried beside his parents in Peaster Cemetery. He was survived by three brothers and three sisters.



lines," children begging in the streets. My grandfather was a New York City cop, and so my dad did not suffer as others did. But he never forgot the brutal scenes and worked hard his whole life to build some financial independence.

Fast-forward to the severe recession of 2008, when millions of Americans lost jobs and equity in their homes. No bread lines, but much pain. The Obama administration responded by pouring trillions of dollars into stimulus and rescue programs, some of which succeeded in stabilizing

tottering banks and auto companies. But along with that, the president and his acolytes openly encouraged Americans to use the welfare system. And now the entitlement culture has exploded.

According to the Census Bureau, more people in America today are on welfare than have full-time jobs. There is a culture of dependency being created that is truly shocking. A recent study by the Cato Institute concludes that welfare now pays more than minimum-wage work in 35 states. So why enter the workforce at the bottom if the government will give you the same compensation for sitting on your butt?

As a person who has worked extremely hard for more than 40 years, I don't want my tax dollars going to drunkards and drug addicts. And in America, there is no substance testing for welfare recipients. Every time that comes up, the civil liberties lobby screams.

America has become a much weaker nation since 2001. The wars we have fought to protect ourselves against terrorism have drained our treasury and created a deep distrust of authority. The hope and change espoused by President Obama has led to chaos in the health care arena and a massive entitlement industry that is growing larger every day.

Unless the voters wise up and get back to selfreliance and responsible government, this nation will continue down the Nanny State road. That path is unsustainable. But even worse, it is un-American.
