

McLeroy begins 21st year at Borden County

(Lamesa Press Reporter)

Enrollment is expected to remain about the same this year at Borden County School, according to Superintendent James McLeroy, who expects the student body to number about 210.

McLeroy, who this fall will begin his 21st year with the school district, said they should have about 65 students in the high school level, with another 55 in the middle school grades. The elementary grades, including kindergarten, he said, should have about 100 students.

The increase in the number of kindergarten students, along with the state-mandated 22-1 student-teacher ratio, will require them to have not one but two kindergarten classes this year, stated McLeroy.

Assisting McLeroy in running the school system are high school Principal Mickey McMeans, who has 27 years' experience at borden County and Ben Jarrett, who has been with the school for 23 years.

A newcomer to the school's staff this year is Joe Bond, who will serve as the Coyotes' new head football coach. A graduate of North Texas State University, Bond has 18 years' coaching experience and comes to Borden County from Carbon, where he was head coach for seven years.

Teachers at Borden County School are paid \$1,500 above the state base salary of \$15,200, said McLeroy, and their benefits include school-provided teacherages. Personnel is the key to providing a good curriculum, said McLeroy, and he placed the number of professional educators at the school at 28.

The school district serves the students of Borden County, a task which entails sending a fleet of 12 buses out onto routes which result in round-trip

mileage of 1,500 miles per day.

Few changes are foreseen in the curriculum this year, said McLeroy, as they expect to continue administering the curriculum and programs initiated last year as a result of state wide school reforms. Language arts are the strongest part of the school's curriculum, which is aimed at preparing students for college, he said.

"We had 100 percent of our students pass the TEAMS exam (last spring), so I feel that we've had a marked improvement in mathematics," commented McLeroy. The school also provides courses in vocational agriculture and homemaking, he added

The budget for this year is down about \$200,000 from last year, said McLeroy, giving them about \$2 million to work with this year. The value of their tax base, which is dependent on oil,

COUNTY **AG-AGENT** REPORT

HARVEST PREPARATIONS
CAN REDUCE BARKY COTTON

A lot of hard work during the growing season can go down the drain if cotton farmers fail to take the proper steps to get their crop ready for harvesting.

Lack of proper harvest preparations can lead to barky or trashy cotton which, in turn, can resutl in price discounts.

Giving attention to the following practices can help reduce barky cotton:

-- Use chemicals to prepare cotton for harvesting to suit your schedule. Waiting too long for a frost when the crop has matured can result in yield and quality losses in the field.

--Use harvest-aid compounds according to label instructions once fiber and seed have

--Start harvesting only after harvest-aid chemicals (or frost) have caused adequate defoliation and plants have dried out.

-- Defoliants used before desiccation can reduce foreign material going to the gin, especially in rank cotton. This practice can improve grades and reduce ginning cost.

-- Don't spray more acres than you can harvest before regrowth starts or stalk deterioration sets

-- Don't spray when there is clear evidence that the next four or five days will be cool or rainy; boll openers, defoliants and desiccants need warm weather for good plant response.

minerals and real estate, has dropped from a high of \$613 million three years ago to its present level of \$395 million. Despite the drop in values, the tax rate will be the same as last year, 40 cents per \$100 valuation.

"We were prepared for the drop in oil prices, we had our business in order." explained McLerov. However, he added, the district will have to deal with loss of an estimated \$300,000, in funds this year because of the drop in oil revenues.

Fortunately for the budget keepers, this will be the last year of payments on \$1.2 million worth of buildings, as their 10 year bond payment comes to an end in 1987. The total value of buildings and physical plant at Borden County school, said Leroy, is about \$3 million.

New construction at the chool this year includes a new activity room, completed during the 1985-86 school year and valued at \$128,000, to be used by physical education students. The roof of the school building is being replaced with a single-ply 'Dura Last'' roof, an undertaking which will cost \$194,000.



PROGRAMATION RESERVE

A signup for the 1987 Conservation Reserve Program (CRP) will begin August 4th and go through August 15, 1986. If you are interested in placing highly erodible cropland into a ten year program and convert the land back to grass, and if your bid is accepted, you will receive cost share payments of up to 50 percent of the elibigle costs to establish a cover crop, not to exceed \$55. per acre, plus your rental payment (rental payments cannot exceed \$50,000. for any fiscal year). If your bid is accepted, you will be allowed to harvest your 1986 crops before the contract becomes effective, if necessary. If you need more information concerning this program, please check with the county office.

1987 WHEAT PROGRAM 1987 wheat program have been announced and in very brief form we will give a few of the provisions: Be a required 27.5 acreage reduction from the farm's wheat base; wheat bases will be an average of planted and considered planted from 1982 to 1986, and 1987 yields will be the same as 1986; target price is \$4.38 a bushel; 50-92 provision will be in effect; limited cross compliance, which means that to be eligible for benefits on a participating crop, the acreage planted for harvest of any other program crop may not exceed the crop acreage base of these crops. The enrollment period for the 1987 wheat program will begin October 1 and end March

The nongrazing and nonhaying period on ACR acres in Borden County ends August 31, 1986. You can begin grazing or haying your ACR acres effective September 1, 1986

FOREIGN INVESTORS Foreign persons who acquire, transfer, or hold interest in agricultural land are required by law to report such transactions and holdings to the Secretary of Agriculture. Any foreign investor who does not report these transactions is subject to penalties.

1986 WOOL REFERENDUM A referendum will be held August 18 thru August 29, 1986, to determine whether wool producers approve of a new agreement between the Administrator, AMS, and the American Sheep Producers' Council, Inc., (ASPC) for the advertising and sales promotion of lamb and wool. If producers indicate approval in the referendum, deductions will be made from shorn wool and

unshorn lamb payments for the 1986 thru 1990 to finance the ASPC's activities.

The location of the polling place for Dawson County wool producers will be at this office. Ballots will be mailed to each known producer of wool or lambs in Dawson County around August 18, 1986. Any individual, corporation, partnership, or legal entity is an eligible voter if: (1) producer had an interest as owner or partial owner in one or more sheep, (2) sheep were 6 months old or older for at least 30 days during 1985, (3) ownership was for at least 30 days during 1985.

There will be no voting by proxy or by agent.

PAYMENTS DEFICIENCY

The Food Security Act of 1985 authorizes cotton loan deficiency payment. Producers who are eligible to obtain a price support loan on the farm and agree to forego the loan are eligible to receive a loan deficiency payment. Producers cannot receive a loan on any portion of this production. Loan deficiency payments must be requested by producers before title is transferred and requested on or before May 31, 1987.

The quanity of the crop eligible for loan deficiency payments is the actual farm production not to exceed the farm program acreage times the farm's program yield. Sufficient evidence must be submitted to

this office that include the grade, staple, micronaire, and net weight of the bales. Warehouse receipts, class cards, or lists with gin bale numbers and gin code is acceptable evidence.

Producers who do not submit acceptable documentation showing the grade of the cotton will receive a loan deficiency payment based on Strict Good Ordinary spotted 1 inch, micronaire 2.6 and below. The net weight of elegible bales of cotton must weigh at least 325 pounds, but no more than 600 pounds. Bales that weight more than 600 pounds can receive a loan deficiency payment, but payment will be on 600 pounds instead of what the bale actually

The loan deficiency payment is figured on a per bale basis. The loan deficiency payment rate is the difference between the loan rate (55.20 cents) and the loan repayment rate (80 percent of the loan value for the bale of cotton).

Payments will be paid in 50 percent cash, subject to Gramm-Rudman reduction, and 50 percent in CCC-6's (certificates).
