4. FIRING OF INEFFICIENT UNION WORKERS CANNOT BE DONE EXCEPT WITH CONSENT OF LABOR BOSSES.

In 1950 Hall County wrote and sponsored a resolution declaring against changes in our labor laws and endorsing our present "Right To Work" labor law.

Under the leadership of Allan Shivers this "Right To Work" resolution was passed by the Texas Democratic Convention in Mineral Wells.

Despite the strenuous efforts of the CIO-PAC labor bosses, this "Right To Work" law has remained unchanged until now.


This year for the first time in Texas history union labor bosses have played a decisive role in a Texas election.


