## EASTER SEAL APPEAL

Kinney County's Easter Seal Repsresentative reporter today that the 1975 Easter Seal. Appeal of the Easter Seal Society for Crippled Children and Adults is going well but urged all citizens who have not responded to the Appeal to do so

Albert Postell, of the First State Bank, serves as Easter Seal Appeal Treasurer for the County. The 1975 Easter Seal Apneal will finance the Easter Seal Society Rehabilitation program for crippled children and adults in Texas. Last year the Society helped 20,152 persons through its program of assistance in finding and making effective use of services for the disabled and their families.

The Easter Seal Society helps support 17 treatment facilities in Texas where children and adults not eligible for other assistance are treated. These centers offer physical therapy, medical diagnois, speech and hearing programs and related services to help the disabled build happier and more useful lives. The Easter Seal Representative is the person to contact for services from the Easter Seal Society. He can be contacted at 563-7315 and ask for Albert Postell, for the request form to be sent to the Texas Easter Seal Society to determine the needs of the disabled person. The Society will provide the services or will direct the handicapper person to the best resources available to help him. Contributions to the Easter Seal Appeal should be sent as soon as possible. The Annual Spring Appeal continues through Easter Sunday, March 30.

## FOOD SHOW HONORS <br> UVALDE----- Sixteen area youth

First and second place contestants were recongnized in each of the four food classes for Senior, Junior, and Preteen competition.

Senior division winners are: Kaye York of Kinney County with "Son-of-a-gun Stew" in the main dish class; Sharon Pfluger of Edwards county with "Sun Gold Potato Mold" in the side dish class; and Dennette Haby of Edwards County with "Southwest Meat Dip" in the snacks andbeverage class. In the breads and desserts class, there was a tie between Connie Wheeler of Bandera County with "Orange Cake" and Marianne Dietert of Edwards County with "Texas Nut Bread". A coin flip earned Connie Wheeler the trip to the State $4-\mathrm{H}$ Food Show next June along with the other three Seniors to vie for $\$ 500$ scholarships in their respective entry classes.

Capturing the alternate position in the Senior division and also a blue ribbon were Denise Kirchhoff, Kerr County, in the main dish class; Vicky Gilliam, Medina County, in the side dish class; Marianne Dietert, Edwards County, in the breads and desserts class and Tammy Henerson, Kerr County, in the snacks and beverage class.

In the Junior division competition, the main dish class held a tie between Melissa Graham, Edwards Edwards County, with 'Texan's Delicious Oven-Barbecued Chicken" and Elaine Hildebrant, Uvalde County; who exhibited 'Tuna-Noodle Casserole". Second Place in this class was won by Lisa Grace, Hays County. Lori Ann Voigt, Kendall County, won the side dish class with "German Potato Salad" while Catherine Edmonds, Kerr County, placed second. Another tie for first place was found in the breads and desserts class between Bexar County's Jamie Wolfe who prepared "Chocolate Buttermallow Cake" and Medina County's Angela Bradgen who made "Caramelized Apple Parfaits". Second place in this class was earned by Dee Anne Smart of Edwards County. And, once again a tied position cropped up. This time it, was in the snacks and beverages class between Teresa Dudley, Bexar county; with "Mystery Pecan Pie" and Roy Jay Harris, Val Verde County with "Banana Punch". Jennifer Taylor, Kerr County, placed second.

The Preteen division competition rated Robert Daniel Foster, Medina County, first place with his "Pork Chops of the South West" in the main dish class and second place went to Karen Walter of Real County. In the Side dish class Sandra House, Atascosa County, placed first with " Carrot-Pineapple Salad" and Ella Blair, Zavala County won second. Josefina Barrera of Kerr County, won the Breads and desserts class with "Lemon Pound Cake" and Elaine VanHecke, Bexar

County, received second place. The snacks and beverages class placed Melissa Harris, Val Verde County, first with her "Shrimp Congealed Mold" and Diana Smart, Edwards County second.
