

COMMISSIONERS COURT REGULAR MEETING APRIL 14, 1975

ATTORNEY SHAHAN READ AND EXPLAINED OPINION OF STATE'S ATTORNEY AS TO BASIS OF SALARY OF J. P. FOR PRECINCT NUMBER ONE

The Attorney General's opinion on the salary for the Justice of the Peace Precinct Number one as follows: the salary cannot be lowered from the January 1, 1972 level (\$6240.00 per year) and is considered as to the office, not the individual elected to the office after that date. Commissioner Glover made the motion which was seconded by Commissioner Talamantez that the salary recommend ed by the State Attorney General be paid to Justice of the Peace Raymond Talamantez, Precinct One. This will be the same salary basis as paid to Justice of the Peace Postell while he held that office. The salary will be retroactive to January 1, 1975. There was unanimous approval to this motion, and the motion passed.

SALARIES FOR CONSTABLE AND JUSTICE OF THE PEACE FOR PRECINCT NUMBER THREE VOTED UPON

Commissioner Talamantez made the motion that the salaries for constable (none at present time) and for Justice of the Peace (David Seargeant) for Precinct Three be set at \$1.00 per year rather that \$300.00 per month. Commissioner Glover seconded the motion. Commissoner Clover and Talamantez voted "yes" for the motion, Commissioners Johnson and Fuentes voted "no", and Judge Seargeant voted "no". The motion failed to pass.

ALBERT POSTELL WANTS SALARY ALLOTED TO J.P. FOR PRECINCT ONE IN HIS NEW OFFICE AS J.P. PRECINCT TWO

Albert Postell, the J.P. for Precinct Two, told the Commissioners that he was investigating the possibility of keeping the same amount of salary that he received as J.P. of Precinct One. Commissioner Glover made the motion that Mr. Postell be allowed his former salary as J.P. of Precinct One, and that the former salary of Pete Gomez be paid to Mr. Gomez's widow retroactive to the time that the constable salary was cut by the Court. Commissioner Clover withdrew this motion when no second was made for it. Commissioner Glover made the motion that Emil Schafer be allowed a Constable's salary of \$2515.00 and \$900.00 travel allowance retroactive to January 1, 1975. Commissioner Talamantez made a second to the motion. Commissioners Talamantez and Glover voted "yes", Commissioners Johnson and Fuentes voted "no", and Judge Seargeant voted "no" which defeated the motion.

A full entertainment schedule is set for the upcomming season including stage shows and Western Melodramas.

Commissioner Talamantez wished to know who made the rental agreements for the Civic Center. Judge Seargeant said he was responsible for renting the Center and would bring a rental rate to the Court for their discussion at the next meeting.

Mr. Postell presented a letter to the court from the Federal Reserve Bank and asked the \$50,000.00 be withdrawn from the Reserve Bank. Comissioner Clover made the motion that the First State Bank make the withdrawal. Commissioner Johnson made a second to the motion which was passed unaminously.

Commissioners's Court was recessed until the next meeting on Wednesday, April 16, 1975 at nine o'clock in the morning.

Meeting adjourned.


PRESIDENT


Johnny On TV

Soil Conservation

Forty years ago, the country faced tremendous problems brought about by erosion, floods, land damage, and violent dust storms.

On April 27, 1935, a new agency, the Soil Conservation Service, was created to combat the forces that threatened to lay waste to millions of acres of cropland. The Soil Conservation Service began working with landowners of demonstrating means of erosion control, but it became apparent that really effective conservation work was done better when landowners led the job themselves.

In 1937, President Roosevelt recommended that each state legislature enact laws permitting landowners and land occupiers to form units to be called Soil Conservation Districts. Rallying to the call, all the states, Puerto Rico, and the Virgin Islands, enacted laws permitting formulation of districts.

Soil and Water Conservation Districts set out to focus attention on land and water problems on all privately-owned land, develop annual and long range programs designed to solve the problems, and to enlist all the appropiate help available from public and private sources.

Now, over 3,000 conservation districts, covering 97 percent of all privarely-owned lands, have formed in mutual concern to protect, conserve, and improve the world we live in.

Typically, a conservation district has five supervisors, elected by local landowners. The supervisors work with the Soil Conservation Service District conservationists and other agencies in helping the landowner apply conservation measures on his land.

More than two million landowners are voluntarily planning and applying conservation measures in local soil and water conservation districts. They are helping to control erosion, improve water supplies, prevent floods, curtail pollution,

and develop recreational areas.

The National Association of Soil and Water Conservation Districts (NACD), organized by district leaders in 1946, is the means by which the districts make their cause known and voice heard.

George R. Bagley, contton

George R. Bagley, cotton farmer and real estate developer of St. Joseph, Louisana, is president of the NACD.

"This land is more than a place to live," Bagley said. "It holds our future. How well we treat it will ultimately determine how well we live."

" Conservation and wise development of our natural resources have never been more important. Soil water, forests, fish and whildlife, open space, and natural beauty are threatened by misuse and waste. Our total environment is under pressure.

"But more that agriculture is involved. Many district programs are directed toward meeting problems of suburban expansion. Districts are cooperating in site location, sediment control, beautification, economic development, and land use panning," Bagley continued.


The principal source of technical assistance to the districts is the Soil Conservation Service. SCS provides a district conservationist for each district to help carry out conservation programs.;

The scope of the Soil Conservation Service program has expanded since established 40 years ago. And the Soil and Water Conservation Districts have grwon beside it, bringing a better life and future to everyone.

Learn About Freezing Food at Home-May 1 in Uvalde

A meal on a moment's notice; fresh corn in December, deer from last fall's hunt-all compliments of the home freezer.

Freezing is one of the simplest most popular methods of preserving foods at home. It retains the natural color, flavor, texture, and food value of most fruits and vegetables, meats and baked goods.

The quality of the food frozen can vary with freshness of product used, methods of preparation, packaging and conditions of freezing.

Freezing food at home will be one of the topics discussed at the Food Preservation Seminar on Thursday, May 1, from 10:00 a.m. --12:00. The Seminar will be held at the Texas A&M Research and Extension Center, in Uvalde. Mrs. Mary K. Sweeten, Foods and Nutrition Specialist with Texas Agricultural Extension Service, will discuss the freezing section while Mrs. Shirley Johnson, County Extension Agent, bexar County, will discuss canning. There will be exhibits of equipment needed for preserving and free publications will be available. The seminar is being sponsored by the Family Living Task Force of STAR and the Texas Agricultural Extension Service. Mrs. Velda Cole of Hondo, Area Program Officer, will preside. Mrs. Naida Garvin of Kerrville serves as Chairman of the task Force.

YOUR REPRESENTATIVE by: REPORTS

This is the critical period in the legislative session when many people would like to voice their opinions on particular pieces of legislation and often wonder how best to make their viewpoints known. The most effective way is to contact your State Representative, There are several ways to do this --- the cheapest and eastiest being to drop a postal card to me (at Box 2910, Austin, Texas, 78767) stating that you're for or against a certain bill. If you want to go into more detail, write me a letter. Or, if time is critical call me at (512) 475-2763. I welcome hearing from constituents.

By the time this column appears the House will have acted on the proposed new State Constitution, which the Senate passed earlier in only one day's time. There are many pros and cons on the actual draft; but I think the concept of salvaging something from the 3 million dollars and many months of work already "spent on Constitutuional revision is a sensible one.

At least it would allow the voters to express themselves once and for all. Until this happens, there will be a continuous, powerful cry to call a very expensive Citizen's Convention (which we've basically already had in the Constitutional Revision Committee and its public hearings) to hask over the same items that have already been dehated at length. No one will ever be able to draft a constitution that is 100% acceptable to everyone, and now is the time to let the citizens of Texas accept or reject a new constitution and then lay the issue to rest.

A very frequent complaint, particularly ir our rather isolated area of the state, is that we never hear about what state agencies in Austin are doing until it is already too late. Hcpefully the legislature has remedied this somewhat by passing a bill which would create a "Texas Register." This information sheet would be published twice a week and available by mail to any interested person. If would list all public hearings that are scheduled by various segments of state government; proposed changes in rules and regulations by State Agencies; and, in general, keep the people of Texas aware of and up-to-date on pending action that affects them.




