
Dear Mr. Loos,

COUNTY ATTORNEY RESIGNATION

County Attorney Tully Shahan presented the following letter to the Court:

I include with this resignation my sincere thanks to you for your cooperation and a chance to work in a field of Law in which I am intersted. My two and nine months as County Attorney of Kinney County will never be forgotten.

Commissioner G.C. Talamantez made a motion to accept Tully Shahan's resignation as County Attorney and Commissioner T.H.Glover seconded the motion which passed unanimously.

JIM FAITH PRESENT

Jim Faith of the auditing firm of Meredith, Colemon & Dalrymple, met with the Court to review the 1975-1976 budget for Kinney County. Mr. Faith requested that the Justices of the Peace turn in all reports by September 30, 1975, to implement the 1975 audit to take place in October 1975.

PROSECUTION ASSISTANCE PROJECT RESOLUTION

Commisioner G.C. Talamantez, made a motion to pass the following resolution for Kinney County's participation in the 63rd Judicial District prosecution assistance project, the motion was duly seconded by Commissioner T.H.Glover and passed unanimously, to-wit:

WHEREAS Val Verde County, Texas, through the auspices of the Middle Rio Grande Development Council of Local Governments is attempting to secure a grant in aid from the Texas Criminal Justice Council to maintain a prosecution the funds as set out below. The motion assistance grant for the 63rd Judicial District; and,

WHEREAS, Kinney County, Texas, desires to participate in such prosecution assistance project;

NOW, THEREFORE, be it resolved the Commissioners' Court of Kinney County, Texas meeting on this 8th day of Sept., 1975, in Regular Session, a quorum being present, as follows;

1. That the County Judge of Kinney, County, Texas as agent for such County, be authorized to execute such document or instruments as may be required to allow such County participate in such project.

2. That the Commissioners' Court make space available in either the County Courthouse of such County or other County public building for use as an office for such prosecution assistance project.

3. That the Commissioners' Court commit such sums of money in support of such project so far as it is able to do so.

The foregoing Resolution was passed at the Regular Meeting of the Kinney County Commissioners' Court, to be entered in the Minutes of such Court on the 8th day of September, 1975.

The sum of \$2,000.00 was included in the new budget for the above project. Meeting recessed until September 12, 1975 at 9:00 o'clock A.M.

Commissioner L.S.Johnson made a motion duly seconded by Commissioner Manuel Fuentes to pass the following resolution which passed unanimously,

WHEREAS, In order to continue with the administration of county affairs, it is necessary at this time to borrow additional funds to cover county expenses; and,

NOW THEREFORE, BE IT RESOLVED by the Commissioners'Court of Kinney County, Texas, that the Commissioners' Court be authorized to execute notes in the amount of Eighty Thousand and No/100 Dollars (\$80,000.00) for the fiscal year ending September 30, 1975.

PASSED AND APPROVED this the 12th day of Sepetmber 1975. TRANSFER OF FUNDS

Commissioner G.C. Talamantez made a motion to transfer the \$30,000.00 to was seconded by Commissioner L.S.Johnson and passed unanimously.

To transfer from the General Fund to the following funds:

Officers' Salary Fund: \$8,500.00 Road & Bridge Fund : \$8,000.00 Kinney County Ambulance Fund: \$ 500.00

General Fund 1975-1976 BUDGET : \$13,000.00

Commissioner L.S.Johnson made a motion to approve the 1975-1976 budget as presented to the Court by the County Auditors. The motion was seconded by Commissioner Manuel Fuentes and passed unanimously.

FAMILY CANCER PLAN INSURANCE

Commissioner G.C. Talamantez made a motion to add extended coverage for the County Employees Famil Cancer Plan Insurance. The motion was duly seconded by Commissioner T.H.Glover and passed unanimously.

TRAPPING CONTRACT

Commissioner L.S. Johnson made a motion for the County to enter into the new contract with the Texas Animal Damage Control Association and increasing each trappers salary by \$25.00 which would amount to a \$75.00 increase for the three trappers working for this county. The motion was duly seconded by Commissioner Manuel Fuentes and passed with the following vote.

A little plant life can make a house or room come to life. There are no. plants that will live without some care. There are, however, some that demand less care than others. For all the fun made of philodendrous and all the talk of the "philodendon syndrome," these plants remain the simplest to care for and can add of outstanding warmth, life and beauty. There is a wide variety of these plants with differing growth patterns. Certainly they do better with lots of light but most do well with a medium amount of light either natural or flourescent. The plant should be chosen for the spot. It's always better to decide where a plant will sit and choose a plant to fit the place. Corners, open walls, large blank places need tall, large leaf or wide spread plants. Coffee table, end tables, step tables, small areas can best use plants of smaller stature and slower growing proclintiy. NATIONAL HIGHWAY WEEK

By official menorandum, Governor Dolph Briscoe has designated the period of September 21 to 27, 1975 as National Highway and Transportation Week in Texas, with the theme "Transportation, America's Lifeline" with a call on all citizens to observe the week with appropriate recognition that transportation is indeed America's Lifeline.

The Highway system was created over a period of about a half-century and has affored Texas with a vital linkage with other transportation systems serving the public. The varied forms of transportation are a direct product of public demand for maxmium service at minimum cost, a demand that will continue by ordinary citizens to sustain their way of life.

In view of the increase in population, inflation, congestion, and the elimination of indiscriminate use of energy, great challenges face those responsible for providing good transportation. The goals are not as clear or as easily attained as they have been in the past. The facing of many of these problems in transportation has been given to a new State Department of Highways and Public Transportation.

Since the New State Department of Highways and Public Transportation came into being in June, public transportation problems are being identified adn studied, and approaches are being planned to meet the challenge, in addition to taking care of normal highway demands.

In each county the creation and maintenance of the Highway System is dependent upon the local highway maintenance sections and engineering residency offices. Men and women stationed locally in the communities they serve are sensitive to the local area transportation needs. These personnel will continue to provide the best possible transportation system for those communities in which they serve.

During National Highway and Transportation Week, the public is especially invited to visit local maintenance section warehouses and resident engineer offices, as well as the Del Rio District Office. The local facilities are located on U.S. Highway 90, East and are open daily to public inspection, to include visits from Public Schools or other school classes. These are the same offices in which you may be provided with travel maps, pamphlets, and brochures, along with general and specific information regarding highway conditions. You will find highway and transportation personnel to be very glad to see you and helpful in providing service and assistance in matters relating to their work.

Transportation, America's Lifelines, means the sustaining of your way of life as safely as possible. You may go from City to City, anywhere in the City, rural areas, or to remote places of majestic scenery, because you have demanded and are willing to pay, as as user, for the great American freedom or mobility. Your continued assistance is important to strengthening the Transportation framework that is so necessary to your livelihood.









