As Mr. Schuehle actually served legally as Kinney County Attorney, but not physically, for one month, I wonder how he can meet residency

# COMMENTS from THE SAGEBRUSH

Nature is strange. One would think as much cold weather as we've had there would be no insects. The hard freezes should have killed them. But it hadn't happened. There are already some bugs to be seen that we normally see much later in the season. This means you should watch carefully any new growth. Ask trees particularly are subject to early insects. As the leaves first open out if ther is any sign of whitish or purpleish substance on the small new leaves the tree should be sprayed innediately. Damage to these early leaves can cause problems for the tree all summer. With warm days and cool nights many types of plant lice or aphids will attack plants, particularly new growth and buds. Spray early and save not only the new growth but prevent loss and later problems.

### Soil Conservation

The Soil Conservation Service has announced the reprinting of a widely used SCS publication, "Conquest of the Land Over 7,000 Years." The author of the journal, written in 1942, was Dr. Walter Clay Lowdermilk, a pioneer in soil and water conservation.

In 1938, the U.S.Department of Agriculture connissioned Lowdermilk tomake a servey of land use in the older European and Asian countries in the interest of conderving our own land resources.

"The Land bears a record of what men write on it....a record easy to read by those who understand the simple language, "Dr. Lowdermilk wrote.

In his tour of England, Holland, France, Italy, North Africa, and the Near East, Lowdermilk followed agriculture from its beginnings 7,000 years ago to modern times.

He observed fields that had been in cultivation for thousands of years. The publication is a prophetic account of his search for reasons why

land that once supported thousands of people now lays in abject waste.


The answer to his quest was soil erosion. He tells why erosion acted as a catalyst in the descration and destruction of many advancing civilizations.

"One of the most important findings on this survey of the use of land through 7,000 years,: Lowdermilk said in summation, "it that tillers of soil have encountered their greatest problem throughout the ages in trying to establish a permanent agriculture on sloping lands."

The publication, AIB-99, "Conquest of the Lnad Over 7,000 years," is available from your local Soil Conservation Service Office.

Call it "eager beaver," "hopeful," "early bird" or whatever.
I put up a humming bird feeder a few days ago. Last year by this time the early flight of birds had already gone through and a few of the early "stayers" were in. But so far not a single bird have I seen.

The hot weather led me to feel the hard winter had passed. The sprouting ash and mulberry and the blooming peach conned me into thinking, "No more cold weather." Yet experience and common sense tells me we're yet to see the last of the winter cold.

How many times we human beings let our emotions run away with our minds. We elect public officials, not on qualifications, but on emotion. We daily make decisions based, not on fact, but on emotions. Our relationships socially are based on emotion. There's nothing wrong with emotions. We'd be a sorry lot if we had no emotions. But emotions in perspective lead to good sensible and noble actions. 

spent hours in hearings of the Armed Services Committee and additional hours studying related documentary material, because our committee must recommend how much money shall be allotted to the Defense Department and how that money shall be used.

Because I believe that our nation must have defense strength second to none-incidentally that's the same position that President Ford has often taken-I've asked each major witness the same question; Are you proposing a budget that will keep our strength second to noe? I've had the same answer every time. It's been this; "Given the current fiscal restraints, this budget is adequate." To be very blunt, I don't find that reply satisfactory.

My concern is with the qualifying phase, "given the fiscal restraints." I've expressed that consern to the witnesses. I've told them that I believe the nation would be better served if they'd tell the Congress what they need, without modifying their requests. I've told them I believe that the "fiscal restraints" are provided by Administration officials, in the White House and the Office of Management and Budget.

I do not believe that whatever their skills are with computers or statistics, the OMB knows enough about our military needs to determine budget levels. I don't want to ask American citizens to pay any more taxes than are necessary, but I believe that the "fiscal restraints" of today could become real dangers to our national security in the next

generation.

The Secretary of Defense, the service secretaries and even the chiefs of the uniformed services are appointees of the President. Each of them noe serving know that Hames Schlesinger was aked for his resignation because he fought hard to remedy the weaknesses he saw. The secretaries, the generals and the admirals must accept the decisions of the Executive, the policies set by the Commander in Chief.

So they call the budget requests "adequate." But they also testify on shortages of personnel and equipment. The navy admits that 50 percent of its aircraft are not combatready, and the Air Force figure is about 30 per cent. General David Jones, Air Force chief of staff, testified that he had more flight training in the first two and a half years of his service that today's bomber pliots get during their whole career. Every service is cutting back on training, and maintenance programs are obviously being reduced when skilled civiliam employees are being laid off.


