## VETERAN'S LAND PROGRAM

Land Commissioner, Bob Armstrong today announced the sale of \$35,000,000 in bonds for the Veterans Land Program at a low interest rate of 4.0623 per cent.

"This sale will enable us to fund veteran loans for the backlog of applications which built up in our office last Fall," Arm-

strong said.

" The market conditions were so favorable that this low interest rate will mean that we can still make loans to the more than 2,800 veterans who have applications pending at our current low interest rate of 5½ per cent," Armstrong


Armstrong said the favorable low interest rate and the high number of bids for the bonds indicate the strong financial condition of Veterans Land Program bonds which are consistently given the highest Triple A rating.

"This is of tremendous importance to Texas veterans who can benefit from a low interest rates we receive," he said.

Armstrong emphasized that this bond sale do not mean the immediate reopening of the Veterans Land Pro- . gram, which temporarily stopped taking new applications in December

ORDINANCE NO. 123

(Excerpt) SECTION 6. The City Marshal and any policeman of the City shall have the right to shoot or kill any rabid dog or any dog in thestreets which shall manifest a disposition to bite.

## **COMMENTS** from

THE SAGEBRUSH DE TOWNSEND

It is now full time for gardening. The fine rains and the warmer nights make things ideal for growing. It's time to put out tomato plants and peper plants. If you haven't lost much. The cool nights and the winds have not been ideal to growth of plants. It's time to plant beans, squash, beets, watermelons, cantaloupes, carrots and the various types of greens, spinach, kale, mustard, leaf let-

tuce for the table, swiss chard, etc. When you plant, don't plant too deep, sprinkle well but lightly. When the plants are well up keep watered; after sprinkle watering or a rain, break the ground well around the plants with a hoe. See that the garden has plenty of water but not too much if you can help it. Some plants will not produce and will die if kept too wet and then faced with too much hot sun. This need not happen because of your watering. If it happens let it be because of too much rain. Watch for insects of any kind and at the first sign of any spray with a good insecticide. This is better but if you prefer to dust the plants this should do the job. Don't let insects rob you of the tasty food you have planned for your




