LOCAL RESIDENT SUCCUMBS

Prominent Brackettville businessman, Tom L. Roselle, 54, died Friday morning of a heart attack in his home.

Services were led Monday at 10:00a.m. at the St. Mary Magdalene Catholic Church, officiated by Father Edward Postert, O.M.I.

Mr. Roselle was born September 30,1921 in Austin and had resided in Brackettville for 30 years. He served as County Judge from 1967 to 1971 and as Mayor and City Council man. Past president of the Rotary Club, Mr. Roselle had just been re-elected as Vice-president of the 36th Infantry Disvision Association. He served in World War II in the African and European campaign and was a member of the Disabled American Veterans, Veterans of Foreign Wars, Non-Commissioned Officers Association.

Survivors include his widow, Mrs. Evelyn Roselle; sons, Micheal, Lee Roselle and Lance Thomas Roselle; daughters, Lisa Roselle; and Traci Roselle; and his mother, Mrs. Grace Earwood of Austin.

REGULAR MEETING, MAY 10, 1976

FORT CLARK SPRINGS UNIT NO. 14 PLAT

Mr. Rich Adams of Fort Clark Springs Association, Inc. met with the court and requested that the Recreational Vehicle Park Plat, Unit No.14, filed in the Plat Records of Kinney County, Texas, be cancelled and a new plat of Unit No. 14 be accepted and approved.

Commissioner Manuel Duentes made the motion to cancel the old plat of Unit 14 and accept and approve the new plat of Unit 14, Fort Clark Springs. Commissioner L.S.Johnson duly seconded the motion which passed unanimously.

1976-1977 HUNTING, FISHING & TRAPPING PROCLAMATION

Commissioner L.S.Johnson made the motion to accept the 1976-77 No. A-4, Statewide Hunting, Fishing and Trapping Proclamation as submitted by the Texas Parks and Wildlife Commission to Kinney County. Commissioner Manuel Fuentes duly seconded the motion which passed unanimously.

LAW ENFORCEMNT COMPLEX INSPECTION

Sheriff Sheedy requested the commissioners' Court to inspect the new jail with him, and pointed out out that there were several leaks in the roof, at least three cell locks that were defective and that the air conditioning was not operating properly. Mr. Graves, architect for the Law Enforcement Complex was present and presented the following copy of a letter he had sent to Walter Droemer Construction Company, the general contractor for the jail project.

Attached hereto is the Inspection REport sent you earlier concerning problems of the Kinney County Jail Project. CONSTABLE PRECINCT NO. FOUR

Commissioner G.C.Talamantez informed the court Emil Schafer, Constable Precinct no. 4 has asked him to tell the Court that if he, Constable Schafer, dod not get his back salary that he intended to sue the County. The court asked County Attorney Hal Landrum to check with the Attorney General regarding the salary of Constable of Precinct No. 4 and the following is his findings, to-wit:

MEMO: TO COMMISSIONERS' COURT KINNEY COUNTY

RE: Authority of Commissioners'
Court to cut wages at mid-term of
constable (Attorney General's
Opinion)

Art. 30-12k Sec. 2. (a) provides that

"The salaries, expenses, and other allowances of elected county and precinct officers shall be set each year during the regular budget hearing and adoption proceedings or by giving notice as provided by this act.

Salaries are set during the regular budget heraring for a full year. There is no exception under Art. 39-12k which would allow the Commissioners' Court to change that.

It is the opinion of the Attorney General's Office that the commissioners' court can't cut wages of the constable at mid-term.

The commissioners' court definitely cannot lower the constable's salary below the salary existing on January 1, 1972.

Op. Attorney General 1973 No. H-39

There was no salary office of Constable of Precinct No. 4, on January 1,1972, so the Court tabled the matter.

BRACKETTVILLE VOLUNTEER FIRE DEPARTMENT

Alvin Hall, chief of the Brackettville Volunteer Fire Department met with the Court and reported that the Fire Department had cleared \$500 on the dance and wanted to purchase tables and chairs for the Civic Center and also a towel rack for the men's room in the Civic Center. Mr.Hall requested that the county pay \$132 on the new tires purchased for the rural fire truck and the Court agreed to pay the \$132.

COUNTY ATTORNEY REQUESTS EQUIPMENT

County Attorney, Hal Landrum requested a new typewriter for the County Attorney's Office. The Court said they would look into the matter.
TRANSFER OF FUNDS

Commissioner L.S.Johnson made the motion to transfer \$14,000.00 from the Road and Bridge Fund to the General Funds. Commissioner Manuel Fuentes duly seconded the motion which passed unanimously.

Meeting recessed for jail inspection.







With the cool weather and rain weeds continue to be a real problem. There are many chemicals in the agricultural field that will kill weeds. Most of these require warm weather and host sum to be really effective. This we have not had so the only good way to control weeds under the present conditions is to have hem hoed out or pull them up bu hand. If they are in your lawn you can feed the lawn and it will eventually crowd our the weeds. In other plans there is no better way than hard work and time to get rid of them. For the most part if you get them cleaned out in good fashion now, you will have a minimal problem in the future. If you let them grow in a "few days" you will be in deep trouble. Only a few days and weeds pretty will take over the place. By all means dispose of them before they seed our and cause you to have more weeds. When hot sum and warm nites arise you can effectively use commercial weed killers. They are the easiest and best---when they work.



Pinales, Gomez To Attend Seminar

Fidencio Pinoles and Florentino C. Gomez of Brackttville, students a Brackett High School, will attend the 16th Annual Texas Nuclear Science Symposium for High Schools at the University of Texas at Austin, June 1--4.

S. Lee Schermerhorn, science teacher at the High School, will accompany them to the symposium.

Central Power and Light Company, a member of the Texas Atomic Energy Research Foundation, will sponsor them. The foundation and the University are co-sponsors of the symposium.
