




Semator Lloyd Bentsen Watching Washington

Smuggling heroin from Mexico into the United States across our own state of Texas has become big business, dangerously big.

Over the past year alone 102 plane crashes along the U.S. Mexican border involved the illegal drug trade. Ninety percent of all the heroin seized in the United States today comes from Mexico, which amounts to about 10 tons a year.

And now there is new and disturbing evidence that stolen U.S. military weapons are being traded for narcotics in Mexico. According to testimony given to Congress by the Director of the El Paso Intelligence Center of the Drug Enforcement Administration, the setup is this:



weapons. Revolutionaries are one, and narcotic traffickers the other. Both have found that

the best way to get these weapons is to trade drugs for them. An ounce of heroin, for instance, will buy them an M-16

rifle worth about \$1,000 on the black market.

It's not a pretty picture, but it's the way it is. The El Paso official says some 700 stolen military weapons have already definitely entered Mexico. And the Drug Enforcement Administration has received repeated reports of numerous aircraft carrying military and civilian weapons into Mexico and coming back, carrying large drug cargoes.

I want to put an immediate stop to this, but apparently the Defense Department is dragging its feet. El Paso's DEA representative told Congress he's had a lot of trouble getting any kind of cooperation from Defense officials, and aside from a get-acquainted visit, there's been no move for a joint DEA-Defense effort to cut off the supply of stolen weapons.

This is why I've personally asked Chairman John Stennis of the Senate Armed Services Committee to conduct a full in vestigation into the situation. This should serve as a needed springboard to whatever steps are necessary to get the job done

In the meantime, we can be encouraged by reports that a cooperative U.S.-Mexican effort to eradicate the poppy fields in Mexico that produce heroin is beginning to show some returns. In the past few months 18,000 poppy fields spread over 5,000-acre area have been destroyed through the use of herbicides.

DEA Chief Peter Bensinger also reports to me that U.S. and Mexican officials are confiscating an increasing amount of heroin being shipped into our country. Last year, 2,459 bounds of heroin were removed from the international market, which is twice as much as in 1974.

Obviously our border monitoring system is an integral part of this effort and I intend to continue my personal fight to obtain enough personnel and enough funding to maintain an effective monitoring system.

I believe this is vital, both to reverse growing drug addiction among our citizens and to stem rising crime throughout the nation.







KAZEN IN WASHINGTON

One important function of the Congress is called "legislative oversight," by which is meant that our committees check up on the effects of our actions to make sure we achieve the purposes we intend. In using our oversight function on the Clean Water program, the House Public Works committee, led by our Texas colleague Jim Wright, has discovered that only nine per cent of the funds authorized by the Congress have actually been put to use during the past three years. Bureaucratic red tape, impoundment of funds and court decisions have snarled the clean-up of our streams.

We are therefore soon to consider a new bill that would streamline the adminstrative: processes and financing requirements that have caused problems for so many local governments, and the legal argument over whether all streams as "navigable waters." It would also revise the distribution of federal funds more equitably.

In our district there are a number of proposed projects which have been snarled in the bureaucratic red tape. These include projects in San Antonio, Pleasanton, Karnes City, Jourdanton, Lytle, Dilley, and other areas.



TEXAS TECH SLATES TRAIL DRIVE

SAN ANTONIO--It's getting mighty close to "head 'em out" time for the Texas Tech Bicentennial Trail Drive slated to depart San Antonio June 27the for the more or less 400-mile trek to Lubbock and Texas Tech's Ranching Heritage Center.

With stops scheduled at Kerrville, San Angelo, Stamford and Midland along the way, the Texas Longhorn herd of some 70 animals will arrive on the Museum grounds during late afternoon of July 2, hopefully, in time for official dedication ceremonies at 6:00 p.m.

Trail boss for this historic event is Chas. Schreiner III, owner of the YO Ranch, Mountain Home, Texas. Schreiner headed a drive to Dodge City in 1966 so this isn't his first encounter with trail drive problems. He also runs a good-size herd of the contankerous Texas Longhorns on his YO Ranch so is familiar with their "cussedness." The drive will be made up from the Texas Longhorn herds of the YO, Carter McGregor near Wichita Falls and Dan Harrison of Houston.

This symbolic event is slated to draw attention to the fabulous 12-acre Ranching Heritage Center of Texas Tech University. A Collection of authentically restored buildings, including a Schoolhouse and aMeat and Milk House, depicting the history of ranching in the United States.

The Ranching Heritage Center opened its first building in 1970 the Renderbrook-Spade Blacksmith Shop, and since that time as the center has grown to its present 20 buildings and near completed condition, more that 80,000 visitors have toured the site.

Ramrods for this Bicentennial historical event are the world renowned cartoonist Ace Reid of "Cowpokes: fame; Jimmy De Lesdernier, Special Texas Ranger and VAn Poorman. Both Reid and Jimmy Dee, as he's more often called, made that long trek to Dodge City in 1966 so they too are familiar with the rigors of trail drives.

As the herd of Texas Longhorns reaches each of the cities along the route where stops are planned the drive will go through town on the main street in most cases so everyone will be able to get a good, close, look at the real Tex-



By now you can easily tell if you have problems with your grass. It you had good turf last year and there is none now, something quite evidently has killed it. If it is carpet grass it well could be some type of grub in the soil or some insect. It may well be a fungus in the soil.Most of the land in this area was rangeland so long that it harbors fungi of many types. No treatment will bring the dead back to life but there is successful treatment for insects and fungi. The simplest treatment for fungi is to dust heavily with wettable powdered sulfur. Perhaps the best insecticide is diajanon in crystal form to be spread with any seed or fertilizer spreader. These treatments where needed when coupled with a good application of some good fertilizer with iron added with the help of good rains or watering will soon have your lawn where you have to mow it more often than you like.

Bentsen Seeks Tighter Bail Laws

WASHINGTON, D.C. --- Senator Lloyd Bentsen Tuesday said he wants to change Federal Court Bail Laws "that put hoodlums back on the street to seek other victims."

"For practical purposes the so-called bail reform law of 1968 permits a judge, when he is considering how high bail should be in a criminal case, to consider only whether the accused will show up for trial," Bentsen said in remarks prepared for the Senate.

"This is a serious mistake. And victims of crime in cities throughout this nation pay for it daily."

"I want to change the law. I want our Federal judges to take into account whether a defendant would be a danger to the community when he is deciding how high bail should be set," the Senator said.

Senator Bentsen cited the example of a young woman shot in Washington recently by four robbers.

"She's been operated on, but she still needs a cane to walk. And she is undergoing psychiatric treatment. And the fact that she might need further surgery caused her to lose her job," Bentsen said. " On top of this all of her would-be killers were released from jail without bail pending trial. They have disappeared. And, since she is a witness as well as the vitim of their crime she lives in constant fear that they will come back gunnig for her."


