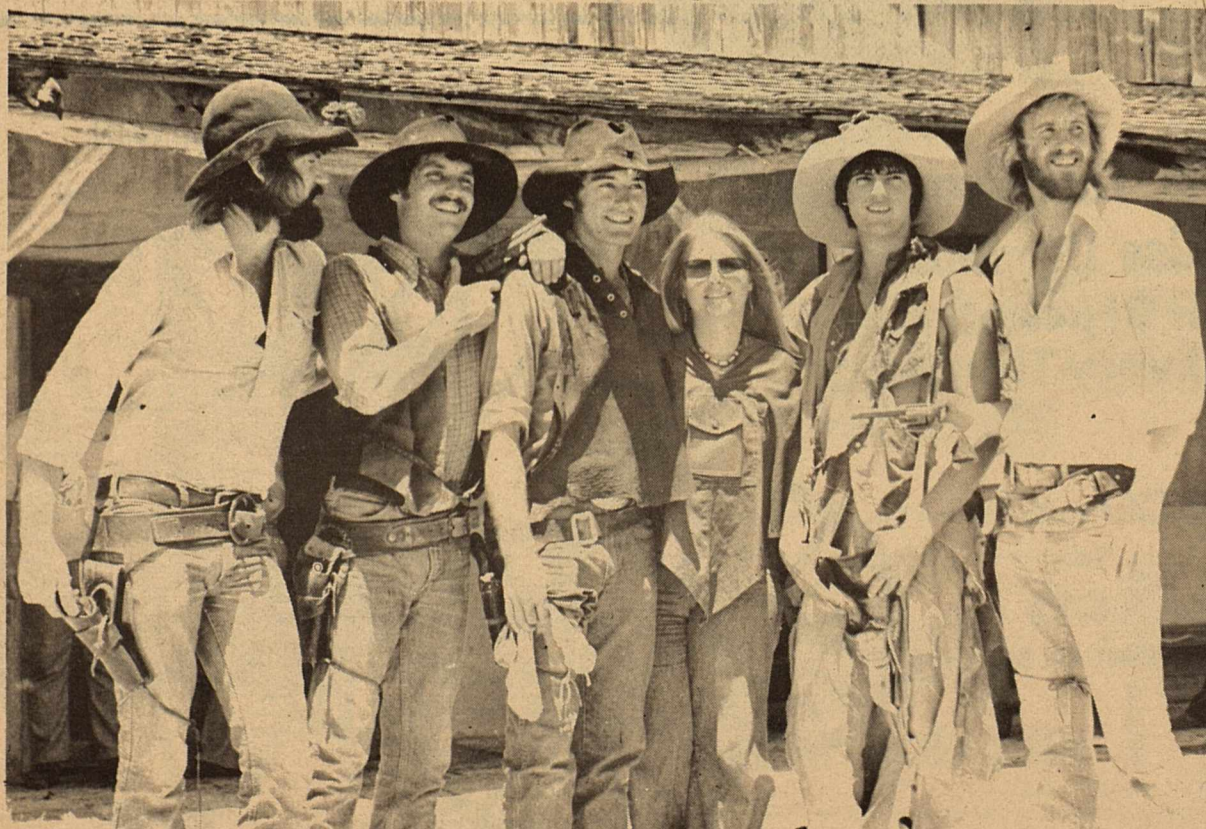
ALAMO VILLAGE HOSTS FOREIGN WRITERS

This part of my letter I would like to direct to those who feel we DO NOT have a need for an airport: If these people would look at an aerial map they would see that there is about 15 or more private strips, with air craft hangered there, on ranches. Why? Because there is nothing else available to use, here in Kinney County. It would be a great asset to our community. When flying the sun sets, and night comes on, it is quite an experience to try to locate the air strip that is unlit, unpaved runway, even if you finally locate the air strip, you have to run the deer off, before you can make your landing. Not to say, what these conditions will do to the cost in maintenance of the air craft. 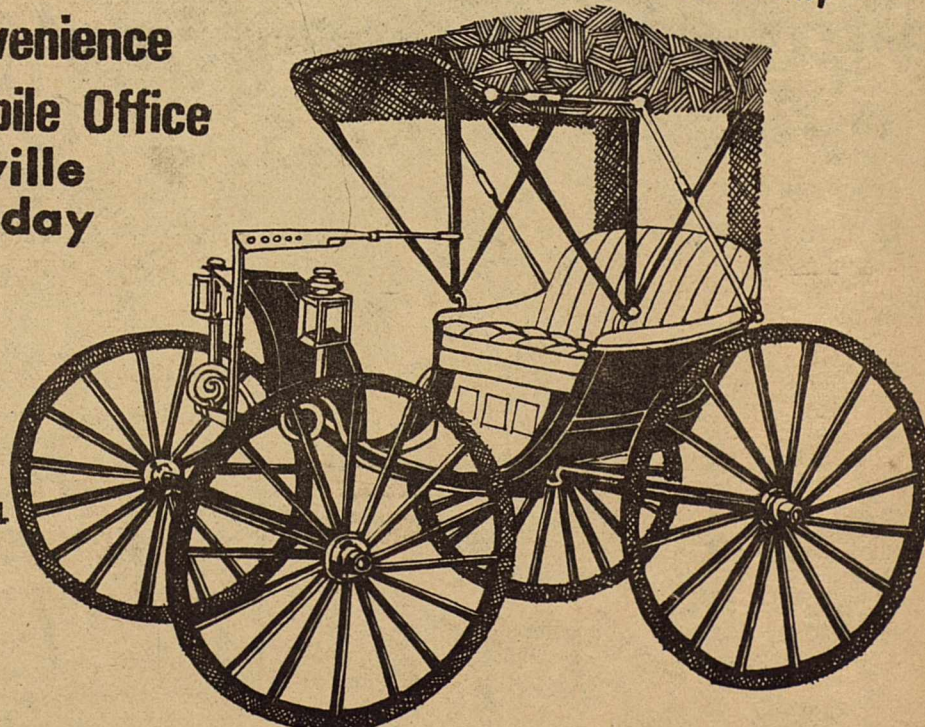

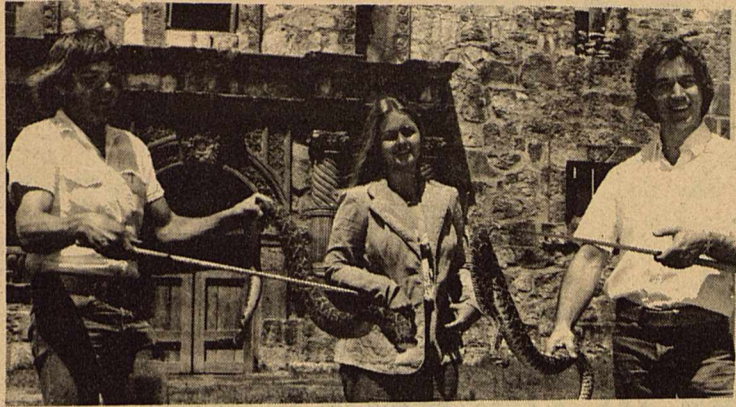

TIPS FOR GREEN THUMBS

As anticipated, the web worms are running wild. Some trees in Brackett are almost totally covered. Some have webs that are noticable; when webs just appear it is time to spray. These worms will rapidly spread and destroy the leaves as they go. There is absolutely nothing to be gained by leaving them in the trees and besides giving the appearance of being carelessly unkempt and there is damage to the tree. Another factor to consider is that your failure to destroy the worms in your trees may be shabby treatment of your neighbors. If he sprays his trees and you do not, most likely worms from your trees will sooner or later move on to his trees and he will be forced to spray again. Be considerate of your trees, the appearance of the trees and your neighbors; rid your trees of web worms.

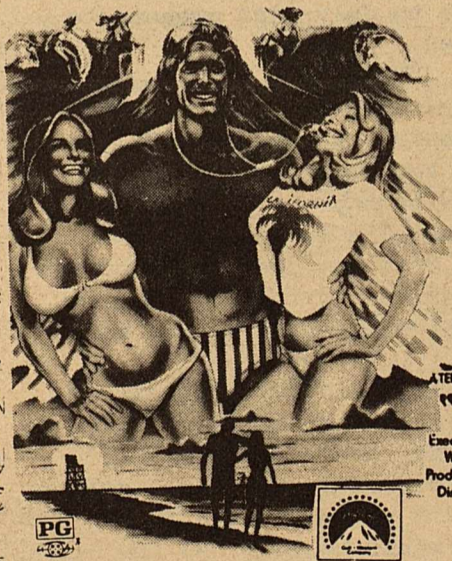

CITY HALL

BUDGET

The City Council after slashing off almost \$15,000.00 from proposed disbursements tentatively adopted the budget from the Operating fund. The Budget showed an increase of \$3,932.19 over the 1975-76 budget. The total for 1976-77 amounts to \$68,423.28.

By cutting the budget the Council was able to maintain the 1976 tax of \$1.50 per hundred at 40% valuation.

The Utility Budget was raised from \$156,378.12 in 1975-76 to \$161,031.03 for 1976-77 year.

JULY RECORD

An eighty seven year old record was broken last month.

The previous record for rainfall in July was in 1889 at which time 10.75 inches was measured. Last month, July, 1976, 13.86 inches were measured by the City.

Of the 31 days in July, rain or a trace was recorded in 19 of them.

The total rainfall for the City from January 1st to July 31st amounts to 23.74 inches.

DELINQUENT TAXES

The City Council at their Regular Meeting, Monday, August 9, 1976, rescinded an Agreement made on March 10, 1969, where by delinquent Taxes would only be charged a 15% penalty and interest. This was done to encourage the citizens to pay their delinquent Taxes at which time the amount was \$29,034.30.

Article 7336 and 7331 definitely sets the penalty and interest rates to be charged by the City. under the Agreement taxes for 1956 would only be penalized 15% while under Article 7336 the amount would be 131%. As the

penalty and interest rates are established by the State and had been followed by the City until 3/10/69, no action by the Council was necessary except to rescinding the Agreement of 1969.

The amount of delinquent Taxes in 1975 amount to \$24,409.41. This despite several tax sales and budget pay on delinquent accounts. The City instead of raising taxes for 1977 will make a concerted drive to collect the delinquent accounts if necessary thru tax sales.

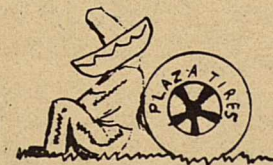

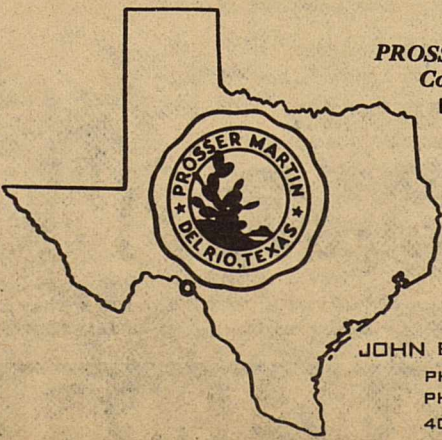

A series of seminars aimed at informing persons concerned with the Employee Retirement Income Security Act (ERISA) of 1974 will be held in Texas during August.

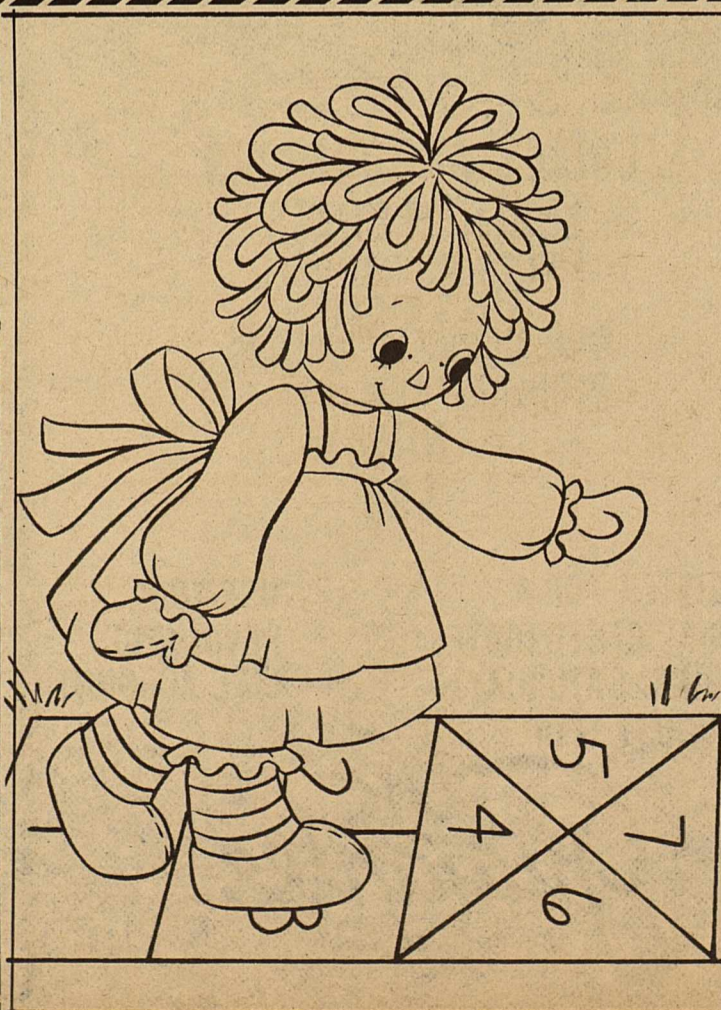
The nearest location for the seminar in this area will be in San Antonio. The seminar will be held there August 17 at the El Tropicano Motor Hotel beginning at 8:30 a.m.

Bank trust officers, attorneys, small businessmen and corporations are all concerned with the implications of the law. Given this interest, the Internal Revenue Service, in cooperation with the Texas Agricultural Extension Service, scheduled the seminar series.

"The ERISA seminars will emphasize new developments and problem areas of the 1974 act," said Glen Fisher, an area Extension economist located in Uvalde. "The seminar will consist of lectures, examples. problems, discussions and questions."

Fisher said there will be a \$12 tuition fee charged to cover materials and lunch. He said enrollments are limited and pre-registration should be sent payable to the Director's Custodian Fund, P.O. Drawer 1849 Uvalde, Texas 78801

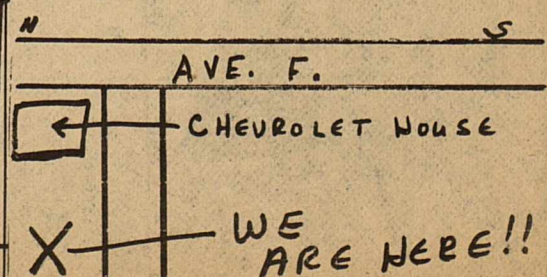

Brackettville Youths Hurt in Car Wreck

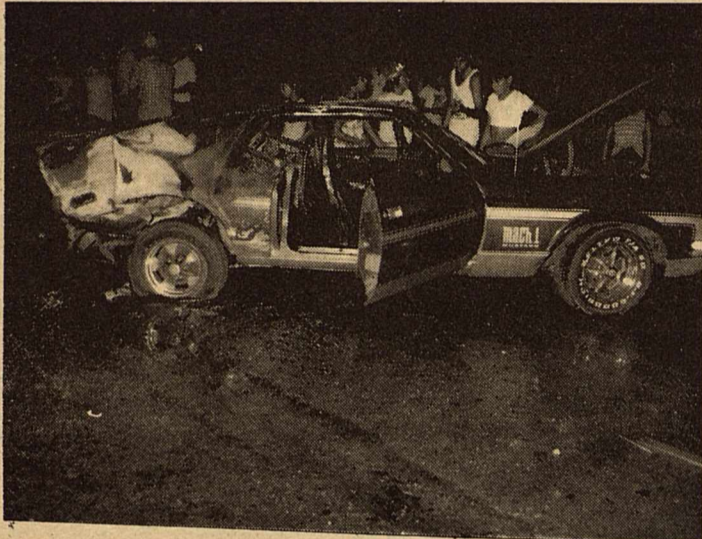
Two Brackettville young men were injured Tuesday night when an automobile, driven by Armando Ortega, burst into flames after it was struck in the rear by a second car.

Jesse Garcia, 17, and Danny Samaniego, 15, were rushed to the Val Verde Hospital for treatment.

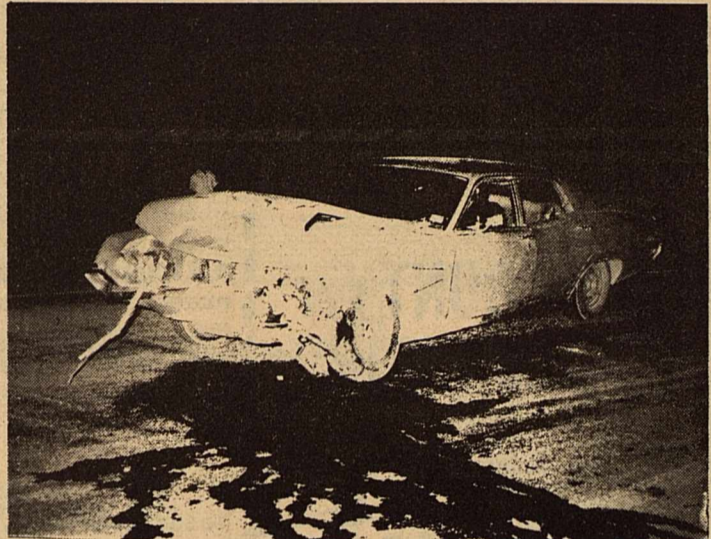

Immediate first aid by the Kinney County Ambulance Crew, Dr. Tom Young and Terry Hennett was given at the scene

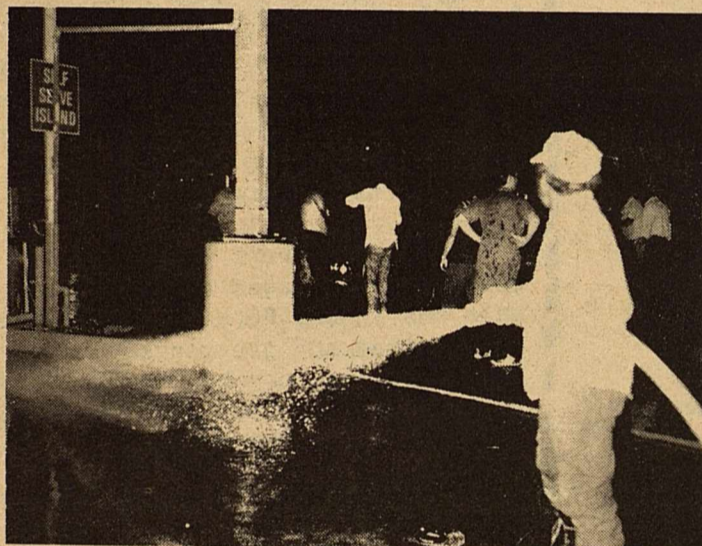

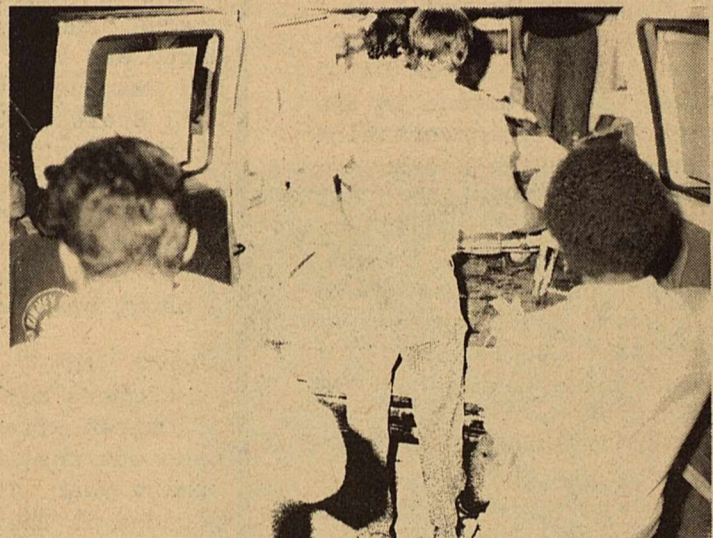

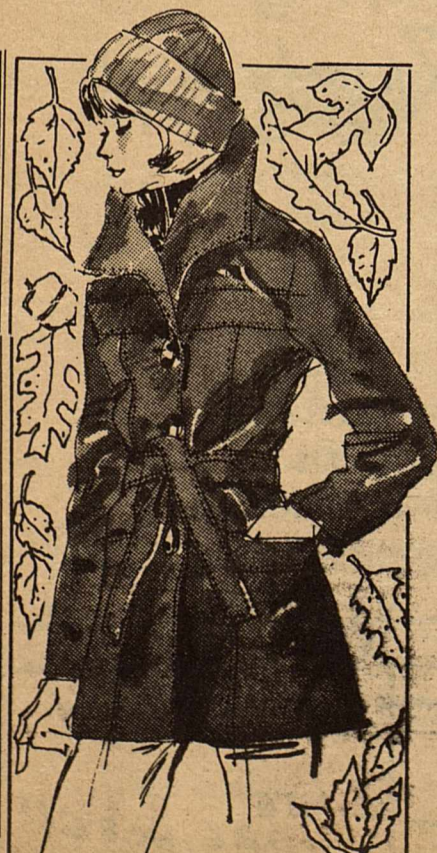

SCREWORM REGULATIONS

All livestock shipped out of Texas must now meet federal inspection and certification requirements, the U.S. Department of Agriculture (USDA) announced Tuesday, August 3.

These intensified regulations are the results of action by USDA's Animal and Plant Health Inspection Service (APHIS designating the entire state of Texas as an area of recurring screw-worm infestation. Prior to this announcement, only the 39 southern counties of the state were so designated.

APHIS officials said the change will mean that all livestock, including cattle, sheep, swine, goats, horses, mules and burros shipped from Texas must be inspected by state or federal animal health officials or accredited veterinarians can be certified free of screw-worms before shipment. Animals found to be infested with the parasite will be treated, and the entire shipment of livestock will be sprayed or dipped with a USDA-approved insecticide.

In addition, all animals shipped from Texas into southeastern states are required to be dipped or sprayed even if found to be screw-worm-free. These special requirements have been initiated in order to prevent the spread of screwworms into the Southeast, an area which has been free of the parasite for over 15 years.

Previously, cattle shipped in interstate channels from Texas counties not designated as areas of recurring screw-worm infestations were not required to be inspected and treated for the parasite before shipment. Many of these cattle had wounds or disease conditions which could harbor screw-worms. When moved without restriction, these cattle could be the means by which screwworms were spread to uninfested states.

Texas has been placed under stricter federal regulation as the result of an increase in the number of laboratory confirmed screwworm cases in the state in recent months. These cases threaten to facilitate the spread of this parasite of all warmblooded animals.

So far this year, over one-half of the 254 counties in Texas have reported screwworm cases. Even a greater number of cases are expected during the traditionally heaviest months, August thru November. The already serious number of screwworm cases reported this year has been due to heavy rainfall in the state, producing ideal environmental conditions for the increase in screwworms.

Owners of livestock should constantly check their animals for screwworm infestations and submit specimen larvae (worms) in the prepaid, self-addressed mailing kits available from County Agents offices, suggests Dr. Robert Miller, of USDA's Mission, Texas, Screwworm Laboratory.

Screwworms are the larvae, or worms, of the screwworm fly. Female flies lay their eggs on the edge of an open wound on any warmblooded animal. The eggs hatch, and the tiny larvae burrow into the wound to feed on the living flesh. Odors produced by the feeding larvae attract other female screwworm flies, which reinfest the wound with their eggs. Untreated infestations often result in the death of the animal.

The USDA's Screwworm Eradication Program, operated by APHIS, is designed to eradicate the world screwworm fly population by releasing millions of sexually sterile screwworm flies every week to mate with the fertile wild flies. Mating between fertile flies and sterile flies produce eggs that do not hatch, thus breaking the screwworm life-cycle.

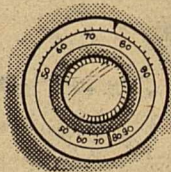

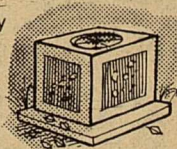
