OLD BUILDING THREATENED

## HISTORICAL SOCIETY OPPOSES BANK PLANS

THE BRACKETT HISTORICAL SOCIETY met October 26 in the library to discuss the proposal of Brackettville State Bank officials to build a new bank building and tear down the present building. The Society claims it is of such historical value that it should be preserved.

C.L. Orr, a bank director, and Virginia Lackey, bank Vice-President and cashier, were present to answer questions.

Mr. Orr began by saying that the bank directors themselves were not entirely in agreement over the matter. He said that the architect, Jack Graves of Uvalde, had submitted a number of tentative plans to the directors. One, which entails tearing down the present building, will cost an estimated \$190,000. Another, which will let the present building stand and entails adding on and remodeling, is estimated to cost \$198,000.

(ed. note: The architect is the same one that designed the new county jail.)

Miss Else Sauer spoke for the Society when she pointed out that the Texas Historical Society urges cities to preserve old buildings, and she cited efforts in Galveston as significant examples. She and other members went on to say that the building was built in the 1800's, having been a saloon operated by a Mr. Nance before the establishment of the bank in 1906. One Society member quipped that a new, modern styled building would seem out of place among all the other older buildings in Brackettville.

Mrs. Lackey returned with the comment that the directors had rejected one plan for a new building (entailing destruction of the present building) in favor of one that maintains design elements reflecting more traditional Brackett attitudes. She said this design, while still entailing destruction of the present building, strongly resembles the present one. Rock for the new building would be quarried in Langtry.

Mr. Orr expressed no strong personal feelings either way, but maintained that something had to be done, as the present facilities were becoming too small to continue efficient bank services. He said whatever course of action was chosen would eventually have to be approved by the State Banking Commission.

Mrs. Lackey emphasized that the architect considered it especially difficult to add on to the present building because it used non-standard materials and techniques of unknown quality. She relayed the architect's opinion that the rock of the present building was "dead," meaning it was beginning to crumble and could no longer be effectively patched. The floor, too, she said, was in poor condition and would have to be replaced.

Society members voiced the opinion that architects, in general, simply do not like to work with old buildings. They further maintained an opinion that architects could use old buildings to great advantage if they just wanted to do so. They ended the meeting by signing a letter to bank directors urging the preservation of the building.

## BAPTISTS TO DEDICATE SANCTUARY

Brackett area Baptists will come together on Sunday, October 31, to dedicate the new sanctuary of the Frontier Baptist Church. The Rev. Joe Townsend, pastor, expresses a wish for everyone to join the congregation in its dedication activities.

Guest speaker for the dedication will be Dr. O.

Byron Richardson, Associate for Revival Evangelism in the Evangelism Division of the Baptist General Convention of Texas. Dr. Richardson has held his office since 1960. Prior to that, he had pastored churches for more than twenty years. His last pastorate being the First Baptist Church of Alice, Texas.

A native of Votaw, Texas, Richardson received the B.A. degree from Baylor University in Waco, Texas, and the M.A. degree from the University of Houston, Houston, Texas. He did additional work at Southwestern Baptist Theological Seminary, Fort Worth, Texas, and received the D.D. degree from Howard Payne College, Brownwood, Texas.

Under Richardson's direction, the Division seeks to lead Texas Baptist churches to have two local church revivals each year. Also, he has trained fifty pastors and education directors as Revival Resource Persons. At request, these Resource Persons help churches prepare for local revivals.

The Evangelism Division, through Richardson, and the Sunday School Division work jointly to assist associations in planning for Evangelism-Sunday School Conferences. These conferences provide an excellent opportunity to project all of the work.

The Frontier congregation first organized September 23, 1974, with 42 charter members. Until now, they have worshipped in rented quarters. The church is a part of the Baptist General Convention of Texas and of the Southern Baptist Convention.

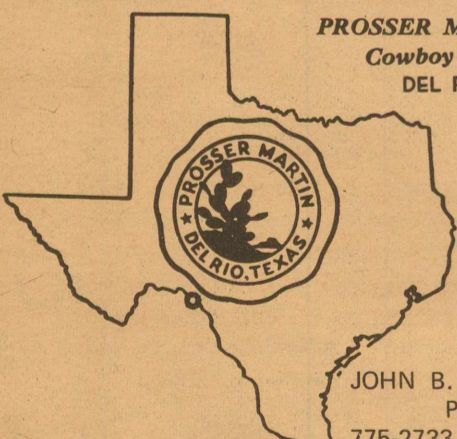

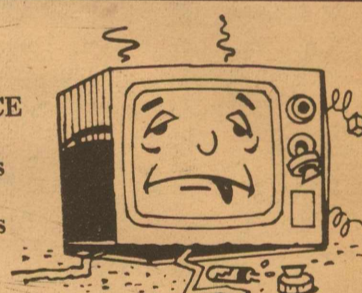

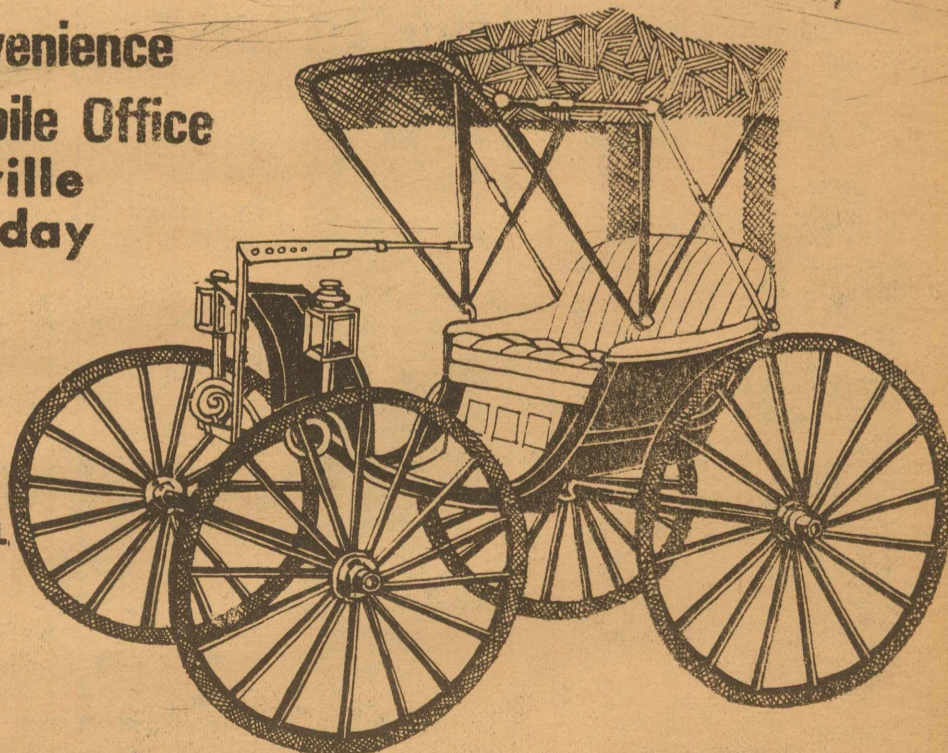

## TEXAS SPEED LIMIT STIRS CONTROVERSY

BIG SPRING--A West Texas district judge Saturday said Texas does not and never has had an

official 55 mile an hour speed limit.

Ralph Caton of Big Spring, judge of the 118th district court, told the West Texas Justice of the Peace Association, "The people of Texas got short-changed with the double-nickel legislation passed in 1973.

"There is a rumor in Texas that we have a 55 mph speed limit. We do not and have never had. The reason is because the Texas Legislature never got around to passing it. What the legislature did was delegate the authority to the Texas Highway Commission, under pressure from the federal government threatening the discontinuance of highway funding."

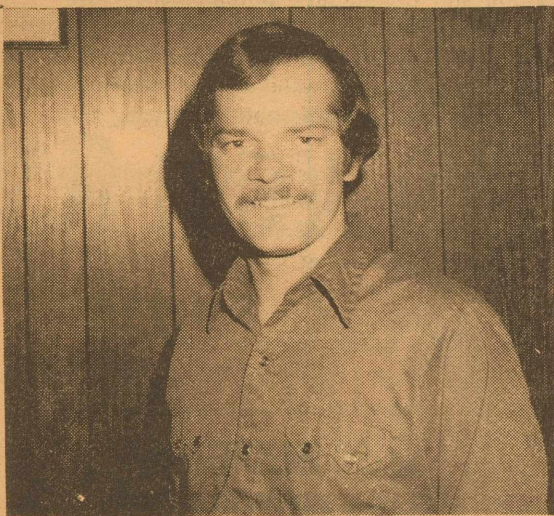
Caton pointed out that an opinion by Attorney General John Hill held the legislative act was invalid because the legislature did not have the power to delegate authority to the Highway Department to establish a uniform speed law in the state.

He said the department could authorize lower speed limits only when driving conditions are not safe or

prudent at 70 mph. Caton said the delegation of authority from one branch of the government to another is unconstitutional, specifically from the legislative branch to the executive branch.

The Highway Commission, he said, does not have the authority to pass laws regarding speed limits.

"Texas justices of the peace have the authority and legal obligation to examine a citation issued for speeding in excess of 55 mph," Caton said. "If the accused violator can overcome a legal presumption that the speed of 70mph was not legal or prudent at the time, he is not in violation of the state's legal speed limit."

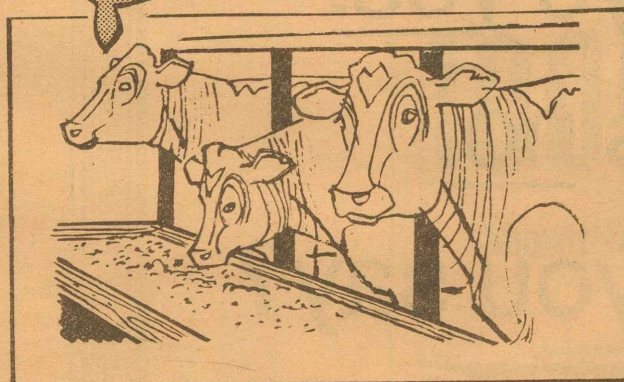

## GARDEN CLUB VISITS LOCAL RANCH

On October 19th, the Retama Garden Club under the direction of Mrs. Laura Seargeant, President, was treated to a visit to the W. L. Moody IV " Rancho Rio Grande" in Southwest Kinney County to observe the natural arid environment and present land uses.

Mr. Moody very graciously gave us a guided tour of the ranch, ranch-house, and grounds. These spacious landscaped grounds border the banks of the Pinto River. Native trees, shrubs, and flowers predominate.

We entered the ranch house through a walled, tiled Spanish courtyard. Saltillo and Monterey tile are used throughout the house, which is done in the style of the very early day hacienda of the old Spanish period. No steel has been used in the building of this spacious home. It literally rose from the ground on which it stands. Mexican artisans, from Mexico, made the adobe blocks from the local ground and built the house with these, forming the walls and archways. Huge pine logs support ceilings and roofs which are of red Spanish tile. There are five bedrooms, each with bath and fireplace, all decorated in either Indian or Spanish Motif.

The living room is divided from the dining room by a massive "see-through" fireplace. Beautiful figured blue rugs from Morocco cover the floors. The heavy Spanish doors and furniture are from Nuevo Laredo, Mexico, and Colombia, South America.

The kitchen is a fascinating combination of early Spanish and modern, with the early Spanish predominating. A table of natural finish solid Cypress four inch by twelve feet boards is the focal point at one end

of the very large kitchen and separated from the work area by a long bar on which hang many sizes of heavy iron skilletts. On the bar was a bread basket of muffins made from Milo maize grown on the ranch and ground in a stone metate. Close by is a large Spanish fireplace with iron cranes for hanging pots for cooking. The stone of the fireplace is native, having been quarried on the ranch.

Refreshments were served by Mrs. Catherine Smith, and a most delightful time was had by all. We feel we have just had a peek into living on a grand hacienda of more than one hundred years ago.

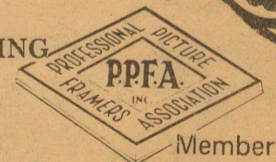

### Between Us

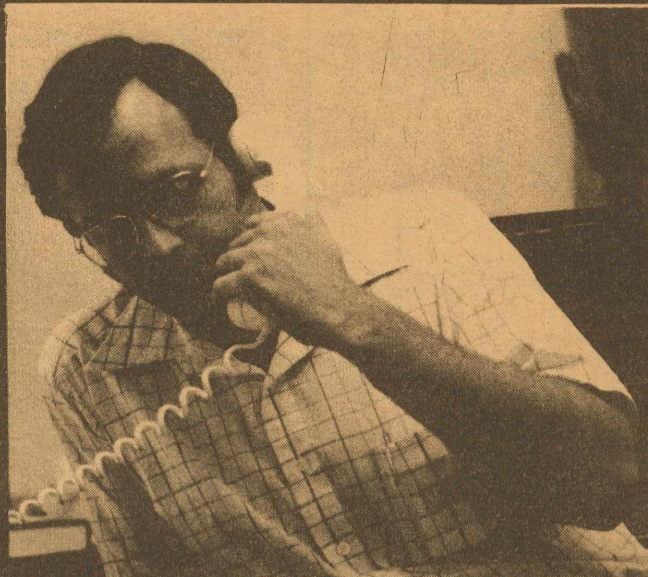

## CB BREAK

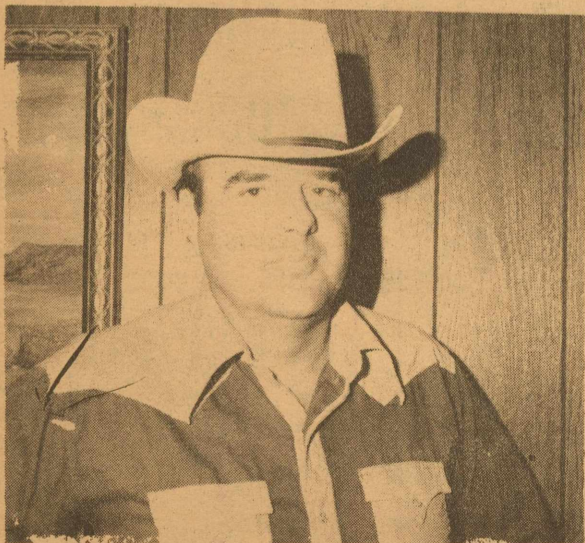

TIPS FOR GREEN THUMBS

It's bulb planting time. Spring bulbs should be planted soon. For lack of sufficient cold weather in our area, most bulbs should be refrigerated for about six weeks before planting. This included tulips, daffodils, hyacinths, narcissers and the like. Anemones and Ronuculus should be planted now for early spring blooms. These early spring displays of brilliant color add much to the colorless, dismal days of bareness of winter. They are the harlingers of the soon to come beauty of the spring. Prepare a good loose soil in the bed, be careful to plant the bulbs right side up. Water the beds only occasionally when there is no rain. An expenditure of a little money, a little effort and a little time will mean beautiful flowers sooner than you think.

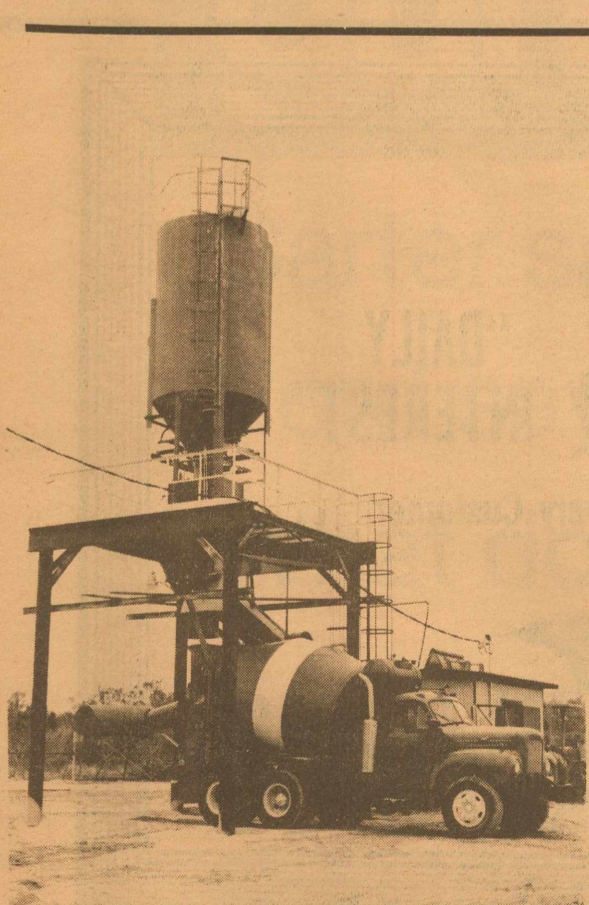

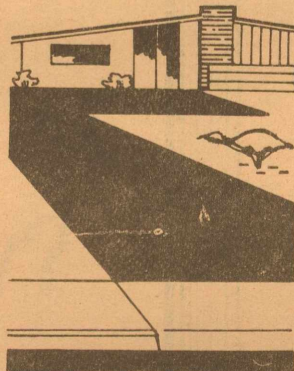
