


"BLUE ANGEL" QUITS

Nepotism is defined, qenerally, as favortism toward relatives in a governmental capacity.

CONSTABLE GONZALES FILES ON COUNTY JUDGE AND COMMISSIONERS COURT

On the 28th of March, Precinct # 1 Constable, Ralph Gonzales, filed suit against County Judge and Commissioner's Court for back wages that he alleges are accrued and payable under the law. The payment of constable salaries in Kinney County has been a controversial situation for some time; and with Constable Gonzales' petition, in the 63rd District Court, the problem may be resolved once and for all.

PLAINTIFFS ORIGINAL PETITION

TO THE HONORABLE JUDGE OF SAID COURT:

NOW COMES the Plaintiff RALPH GONZALES and for cause of action would show unto the Court as follows:

Plaintiff is a resident of Kinney County, Texas. Plaintiff is the duly elected Constable of precinct number one of Kinney County, Texas having been elected on November 2, 1976 and sworn in as such on January 1, 1977.

Defendant Tommy Seargeant is the County Judge of the County of Kinney, Texas. Defendant David G. Luna is the Commissioner of precinct NO. one of the County of Kinney, Texas. Defendant Manuel Fuentes is the Commissioner of precinct


number two of the County of Kinney, Texas. Defendant G. C. Talamantez is the Commissioner of precinct number three of the County of Kinney, Texas. Defendant L.S. Johnson is the Commissioner of precinct number four of the County of Kinney, Texas. This suit is brought against each defendant individually and as a member of the Commissioners Court of the County of Kinney, Texas.

The Commissioners Court of Kinney County, Texas meeting in regular session on January 11, 1971 for the purpose of transacting their regular monthly business and setting annual salaries of county officials and employees set the salary of the Constable of Precinct number one at \$3,300 per year plus \$900.00 in travel. This is the salary that existed for the office of Constable of Precinct Number One of Kinney County, Texas on January 1, 1972. III.

On January 1, 1972 article 3912K, V.T.C.S. became effective. Section one of this act provides that "the Commissioners Court of each county shall fix the amount of compensation, office expense, travel expense, and all other allowances for county and precinct officials and employees who are paid wholly from county funds, but in no event shall such salaries be set lower than they exist at the effective date of this Act." IV.

On January 13, 1975 the Commissioners Court meeting in regular session voted to set the salaries of the Constables of Kinney County at \$10.00 per year. This resulted in an

attempted reduction of the salary of the Constable of precinct number one to an amount lower than it existed on January 1, 1972 the effective date of Article 3912K, V.T.C.S.

The action taken by the Commissioners Court of Kinney County on January 13, 1975 and their continous refusal since then to authorize the Plaintiff as the Constable of precinct number one the salary for such position as it existed on January 1, 1972 is in volation of Texas law to wit: article 3912K, V.T.C.S.

Plaintiff alleges that defendants will continue to refuse to authorize the payment to him as the Constable of precinct number one of Kinney County, Texas in the amount of \$3,300.00 per year plus \$900.00 for travel expense. Such authorization under the law and facts of this case is the clear legal duty of the defendants, and they are fully able to perform said duty which is required of them by

Plaintiff has no other adequate remedy to compel said action to be taken, and it is therefore necessary that a Writ of Mandamus issue against defendants.

VIII.

Plaintiff would further show that his claim for his salary as herein alleged, was presented to defendants more than thirty (30) days preceding the filing of this suit, and that said claim has not been paid and satisfied, and it has been necessary for Plaintiff to employ an attorney to represent him in such claim, and Plaintiff has employed Rogelio F. Munoz, a practicing attorney of Uvalde, Texas to represent him in the collection thereof, that by reason thereof, Plaintiff is entitled to recover in addition to his salary, a reasonable attorney's fee, which is alleged to be

the sum of One Thousand Five Hundred Dollars (\$1,500.00). WHEREFORE, Plaintiffs prays:

1. That a day he appointed for a hearing on the merits of this matter;

2. That defendants be cited to appear and answer;

.3. That Plaintiff have judgment against defendants for the sum of \$1,500.00 as reasonable attorneys fee;

4. That at the conclusion of the hearing this Court issue a Writ of Mandamus requiring defendants to authorize the paying of the Plaintiff's salary as Constable of precinct number one of Kinney County, Texas, and for such other and further relief to which plaintiff may be entitled. 

FHA MEETING TO CONVENE

"Shaping An Unfinished World" is the theme for the annual meeting of the Texas Association, Future Homemakers of America when more than 6,500 junior and senior homemaking students and their advisors meet at the Astroarena in Houston, April 21-22. The convening delegates will represent 75,724 student members in 2,301 chapters in Texas.

The two-day convention will include a wide variety of educational as well as entertaining sessions, featuring FHA members and outside speakers. An important part of the event will be a series of twelve workshops with topics such as "Child Abuse", "Wanted: Healthy Babies", "Future Family, 1998", "Family Situations and Problems", "Food Abuse" and others. The discussions will be lead by well-known speakers from around the state.

Keynote speakers will be Reverend Dan McBride and Joseph N. Sorrentino. McBride is a well-known musical satirist whose subject material includes the lighter side of grass roots issues affecting modern society. Sorrentino is a nationally-known Los Angeles juvenile court judge who recently was the subject of the CBS news show "60 Minutes." He will speak of his personal experiences as a former longtime lawbreaker and now a lawyer who has served on the bench.

As part of the agenda at the Friday session, 1976-77 state FHA president Phyllis Cicero will deliver her farewell address, "The Times Of Your Life." She then will conclude her presidential duties by presiding over the installation of new state officers

On hand to welcome the FHAers will be Cadar Parr, associate commissioner for Occupational Education and Technology, Texas Education Agency; and Billy Reagan, superintendent of the Houston Independent School District. Others present to greet the delegates will be Kay Hallman, president of the state association of Young Homemakers of Texas; Louisa Liddell, associate director of the national association of FHA; and Elizabeth Garcia, Houston FHA representative.

During the meeting nine scholarships of \$500 each will be presented to homemaking students, and 37 community leaders from around the state will be awarded honorary membership in FHA.

The state association functions under the guidance of Home-making Education, Texas Education Agnecy, with homemaking teachers serving as chapter advisors. Mrs. Elizabeth F. Smith is director of Homemaking Education, Texas Education Agency, Austin. Mrs. Betty Romans, a consultant with the department, is FHA state advisor.



Phyllis Cicero, president of the Texas Future Homemakers of America for 1976-77, will conduct the first general session of the annual state FHA meeting at the Astroarena in Houston, April 21-22. A senior at John Tyler High School, Tyler, she plans to attend the University of Texas, Austin, majoring in speech and drama. Phyllis also will participate in the awards of honorary memberships at the state meeting, will deliver her farewell address "The Times Of Your Life," and will conclude her presidential duties by conducting the installation of new officers for the FHA state association.

Senator Lloyd Bentsen

Watching Washington

Washington, D.C.--Senator
Lloyd Bentsen Thursday proposed
that the upcoming ban on saccharin be delayed until government scientists can determine
whether the risks in using the
artificial sweetener outweigh
the benefits.

Bentsen joined in cosponsoring legislation introduced in the House and Senate in response to a decision by the Food and Drug Administration to prohibit the use of saccharin.

"The problem lies with a
19 year old law, known as the
'Delaney Clause,' which requires
the F.D.A. to ban a food additive if any appropriate test
shows that the additive can
induce cancer in man or animal.
In the case of saccharin the
test was conducted in Canada;
an experiment in which rats
were fed an amount of saccharin
equal to human consumption of
800 cans of diet soda a day,"
the Senator said.

"I do not seek repeal of the Delaney Clause. I seek, rather, to amend it so that our scientists can use their judgment before imposing any ban."

The legislation would give federal officials discretion to evaluate the relative benefits and risks involved before making a decision to prohibit the marketing of a food additive.

Specifically, it would permit the Secretary of Health, Education and Welfare to determine whether the risks of continued use outweigh the benefits of such use. The bill would also postpone the ban on saccharin until such an evaluation can be made on it.

"There are an estimated 10 million diabetics in this country for whom sugar is poison and for whom saccharin is the only sugar substitute available," Bentsen said.

"one out of four Americans is overweight and suffers from

a greatly increased risk of heart disease and arteriosclerosis. For them, saccharin is essential and I belive the government ought to weigh the benefits of its continued use against the risks before imposing any ban," Senator Bentsen said.

GARDEN CLUB NEWS

On April 19th, The Retama
Garden Club was treated to a
special field trip to the L. R.
French Anacacho Ranch in the
Anacacho Mountains. Arrangements were made by the Club's
President, Mrs. Laura Seargeant.
Mr. Howard Ragsdale, S.C.S.
Tech. with the U. S. Department
of Agriculture was the tour
guide.

The group met at the Retama Plaza and continued by car to the Ranch where they were met at the gate by Mr. Jesus (Chuy) Pena, foreman in charge of the Ranch. As he guided the line of cars along the road, a large, grey ostrich kept pace with the group up hill and down, until it came to a fence which prevented its going further. As the cars entered the formal grounds of the Ranch, one could see zebras in a distant pasture.

Mr. Pena has seen the development of the Ranch for 42 years and under his expert guidance the group saw the beautiful grounds, statues imported from Italy, rare imported plants, and enjoyed the architecture of the Spanish castle type ranch house with its large Mexican bell above the patio. This bell was used in past years as a morning rising bell and also as a warning bell during the day in case of trouble. The ranch house was built in 1928, with five bedrooms, a large living room, library, kitchen, dining room, sun room and family room, all air-conditioned. The house and all out buildings are made of native stone with red tile

Next the group visited the garage with many cars, but the two which drew the most attention were the "64 model Rolls Royce, a \$50,000 car with telephone, bar, A.C. and other conveniences and a Model A, 1931, Ford complete with open rumble seat. Also note was a dune buggy and a dog carrier for transporting 6 quail hunting dogs.

Then on to the stables, past the bat house where the guano is used as fertilizer, to the pasture where two midget horses graze, and next the "jogging" ring for the exercise and training of the horses. The stables contain 32 stalls and are completely fireproof. The tack room contains many memorabilia of racing horses, present and past, that have belonged to these stables. Here is seen the picture of Edna Mae's King, a \$40,000 horse which Will Rogers rode while visiting the Ranch. Many pictures of Mr. French's winning horses line the walls and a display of saddles of many types, including those for

"Proceeds will benefit the Mental Health Association in Texas," said Shirley K. Camfield, state President of the voluntary citizens' association.


As a non-governmental agency the association can and does speak for the consumer -- the person who needs professional help for an emotional disturbance.

BETWEEN US


