# TIPS FOR GREEN THUMBS by:

Summer is the time of lush growing for most pot plants. There are basically only three factors in plant growth, LIGHT, WATER, & FOOD. If plants do not do well one or more of these factors is deficient. Plants vary as to their light requirements. A good rule to follow is "when you find a spot where a plant does well--don't move it!" If it does not do well where it is-try a different spot. Most plants do better the more light they get but many do not do well in direst sun, especially through a window. No plant does well if it is allowed to become too dry. No plant does well if is kept too wet. All Plants need to be fed from tine to time. There is not substitute for experience. Much that is written you will find will not fit this area nor your plants, a little commonsense and basic understanding make for a "green thumb". Our mythical fantasy that "So and So" has a green thumb really means that the person applies some knowledge of basic growing needs and comies this with dirty finger nails.



## PUBLIC HEARING SLATED

San Antonio is among several Texas Cities chosen to be the site of regional public hearings on the proposed comprehensive annual service program plan CASPP) for the Title XX of the Social Security Act. The San Antonio Hearing will be held at the First Presbyterian Church to Children's Foster Care and 4th and Alamo Streets, July 7th, in-Home care of the community's from 9:30 a.m. to 4:30 p.m. Title XX is the funding and planning mechanism for most Social Security services deliver- agencies and organizations on ed by the Texas Department of Public Welfare, the designated Texas Title XX planning Agency.

The CASPP is the Title XX planned which details what Social Security will be available in the various regions of Texas and to what extent those services will be delivered.

The public hearing process provides citizen planning and participation in the determination of services to be delivered and in what quantity.

"San Antonio's Public hearing will be representing a 21 county area of South Texas," said David Brock, Regional Director for Social Services of the State Agency. "Testimony received at the San Antonio Hearing will bear as much weight as testi mony delivered at the Statewide hearing in Austin. The regionalization of the hearings will save those wishing to testify the time and expense of traveling to Austin," he said.

The games scheduled for June 24th were not played due to the wet conditions of the field.







# Sheep and Goat Industry News

Livestock producers, farmers, and home gardeners who have anything to do with pesticides have proably already been warned that the federal Environmental Protection Agency will publish a list by this fall of various pesticides that willbe restricted.

Many of the present and hopefully, future users of such chemicals have taken steps to assure themselves of the opportunity to use these products, but things have not been going so well. The Texas Department of Agriculture, which is saddled with the task of approving individual Texas pesticide users, is currently about two months behind in processing applications.

TDA spokesmen, however, say that things are beginning to straighten out, and they soon hope to bring the program up to the point of a one-month lag. While this may be good news for those who have fulfilled certification requirements within the past few months it may taste like sour grapes to those undergoing testing shortly prior to

the October 21 restriction implementation date.

These is apparently no one to blame for the delay. David Ivie, TDA spokesman, says applicant numbers were simply much greater that anticipated. "Response to the program has been very good," he says.

"We thought we'd get about 500 applications a week, asn we actually got over 1500 a week for a while.We just got them faster that we thought."

The change in leadership at TDA didn't help much, either. Ivie explains that the pesticide application certificates must bear the name of the Texas Commissioner of Agriculture in order to comply with legal requirements. When former Texas Ag Commissioner, John White, left his post to help run the federal agriculture program he left behind a large number of White-stamped, but undelivered certi-

The appointment of Reagan V. Brown to the Ag Commissioner post, explains Ivie, necessitated reprinting of all

but about 6000-7000 of the certificates already completed at the time. The uncorrected items were only those that has already been mailed. Unoffical estimates have placed the reprinting "down time" at about three weeks.

The EPA has yet to release the list of pesticides to be restricted and chances are the list will not be generally available until its prohibitions become official in October. Ivie says it is likely that even then, many pesticides up for review will still be in the study basis. The chemicals, he explains, are being investigates in order of their toxicity levels, so the less poisonous compounds, though still subject to restriction, may be aviable for some time after October deadline.

In view of the uncertainty surrounding the restricted list, it is imperative that producers currently using almost any form of pesticide make arrangements to have themselves accepted as certified applicators, the sooner the better. A test taken in September that nets a certification in November will be of little good to a producer who needs to buy a restricted chemical on October 22.

## ENGLISHMAN A CHIEF ?

LIVINGTON, Tx.--With the fading remnants of last year's Bicentennial still lingering in the back of our minds, it may strike one as rather ironic that in this years outdoor drama, "Beyond The Sundown," on of the principal chiefs of the Alabama-Coushatta will be played by an Englishman.

Bert L. Taylor, born in St. Bartholomew's London, ("within spittin' distance from St. Paul's Cathedral where all true Cockneys are born"), is a professional actor with over 36 years of stage experience. Taylor, the literal incarnation of "John Bull" will put himself to the test of creating the demanding role of Anton, Chief of the Alabama Tribe.

The transformation from Cockney to Indian Chief is not entirely new to Mr. Taylor. He faced a similar dilemma as Chief Black Hoof in the 1976 production of "Tecumseh" in Chillicothe, Ohio. Taylor explains, "Whereas the character of Black Hoof accepted defeat by the white man, I see Anton as a man who never accepted defeat, only a way for his people to survive," and to as actor with 105 productions to his credit in the last 11 years he should face no serious problem.


"Beyond the Sundown," by veteran playwright Kermit Hunter, portrays the drama of the alabama-Coushatta Tribes during the War for Texas Independence. The elders of the tribes, having sworn to live in peace, would rather give up their homes than to fight. The conflict evolves when the young warriors leaves to fight on the side of Sam Houston and "become Americans". The drama offers more than polished spectacle to the viewer. #### 1977-78 ARTIST IN SCHOOLS PROGRAM


The Texas Commission on the Arts and Humanities' Education Division is accepting applications for the 1977-78 Artist in Schools Program.

Available to Texas Schools this year are: two components, an Interdisiplinary Team Residency and an Arts in General Education Residency; and seven continuing components--Visual Arts and Crafts, Music, Creative Writing, Folk Arts, Architectural and Environmental Arts, Film and Theatre. Interdisiplinary Team Residency is designed to focus on characteristics which two or more art forms have in common. The Arts in General Education component is designed to enhance learning in general by bringing the arts and the professional artist into non-art classroom.


### WELFARE NEWS

Households which were receiving rent or mortage supplements from the Department of Housing and Urban Development (HUD) between August 5, 1974 and October 8, 1975 may be entitled to increased food stamp benefits.

The State Department of Public Welfare announced today that the housing supplements paid under provision of the Housing Act of 1937 should not have been considered as income to food stamp households during this period


