### Department of Human Resources

The State Department of Public Welfare will have a new name Monday, August 29, but it will be doing the same job.

A bill passed during the regular session of the 65th Legislature goes into effect Monday, changing the name of the agency to the Texas Department of Human Resources (DHR).

As the Department of Human Resources, the agency will continue to offer the same services as it did as the Welfare department. Public assistance in Texas primarily is provided to the needy aged, disabled, and to dependent children.

Publications of the agency carrying the old welfare name will be used until supplies are exhausted then will be reprinted with the Department of Human Resources name.

Beginning Monday, however, telephones will be answered the Department of Human Resources, not welfare department.



#### TEXAS TRAILBLAZERS

"A new tourist information and promotional service for Texans, to encourage planned travel adventures on Texas Travel Trails."

That describes both role and goal of Texas Trailblazers, a new concept in Texas travel promotion under current development from Austin, according to Al McGehee, president of the venture headquartered at 701 Timberline Office Park.

Combining McGehee's love for his native state with a belief that traveling Texans are not generally aware of the attractions that abound in Texas, Texas Trailblazers is developing, for starters, a series of 10 Travelplans, each detailing the route and attractions of a specific Texas Travel Trail.

"The Travel and Information Division of the Texas Department of Highways and Public Transportation has done a most creditable job of defining, mapping, and detailing points of interest along all of the Travel Trails,"

McGehee said. "Texas Trail Blazers proposes to turn these interesting maps into mor interesting more helpful Travelplans."

The Travelplan packet will include a detailed map of the particular Trail inside the jacket, with mileage and points of interest spotted along the route. For driver convenience in handling, the accompanying descriptive copy will be presented on five-by-eight inch lose leaf pages with strip and/or spot maps placed beside the easy-to-read copy.

The travlers need only read the map segment for the area they are them traveling, On the reverse side of each segment page, the maps will be repeated to allow "comerical" attractions, accomodations and services in the particular Trail town or area to be spotted and described in controlled, tasteful prose, pictures and artwork. Map segment pages will be devoted to individual cities and/or legs of the Trail covering distances of 50 to 90 miles.

Other information helpful to travelers will be included in the Travelplan packet. In preparation for the ultimate metric conversion, a mile to kilometer conversion chart will be included. Later Travelplan editions will show map distances in kilometers.

Distribution of the Travelplan will be made through the State Highway Department's tourist and information bureaus, chamber of commerce, convention and visitors bureaus and other tourist and travel related agencies. Major distribution of the separate Travelplans will be made outside the Trail area which a particular Travel plan describes.

STATEMENT OF INTENT BY LO-VACA GATHERING COMPANY AND COASTAL STATES GAS PRODUCING COMPANY TO CHANGE RATES

TO THE HONORABLE RAILROAD COMMISSION OF TEXAS:

Lo-Vaca Gathering Company ("Lo-Vaca") and Coastal States Gas Producing Company ("Coastal"), pursuant to the requirements of Section 43(a) of the Public Utility Regulatory Act (1446c, T.R.C.S), files this statement of intent to change rates, effective September 1, 1977, the rates they are charging all customers on the Lo-Vaca system for the purchase of natural gas to a uniform rate applicable to each customer on the system, which rate consists of 100% of Lo-Vaca's weighted average cost of gas plus 16.70 cents per Mcf. The cost of gas is to be adjusted each month in accordance with Lo-Vaca's billing procedure, which is Lo-Vaca Exhibit KLH #515, filed with the Railroad Commission of Texas ("Commission") in Gas Utilities Docket No. 500 on June 13, 1977.

The present rate charged by Lo-Vaca for the sale of natural gas to nearly all Texas customers is 100% of Lo-Vaca's weighted average cost of gas (determined in accordance with the billing procedure set forth in Lo-Vaca Exhibit WKA #17 in Gas Utilities Docket No. 500) plus 5 cents per Mcf.

The new rate is anticipated to increase Lo-Vaca's revenues by \$60,196,106 in calendar year 1978. This is an increase of 5.61% over total revenues which would have been received if the present rate were continued in effect for that year.

#### FARM & RANCH MANAGEMENT PROGRAM OFFERED

UVALDE--Southwest Texas Junoir College was one of the first colleges in Texas to establish a two-year farm and ranch management program for students ani-xous to get out of the classroom and into the field.

"Now there are about 22 junior colleges in the state offering the same type of program," observed Agriculture Division Chairman Billy Word.

This two-year terminal program is designed for the student who is interested in farming and ranching and does not plan to secure a four-year college degree.

"The curriculum is aimed at increasing the technical know-how of the individual who is involved in a family operation," Word said, "and it enables him to go back to the farm or ranch and hopefully be more efficient in his management.

"This program is for the student who wants to go to work in the country directly with agriculture. He doesn't need the chemistry and other academic courses associated with a four-year degree. He just wants to become involved right away in agriculture."

Although students in the farm and ranch management program do not take such liberal arts as English, government, chemistry and physical education they are required totake a few "non-ag" courses which nevertheless relate to

agriculture

A special conversational Spanish is required of all farm and ranch management students and it designed specifically to acquaint them with such agriculture terms as the Spanish names of a tractor, plow or disc.

In addition, the students are required to take a special business Inglish course, agriculture accounting course and an agricultural math course.

An average of 70 students participate in the program each year, according to Word, and at least 15 per cent of thestudents "to go academic" which means complete a four-year degree program by transerring to a college or university.

"A lot of them wouldn't have gone to school at all," said Word, but they get started in this short-term program and them become interested. Then they say, "Well, college isn't so bad. I believe I'll go on."

The Junior college students spend about one-third of their time in the field and about two-thirds on campus. A \$25,000 agriculture barn located on the campus serves as a laboratory for the program.

A highlight of each year's tivities is a field trip to the Davis Mountains where students brand, castrate, de-horn, ear mark and vaccinate 500 head of calves.





## Town Buys A Doctor

A country town finally got the doctor it so badly needed-by paying for her medical education and building a clinic for her to practice in.

Dr. Maurice Wilkinson opened her practice in Flatonia, Tex. last month three years after residents of the town agreed to send her to school and build the clinic.

The ranching community of 1,100 had been without a doctor for seven years and medical care in the area had

grown so scarce that some people had to seek out doctors 100 miles away.

That's when Dr. Wilkinson, then a college student, approached cafe owner Joe Greive and asked if he could persuade the town to pay for her schooling and to build a new clinic.

Greive considered the request, sought out other town leaders, and then agreed to help found the South Texas Health Improvement Foundation.

To date, that agency has raised \$100,000 to help pay for the doctor's education and build the clinic. And now the scheme seems to be paying off.

In recent weeks, a number of retired people have purchased land near Flatonia and will move there now that they're assured of adequate medical care.

And several industries are considering building in the town as well.

Dr. Wilkinson's husband quit his schooling and will now work as the clinic's business manager.



#### Seminar

Puppet Training seminar

A seminar on the usefulness of professional-quality puppets as effective instructional tools is scheduled at the First Baptist Church, Del Rio on Saturday, August 27, 1977, from 12:30-4:00 P.M.

The three and one-half hour training session will be contacted by professional puppeteers from Puppet Productions, Inc. (PPI), a San Diego, Califonia company that has trained more than 35,000 persons in similar sessions.

To demonstrate the effectiveness of puppetry as a communications tool, video tape, film and live proformances will be use. Included among the live demonstrations will be the instruction of an entirely new and exciting puppet form...the larger than life hand puppet complete with full body and legs. Fluorescent puppets and black lighting will also be used in a dramatic visual display.

In recent years puppets have proven to be valuable aids in instruction by increasing motivation and holding the attention of young students. Presentations similar to the scheduled seminar have been made at national education conventions, and pilot programs for public schools districts have been overwhelmingly successful.

The universal appeal of puppets is also reflected in the thousands of churches which have begun using puppets in their education programs.

"Puppets create an excellent climate for learning, whether the subject
matter is secular or religious,"
said Bill Hawes, President of PPI.
"The seminar is designed to aid both
beginners and experienced puppeteers
in using this valuable tool."

Subject areas covered in the seminar include how to manipulate hand puppets, organizing a church puppet ministry, the use of instructional puppetry for schools, giving puppets genuine "personality" on stage, and tips for working on T.V.

Chris Gomez asked the Court to
consider buying a Back-up Unit for the
present ambulance service. He has found
a 1974 Surburban model for sale in Del
Rio. It is fully equipped and ready for
use at a price of \$5,000.00. No action
was taken by the Court on the request.

#### SPOFFORD WATER TOWER

Don Bradford announced that the survey and drilling crews would be ready to start operations at the site of the Spofford Water Tower at 1:00p.m. that day. Kinney County has a Federal grant of \$53,000.00 for construction of a water tower.

#### COUNTY RE-DISTRICTING

The Galbraith Engineering Company requested by Don Bradford, has offered a proposal of Re-districting the four precincts and acting as Consulting Service for the County. They plan to do the work within ninety days at a cost of not over \$4,000.00. A motion was made by David Luna and seconded by Manuel Fuentes that the Court execute the necessary papers to hire the Galbraith Engineering Company for the redistricting job. Three was a unanimous vote of "yes" for this motion. The Judge asked that his "yes" vote be noted.


