

The Awards Banquet will be held the 11th of October. Everyone is invited to attend.


The next 4-H meeting will be the second Monday of November.






Texas is a Single-State Council.


# TIPS FOR GREEN THOMBS

It's time to watch carefully for cutting ants. Especially after the rain they will be working. Already signs of their destruction are being seen. It is unbelieveable how much damage they can do in a short time. They seem now to be working at night. This makes doubly hard to control the ants, If you see them working it is a simple matter to follow the trail to the den. Sprinkle chloradane dust in a circle about 24 inches in diameter with the hole in the center. If you can't find the den sprinkle a swath of powder chloradane that they must cross to reach where they are working. They will carry some of this back to the den on their feet and may kill out the ants in that den. A little time spent looking for them may save some flowers, plants or even trees. It only takes one night for them to destroy many weeks of growth.
