#### State Board of Insurance

AUSTIN--State Board of Insurance Chairman Joe Christie announced today a study of the board staff shows annual savings of almost \$1 million a year resulting from increased productivity.

The study results were presented to the board by Carl Blonkvist from the management consultant from of Booz, Allen and Hamilton in Dallas.

"While the number of state employees grew by 13.9 percent during the last three years, the State Board of Insurance staff actually decreased in size by 2.6 percent," Christie said. "This reduction resulted in a staff size this spring of 584, compared to the 701 initially projected. The reduction has been accomplished according to our consultant, with no loss in service."

Further reductions this year, Christie said, have lowered the agency staff size to 568, the lowest it has been since 1972.

The workforce reduction, Christie said, was not accomplished without resentment from division heads. "The consultant found, as we had expected, that the division heads were upset at the loss of total control over their


employees.

However, I am optimistic that the tremendous savings provided by this program will convince the ageny's staff management that the end result is worth the sacrifices they had to make to accommodate the program," Christie said.

The program utilitzed two approaches: one to equalize the volume of work with the manpower needed to complete the work, and the other to evaluate these kills and talents of employees to match those attributes to individual jobs.

## PROGRAM SLATED





## TIPS FOR GREEN THUMBS

Now is the time to fetilize trees and lawns. If your trees have had trouble this summer and had a tendency to have mostly yellow leaves now could be a good time to give them a heavy dose of iron. This can be done by working copperas into the soil out as far as the drip line of the trees. Another and quicker method is to use a root feeder and use liquid iron. The soil here is iron poor and almost all vegetation needs more iron and give than is soil available. This is true of grass also -- particularly carpet grass. Feed it good now with added iron--you'll see the difference in the Spring and all next summer.

#### NUMBER ONE ON THE BALLOT (S.J.R. 18)

S.J.R. 18 proposes an mendment to the Texas Constitution to provide for expanding the Court of Criminal Appeals from its current membership of five udges to nine judges and to permit the court to sit n panels of three judges.

The wording of the pro-posed amendment as it will appear on the ballot is as

'The constitutional amendment increasing the size of the Court of Criminal Appeals to nine judges, and permitting the court to sit in panels of three judges.'

#### NUMBER TWO ON THE BALLOT (S.J.R. 13)

S.J.R. 13 proposes a contitutional amendment to provide for an additional 200 million in bonds or obigations of the State of Texas for the Veterans' Land Fund and to allow surviving widows of veterans to purchase tracts under

ircumstances The wording of the proosed amendment as it will ppear on the ballot is as ollows:

"The constitutional amendment to provide for an additional \$200 million in bonds or obligations of the State of Texas for the Veterans' Land Fund and to allow surviving widows of veterans to purchase tracts under certain circumstances."

#### NUMBER THREE ON THE BALLOT (S.J.R. 3)

Under current Texas law a person charged with a felony offense who has previously been convicted of two felony offenses may be denied bail. S.J.R. 3 proposes an amendment to the Texas Constitution which would also result in the denial of bail, for a limited time and subject to appeal, to a person accused of committing a felony while on bail for a prior felony for which the person has been indicted, or accused of a elony involving the use of

a deadly weapon after being convicted of a prior

The wording of the proposed amendment as it will appear on the ballot is as follows:
"The constitutional

amendment permitting denial of bail to a person charged with a felony offense who has been theretofore twice convicted of

a felony offense, or charged with a felony offense committed while that person was admitted to bail on a prior felony indictment, or charged with a crime involving the use of a deadly weapon where there is evidence such person has been convicted of a prior felony offense; providing for a 60-day limit to that person's incarceration without trial; and providing for that person's right of appeal."

#### NUMBER FOUR ON THE BALLOT (S.J.R. 5)

S.J.R. 5 proposes an amendment to the Texas. Constitution authorizing the tions or other relief from ad valorem taxes on property designated for the preservation of cultural, historical or natural history resources.

The wording of the pro-

posed amendment as it will appear on the ballot is as follows:

"The constitutional amendment authorizing tax relief to preserve certain cultural, historical, or natural history resources.'

#### NUMBER FIVE ON THE BALLOT (S.J.R. 19)

S.J.R. 19 proposes an amendment to the Texas Constitution authorizing the formation of associations authorized to collect certain refundable assessments from producers of poultry, livestock, and other raw agricultural or marine products and validating the 1967 law regarding the formation of such associations.

The wording of the proposed amendment as it will appear on the ballot is as follows:

"The constitutional amendment authorizing the formation of agricultural or marine associations which may mandate PROPOSICION No. 1 the collection of refundable assessments for improvement of production, marketing, or use of their enmienda a la Constitución products."

#### Comptroller's Rep. to Visit

AUSTIN--Comptroller Bob Bullock alerted Texas business Monday to begin looking for a friendly visit from a Comptroller's enforcement officer sometime during the next nine months.

The Comptroller said that the enforcement officers from his 40 filed offices will fan out across the state with the goal of offering personal assistance to each and every Texas Busi-

A testing of the canvassing program in July showed that 19 percent of taxpayers contacted required assistance or needed permits, he said.

"The theme of this project is Taxpayers assistance," Bullock said. "We have found that in many instances only personal contact can eliminate errors that eventually prove costly both to the taxpayer and the Comptroller's Office.'

He said his employees, armed with smiles and packages of taxpayer information, will be knocking on doors with the hopes of:

---providing education to taxpayers; --- making sure business is properly premitted:

-establishing personal lines of communication between taxpayers and the individual enforcement officer responsible for this area;

-- updating Comptroller's Office records ---making certain each taxpayer is filing and paying tax properly.

July's sample of 4,702 businesses showed that 97 were operating without needed permits, 766 had changed address or business name without notifying the Comptroller's Office and 37 were not paying tax properly, Bullock said.

"We hope to take care of every little problem on the spot, before it turns into a big problem, "he said.

"Above all," Bullock added, "we want people to believe us when we say I'm from the Comptroller's Office and I'm here to help you."






