



The Future Farmers of America held a meeting on October 18, and elected Karen Bunsen as their Sweetheart for the 1977-78 year.







"JACK FROST" CLAIMS
LUSH NEW GRASS GROWTH

UVALDE --- The greening of Southwest Texas was slowed considerably last week as back-to-back cold fronts brought the first frost of the season into the region.

Late fall rains made the lush, new growth of grasses highly vulnerable to frost damage, and the cold may have spelled the end of warmer season grasses on the range for this year.


With the first frost, deer hunting fervor hit a feverish pitch as hunters poured into the region to check their deer leases and await dawn Saturday. Preparations have been underway for the big day for weeks.

Texas Agricultural Extension Service Agents reporting said oats are growing well and generally look good. In the Southern end of the district, the late fall moisture has slowed the late peanut harvest almost to a standstill. Launching of the soybean harvest also has been delayed due to the wet weather.

Pecans are being harvested with those reporting points rating the crop yields from fair to good. Most are qualifying good yield reports, however, with complaints about poor quality due to seab and other disease damage. In the Wintergarden, worm damage on cabbage continues to be a problem. Kale is ready for harvest and spinach will be cut in about two weeks. More spinach is being planted and onions are growing well.

Some cattle marketing continues with stock water short in certain areas. Supplemental feeding of fivestock is underway in some parts of the region.

1977-1978 BUDGET APPROVED






Noemi: How do you like Brackettville?

Friday night, November 11, the Brackett Tigers met Charlotte in Tiger Stadium for the game to decide the District 30 A Championship. Charlotte was the number seven rated team in the state, but this fact did not intimidate the Tigers. The Tigers were able to pull out a devestating win over the Trojans and win the championship. The last time the Tigers took the District Crown was in 1973.

The game was, in the words of Coach Simmonds,"....probably the most exciting high school game anyone would see this year." Brackett dominated the score the entire game but with about one minute left to play, Charlotte was knocking at the door. The Tiger defense would not open up for them, even though the Trojans tried four times to cross the goal line. When Brackett took possession they had the ball on the 6 inch line!

The exciting goal line stand was not the only source of excitment during the game. Two records were set in the game. One was a state passing record set by the Charlotte quarterback, Carlos Tijerina, who passed for 398 vards. The second was a Brackett team record for yards rushing in a 10 game season. The record was held by Ronnie Hobbs until Moses Benites ran 139 yards in Friday's game for a year total of 1069.




