

Senate bill aids new rural doctors

Health care in rural areas of Missouri may get a boost from a bill approved by the Senate and sent to the Governor Thursday. The legislation would establish a system of state loans to medical students with the provision that the debt could be eliminated if students later practice in small communities.

State Senator Ralph Uthlaut of New Florence, who guided the bill through the Senate, said the measure is desperately needed to help attract physicians to outstate areas of Missouri. "As most people realize, many small towns are suffering from a serious lack of health care services." Uthlaut stated. "And the situation seems to be getting steadily worse. Through a student loan program, we can provide an incentive for young doctors to seek out less-populated areas for their practice.

Loans for as much as \$6,000 per year would be granted to medical students enrolled in either M.D. or D.O. programs. An individual student could receive funds during four consecutive years. For every year later spent practicing in communities with 6,000 or fewer residents, one-quarter of the student's debt would be eliminated.

"No one expects this to solve completely the shortage of doc-

tors in rural areas, but it certainly is something the state can—and should—do to encourage young graduates in that direction. Once established in practice, such doctors are more likely to remain in the community."

The program won unanimous approval (29-0) in the Senate after passing the House by an overwhelming 148 to 9 margin in February. It is nearly identical to a bill sponsored by Uthlaut last session. The 1977 bill passed the Senate, but was not acted on by the full House.

If signed by the Governor, loans under the program could be available in the fall of 1979. During its first year, the program would grant up to 25 loans. Another 25 would be available the three subsequent years up to

Soil Conservation

A new leaflet explaining the Resources Conservation Act of 1977 and the public's role in its implementation is now available at offices of the U.S.Department of Agriculture Soil Conservation Service.

Under the new law, SCS will appraise the nation's soil, water, and related resources; develop a comprehensive 5-year strategy to guide conservation efforts; and evaluate the effectiveness of ongoing conservation programs. SCS will carry out the work in cooperation with appropriate citizen groups; conservation districts; and other federal, state and local agencies. The appraisal and program will be completed by the end of the 1979 and updated every 5 years.

Copies of the leaflet "Your Role in Conservation's Future" may be obtained by calling 563-2414 or coming by the Soil Conservation Service office.

"The West Nueces-Las Moras Soil and Water Conservation District and the Soil Conservation Service will co-sponsor a workshop or open meeting about this legislation in the future," Howard Ragsdale, SCS district conservationist, said, "and it would be helpful to read the leaflet before the meeting."

Ragsdale said that public particapation is a built-in feature of the Resources Conservation Act, and suggestions from interested groups or individuals are welcome at any





1) Ball must be hit by a girl member each time the ball goes over the net. The ball can only be hit 3 times before going over the net. No one member can hit the ball twice in a row.


- 2) A team member cannot touch the net with any part of the body.

It's by no means too early for producers to begin planning their whereabouts for Thursday, May 25. That's the day the government boys will be in San Angelo to talk pre-

The hearing, onw of four designed to gain information about the predator problem, is scheduled for Houston Harte Cenrer, Angelo State Universtiy May 25. Other sessions will be in Boise, Idaho Casper, Wyoming and Washington, D.C. It is all part of an Interior Department reevaluation of predaotr control and the government's role in that en-

Heading the reevaluation effort is the Interior-appointed Animal Damage Control Policy Study Advisory Committee. (Now you know why they insist on reducing names to initials). The ADCPSAC is made up of government, industry, environmental and academic representatives, and will be charged with interpreting both research and public hearing data; the outcome will supposedly be used to direct the trust of predator control efforts in the future.

The government says of its program: "The analysis will produce two products -- a report and option paper. The report will bring together, in an analytical framework, relevant information and date relating to the topic as identified in this study plan. (Mammal predation on western livestock) The option paper, derived from the report, will be used as a basic decisionmaking aid at the Secretarial level."

Translated, the latter portion of the statement above means that, it the Interior Secretary hears what he wants to hear, it will be used to justify his doing what he had planned to do in the first place. at least that; s the sceptic's way of looking at it, and Interior secretaries the last few years have been very successful at fostering scepticism.

The committee, probably to help

generate comment, has been working on a "first draft report" of their suggestions prior to the hearings. The report is to be made available May 5 to interested parties, which should include everyone west of the Mississippi River.

The report will thus be available in plenty of time before the hearings to allow thorough study; reliable accounts indicate that the document may contain some astounding and hair-rais ing proposals.

The Texas Sheep and Goat Raiser's Assn. suggests that all interested parties first write for copies of the first draft report (do it now--don't wait until May 5 and depend on getting it through the mail in time for study), then prepare written testimony for the San Angelo hearing. The assocation and the entire industry are especially interested in giving the committee factual, non-emotional restimony capable of adequately demonstrating our problems with predaotrs.

Particularly needed to testimony form former sheep or goat producers driven out of the business by predation Again, we need facts--emotional carryings-on and fanciful dramatizations are the province of propredator forces and are counter-productive.






