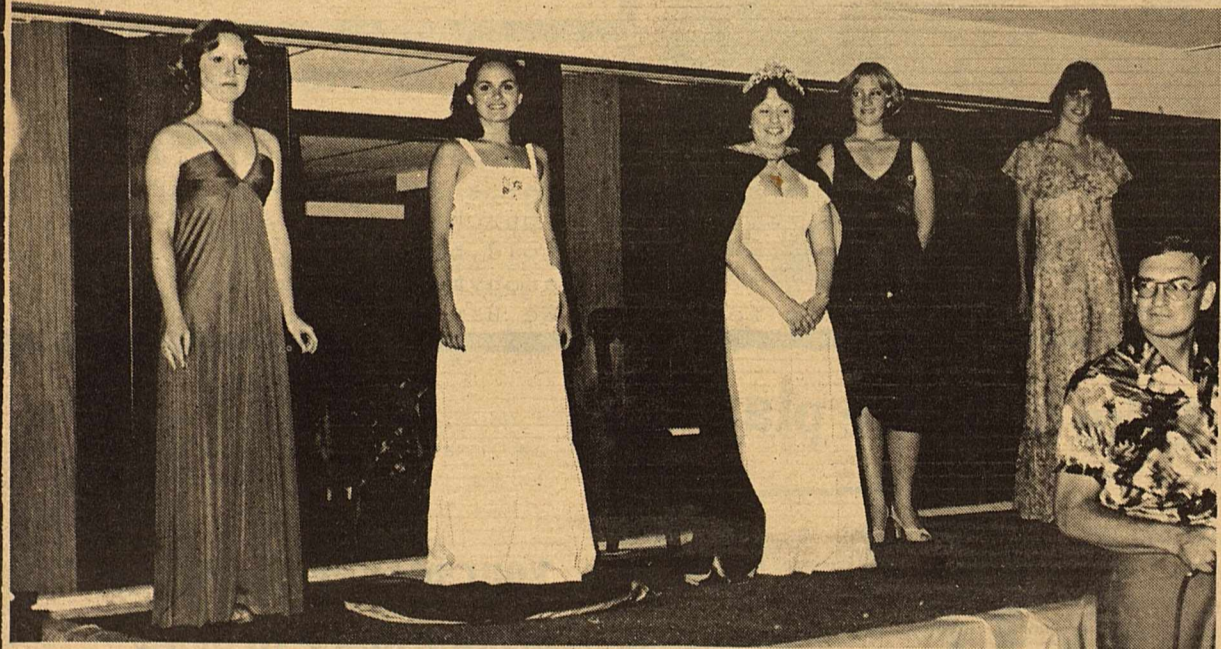
FIRE DESTROYED HOME

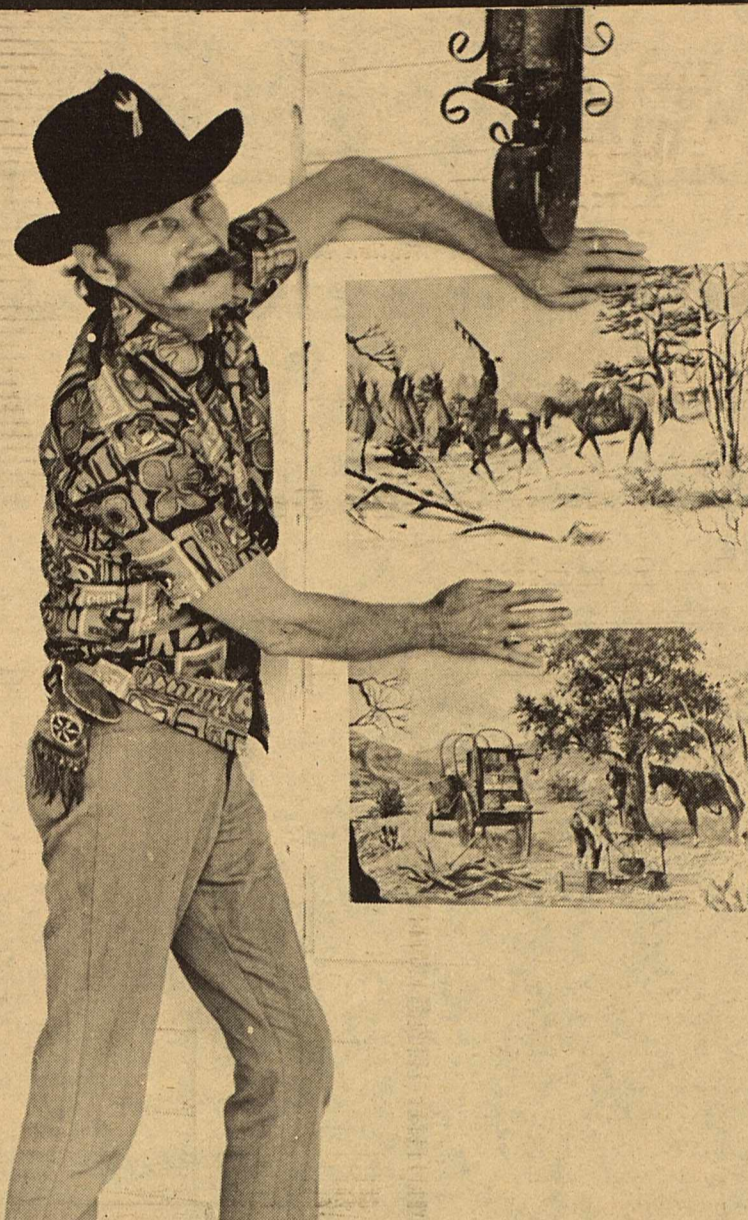

Alamo Village will officially open its summer season Memorial Day, Monday, May 29. Department of Human Resources

In response to a federal court ruling (Aiken vs. Obledo), the U.S. Department of Agriculture has issued changes in the food stamp regulations that may allow certain households to receive additional free food stamp coupons.

The new regulations overturn the Texas Department of Human Resources' policy of obtaining verification of need prior to the issuance of emergency food stamps. Texas' policy and been to either contact a person who was not a member of the household in order to obtain confirmation of the household's need or have the household itself provide proof of its needs for emergency food stamps.

A second policy overturned by the new regulations was the limitation of of one emergency food stamp issuance in a six month period. The federal court decision has ruled that it was not legal to limit a household to emergency stamps only once every six months or to require confirmation of the household's need before the emergency stamps could be issued.

In response to the ruling, the USDA has mandated that the Texas Department of Human Resources review, on request, emergency food stamp eligibility dating back to August 1974. Further, the federal government has ordered Texas to review situations of those persons who had considered applying, but did not apply because

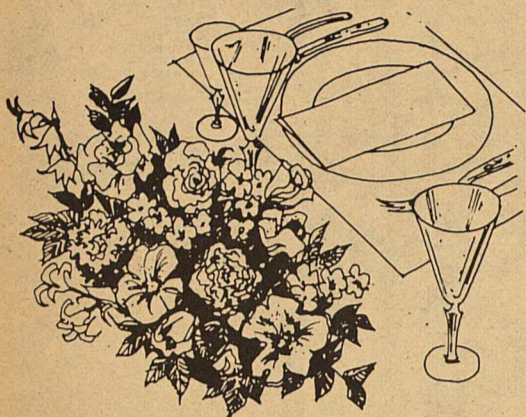
Persons who received food stamps at no cost but did not begin receiving the stamps in the same month they applied, and person who households had little or no income (usually less than \$90 per month) and had contacted a food stamp office but did not apply, or applied but did not follow through with application procedures because of assumed difficulty or delay in obtaining proof of need should contact

a local department of Human Resources food stamp office.

Persons need not be currently eligible for food stamps in order to obtain benefits under the ruling. If households currently enrolled in the program are granted assistance through this change in regulations they will be entitled to additional benefits or a reduction in the current purchase price.

COUNTY DRESS REVENUE SET

Interested 4-H'ers will model garments they have carefully selected and made to suit their age, figure type, personality, skill level and career, when the Kinney County 4-H Dress Revue launches Saturday, May 20, at Fort Clark Springs.

"Construction judging of the garments will begin at 9:30 a.m. at the Member's Lounge of the Las Moras Inn Restaurant with the models arriving at 1:00 p.m. for judging the outfit and the model. "Freedom To Be," a fashion show full of career exploration ideas, is set for 2:30 p.m. at the Poolside. The Public is encouraged to be present for this extra special viewing of our career minded 4-H models from Kinney County," stated Becky Rogers, County Extension Agent-at-Large.

Youth ages 14-19 will compete in the senior division, while the junior division contest involves ages 11-13 and preteens are 9 and 10 year olds. "One participant in each division will be selected for district competition scheduled for July 17 at Windsor Park Mall in San Antonio," Ms. Rogers explained.

12 4-H members from the Brackettville 4-H club have been studying clothing in project groups taught by adult and junior volunteer leaders. Leaders teaching clothing groups are Miss Trisha Forbes, Mrs. Antonia Graza, Mrs. Joyce Hooten, Mrs. Sylvia Meyer, Mrs. Linda Parks, and Mrs. Linda Rech.

"In order that the individual may select and make clothing which is becoming and expressive of the personality, our clothing program emphasizes development of an understanding of 'self', as well as developing skills in planning, buying and constructing clothing," the agent added. "other purposes are to develop the ability to select suitable and becoming accessories, to develop grace, good posture and habits of good grooming while learning to work and share with others.

The 3 major areas judged and the points each counts are: overall appearance--5 points; construction--35 points and record--15 points. The record is a 2-page questionnaire to help determine leadership and personal development which is judged by leaders prior to the 4-H contest. The construction judging is a thorough examination of the garment off the girl for quality of work, suitability for fabric and pattern style and creative techniques. Judging for overall appearance becomingness and suitability of garment and accessories, fit for the person and current fashion; and practicality of the outfit for the person's age, activities, and personality.

Whoever your are, whatever you do, 4-H had a place for you. The 4-H clothing project is just one of its many-sided phases.

The dress revue is a national 4-H awards program sponsored by Simplicity Pattern Company in cooperation with the Texas Agricultural Extension Service, The Texas A&M University system.

Shall I send flowers to the funeral? This has come to be a question in the minds of some people. After all the flowers wilt and fade rapidly and are gone. Soil Conservation

"Alamo" switchgrass is the newest grass variety to be selected, named and released for public use by the U.S.D.A. Soil Conservation Service.

The native strain was selected and tested to fill a need for use in range seeding or tame pasture plantings in the central and southern portions of the state.

Other strains of switchgrass now available are adapted only to the northern portions of the state and if they are used in our area they either would not grow or would die out in a few years.

The plants primary area of adaptability is where the average rainfall amount to 25 inches or more but will grow in drier areas if it can receive

extra moisture from runoff or is grown under irrigation.

It looks as if this plant can fill a need in our area if grown under irrigation. Switchgrass is a native, warm season bunch grass that grows three to seven feet high. It is very palatable and is a higher producer. It produces excellent high quality summer forage.

The original plant from which the strain originated was found growing on the north bank of the Frio River near Three Rivers in 1964 by Laramie E. McEntire, who was then an SCS range conservationist. Recognizing that the robust plant had superior growth characteristics, McEntire dug the plant transplanted it in his yard at George West and nurtured it. Seed from the plant were collected and evaluation plantings were made in the SCS Plant Materials Center at Knox City.

"Alamo" switchgrass is so genetically oriented to the South Texas climate that it is greened up earlier than commercial strains at Knox City and

produced seed two months later. These traits add up to a longer period of forage use during the year.

Some 900 pounds of foundation seed was planted by seed growers during the spring of 1978. Since the recommended seeding rate in rows is one or two months per acre, this should have planted 450 to 900 acres.

The Inmates Have Taken Over

 Belmont, Massachusetts — In 1965 a friend of ours suggested that we give the following response if we should happen to be asked for directions to the nearest insane asylum: "Don't budge an inch! Not only is the whole country one vast insane asylum, but they are letting the worst patients run the show."

Lest you think that such a characterization of present-day America is too harsh, we ask you to consider some recent news items which caught our eye.

- Two applicants show up for a job. One of them is drunk. You hire the sober workman, right? Wrong. The Washington bureaucracy has ruled that you can't discriminate against either alcoholics or drug addicts. In fact, you have the obligation "to find and hire drug abusers and alcoholics," according to an assistant labor secretary. And Attorney General Griffin Bell has said that under the 1973 Rehabilitation Act, "alcoholics and drug addicts are handicapped individuals for the purposes of Section 504."

Mind you, the government is not talking about cured alcoholics and junkies who could hold down a job. They mean active drunks and addicts. (From *Walls & Ceilings* magazine)

- Trucker A files an application with the Interstate Commerce Commission for a license. Trucker B opposes it and asks for his own license covering the same route. The ICC grants A's request. B asks for reconsideration. The ICC, until it can make a final ruling, postpones issuance of the license to A.

Meanwhile, B wins his license. The ICC ultimately rules that, because there is already a trucker on the route — Trucker B — and there is not enough business to support a competitor, the original ruling awarding a license to Trucker A should be reversed. (From a speech by Joe Sims, Deputy Assistant Attorney General)

- Last December, three grain elevator explosions killed 52 per-

sons and destroyed property worth more than \$100 million. Some grain elevator insurance underwriters believe that there may be many more such explosions because of new Environmental Protection Agency regulations.

In the past, grain elevators vented the dust into the air along with the methane gas that is produced by the stored grain. However, EPA regulations now prohibit elevator operators from venting the gas and dust into the air, causing larger buildups of the two volatile products. (From *The National Underwriter*)

- The United States will soon offer Red officials from the Soviet Union and its East European allies air time on Radio Free Europe and Radio Liberty. The plan was initiated by John A. Gronouski, chairman of the Board for International Broadcasting, an independent agency which supervises the two stations.

The two radio stations have been broadcasting in 16 languages to the Soviet Union and in six languages to Poland, Bulgaria, Hungary, Romania, and Czechoslovakia since the early 1950s. The Soviet Government and some of its East European allies have denounced the programs as "defamatory propaganda." (From *The New York Times*)

- Thomas H. Glenn, a Highway Safety Administration scientist, has been forced to suppress his anti-air bag evidence on orders from his boss, Joan Claybrook. Glenn's findings, which came from crash tests conducted in Buffalo using dummies and cadavers in off-center frontal collisions, found that air bags would not have protected occupants against fatal injuries. (From the *Los Angeles Herald-Examiner*)
