








SUMMER READING PROGRAM



A highlight of the second night of the pageant, June 29, will be the selection of Little Miss and Mister South Texas with some 23 contestants trying for the coveted titles.


Representing Kinney County will be "Little Miss " Jennifer Javins and "Little Mister" Anthony Lopez.



#### JOHNNY RODR IGUEZ RE-SIGNS WITH MANAGER, SHAHAN

NASHVILLE, TENN. -- Johnny Rodriguez, the rags to riches, Mexican heart throb whose "overnight success" catapulated him to the top of the country music charts, has reunited with his former mentor, Happy Shahan, and Nashville music business attorney Hon Lentz, for total career direction. The pact between the trio brings together three of the original principles which were responsible for Rodriguez' initial success and development as a major artist.

The deal was cinched with the traditional Texas-style handshake on June 8 at Rodriguez' home in Nashville during Fan Fair. Rodriguez has recently separated from his wife, and divorce proceedings have been filed.

"Johnny Rodriguez has gone full circle," Shahan said, "and he is now getting back to the basics."

"Johnny wants to write songs, and explore new areas of music to broaden his listening audience and further develop his own sound. He's also anxious to get back in touch with the people," Shahan said.

As part of the agreement, Rodriguez' bookings and personal appearance will be coordinated by Celebrity Management, Inc., a Nashville based entertainment organization, which is jointly owned by Shahan and Bob Bray, president.

In 1972, Rodriguez was signed to Mercury Records, and his first single "Pass Me By (If you're Only Passing Through)", became an immediate success. Since that time, every Rodriguez single has gone Top 10 and all of the country music trade charts. His explosion on the country music scene resulted in many awards, including Most Promising Male Vocalist by the Academy of Country and Western Music and the 1974 Billboard Magazine Trendsetter Award for "Emerging as the first young Chicano country music star...to capture the national audience.



## **SWTJC**

UVADLE -- Southwest Texas Junior College Board of Trustees met here Thursday night to approve a 1978-79 operating budget which provided only a slight rise in expenditures despite continued cost-of-living increases.

The new \$4,741, 088 budget represents an increase in expenditures of only \$29,190 over the previous budget with faculty salary raises accounting for the major portion of that in-

"I am pleased to be able to recommend a budget that contains only a small incresse in expenditures," president Wayne Matthews said as the board convened in regular session for the annual budget hearing.

"It has always been our goal to provide students with a quality education for the least amount of money possible," he said. "We have continhally managed to do this at very little expense to the taxpayer."


Matthews explained that the college tax rate has remained the same for more than 30 years with tax revenue from the tri-county district providing only 4 percent of the total college income.

The board again set the tax rate at 20 cents per \$100 of assessed valuation as determined by the Commissioners Court within the tri-county district.

Taxes combined with tuition and fees provide more than 15 percent of the operating income with state appropriations and state contracts contributing nearly 49 percent of the total income. Income derived from federal funds totals only 15 percent of the budget. Auxiliary enterprises such as the bookstore, dormitories and food service provide more than 13 percent of the operating budget.

In additional action the board increased summer room rates in the dormitory form \$15 a week to \$20. new rate becomes effective during the second six-week session and became necessary as a result of the rising cost of utility services.

Room and board ces for the upcoing fall semester were also increased



from \$420 a semester to \$500.

"It has always been our policy to keep down room and board fees as much as possible," Matthews saids, "But a steady increase in food, utilities and labor has forced us to request an increase in the room and board rates."

Matthews stressed that even with the increase Southwest Texas Junior College is still well below room and board rates being charged by other comparable state institutions.

Board members also approved a health fee increase for students from \$7 a semester to \$10 in order to defray the increased cost of operating the health center.

Other action taken by the board included restructing the adminstration to provide a Dean of Special Services rather than the former Dean of College

Areas of responsibility delegated to the Dean of Special Services will be adminstration of the Adult Basic Education Progam, the Regional Traffic Saftey Program, the Regional Law Enforc-

emnt Academy, Campus security, and the Higher Education Migrant Program.

The board also approved purchases of a postage meter which will be used to set up a centralized mail processing department for the college.

They also accepted the resignation of Walter Stueck, coordinator of the Traffic Safety Program, and Marilyn St. Clair, an instructor in the Division of Business Administration. Stueck resigned to accept a similar position at Texas Tech while Miss St. Clair will teach in the business department at Weatherford College.

The board accepted the low bid of Ballard and Haile for placing a seal coat on the college circle and repaving some areas of the parking lots in addition to curbing a new parking lot.

Dr. Jimmy Goodson, dean of administration services, reported that the Zavala COunty suit against the college which had been filed in federal court in Austin was dismissed by Judge Jack Roberts. The county has filed a motion for a new trail, he said, and the college attorney has answered that motion.





## Present Day Myths



of stupidity and mental sickness.



#### It Even Costs More to be Poor

The rising cost of living has even forced the poverty level up. The Labor Department has redefined the official poverty level to reflect the effects of sharply higher consumer prices. The poverty level for non-farm families living in the continental United States averages \$350 higher than last year, according to the department. For farm families, the increase averages \$290.

That means that an urban family of four can now earn up to \$6,200 a year and still qualify for the poverty category, compared with \$5,850 in 1977. The farm family figure is now \$5,270, compared with \$4,980 last year.

#### Marshall Musters Fraud Force

Labor Secretary Ray Marshall has created a special 200-man permanent force to investigate alleged corruption, mismanagement and fraud in the department's \$25 billion government assistance programs.

He said the investigations will include such programs as the Comprehensive Employment and Training Act, which funds the hiring of public employees; workers compensation; and the black-lung benefits program

"Our programs are generally successful and well-administered," Marshall said. "The scattered instances of fraud and mismanagement involve only a tiny percentage of our \$25.4 billion budget." While declining to name any figure, Marshall said he believes the amount of money lost to fraud is less than \$1 billion.

#### IRS Says Going Broke is No Excuse

The Supreme Court has ruled 5-4 that an employer who goes bankrupt must still pay the full penalty for failing to collect withholding taxes from workers and turn them over to the government.

The case involves Onofre Sotelo of Alpha, Illinois. He was president of O. J. Sotelo and Sons Masonry Inc. until the corporation went bankrupt without having paid the IRS taxes it was required to withhold from employees.

The Supreme Court agreed with an earlier decision by a bankruptcy court that Sotelo had to pay the IRS fine even though his company and he, personally, had gone bankrupt.

#### AID Aids Its Own, Says Senator

Sen. William Proxmire (D.-Wis.) says employees of the Agency for International Development (AID) are overpaid, over-ranked, overage and too many of them are "over here" instead of overseas.

Proxmire awarded his "Fleece of the Month" award to AID. It goes for what he calls "the biggest, most ironic or ridiculous example of government waste."

The senator said that AID's foreign service officers get an annual salary of \$31,139, about \$6,000 more a year than their counterparts at the State Department, which is in charge of foreign policy.


