## ALAMO VILLAGE

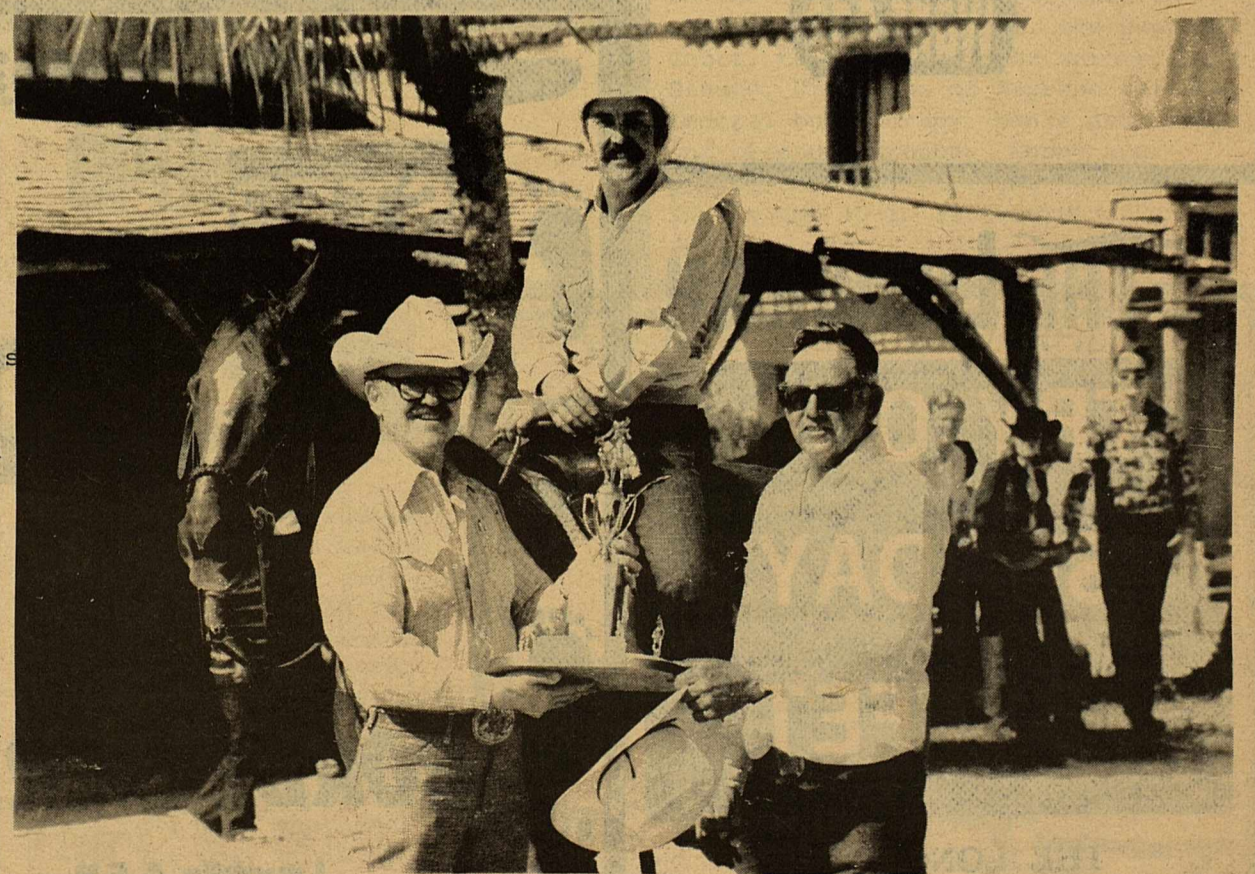
Alamo Village was the site of the 18th Annual Labor Day Cowboy Horse Races, September 4th.

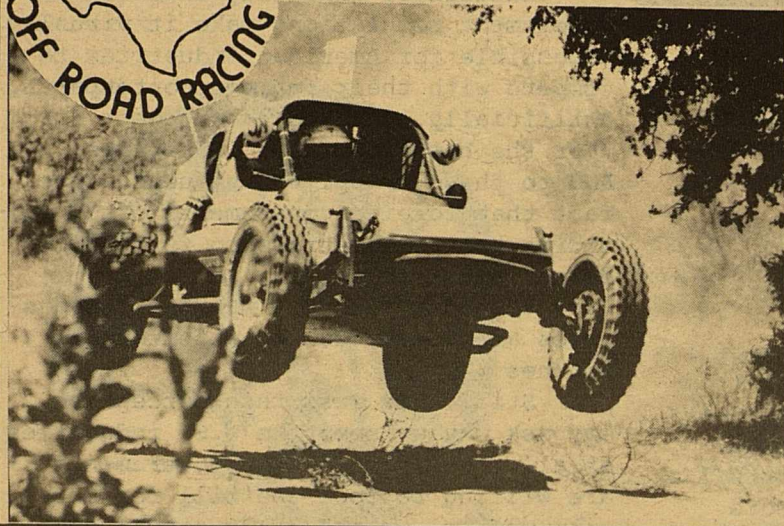
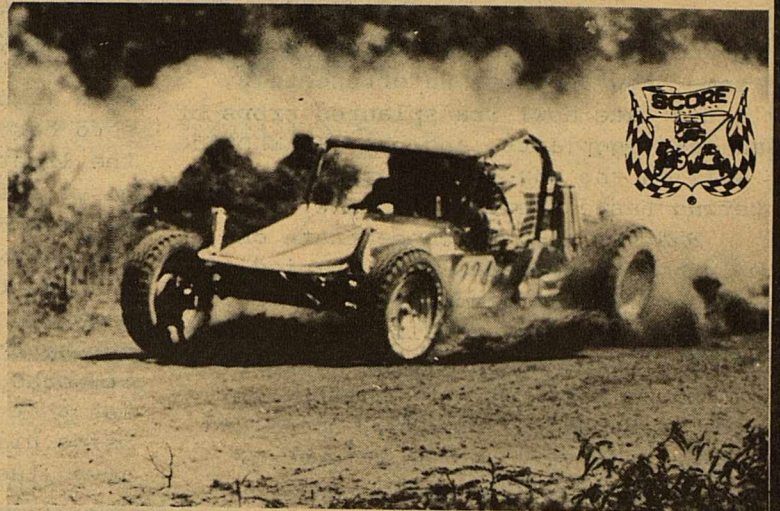

## Present Day Myths

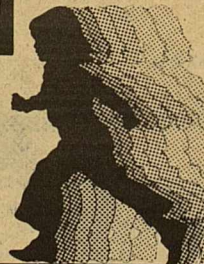

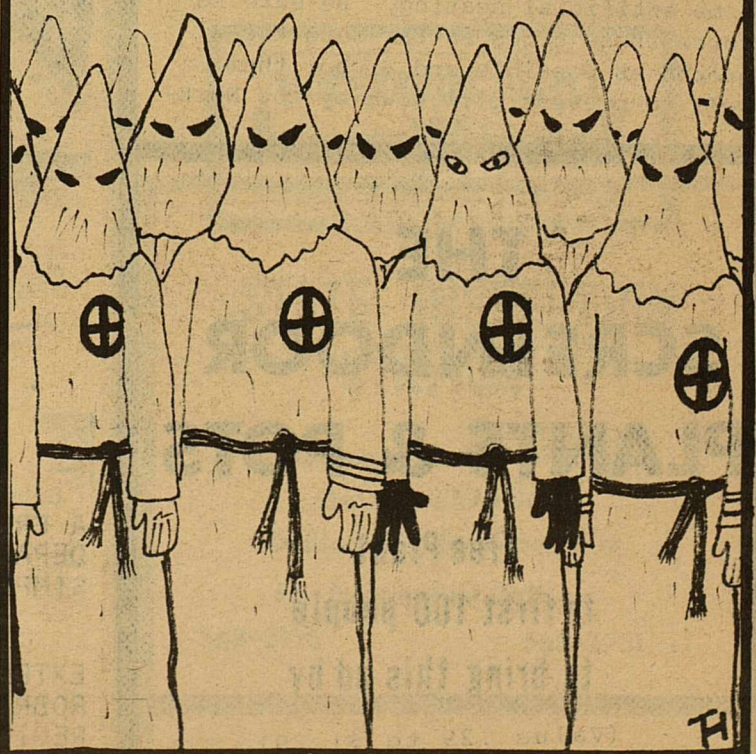
### ELEVENTH MOST POWERFUL

Results of a recent survey conducted by the U.S. News and World Report have newspapers ranked 11th among the most powerful instutions in the the nation. In the survey, 1,200 "influential Americans" were asked to judge the importance of each of 29 listed instiutions according to the amount of influence it has on decisions affecting the nation as a whole.

The White House was judged to be the most powerful, followed in order by large business, the Supreme Court, television, labor unions, U.S. Senate, U.S. House of Representatives, federal bureaucracy, banks and lobby and pressure groups. Lobby and pressure groups replaced newspapers in the top 10 in 1977 survey.

**VEGETABLE Task Force**

Fall planted gardens are beginning to look great in the area. All of those skeptics are now wishing they had planted some "new" plants. Unfortunately, it's too late now! Transplanted crops of Tomatoes, eggplants, and peppers should be well on the way to producing mouth-watering taste treats this fall.

What we need to concentrate on how is how to lengthen this "period of joy" we call fall gardening. Now is the time for action, especially if you intend to protect those tender mouth-watering delights we call tomatoes. Plants of tomatoes, peppers, beans and eggplants are very easily injured by frost and cold weather.

If these crops are to survive out "Blue Norther" cold snaps, they must be protected. With the Blue Norther usually comes high wind which plays havoc with weak protective shelters erected when the weatherman sounds the alert. Another factor which causes problems is the size of our plants by late November when protection is needed.

There is an answer to this problem if you act now. The simple solution is to erect a miniature greenhouse structures now before your plant gets too large. The best structure available is a 20-inch diameter circle of concrete reinforcing (10 gauge) wire commonly referred to as a "cage"

If you have attended our gardening seminars, you know that these are the most effective means of tomato plant support available, fall or spring. IN the fall the serve not only to support the plant and fruit but also as a circular structure which can be covered with plastic and turned into a miniature greenhouse.

Th way to make cages is simple and relatively inexpensive. Locate a hardware or lumber company that sells concrete reinforcing wire. Purchase a 5-foot length of wire. when formed into a circle and fastened, this 5-foot length will make a 20-inch circle which when stood on end, will be 5 foot high. This should be slipped over the plant before it grows too large. In the fall, it is a good idea to encourage all branches to stay in the cage, and as they grow just push them back when they start growing out of the cage.

When the Norther approaches, cover the insulating material. If a cold snap with temperatures below 32 degrees is coming, run an electric cord and one or two light bulbs to each cage for some artificial heating. Be sure to force these cages as far into the ground as possible and anchor them well to prevent blow down by the Nort-

her winds.

All of this sounds like a lot of trouble, but, by the same token, Christmas tomatoes are mighty good eating. When the rapidly moving Northers have passed, remove the protection and let the plants grow normally again in the cage.

Statistics indicate that no home with lighted plant cages in the back yard has ever been burglarized--and the lighted cages also give a "Christmas" effect! Just as Ben's friend, Patrick Henry, said: "I have but one lamp bu which my feet are guided, and that is the lamp of experience. I know of no way of judging of the future but by the past." I have tried this--it works, but you must act now. I'll bet that even Patrick Henry would be using his lamp on tomatoes if he enjoyed them as much as I do!

**SHEEP & GOAT RAISERS NEWS**

It's trade negotiations time again. This may not sound as exciting as the Superbowl, but it has far-reaching implications.

One particularly crucial area is limitation of textile and apparel imports. The Carter Administration has been talking tariff cuts, that is, lessening restrictions on imports. With a few exceptions, these cuts should cover alomst all imports including textiles and apparel items.

The entire domestic fiber industry, from cotton producers to wool growers to the weavers of Navajo rugs and makers of Pendleton sweaters have a major stake in the outcome of the talks. Industry leaders, armed with computer data, predict that any cut in tariffs on foreign textiles and apparel could deal a death blow to the domestic industry. This, they add, would mean the loss of as many as 2.2 million American jobs.

The question of import restrictions is a particularly touchy one. Supporters of relaxed restrictions point out that the most basic of American Business philosophies calls for market regulation by the law of supply and demand..efficient industries need not fear competition, and those that must be protected from competition aren't viable anyway. Afer all, don't most U.S. industries use this argument themselves to justify demands for less federal intervention?

The argument is sound...at least as far as it goes. It's the very philosophy that ma-e the U.S. a superpower in the first place. It has one critical failing, however, when applied to international trade. It presupposes that American industries are allowed to be competitive, and the simple, uncomfortable truth is that they often are not.

Excessive, generally unwarranted government regulations make it virually impossible for American industries to compete with their foriegn conterparts. Artificially inflated labor costs further the hamstringing most industries. Add to these crippling influences the fact that foreign governments often subsidize their industries to further undercut American prices, and it's not hard to understand why many U.S. industries are today reeling with foreign punches.

Still, the less-than-perceptive may ask why we need the U.S. industries at all...why, if foreign governments are willing to foot the bill for our consumption, we shouldn't simple take them up on it and let American Industry go to the dogs. Yes, they definitely are less that perceptive.

From their own selfish point of view they should have enough sense of realization what it would mean to their own jobs. They may or may not be able to see far enough down the road to imagine what would happen if we became completely dependent on foreign goods and then those goods were

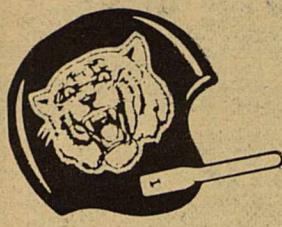

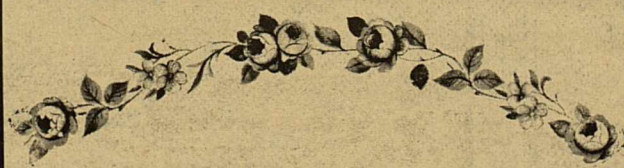


## GREEN THUMBS

by: JOE TOWNSEND

If you have roses it is time to give them a little attention. They should be checked carefully for the presence of fungi. If the leaves turn a dull gray or if there is a great deal of yellow or black spots you likely have fungus problems. The best and cheapest way to deal with the problem is to dust with powdered sulfur. If the plants look sickly they probably need to be fed. Use any good all purpose fertilizer. If the leaves are yellow the plant likely needs iron--use copperas or iron chelate--the basic difference is a matter of density. Roses should be healthy and in good condition before they go dormant which is usually December in this area.

withheld to run up prices. There must be many people out there who can't see that far--if they could, they'd see that it was already happened in the case of foreign petroleum. It's a classic example of excessive domestic regulation going much to far and foreign suppliers taking natural advantage of it.

There are at present, two bills, Senate Bill 2920 and House Bill 10853, that would exempt textiles and apparel from the current round of tariff-cut talks in Tokyo. It's a place to start The Texas Sheep and Goat Raisers' Association supports these bills and urges their passage. Fiber production, whether it be wool or cotton, is a major Texas industry and is totally dependent on the domestic textile industry for an outlet. A blow dealt to the domestic apparel or textile industry is a blow dealt to American fiber producers--they are out only customers.

Write you Senators and Congressman in support of the bills. Vital American industries simply cannot compete fairly with foreign products that are not subject to the same crippling pressures. If the U.S. government is going to beat its own industries about the head and shoulders, the least it can do is offer them a little protection from others who would run in and throw a cheap shot when they're down.

**AND CONSTRUCTION IS EXPENSIVE.**

Because of governmental regulations curtailing the amount of natural gas that can be delivered to Texas utility firms for electricity production, Central Power and Light Company is turning to nuclear and coal-fired plants for generation of electricity.

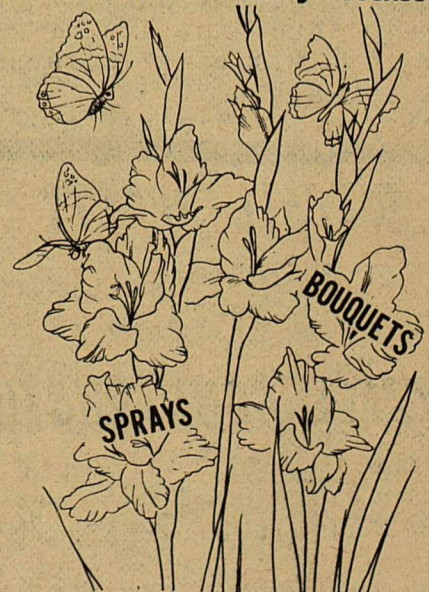
