Dear Editor,

Often, in the course of political campaigns, charges and counter-charges are made which create confusion about where a candidate really stands on an important issue. This is the case in Senator Tower's current campaign for re-election to the U.S. Senate from Texas, where attempts are being made to distort Senator Tower's position on the question of federal gun control laws.

At issue is the significance and meaning of Senator Tower's vote for the gun control Act of 1968. As you well remember, in 1968 the assassination of President John Kennedy was still fresh in the minds of many, and in the spring of that year, both Martin Luther King and Senator Robert Kennedy had been murdered. The national news media was leading a hysterical campaign for "gun control" and the Johnson Administration had introduced a bill calling for the registration of firearms and licensing of all gun owners. By comparison, the Gun Control Act was mild, and many of our best friends in Congress voted for it, out of conviction that if it were not passed, an even worse bill would have been enacted. In voting for the bill, Senator Tower joined with Senator Roman Hruska, who had for years led the fight against the Dodd bills and other repressive firearms laws.

I've known John Tower personally since his early years in the Senate, when I was a political reporter on his hometown newspaper, the Wichita Falls Record. And I know that he is not "anti-gun" by a stretch of the imagination.

From 1966 to 1968 I was editor of Gun Week, and I covered the series of Dodd bills that eventually became the Gun Control Act. One of the fights over the wording of that law--after it had passed the House and we knew that it was going to pass the Senate--was how "antique firearms" were to be defined. Senator John led that fight, pushing for the definition written into the law. Because of his work, guns made before 1898 and modern replicas of those guns including all black powder models, are exempted from the law.

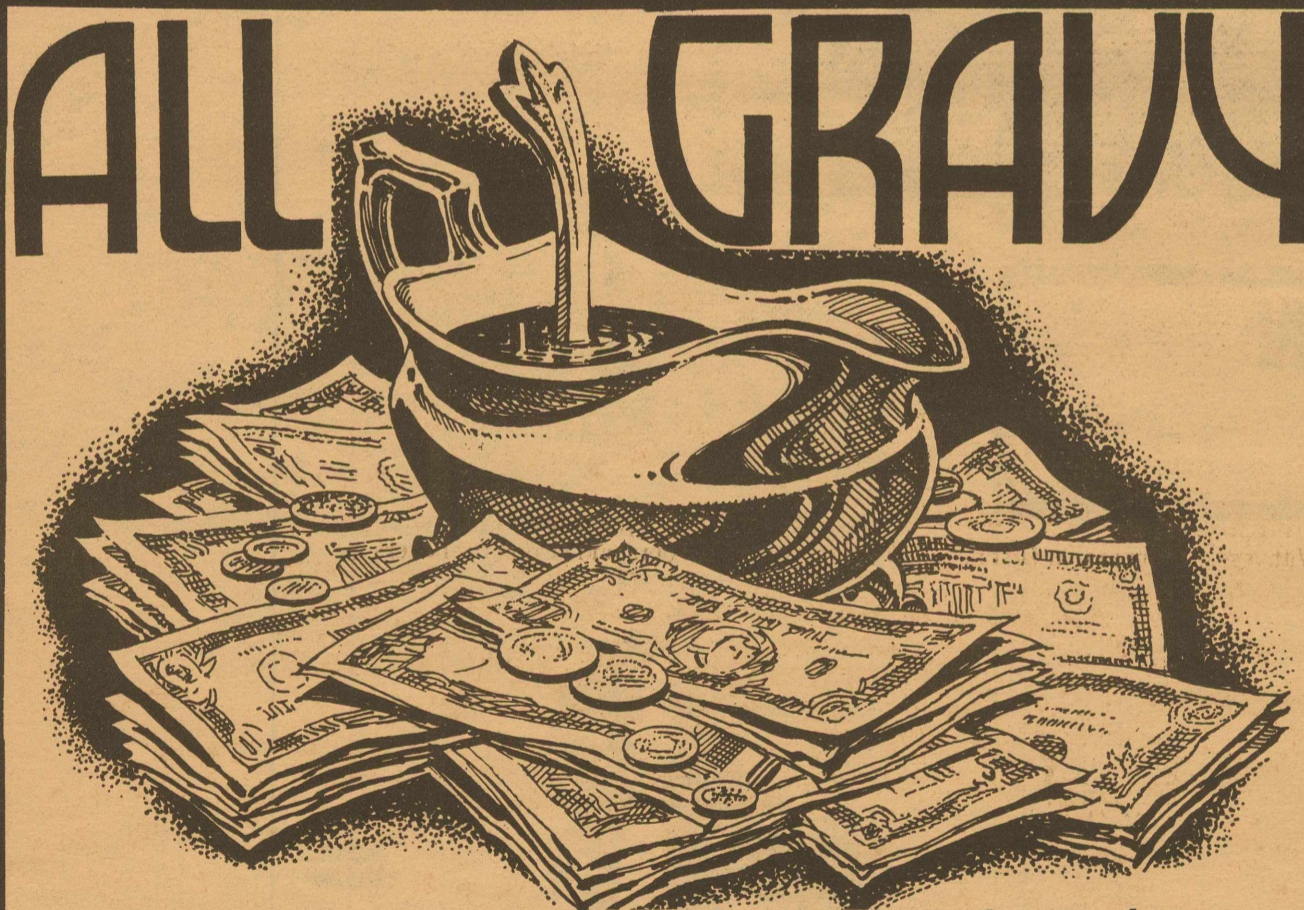
Three other amendments, which would have required firearms registration and licensing were offered during the Senate consideration of the bill. Senator Tower voted against each of those amendments, and each was defeated. The bill was finally approved by an overwhelming 70-17. In 1972, the Senate again considered gun control legislation, the Handgun Control Act. This measure would have prohibited the sale of any handgun except those specifically approved by the Federal Government as suitable for sporting purposes. Although the bill was passed by the Senate by a vote of 68-25, Senator Tower voted against it, arguing that it would be ineffective in controlling crime and that it would set a precedent for further Federal controls and registration.

While no further legislation relating to gun control has come before the Senate in the last six years, the Bureau of Alcohol, Tobacco and Firearms of the Federal Treasury Department recently announced its intent to promulgate regulations computerizing all firearms sales. Senator Tower strongly opposed these regulations, and co-sponsored a measure introduced in the Senate calling upon BATF to withdraw the proposed regulations before they take effect. In addition, he supported a Treasury Department appropriations bill specifically prohibiting any expenditure for those regulations and voted for an amendment deleting any expenditure for those regulations.

voted for an amendment deleting \$3.8 million which BATF had indicated it would use to implement the regulations.

It is unfortunate that a letter such as this one needs to be written, but I hope that these comments will dispel any confusion which exists concerning Senator Tower's views on the firearms issue.

- 1/4 teaspoon seasoning salt

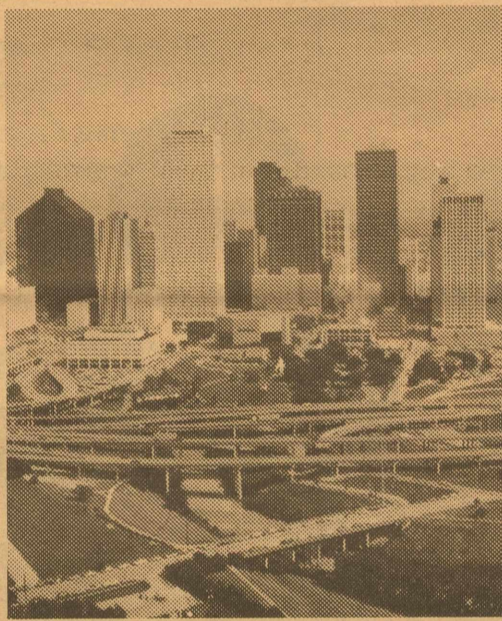

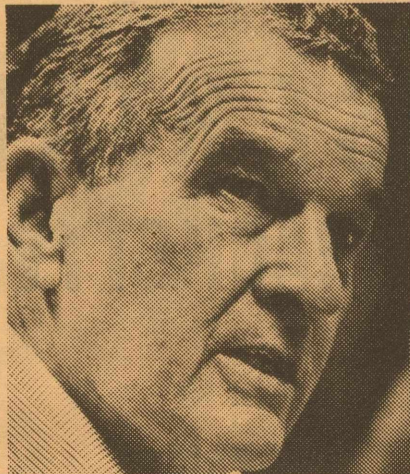

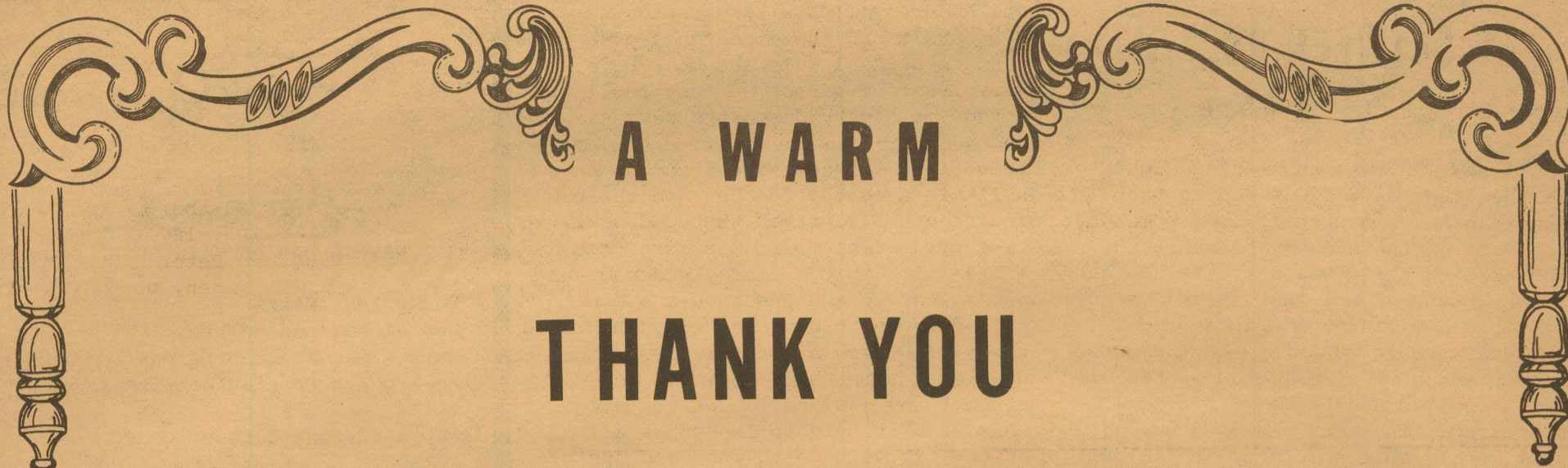

Mrs. Martha Petersen Bartberger was born in Denmark, October 25, 1879. She was the daughter of Niels Peter Petersen and Nettie Olson Petersen, natives of Denmark.

Martha came to the United States with her mother when she was ten years old. She saw her father for the first time when she was nine.

Martha's father bought an interest in the Roach Mercantile Company in 1896 and in 1904 he bought out all other interests thus becoming sole owner of the store. Petersen and Company became a landmark in Brackettville.

In 1906 Niels Petersen, his brother, Hans Petersen and other citizens in Brackettville organized the first bank---The First State Bank of Brackettville.

Alfred E. Bartberger and Martha Petersen were married in St. Andrew's Episcopal Church on November 5, 1919.

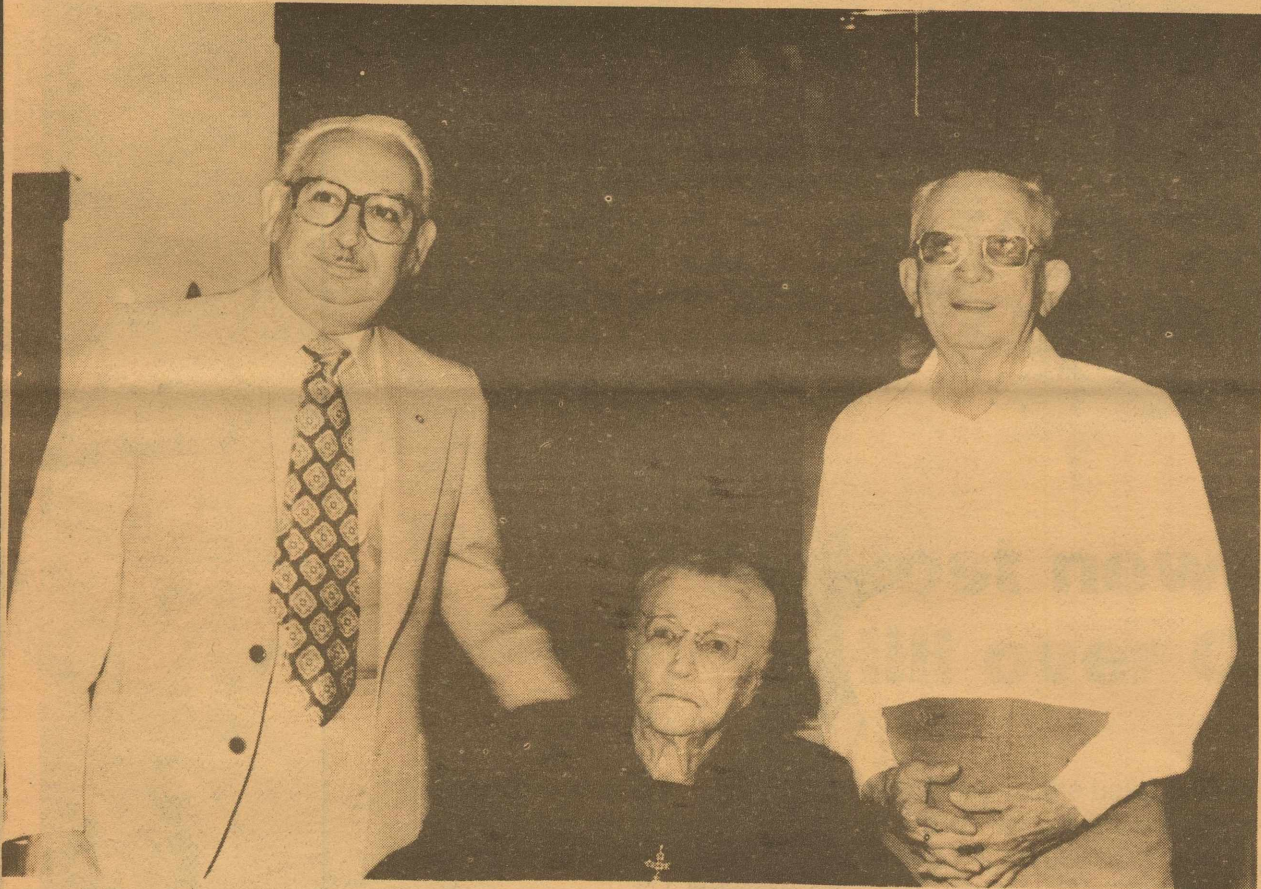
During all of their active years the Bartbergers contributed time and financial aid to people throughout this section of Texas.

In 1950, Mrs. Bartberger became a director of the Brackettville Bank and still retains that position.

Martha now lives in the Memorial Medical Nursing Center, 315 East Lewis Street, San Antonio.

Each year her family, Mr. and Mrs. Martin Petersen of California and Mr. and Mrs. Preston Sights of Brackettville host a party for her birthday.

This year the family held their party at the St. Andrew's Parish House, with approximately 75 people attending the 99th birthday celebration.

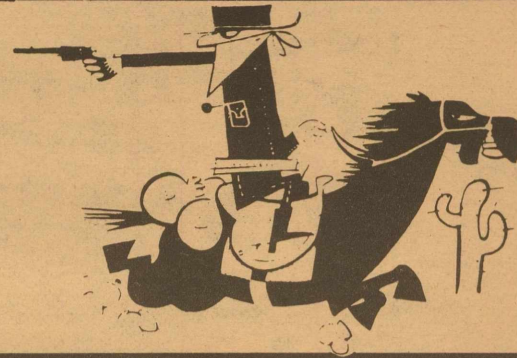

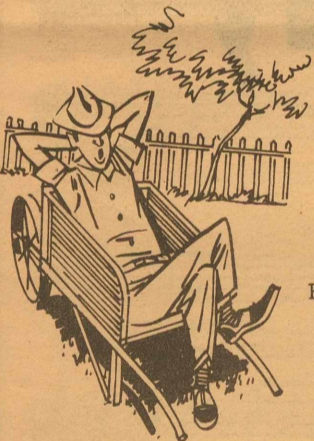
COUNTY YOUTH HONORED DURING UVALDE LUNCHEON

GREEN THUMBS

are considering the protection of plants through the winter. One big thing to remember is that wet plants in wet soil will withstand a great deal more cold than dry plants in a dry soil. If there is to be a freeze or frost water heavily any exposed plants the night before.

It is important many times to water heavily any plants that have been exposed just before the sun comes up. Watering plants heavily raises the temperature of the plants. It also can melt the frost with little damage to the plants if it is done before the sun hits the plants. Plants covered with ice are much less likely to be killed than plants exposed to the same temperature in a dry condition. Plants can be covered with plastic to protect them but unless the plastic is removed during the day's heat with a bright sun the plants will "scald." Just because plants are in a building is no sign or guarantee they will not freeze and be killed. The temperature must be maintained at a safe level inside. Many plants will do better outside at the same temperature as inside especially if they are well watered.

IN 1921, Bill Fultz came to Fort Clark and assumed duty as a Communications Seargant for the 2 nd Squad of the 5th Troop.

This interesting bit of information was unearthed by roving reporters Catrina (age 2) and myself (age 30) as we sat at the Burger & Shake arguing over whether to have ice cream before, or after she finished her hamburger (needless to say I wanted to wait until after, and she disagreed). How, you ask, could we learn about Bill Fultz in the midst of an arguement? Ah, therein lies a pleasant tale; To a two year old, the world itself is a new toy, and each person one meets is a dear friend, worth listening to and getting to know better. Isn't it sad that we "adults" lose our fascination with people as we grow older? Enough nostalgia, on with the tale....

Somewhere in the midst of the aforementioned arguement Catrina looked at the man next to us and hollered (literally) "Grandpa!", I turned of course, and saw an elderly man with alert eyes and a cheerful smile. He reached down to the table, picked up an odd looking device, held it to his throat and through the wizardry of electronics, "spoke" to us. Over the next half hour or so, the odd mechanical buzz of Bill's speech faded and a warm, friendly human being emerged. Here is the rest of his story....

In those days, wireless communication was still in it's infancy. When Bill and his troops went into the field, they carried, via mule pack, a large cumbersome generator type device which was unloaded on site and hand cranked by two men. Setting up, what with antennas and ground wires to run, as well as unloading the mules, was rather time consuming. Once set up and operating, Bill's equipment had a maximum operating range of 27 miles. As well as being responsible for the transportation and operation of radio equipment, Bill and his men were also in charge of handling and use of explosives (TNT). Bill didn't seem to mind the explosives or lugging around the heavy radio equipment though and he spent four years at it. Bill left Ft. Clark, and the Army, in 1925 and for the next 30 years or so, worked for RCA. Recently, in the last few years, Bill has traveled all over the United States, passing through or visiting in all of the continental states except Oregon. In December, Bill is coming "home" to Ft. Clark (they should be finished building his home by then) and plans to settle down.

I, for one, feel that our little Fort Clark/Brackettville community will profit greatly from Bill's move and I wish to take this opportunity to say "Welcome Bill, Thanks for join-

CASE HISTORIES OF BENEFITS PROVIDED

Last week we learned that the Service Units of the Salvation Army, composed of civilian volunteers, are organized for the purpose of performing the same mission of helping those in need that their uniformed counterparts do in the larger Corps cities.


When Services Units are challenged by the distress of their fellow residents in their area, these volunteers take the responsibility of deciding how best they can help ease these problems. They act without ted tape and with overhead in all such situations. No cases of genuine need are turned away; they only make sure that they are not duplicating services available from other agencies. Here are a few case histories that illustrate how neighbor helps neighbor with a "hand to man".

CASE #1 One Chairman was preparing to close up and go home one afternoon after five recently when the phone rang. The caller was a man asking help with a problem. As head of the Salvation Army Services Unit, the Chairman was used to receiving phone calls at all hours from troubled people. "I've started work on a regular job," the caller said. "But I don't get a check for ten days and there's no food in the house for my family. Can you folks tide me over with groceries until I get paid?"

The Chairman questioned the caller to ascertain his needs, then he instructed him to contact the Service Unit's Welfare Secretary who would issue a purchase order for \$30.00 worth of groceries. When the call ended, the caller seemed much relieved.

CASE #2 Another case, in which the Salvation Army's response was able to alleviate a temporary problem, was called to their attention by the school's visiting teacher. The coincidence of 3 transients in one family just as school opened made her unusually curious, so she visited the home located in the middle income section

However, not all the cases are people who live in the community. Stranded travelers sometimes need a meal, lodging, or gasoline or a bus ticket so they can complete their journey to family, friends, or a familiar environment. Take the case of the family of four from Detroit who came to Texas for promised employment. But on the way their car broke down, and with only enough money for skimpy meals, the family lived in the car for 2 weeks, until help from the Service Unit came to the rescue.

Being stranded, broke and alone in a strange place can be a terrifying experience, and people in that fix can be tempted to invade a peaceful home or business to take what they desperately need, so really help by the Salvation Army may prove to be a kind of community peace insurance. Many Service Units all strangers for screening at the Police or Sheriff's Department; there, the skilled professional lawmen make sure that the requests are valid and the Salvation Army money is not spent on a fugitive or wanted person.

CASE #3

There she learned from the brave but discouraged mother that the father had had an accident that put him in the hospital for several weeks. He was recovering well, but the family was struggling against the double load of lost income and heavy hospital costs. They were eating enough, but there was simply not enough money left over to get the kids some shoes and clothes they needed to begin school this fall.

The visiting teacher knew the family to be a hard-working and responsible one so she could vouch that their plight did not result from spending excesses. She found the Salvation Army Service Unit responsive so they could rejoin their classes without shame.

Over the next few months the Service Unit Treasurer found his books did not balance with the bank's because a number of deposits had been mysteriously made to the account. He checked with the tellers and learned that the mother had been making regular weekly payments to repay the benefit they had received. It was explained to her the help was a grant, not a loan, but she said, "We are not welfare people, who have to take help, and we sure want this money to be available to help some other folks who are hit by hard times!"

Veterans who expect to receive educational GI bill benefits during the spring semester at Southwest Texas Junior College should contact the college Veterans Office prior to Dec. 1. In order to receive advanced pay at the time of registration, students must apply not less than 30 days before the registration date.

Financial aid for veterans is available not only for students taking college level academic and vocational course but also for students needing to complete requirements for a high school diploma.

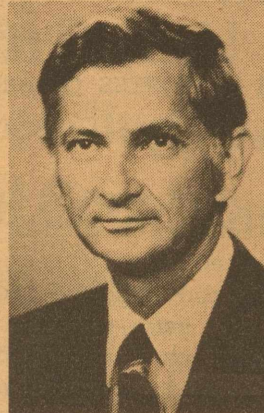
Present Day Myths

Keep an outstanding person in this important job.



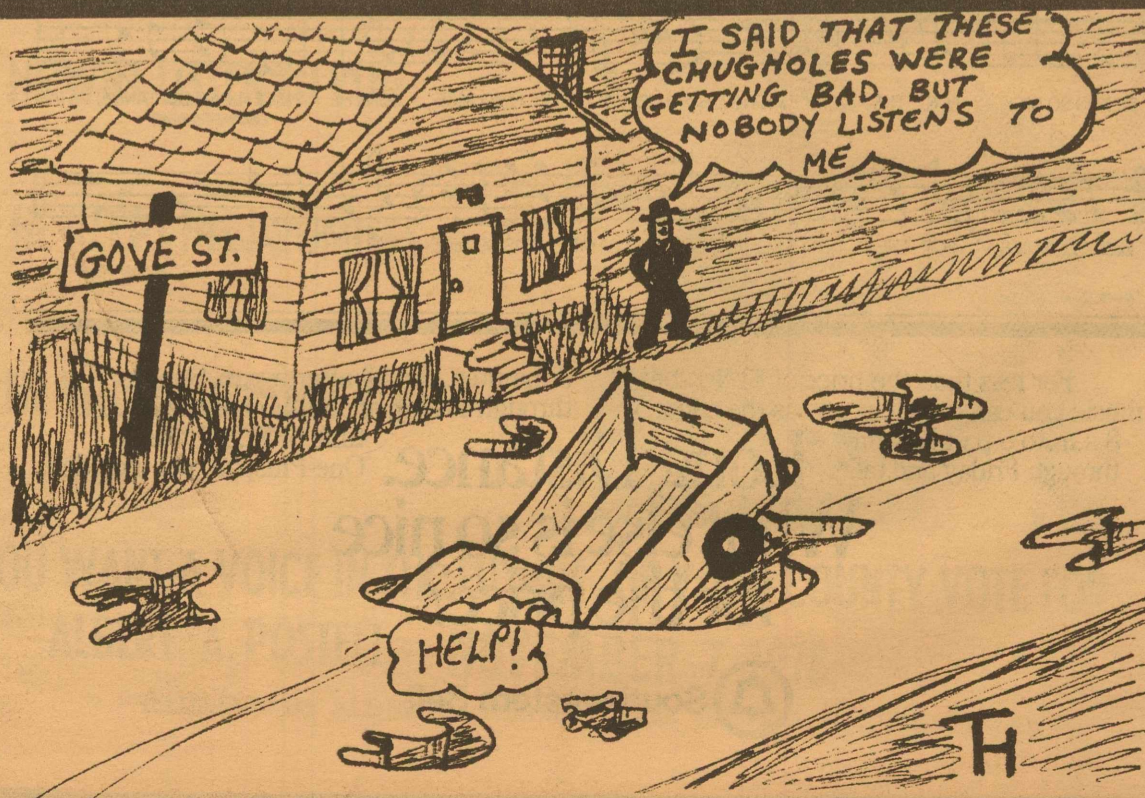

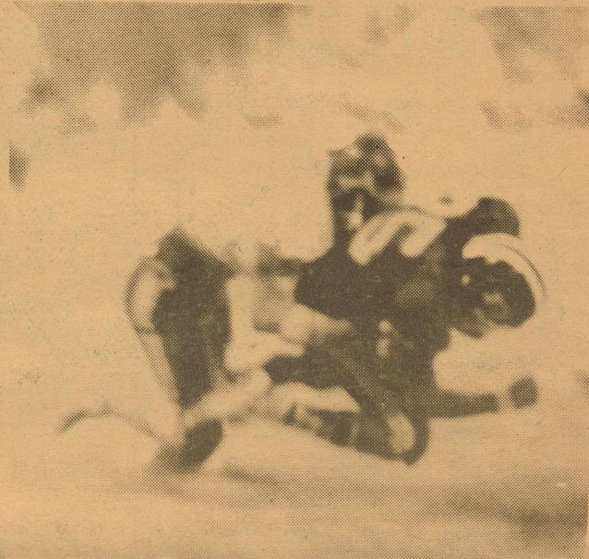

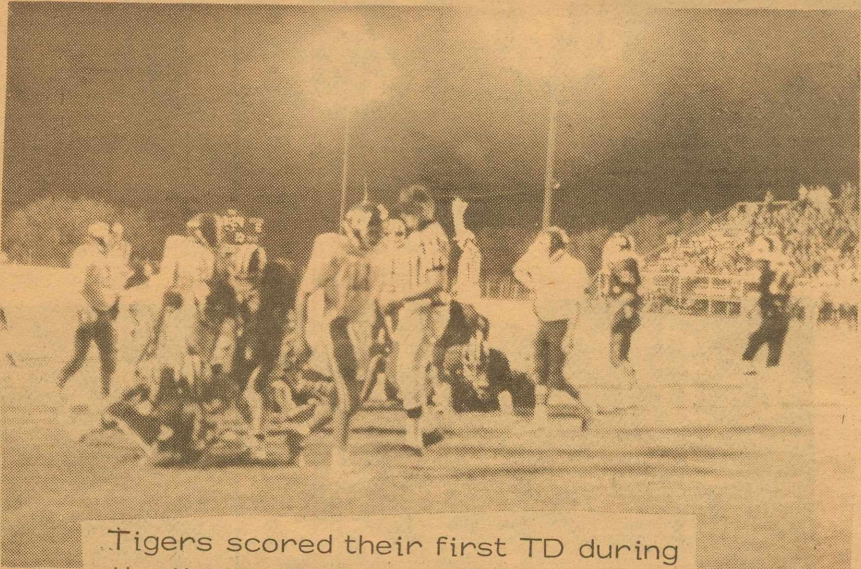

DYNAMIC PROJECT

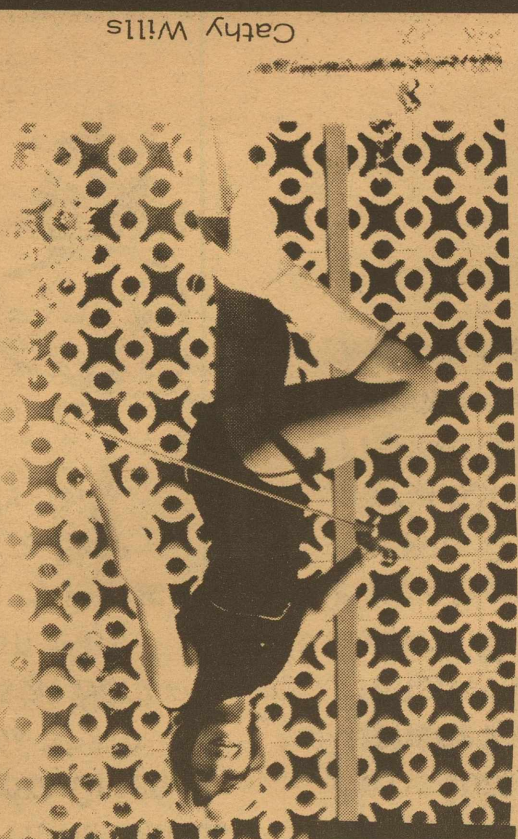

PROPOSITION 4: THE SOLAR PROPERTY TAX EXEMPTION

The stage is being set for the development and commercialization of solar energy in Texas. St. Rep. Bill Keese (D-Sommerville) says that passage of Proposition 4, the solar energy property tax exemption, which is on the November ballot is considered crucial if solar energy is to play a key role in holding down energy costs for Texans in the future.

Passage of Proposition 4 by the voters will avoid the anticipated problem of solar energy devices being taxed and thus, making it less economic. Proposition 4 had substantial support in both the House and the Senate.

"We don't want to be in the situation in the future of having the financial savings that will come from having solar energy devices on our homes and businesses eaten up by the property tax, Keese noted.

Solar energy is different from most conventional sources of energy in that it requires large initial cost for the equipment and no fuel cost, and economical benefits will not be seen for years to come."

while conventional fossil fuels require a smaller equipment cost but fuels that are increasingly more expensive.

Passage of Proposition 4 will only be the beginning of a solar energy policy for Texas, Keese said. The Texas House member further stated that on an omnibus Solar Energy Act is currently being developed and will be introduced in the next legislative session in 1979.

"This Solar Energy Act, along with the passage of Proposition on the November ballot, will provide Texans with a basic policy framework for the Senate."

Besides conserving valuable fossil fuels and the future economic savings, Keese noted that solar energy will generate more employment than that of the more conventional energy sources, diversify Texas industry and create a new energy industry for Texas.

"However, should Proposition 4 fail to pass, the developing solar energy industry will be greatly slowed in the State and the financial and economical benefits will not be seen for years to come."

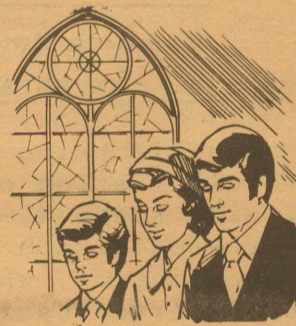
