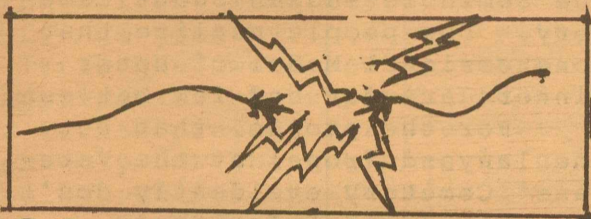

4. It is also rumored that the contractor did not have a legal bond for this construction project. Who was responsible to see that he was legally bonded?

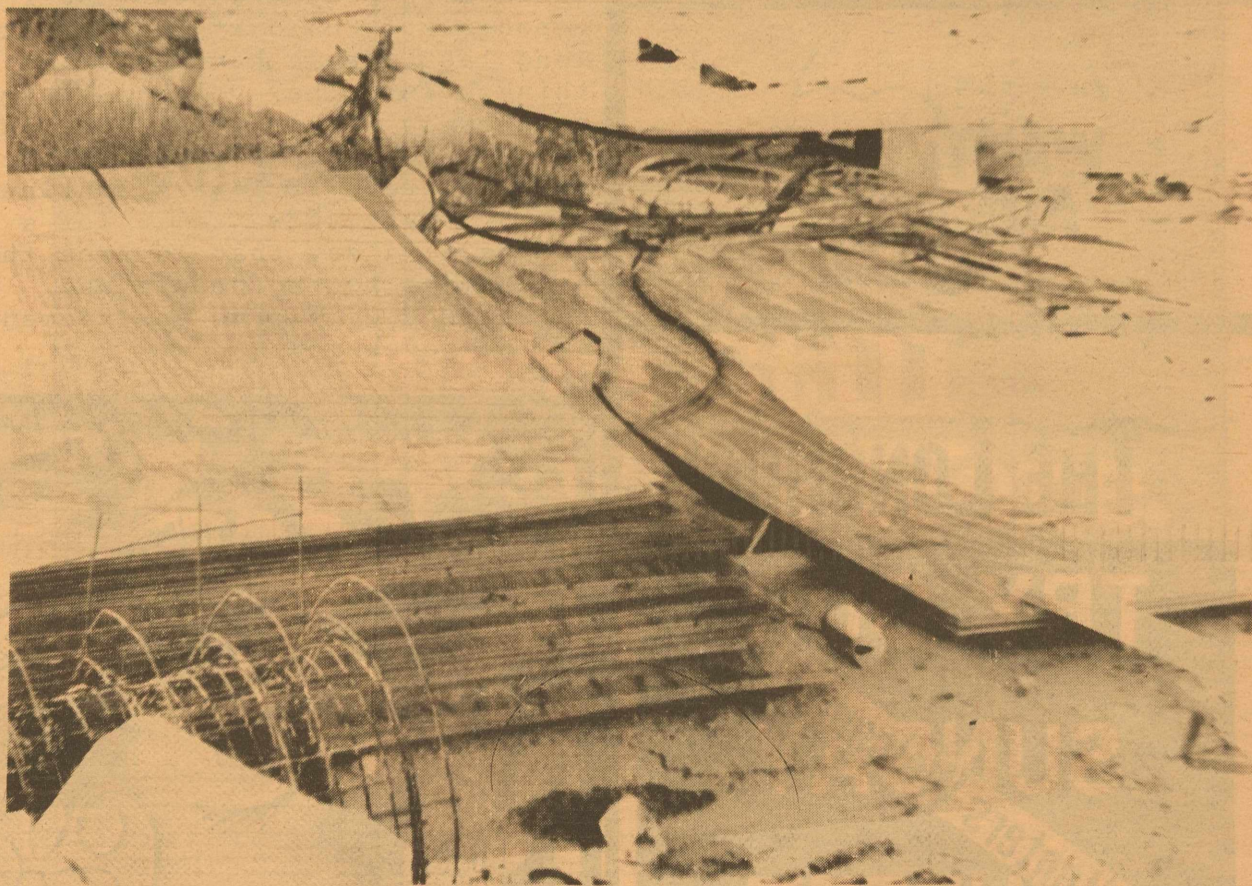
Our County Commissioners' Court last week, decided that they should terminate the services of the contractor...AFTER MONTHS OF INACTIVITY.

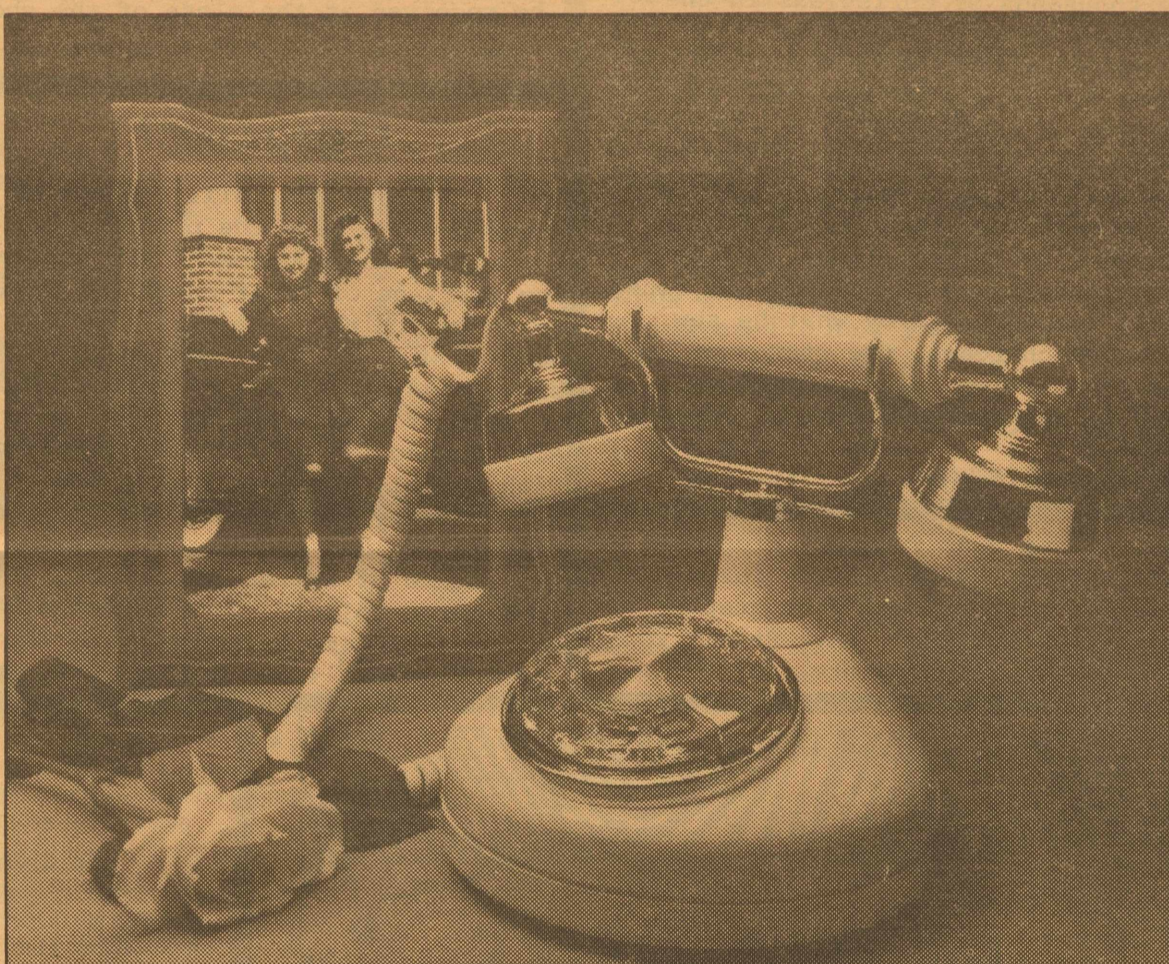

RED AND GREEN CHRISTMAS CAKE

- 1 lb. Pecans, chopped
- 1 lb. dates, chopped
- 1 lb. Maraschino cherries, chopped
- 1 lb. Candied pineapple, half green & half red, chopped
- 1 cup sugar
- 4 eggs beaten
- 1/2 cup flour
- 1 teaspoon salt
- 1 1/2 teaspoon baking powder

Some juice from the cherries
Mix all the fruit and nuts together. Add flour, salt, baking powder and sugar, mixing well again and add cherry juice and eggs, mixing well again.

Turn into 2 loaf pans or 1 tube pan well greased. Bake in slow oven (300 F. to 325F.) for 1 hour--soak in brandy for 2 weeks or more.

Brown 2 pounds of vension steaks cut in serving size pieces and dipped in flour, in fat, oven moderate heat. Add 1/2 cup sour cream, 1 teaspoon worchestershire sauce, and celery salt. Cover sillet and simmer 1 hour.

PROJECT MATCH NOW AVAILABLE TO REGION 20 SCHOOLS FOR CAREER EDUCATION.

It's never too early for youngsters to begin thinking about a future occupation. That's the premise behind a new career education program being offered schools by Education Service Center, Region 20.

Project MATCH, an educational approach which originated in Canada, is designed to get kindergarten through eighth grade youngsters to begin focusing on what they want to do when they enter the world of work.

The program matches attitudes and talents of the elementary and middle school students to possible careers, according to Betty Child, Region 20 project manager in charge of the new venture

School personnel from throughout region 20's 14-country Southwest Texas service area will spend Wednesday, Nov. 29, undergoing training to learn how to implement the program in their schools and how to teach others in their districts to do so.

The educators will spend from 8 a.m. to 5 p.m. involving themselves in the training which will be conducted in Region 20's first floor conference room, 1550 N.E. Loop 410, in San Antonio.

The Project MATCH (Matching Attitudes and Talents to Career Education) concentrates on integrating career education information into the regular curriculum of elementary and middle school students. It especially strives, according to Mrs. Child, to answer for students the question of how learning basic skills will help prepare them for the job market in the future.

The program was developed originally for a Canadian school system and after success there has been successfully implemented in several U.S. school districts.

Project MATCH research has shown that students often do not take their school work seriously because they see no meaning in what they are learning. Development of career interests can, Mrs. Child stresses, lead to greater learning by students and higher scores on standardized tests.

Eligible to participate in the new program are 50 school districts in Bexar, Atascosa, Banderita, Dimmit, Frio, Kerr, Kinney, LaSalle, Maverick, Medina, Real, Uvalde, Wilson and Zavala counties.

Camino Real health systems agency Planning for Community Health

Publication of a new informational brochure has been announced by the Camino Real Health Systems Agency, Inc.

The new pamphlet is entitled "Camino Real Health Systems Agency and the Five W's." The 'Five W's' is a reference to one of the basic news-gathering tools used by journalists.

"Since the image of the agency had been somewhat insufficient, the first task was to ask and to answer some very basic questions," said Celso I. Martinez, Public Information Officer.

The five w's stand for who, what, when, where, and why. Journalist agree the information gathered after answering these basic questions offers a solid foundation for further development of a news story.

Martinez assumed the reins of the organization's public information effort after serving a number of years in the field of broadcast journalism.

"In addition to answering the five w's, the brochure offers readers a feel for the geographical area served by Camino Real by virtue of a map that appears on the back," added Martinez.

NEWS BRIEFS

Check That Out

The 200 mailmen in Santa Cruz, Cal., were shorted a week's pay on their checks recently because their time cards got lost—in the mail.

Hot Line

For several weeks, the phones in the office of a group of attorneys in St. George, Utah, would ring, but nobody would be on the other end.

Finally, one of the office staff noticed that every time somebody went to the restroom, the "phantom" would call. Closer inspection revealed that when someone sat on the commode, the circuit would be broken and the phone would ring.

Mountain Bell technicians were called in and found the telephone system in the office was grounded to a water pipe on the floor below. When someone sat on the commode, the circuit would be broken and the phone would ring.

Productivity Drops

The Labor Department reports that productivity of American workers fell 3.6 per cent at an annual rate in the first three months of 1978, the biggest decline in four years.

The sharp decline in output from the same number of paid hours of work increases inflationary pressures on the economy because labor costs per unit go up, the report said. It also noted that total hourly compensation, which includes wages and benefits, rose at an annual rate of 14 per cent during the quarter, the largest increase in five years.

No Bang for the Buck

What if they held an underground nuclear bomb test and it wouldn't explode?

They did. It didn't.

Scientists at Yucca Flat, Nev., say there is no danger the dud will go off accidentally while they try to find out what happened—or didn't happen May 10. The bomb is buried under tons of cement at the bottom of a shaft 2,100 feet deep in the desert, which makes digging it up again a sizeable problem.

The cause of the fizzle, when they find it, will likely not be made public, since such things are usually classified.

From Russia, With Love

A 92-year-old Russian who came to the United States in 1906 sent President Carter a check for \$35,000 last October.

"Dear Mr. President," said the handwritten note on a scrap of paper from the unidentified West Coast resident, "the check of \$35,000 is a gift for the U.S.A.—long live."

The check has gone to the Treasury's gift section, and the elderly donor has received a thank-you from Treasury Secretary Michael Blumenthal.

- If you don't know how, we will teach you.
- If you don't want to, we will make you.

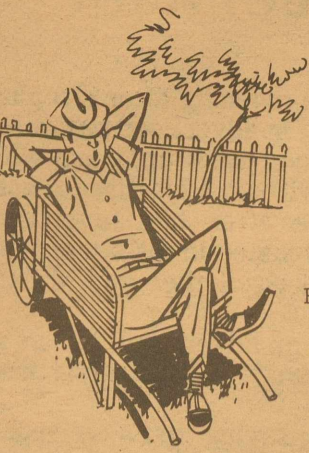
PSSST!

GREEN THUMBS

It will very soon now be tree planting time. It is now time to begin thinking and planning toward that end. In planting trees you are always safer to select trees that do well in this area, and there are many of them.

It is essential to consider the future size of the trees and to allow room for growth. It is generally better and safer to plant trees that are balled and burlapped. Bare root trees are subject to mistreatment between digging and planting and hence many times have a high percentage of death loss. Trees of much size (3/4" cal. or larger) when grown in containers have their roots winding in circular fashion and hence do not readily spread out when planted and hence do not do so well. When planting, allow plenty of loose soil in the hole and around the tree, water regularly and often. Plant as early as possible in the year.

Dear Mom,

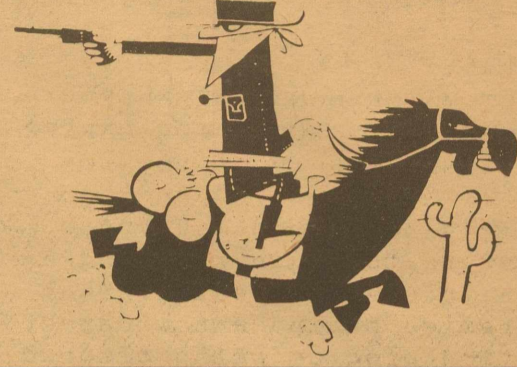

AT RAYBURN HOUSE
ACQUIRES PERSONAL PROPERTY
STATE HISTORICAL COMMISSION

AUSTIN--In a meeting here today the Texas Historical Commission officially accepted ownership of all the personal property associated with the Sam Rayburn House Museum in Bonham. Ownership of the property was transferred to the Commission by the Sam Rayburn Foundation, a charitable trust. The transfer agreement states that the property must be "perpetually maintained in an appropriate manner at the Sam Rayburn House and grounds in commemoration of the late Sam Rayburn, former speaker of the United States House of Representatives and the Texas House of Representatives." The document also specifies that, should the Commission not maintain the property in a satisfactory manner, ownership of the transferred items will revert to the Foundation.

In September 1971, the Foundation donated the Rayburn House and grounds to the THC with a similar understanding--that the Foundation would reassume ownership of the residence and ground if the Commission did not maintain them properly. Historical Commission staff have operated Rayburn's "home place" as a museum since April 1, 1975.

The personal property now belonging to the THC consists of 2600 articles which are situated in the various rooms of the Rayburn House. Among the objects from Rayburn's bedroom are a well-worn pair of cowboy boots; a saddle, bridle, and halter; rocking chairs and a desk. Items from other parts of the house include a cane inlaid with pearl cards from the 1934 Democratic primary; and a knife bearing the inscription, "London Blitz, 1940-41."

Foundation officials voted to transfer ownership of the personal property to the Commission at an Oct. 9 meeting in Bonham.

A recent proposal by the Texas Parks and Wildlife Commission to change some of the wording in relatively new bobcat pelt tagging regulations has met with disapproval from the Texas Sheep and Goat Raisers' Association.

TS&GRA executive secretary Bill Sims says the changes are likely to mislead trappers. The

proposed new wording, he explains, may lead trappers to believe that there is a limited season on Texas bobcats. Bobcat in Texas are, rightly enough, classified as predators rather than furbearers; they may legally be taken year-round.

Until last year there were virtually no rules on bobcat trapping in Texas at all, but a convoluted series of back-room federal dictates forced state officials to institute an emergency pelt tagging program. Had the state been unwilling or unable to do so, pelts taken in Texas would have been barred from overseas export, the eventual market for the vast majority of all bobcat pelts taken in the U.S.

The emergency nature of the state tagging regulations naturally meant that a few loose ends would eventually crop up, in this case the fact that a largescale year-round tagging program would impose a heavy financial burden on the Parks and Wildlife Department.

In an attempt to lighten the burden, the Parks and Wildlife Commission has proposed to limit the program to a certain period of the year. It's here that TS&GRA and the Commission begin to disagree.

The commission proposal would limit tagging to the period between November 15 of one year and February of the following year. No explanation is given for the choice of dates, but it may be assumed that they simply correspond with the traditional winter trapping season for furbearing animals--pelts are generally thicker and fresher during the cold months, hence they are worth more.

Sims take issue with the proposed tagging period, pointing out that pelt quality is desired

able for a much longer period of time. Fur experts, in fact, say that because of Texas' relatively warm climate, winter bobcat pelts command little or no premium over those taken at other times of the year. Sims has suggested that the tagging period extend to at least May 31, rather than being cut off in February, and that a much smaller-scale program be carried out at regional commission offices the rest of the year.

He also takes strong exception to the terminology used in the proposed changes. The Commission proposal defines the November-to-February period as a "harvest year" rather than a "tagging period", which it really is, he says.

The obvious impression given by the term "harvest year" Sims contends, is that bobcats can only be taken during that limited period. He adds that it's not unlikely there are some individuals involved in the proposal who actually want trappers to be misled. Federal Wildlife agencies, Sims says, are not the only ones with unreasonable protective employees on the payroll.

FORT WORTH, TX., NOVEMBER 13--President Carter's "pocket veto" of the Meat Import Act of 1978 Saturday night virtually assures higher beef prices for American consumers for several years, says John B. Armstrong, president of the Texas and Southwestern Cattlemen's Association, representing 14,000 cow/calf producers in Texas and surrounding states.

"Retail beef prices will remain high for years to come," Armstrong said, "because farmers and ranchers have very little incentive to rebuild their herds and their confidence in the government has been shaken severely by the president's action. Current domestic cattle numbers are down because producers have been forced to sell off their herds in recent years as the cattle industry went through a financial bloodbath.

This legislation would have given cattlemen and consumers much-needed market stability. It was, in fact, anti-inflationary," Armstrong said. "I am personally shocked that the president can ask us, as American citizens, to voluntarily comply with his new anti-inflation program when he exempts himself. The president's handling of the meat import act is a sad example of what happens when political trade-offs undermine the welfare of the U.S. cattle industry."

The counter-cyclical beef import bill, which received overwhelming approval from Congress, would have decreased imports when U.S. production was up and increased imports when U.S. production was down.

"What can cattlemen think when their president rejects legislation that is favorable to the cattlemen and to the consumer?" Armstrong said.

Girls who have already demonstrated a tendency toward a problem life are referred from Service Unit towns to the Peacock Home for Girls in San Antonio. There, girls from 10 to 17 receive guidance, sympathetic but effective counseling, and new healthy, positive approach to living.

PRISONERS & PAROLEES

Among the many people who receive aid are the families of men and women in prison. And not just the family. The person about to be paroled is given contacts to jobs outside, and, if they need it, a place to stay at an Army lodge. The program is made available to Service Unit towns through the State Services program.

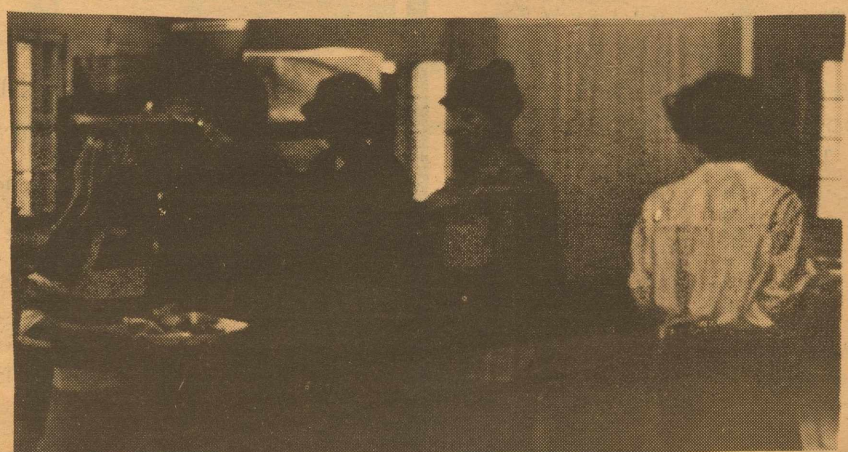
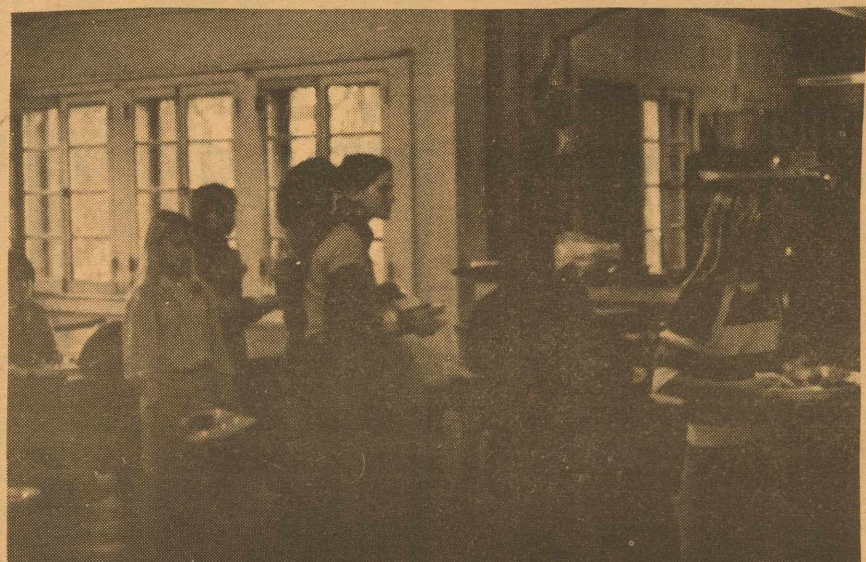
The Tigers finished their 78 season on a positive note by soundly defeating the Sabinal Yellowjackets last Friday, November 17 in Sabinal.

CRIME

TEXANS ARE FEARFUL OF GROWING CRIME RATE

More than half of the Texans re-

sponding to the most recent Texas

Crime Poll live with the fear that they

will be the victim of a serious crime

within the next year.

The poll is conducted semi-annually

by a team of social scientists at the

Criminal Justice Center at Sam Houston

State University in Huntsville.

The most recent survey is the

second in which copies of the Crime Poll

questionnaire were mailed to a random

sample of 1,000 Texas residents.

One of the questions was:

"Do you feel that you may be the

victim of any of the following crimes

within the next year? If so, please

check which ones."

A total of 365 of the 642 who re-

sponded to the survey (57%) felt they

were in danger. The crime which they

felt most likely to be a victim of was

burglary (35%), followed by theft (34%)

vandalism (34%) robbery (23%) vehicle

theft (22%), assault with a weapon (10%)

assault with body (10%) and rape (8%).

"The public's fear of crime is

reflected in the efforts that have been

taken to protect both themselves and

their property from criminals," said

Dr. Raymond Teske, Jr., director of the

Texas Crime Poll.

A total of 77% of the persons

completing the survey had placed one

or more devices in their home for rea-

sons of security. The most common item

was door bolts, followed by guns, extra

door locks, and outside security lights

Other included guard dogs, window guards

burglar alarms.

Other questions focused on fear of

walking near one's home at night. One

question was: "Is there any area within

one mile of your home where you would

be afraid to walk along at night?" Over

one-half of the respondents indicated

that there is such an area. Moreover,

23% responded affirmatively to the

following: "Would you be afraid to walk

alone within one block of your home at

night?"

Females were slightly more concern-

ed that they would be the victim of a

crime (60%) within the next year than

males (55%). Also, Mexican Americans

were more likely to be concerned about

being the victim of a crime during the

next year (60%) than where whites (57%)

or Blacks (50%). At the same time, a

greater proportion of whites (78%)

than Mexican Americans (75%) or Blacks

68% had placed some type of security

device in their home.

Fear of walking within one mile

of one's home at night also varied

slightly by race. Mexican Americans

were more fearful (60%) than were Blacks

(56%) and Whites (52%). Blacks (32%)

and Mexican Americans (37%) were also

more fearful of walking within one

block of their home at night than were

whites (21%).

There was also a marked difference

between sexes. Almost seven out of ten

(69%) of the females indicated that they

were afraid to walk within one mile of

More than 1,000 college stu-

The program, initiated by

60 South Texas banks, is open to middle

income students who live in South Texas

or attend college in the South Texas

area.

STHEA was founded by the

Council for South Texas Economic Pro-

gress (COSTEP) in the belief that im-

proving levels of educational advance-

ment will increase marketable skills

and create new jobs throughout South

Texas.

The latest loan acquisition re-

jects that an additional \$1.6 million

was loaned for the current year, bring-

ing the total volume of all STHEA

loans to nearly \$3 million since the pro-

gram's beginning last year.

The success of the program is

due largely to the unique nature of the

loan itself. Monies are generated by

STHEA through the sale of tax free

revenue bonds to the private sector.

With these funds, federally insured

students are acquired from partici-

patting banks in South Texas. This

secondary market concept is now being

followed in other states as well as

elsewhere in Texas.

COSTEP was founded under the

leadership of U.S. Senator Lloyd Bentsen

in January of 1972 as a non-profit or-

ganization with the purpose of develop-

ing, coordinating and sponsoring a

multi-faceted program to foster econo-

mic development in South Texas. The

following year COSTEP founded STHEA as

a means of providing student loans for

middle income families in South Texas.

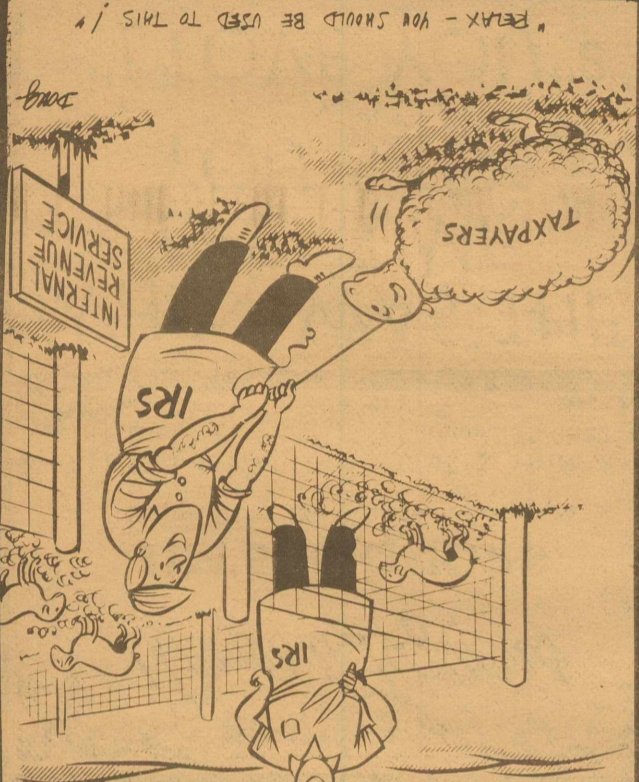
