
The auction sale sheets will be prepared by Mr. and Mrs. Chuck Hall in cooperation with the Rio Grande Electric Co-op.

During the early part of this week we heard a rumor that lunches for the elderly confined to their homes would be discontinued, UNLESS THEY SHOWED UP ONCE A MONTH AT THE CIVIC CENTER.....

Now there is nothing worse than a vicious rumor So I called Mrs. Sanchez of the Maverick Multi-County Nutritional Division, in Eagle Pass (which I understand manages seven counties, including Kinney).

The KINNEY CAVLARYMAN them asked Mrs. Sanchez "What is

for these people to receive these free meals?" the criteria MRS. SANCHEZ: "They must be over sixty (60) years of age." CAVALRYMAN: "What about their income?"

MRS. SANCHEZ: "We are not allowed to ask." CAVALRYMAN: "In other words, a Multi-millionare driving up in a brand new car is eligible for the program--of a free lunch at tax payers money --- but the elderly person that cannot leave their home is not?

MRS. SANCHEZ: "Anyone, regradless of their income is eligible for this program, as long as they are over the age of sixty. This is a Federal funded program that the Government pays 90% and the county pays only 10%. If you want more information contact Mrs. Lorenza Gutierrez in Brackettville."

About an hour later, Mrs. Hector Pena and Lorenza Gutierrez came by our office.

Soil Conservation

CEDAR BECOMING MAJOR PROBLEM

Ashe juniper, commonly called cedar, is causing deterioration of rangeland at rapid rate in Kinney County. The range of the cedar is spreading and the stands are becoming thicker.

The thicker stands shade out all grasses and other desirable forage plants. This greatly reduces the overall production of the range.

A solid stand of cedar provides a poor wildlife habitat. It can be controlled in patterns which will easily double or triple forage production and yet retain the cover that is needed for wildlife.

Dozing individual trees is one of the most effective methods of control. If all of the top is removed at one time the remaining stump will die.

The dozing also provides some ground disturbance on which grasses can be seeded.

Axing the individual trees applies the same principle of top removal as dozing. Axing is expensive and is seldom done unless there is post sized material available.

The most commonly used control is chaining. It is the least expensive of the workable methods. The soil should be moist enough so the larger trees will pull out of the ground. Resprouting does occur when the cedar is broken over and still attached.


Chaining two ways is the most effective way to reduce the amount of resprouting. Goats will utilize some of the young tender regrowth.

Chaining will need to be repeated every few years to maintain an effective control. The old brush left on the ground makes excellent wildlife cover.

THe pasture should be rested during the growing season following treatment. This will allow the other plants to utilize the additional moisture which will be available. ##



It will very soon be time to plant trees. Whether it be fruit or shade trees the sooner they are planted the better. They need to be in the ground in order to begin orienting to the new location and establishing a root system. Some fruit trees of good stock and size when planted in the early part of the year may bear some fruit the first year. This is particularly true of peach trees of the right variety. When planting trees it is well to remember that you are investing in a long term project. The difference in a "cheap" tree and a good one is negilible whe considered in the light of life and production of the tree. It is better to plant a good siz able tree of a real ggod variety and have fruit or shade the first year or second year than buy a cheap "packaged" or "supermarket" type tree and wait three or four years for it to produce as well as taking the risk of loss. Good judgement and a few more dollars will prove the best investment. ####


