suit against Mr. Bob Meyers
d/b/a Meyers Construction Company
on the construction of the new
Kinney County Library.

The San Antonio law firm will file the suit against the Uvalde contractor in District Court to determine responsibility areas on the imcomplete library building located on Spring Street.

### city hall

The Brackettville City Counsel voted unanimously to begin the extermination of all strays on July 23 allowing those dogs who received the rabies vaccination recently at the clinic to be tagged. Approximately 200 dogs were vaccinated from and around the City.

As everyone knows the strays are a real problem that must be brought under control.

Police Chief Morgan Bailey stated that any dog--tagged or untagged--should be leased or penned and not be allowed to run the streets.

The Council also discussed the utility costs problems and the rise hikes were confirmed for the second time.

As Brackettville has sent all the paper work to HUD on the claim that the City owes HUD \$19,500 for a grant issued in 1973. HUD stated the problem arose when he City started the project before the confirmation was received from HUD and the City then produced papers and letters stating that the okay was given by HUD when the project was started.

City Manager, Tim Ward, reported to the Council that he had forwarded to HUD the itemized amount for labor and materials expended by the City was \$14,767.85. He also informed the Council that the agency acknowledges receiving it but that no action have been reported to him. If the agency action is taken, it would mean of the \$19.500 only \$4,800 would be against the total sum.


## Present Day Myths

## PROPANE ENGINE FUEL OFFERS MOTORISTS MANY ADVANTAGES

AUSTIN--High prices and gasoline shortages are causing record numbers of motorists to consider converting their automobiles to operate on propane (liquidified petroleum gas) engine fuel, according to Lowry M. Carpenter, Executive Director of the Texas LP-Gas Association.

Propane has many distinct advantages over gasoline as engine fuel, the expert explained. It is an unleaded fuel with a naturally high octane rating of 110-120-which is considerably higher than most unleaded gasoline.

LP-Gas has a lower cost per gallon, a cleaner burning engine and lower exhaust emissions than gaoline, he continued. The fact that it contains no lead, carbon or other sludge-creating properties means fewer oil filters are used, fewer oil changes are required, carburetor expense is reduced, engines require less downtime andless money is spent on overhauls. Carpenter said propane also extends spark plugs life, and eliminates pilferage and spillage.

Conversion costs, he said, are quickly recalimed; and within a short period of time motorists begin saving money on the operation of converted automobiles.

Carpenter emphasized safe and efficient operation of a propane fueled vehicle depends in large part on proper installation of the entire system. The Association Executive stressed that conversions should be done by qualified firms employing experienced personnel. In addition to the installation of the propane fuel system, the vehicle's engine may require internal modifications for efficient operation Such modifications require considerable expertise, in addition to special parts and equipment. LP-Gas engine conversion, Carpenter said, is "not-a-do-ityourself" project.



GREEN MUMBS

A man said to me, "It is a waste of money to spray trees. I had mine sprayed and it did no good." He was right and wrong. You can certainly waste money spraying trees. We heard a lot this year about spraying for case bearers in pecan trees. In this particular area money is generally wasted in spraying for case bearers in pecan trees.

To see the damage done by the case bearers when don't spray, just wait awhile. If pecans begin to drop off before they are mature examine them. If there is a small hole in the pecan a case bearer got it. Gather all such pecans and figure the sale value if they had matured. Compare that to the cost of spraying the tree. Remember also that when you spray that tree you kill all the beneficial insects and increase the need of further insect kills by spraying. Everything considered you will find that spraying for case bearers in out immediate area is an expensive exercise in futility. There have been ases even this year where a man comes in to town and cons people into spraying there trees. Two or three weeks pass and you look out and are amazed to see webs and web worms or army worms in your trees. Yiu immediately decide it does not good to spray. There is no way to control web worms and army worms in trees except to spray. The time to spray is as soon as you see the worms. The idea is to kill them before they can do much damage. Spraying your trees last month is no benefit. You must remember too that you can expeet a new hatch of worms on a three to four week cycle normally. This year we have already had two hatches of "web" worms and two hatches of "army"worms. We may yet have another hatch of each. Spraying trees for these pests is a continous program. No known spray will leave a residual lasting more than a few days at most. Nor is there any systemic insecticide that can kill over a long period of time, and not be too dangerous to be practical It does good to spray trees. They must be sprayed when the worms are there. Spraying trees early in the spring can in no way prevent web worms and army worms from devastating the trees.



# Texas literary sites included in new book

A new book published by Morrow, "A Literary Tour Guide to the South and Southwest", includes data on four Texas locations.

The author, Rita Stern, starts out with Austin and the story of O. Henry, whose early writing was done in the capital city. She has information about the O. Henry Museum in the former home of the author and his wife. It is located at 409 East Fifth St. and is open Tuesday-Saturday from 11 to 4:30 p.m. and on Sundays from 2 to 4:30 p.m.


San Antonio is included because of O. Henry's attempt to publish his "The Rolling Stone" there after it failed in Austin and because of the O. Henry house on the Lone Star Brewing Co. grounds at 600 Lone Star Rd.

Ms. Stern includes a reference to the Alamo because of the many books written about the shrine of Texas freedom, including Paul I. Wellman's novel,

"The Iron Mistress", and Lon Tinkle's "Thirteen Days of Glory: The Siege of the Alamo."

The Institute of Texan Cultures is listed because of its exhibits about the many ethnic groups of the state. She mentions Langtry because of the books about Judge Roy Bean, and there is a listing of the Armstrong Browning Library at Baylor University, Waco. The Erle Stanley Gardner study at the University of Texas in Austin has mention in the book as well. The author writes, "Everything, including the walls and floors, is as it was in Gardner's study in his home in Temecula, California. Mementos and trophies hang from the wood walls and from wooden ceiling beams. His huge desk is covered with memorabilia from all over the

The book says the study is open weekdays from 9 a.m. until noon and from 1 to 4 p.m. Data is available at the Visitor Information Center in Sid Richardson Hall.




### NOTICE OF HOMESTEAD EXEMPTIONS FOR 1979

The Brackettville ISD hereby annouces that all person are entitled to receive an exemption of \$5,000 from the market value of their residence homestead for the purpose of school taxes. In addition, all persons who are 65 or older or under a disability for purposes of payment of disability benefits under Federal Old-Age, Survivors, and Disability Insurance are also entitled to an additional exemption of \$10,000 from the market value of their residence homesteads for the purpose of school taxes.

To qualify for these exemptions, an application must be filed with the school district tax office by July 19, 1979. Application forms are available at the school tax office located on Ann Street.




