RADIOLOGICAL MONITOR SCHOOL SLATED FOR AREA EMERGENCY PERSONAL

Use of radiation detection equipment by emergency personnel will be the subject of a three-day Radiological Monitor School beginning October 2, in Brackettville under the sponsorship of the division of Emergency Medical Services of the Texas Department of Health and the Kinney County Civil Defense Office.

The October 2-4, school will be held at the Teen Center, Fort Clark from 7:00--10:00 p.m. Further information may be obtained by contacting T.J.Hill Director of the Kinney County Civil Defense.

The instructors from the Emergency Medical Services Division of the Texas Department of Health in Austin will be Barry Lister and Bill Patrick.

This training will assist local officials in developing a monitoring capability to cope with a nuclear emergency. Also, the use of radioisotopes has increased greatly in Texas, and the risks of an accident involving transportation or use of these substances also has increased. This strengthens the need for emergency personnel trained in the use of monitoring devices.

Dear Mr. Ward:

It is the intention of Central Power and Light Company to provide good electric service to our customers in and around the City of Brackettville. We appreciate being able to serve the city and we had no intention of incurring the displeasure of the citizens of Brackettville.

We do, however, have a strong mandate to avail ourselves of any reasonable economics we are able to identify and obtain. Based on our experience in other communities, we believe our method of operation in Brackettville will be more economical to Central Power and Light Company and, in turn, to all our customers while providing good electric service.

As you know, due to Mr. Robinson's medical retirement, we will be changing our operation from a combination employee--service and clerical--to a full time clerical employee. The disadvantage, as you stated, is that the service calls will be handled from Del Rio. It is not uncommon, however, for our servicemen to travel such distances, South Texas being spread out as it is. The advantage will be that the office will be open five days per week and eight hours per day so that ready access to CPL employees is available to all.

Again, we value our relationship in Brackettville and believe that this new operating procedure will provide good service. I hope you will understand that this is a decision made by our management after a great deal of thought and evaluation, one we feel is in the overall best interests of our customers and CPL.

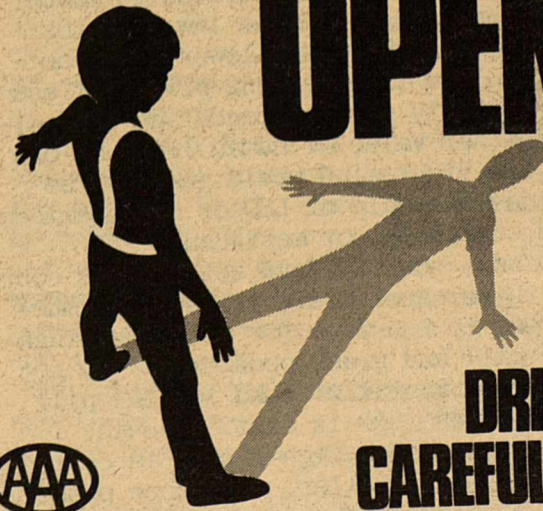

Present Day Myths

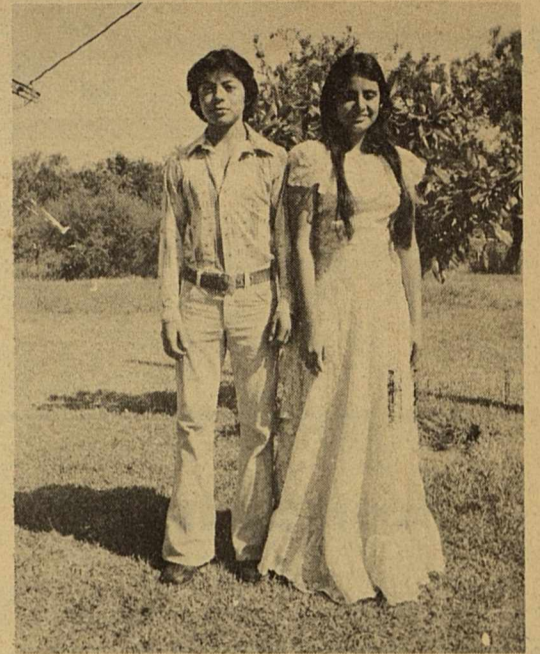

 The murder was released on \$15,000
 bond. The pill peddler was put under
 \$50,000 bond. These two cases were
 before the same magistrate. It maybe
 she was doing what the law dictates.
 If so the law puts a lower value an
 human life than selling pills. If she
 arbitrarily set the bonds she demon-
 strates her value of human life. No-one
 in his right mind would justify the

 money in his pocket is beyond estimate.

 the pusher. Somewhere priorities must
 be rearranged—they are all out of

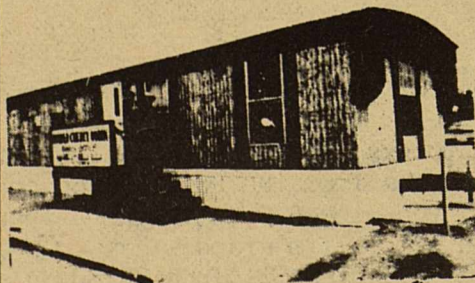

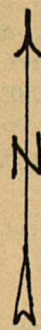
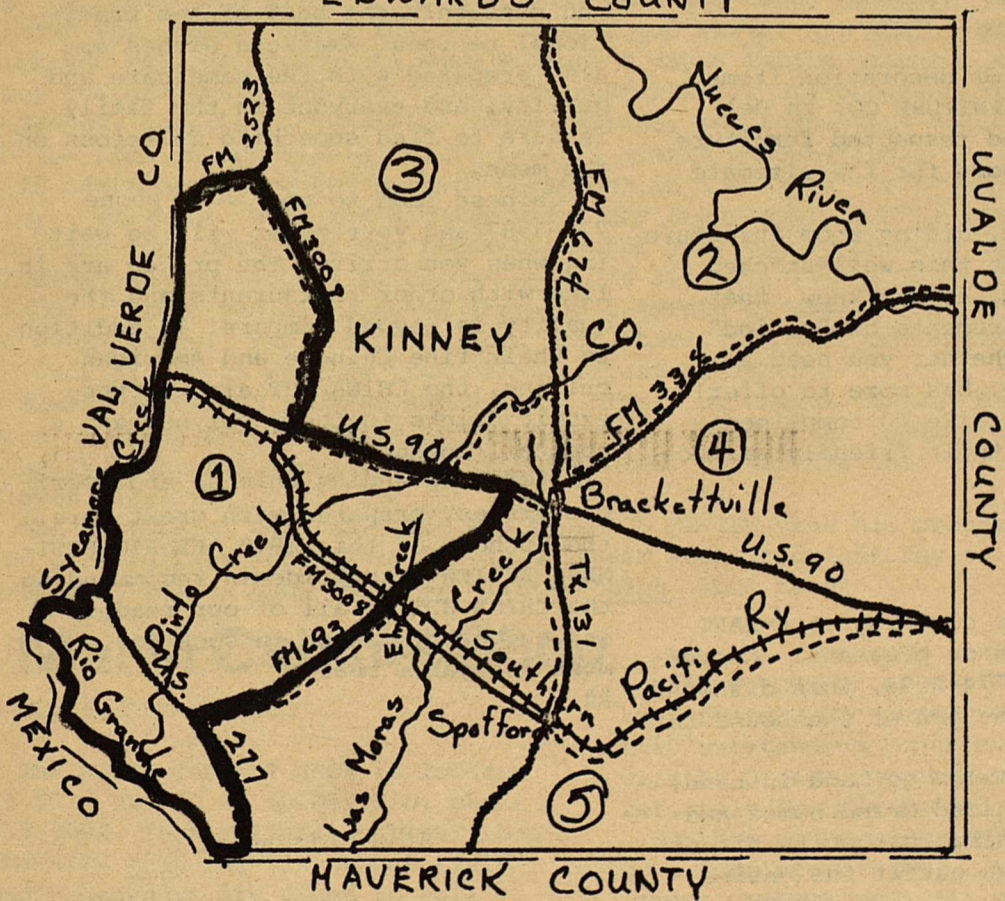

tion is being held. The person must also live in a county all or any part of which is in the district and the voter must be 21 years of age.

Legal qualifications state that a candidate for the office of a soil and water conservation district director must own land in the zone he represents, be 21 years of age and be actively engaged in farming and ranching. He must also live in a county all or part of which is in the district.

Zone 1 of the district is shown on the accompanying map. This map also shows the district and zone boundaries of the West Nueces-Las Moras Soil and Water Conservation District.

The purpose of the district with headquarters in Brackettville is to promote sound soil and water conservation programs on farm and ranch lands within the district and so serve as a voice for farmers and ranchers on conservation matters and other issues affecting private property rights of land owners.

The district board of directors coordinates the conservation efforts of the various local, state and federal agencies and other organizations and has authorities to enter into working agreements with these governmental agencies and private concerns to carry out its purposes.

all conservation programs managed by the district are of a voluntary nature to the landowner or operator.

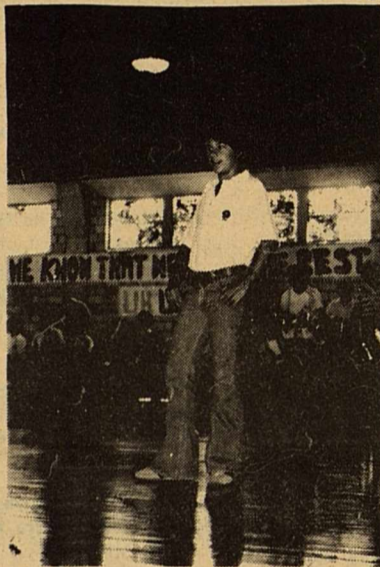
The second string took over during the second half and gained valuable experience. They allowed Canyon to score but the game ended in a Cub victory--40-20.

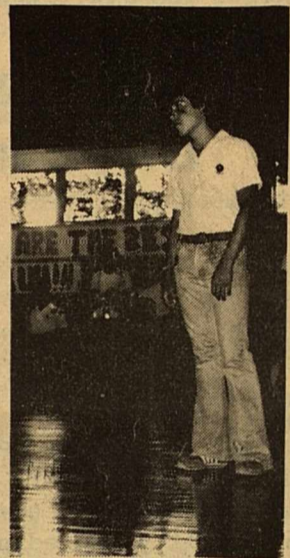

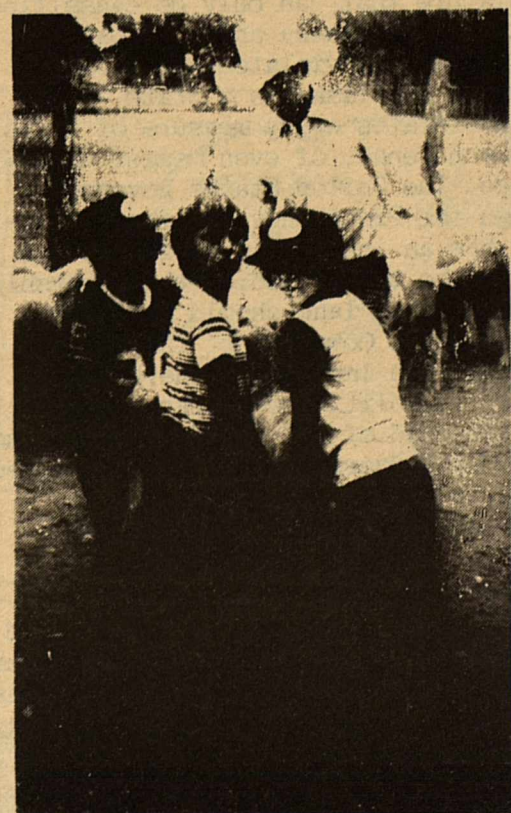

Approximately 100 lambs were picked by the 4H members. All the lambs were drenched and given shots.

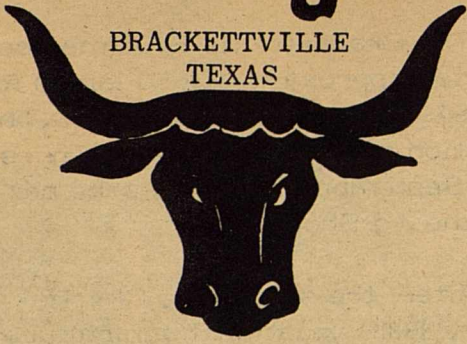

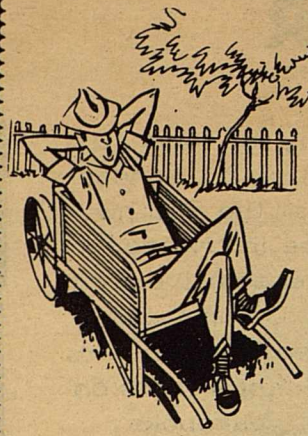

**SHEEP & GOAT
RAISERS NEWS**

Late on the afternoon of Tuesday, September 18, the U.S. House of Representatives chose to listen to livestock producers, at least on one issue. The majority of House members voted against a measure that would have placed limitations on the export of hides.

That controversial measure, known as the Shannon amendment, had the backing of the domestic leather goods industry and, openly or otherwise, organized labor. It was strongly opposed by all major livestock industry organizations, including the Texas Sheep and Goat Raiser's Association.

That the House would consider the needs of western livestock producers over the demands of a predominately eastern-oriented industry was a gratifying step toward reason on the part of the legislators. That stockmen's legitimate needs prevailed over the pleas of organized labor was not only gratifying but somewhat surprising.

At that, the decision was by no means a runaway affair--the measure fell by only about two dozen votes. It had been proposed as an amendment to a bill re-authorizing federal export limitation authority in general, and was prompted by claims from the leather goods industry that a shortage of hides was forcing up leather prices to the detriment of domestic manufacturers forced to compete with less expensive imports.

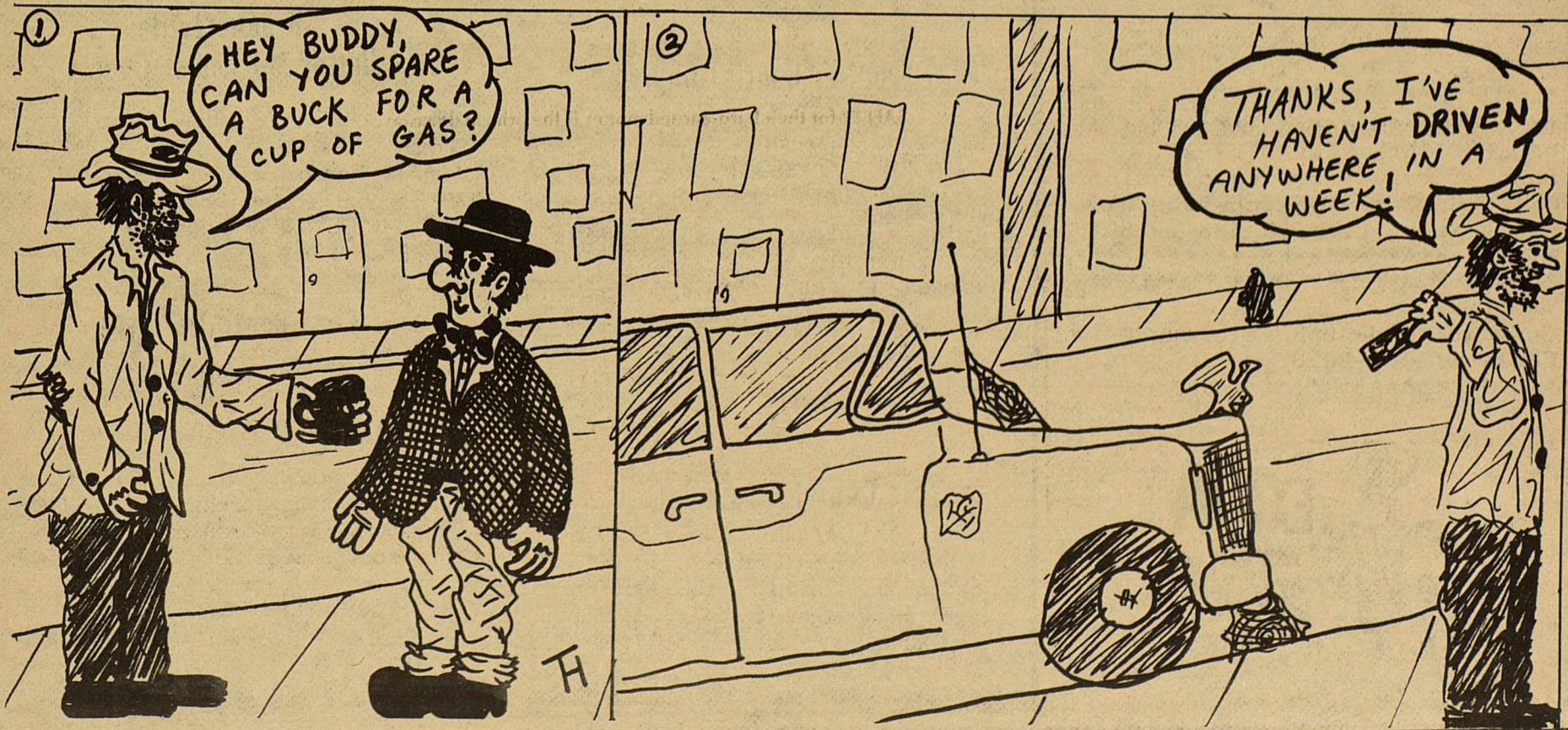
The worries were legitimate--to a point. It's true that much of the domestic leather goods industry has been in a slump lately, and also true that leather prices have risen along with improved cattle prices. Opponents of the measure have pointed out, however, that higher leather prices are really not to blame for the industry's woes--in fact, the cost of leather makes up only a very small percentage of the finished price of most manufactured leather goods and apparel. Indeed, it's been noted that leather prices have actually fallen several times in recent years while the finished cost of leather goods have climbed merrily along.

Where does the fault lie? Partly in outdated machinery and technology and partly in outrageous union labor demand. Both of these problems can be traced in turn directly to the government, mostly federal but in some cases state government, too. Government regulations and tax policies have virtually guaranteed a shortage of investment capital desperately needed to update factories. The same government that blessed the industry with these problems also blessed it with labor laws lopsided enough to scare off what investments might otherwise have been forthcoming, not to mention strangling the industry outright.

The proposed amendment, then, would have been an attempt to dilute the problems caused by government meddling with another generous dose of government meddling. In addition, it would have deprived the U.S. economy of a much-needed export commodity valued at an estimated \$600 million dollars annually.

Fortunately, someone caught on. Who know? Maybe it'll start a trend!
