



A week ago, this past Monday,

The accident involving a truck and a butane tank certianly by two local volunteer organizations. The Brackett Fire Volunteer Ambulance Service pre-

formed admirably.
Occasionally I have heard people criticize both of these fine organizations. Of Course! It is always someone that dosen't belong to or assist either group.

I had just returned home from the City Council meeting, Monday night, when I heard the explosion. I immediately climbed part way up my radio tower to see where the problem was. I grabbed my camera and drove to the location, (parking a block away). The point I am trying to make is: no more than 3 to 5 minutes could have elapsed from the time of the explosion till I arrived AND THE FIRE DEPART-MENT WAS ALREADY FIGHTING THE FIRE! THAT IS FAST! ABOUT 1 MINUTE LATER THE AMBULANCE ARRIVED WITH A FULL CREW! YET I HEARD A BYSTANDER YELL JUST BEFORE THE AMBULANCE ARRIVED: "WHERE THE HELL IS THE AMBAULANCE, WE HAVE BEEN WAITING 20 MINUTES!" This is totally

ANOTHED IMPAID AND DANCEROUS SITUATION are people blocking access to an accident like this with their vehicles. Even worse are the bystanders that crowd around the scene and hinder the operation of these trained emergency crews. The ambulance crew was particuarily hampered by a large group of people gathering around the accident victim and slowing down them from getting neccessary medical supplies from the ambulance. Our ambulance crew takes extensive training and have to be certified by the

State as Emergency Care Attendants. Part of thier training besides first aid is how to handle the different situations at the accident scene.

I know all these spectators are well meaning people (?) and don't intend to interfer but they do. Under no circumstances should anyone attempt to help these crews unless specifically asked to do so! They are trained and know the best way to handle the situation.

I think we should all remember pointed out the benefits supplied that five years ago we had no ambulance crew and the accident the other night would have been much worse on the accident victim if he had not had this rapid and efficient treatment. NOt only the man that was treated that night but scores of other people who have received aid in the past five years.

Only a hand full of our citizens are willing to go through the rigious training and give of their time to serve on our ambulance crew.

Lets all help our Fire Department and Ambulance Crews by co operating in an emergency.

KAZEN IN WASHINGTON Abraham (Chick) Kazen, Jr., M.C.

Every citizen knows that there is widespread concern over the buying power of the dollar, but I foresee a controversy over the size, shape and material of that basic element of our currency. The Federal Reserve System and the Bureau of the Mint, in the Treasury Department, apparently plan to push for total repalce ment of one dollar bills by the

new Susan B. Anthony dollar coin. There is considerable opposition to such tactics in the House of Representatives.

Some members are concerned that the Mint has produced 500 million of the new coins, with little regard for public opposi tion to using them. We are advised that many store clerks reject them, fearing that errors in making change will cause employers to charge them for mistakes if Anthony dollars are passed out as quarters.

In answering objections to the size of the new coin, the Mint reports it islarger than our quarter coin by the same ratio as the quarter to a nickel. The Anthony dollar has an 11sided inner border within the outer circle of thecoin. Mrs. Stella B. Hackel, Director of the Mint, says the recognition difficulty is about the same as telling a \$1 bill from a \$10 or


The new coin costs about five cents to produce, and is suppose to stay in circulation for 15 years in good condition. The paper bill costs two cents to produce, lasts only 18 months in circulation, and then must be withdrawn from distribution, destroyed and replaced by a new bill. Mint Officials say they could save up to \$50 million a year byuse of the coin.

Critics contend that the production savings will be eroded by the cost of transporting the coins between the mint and hanks. They say that if the American people accept the Anthony coins to the point that the paper dollar can be eliminated, there will be time to change the currency. Some 97 members of the House are proposing legislature to keep the dollar bill in our currency system. As usual, if you have an opinion on this matter, I would welcome your views.

SOVIETS IN CUBA


During my time in the District this last week, I watched with interest to see how many people were deeply concerned about the presence of Soviet military forces in Cuba. I found that what reaction developed was quite practical -- the people who asked questions generally believed that a few thousand Russians were no serious threat to our Nation, and they believed President Carter was doing the right thing in increasing our surveillance over what the Russians might try to do with those forces, and stepping up our military visibility in the area by increasing the frequency of our maneuvers there.

The Russians have had a military continguent in Cuba since 1962. I see their presence as an annoyance but not a threat. If the Russians want them to stay and the Cubans want them there our only alternative would be action to force them out. I found no one in the District who

Along Texas Trails—

Authentic touches at historic fort

FT. DAVIS—This West Texas frontier fort, used in America's westward expansion, gives the visitor a feeling of the "real thing."

The Park Service guides wear uniforms that are exact replicas of those worn by the 19th century fort soldiers, including the woolen long johns. Doug Mc-Christian, the historian who researched the site, doesn't believe anyone can interpret the lifestyle of that day unless he has the true feeling, right down to the itchy underwear.

As you walk from building to building, you catch the tantalizing scent of baking bread wafting through the air. Follow your nose to the barracks kitchen and you find cooks taking loaves from ovens heated by wood as they were when the post

was active.

The fort, mountains and the Texas County surrounding were named for Jefferson Davis, the Confederate president who served as U.S. secretary of war prior to the Civil War.

Films which depict various aspects of frontier life, including the near extinction of the buffalo, are shown regularly in the barracks theater. The same building houses a museum with dioramas explaining the fort's significance. Visiting hours are 8 a.m. to 8 p.m. in the summer and 8:30 a.m. to 5:30 p.m. in the winter.

In the pleasant community of Ft. Davis you will find the newly-remodeled Limpia Hotel, with another fine dining experience awaiting you. And it's only a short drive on to Alpine, with a selection of excellent motels and places to eat.

Most visitors to Fort Davis also take time to see the McDonald Observatory of the University of Texas. It is world famed for its telescopes and the work of internationally-known astronomers who utilize their powers to pierce the heavens. The skies are so clear around this area, that sky watching could be just about the finest in the world.
