All parents and persons interested in coaching, umpiring, announcing, or just interested in the young people to attend.





SSI is the federal program which provided cash assistance to the needy who are aged, blind and/or disabled.

## Soil Conservation

This week is the start of a 60-day public review period during which time interested people are being asked to comment on the direction they think future U.S.Department of Agriculture conservation programs should take.

The pubulic review period starts January 28 and ends March

Four draft documents describing the Nation's non-federal soil and water resources, their condition, projected demands, and seven proposed alternatives strategies can be reviewed at the local Soil Conservation Service

James, Crumley, District Conservationist said the porposal Write your judge and commissioners for a national soil and water con servation program were developed by a coordinating committee made up of members from nine U.S. Department of Agriculutre agencies plus the office of Management and Budget and the Council on Environmental Quality. The process, mandated by the Soil and Water Resources Conservation Act of 1977 (RCA), included consideration of public imput from 9,000 public meetings held in the United States during 1978.

> The Act directs the USDA to appriase the condition of the Nation's renewable natural resources and to propose alternative programs to guide the Nation's conservation activities. The appraisal revealed that one-third of the Nation's cropland---136 million acres--is eroding at an excessive rate.

Basic information about the RCA process andproposal may be seen in four documents:

The first document, DRAFT AP-PRAISAL, Part I, describes the staus and condition of our natural resources and provides information on their quanitity and quality and major uses of non-federal land. The completed draft identifies national conservation objectives

----Reducing erosion and preserving prime farmlands

-improving water quality

----COnserving Water ----Improving fish and wildlife habitat, including the preser-

vation of wetlands ----Reducing upstream flood damages

----Conserving energy ----Solving related resource

The second document, DRAFT AP-PRAISAL, Part II, projects demands on soil and water resources to the year 2030 and suggests levels of management that could be used to preserve these resources. It also summarize trends in rural land ownership and describes the contribution of state and local programs to soil and water conser-

The third document, PROGRAM REPORT AND ENVIRONMENTAL IMPACT

STATEMENT, outlines seven possible approaches—called alternatives strategies—for changing USDA conservation programs and outlines the probable environmental impact.


The fourth document, SUMMARY OF APPRAISAL, Parts I and II and PROGRAM REPORT is a brief summary of the other three documents.

During thepublic review period three public meetings will be held in Texas to discuss content of the documents andprovide an opportunity for comments. The meetings will be held in Arlington on Feb. 26; Lubbock, March 4; and San Antonio, March 6.

Interested citizens are invited to send written comments about the documents or suggestions about future conservation programs to the RCA Response Analysis Center, P.O.Box 888, Athens, Georgia



CONNALLY QUALIFIES IN TEXAS WITH MORE THAN 27,000 NAMES

The Connally for President Committee qualified John Connally for a spot on the Texas Republican ballot for president by turning in 27,000-plus names to the State Republican Party office, more than five times the number of qualified voters needed.

Texas campaign Chairman Paul Eggers personally delivered the signatures to the party headquarters after holding a news conference at the State Capitol.

"There are actually more than 30,000 qualified voters on these petitions," Eggers said, "but we had the workers stop counting at 27,000 because they needed to get to work on the big upcoming nationwide telethon Governor Connally will hold February 14."

Eggers said the Committee gathered 3,488 pages of names to turn in qualify Governor Connally for a spot on the May 3 Primary ballot. He said some had more that the 10 signatures each page had lines to accommodate and some were half-filled.

"I would say there are well over 30,000 names of qualified voters," he said. "There is no doubt that the people of Texas support Governor Connally, and they are the people who know him best."

Eggers said workers had obtained enough signatures in Harris County alone (5,600 names) to qualify Connally for the ballot. He added that 4,200 names were turned in from Dallas County

Eggers said more signatures were coming in daily, but would not be included in the total.

"We are obviously quite pleased with this expression of widespread grassroots support for Governor Connally's candidacy," Eggers said. "This is a true indication of the organization we have put together in Texas, which we believe will be vital to the success of any candidate on the Republican ticket this year.

"We are completely confident of the outcome in this race, not only in Texas, but across the nation as well," he added. "as the results of Democratic foreign and domestic policy disasters become more and more evident to Americans, we believe the leader ship qualitifies of John Connally will become more and more attractive to the voters."

The Governor's Advisory Committee on Education will conduct a public hearing on San Antonio on Tuesday, Feb.12. The hearing will begin at 2 p.m. at Region 20 Education Service Center-Instructional Media Center-1314 Hines Ave. (exit IH35 at Walters St.)

The purpose of the hearing is to receive testimony regarding the state system for public elementary and secondary education. The Committee is seeking citizen's comments on issues of interest and specific recommedation for the improvement of the education system. School district representatives are encouraged to participate. The Committee recognizes that school districts, their boards of trustees and personnel, are the ultimate deliverers of educational services to thestudents. Therefore, it is particularly interested in receiving their comments.

Those who do not register in advance may request to be placed on the agenda immed iately prior to the beginning of the hearing on Feb. 12. Each speaker will be allotted to more than five minutes.

#### SEES LONG-TERM NEEDS







Austin museum By Gordon M. Quarnstrom Travel News Service

AUSTIN-Come with me to visit the oldest house in Austin, a charming example of Creole architecture built in 1841 for the French charge d'affaires to the Republic of Texas, back in the days before there was a Lone Star State.

The building, carefully restored and furnished, has been open to the public since 1956. It is a museum, really, with great interest to visitors who want to see this example of frontier ele-


gance. The house is not pretentious and for three generations was the home of the pioneer Robertson family. It was acquired by the State of Texas in 1949, with the encouragement of the Daughters of the Republic of Texas, who were named

Restoration was done and the furnishings were chosen

Rooms added to the original house were removed. Behind the house is the only known reconstruction of an early French Creole kitchen in the United States. It is built on the original founda-tion stones. The furnishings are French antiques.

The French Legation is at 802 San Marcos St., near downtown Austin. It is open from 1 to 5 p.m. daily, except Monday, with admission of \$1 for adults and 50 cents for children.

The ladies who serve to answer questions of visitors point out the builder of the house was Alphone DuBois, who actually was in Austin little more than a year. He purchased 21 acres and built the home, but there is a question as to whether he ever lived in it. He left Austin early in 1841, the house not finished. It and the gardens now occupy five of the original 21 acres.



HERE'S A DANDY chart to clip and save during these cold winter days. Prepared by the U.S. Naval Observatory, it shows the "chill factor" of our weather. The "chill factor" is the "effective" temperature when the outdoor mercury reading is paired with the wind velocity. To find the chill factor, see the wind speed (horizontal numbers at bottom) and find the outdoor temperature (vertical numbers at side). The panel which meets at the convergence of the two number sequences gives the chill factor. For example, a temperature of 22 degrees, coupled with a wind velocity of 15 mph, would pin a chill factor of 1 degree above zero.


