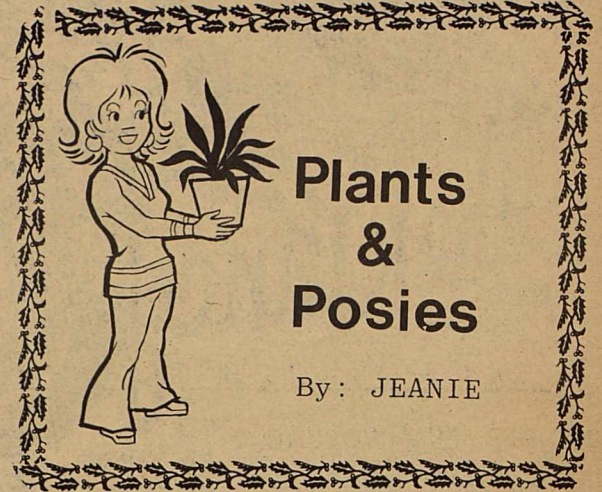
## THE RED GARTER SALOON IS WHERE IT'S HAPPENING THIS WEEKEND!!!

## Plants & Posies

### MAKE POTPORII !!!!!!!

When you receive a flower arrangement, there is an easy way to get extra and lasting enjoyment from your gift. As your flowers die down, pull all the petals off. Put them in a box, or other container, and simply put them in the sun for a few days. The petals will dry and shrivel up very quickly in the Brackettville heat! After the petals are completely dry, you can scent them as you wish. Oils in various fragrances are available, such as roses, lemons, etc. An easier and probably cheaper method would be to add spices--cloves, cinnamon, etc, or extracts--lemons, vanilla. Add whatever you prefer to your petals and put them in a small jar, cap it tightly for a week or so to get your scent really soaked up by the petals. Now your potpourii is ready, lift the cover any time for a delightful scent, and a remembrance of your arrangement.

P.S.: A few drops are all that is necessary to scent your potpourii, you can always add more in the future to revive your petals.

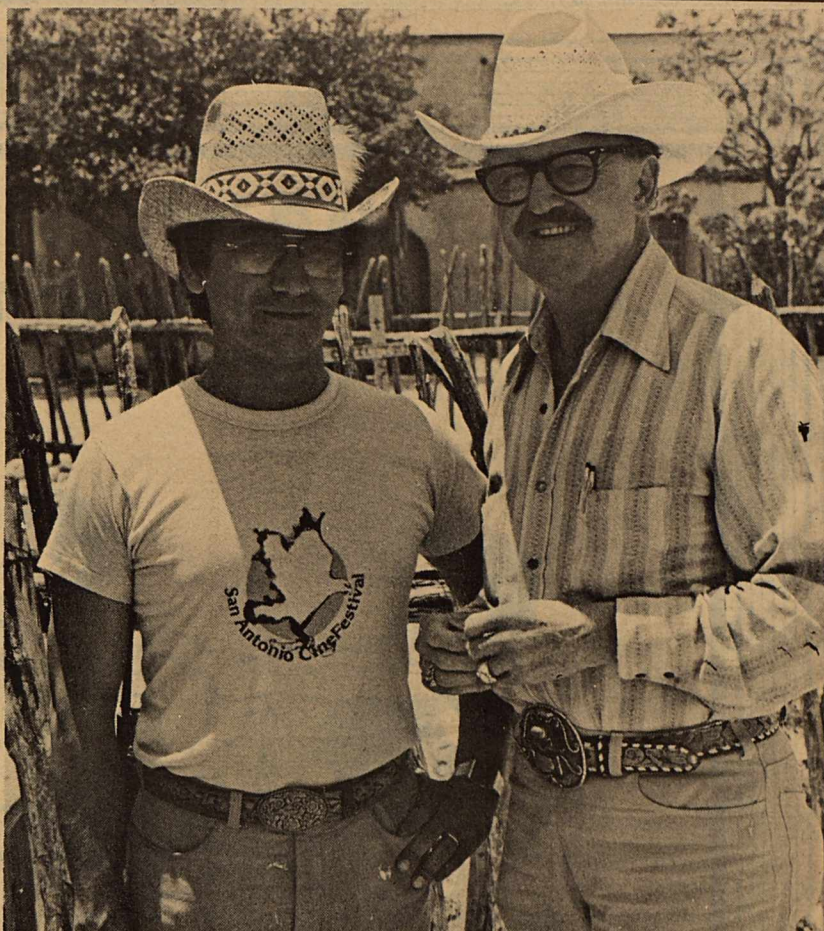

## CITY HALL

The City Council met in Special Session Monday July 21, with Chris Gomez, Louis Dimery, Joe Garza, Lingo Sandoval, Don Nance, Richard Garcia, and Tim Ward present.

The Council looked over the new budget with Manager Ward stating that the tax rate for the City is predicted to be 70¢ per \$100. Residents of the City questioned the Council as to why some taxes are being allowed to go as long as 20 years and not being collected. Tim Ward said that the City does have an attorney collecting these past due accounts, but that this was another addition to the budget costs. Ward also stated that the City is having to pay for the vapor lights that were installed for Brackett Businessmen with the agreement in the beginning that the City would install the poles and the businessmen were to pay for the utilities. He estimated this cost to the City at around \$600 per month. Mr Ward also told the Council that there was nothing in the budget for a sanitary landfill, and he felt that the State would not allow the City to use the present dump very much longer.

Mr. Ward also stated that the City had budgeted \$5,000 for the tax reappraisal work now being done and that the City would be participating in the Central Appraisal District, their share being 10%

The City Council, after discussing all the items, decided to the Budget as presented.

The Council then moved on to pass the Ordinance requiring lots to be cleaned and maintained. Mr. John Bennacci appeared to oppose the passage of this ordinance stating that he did not feel it was necessary and he did not like so many regulations being placed on the citizens of Brackettville. Other people present at the meeting argued that the Ordinance was necessary because lots that were not being maintained by the owners were nothing by a breed-

ing place for disease and snakes.

This Ordinance requires that lots be maintained and that the City has the right to give notice and after 10 days also has the right to go in and clean a lot. The charges for cleaning a lot in this matter was set at \$50 for a regular City lot (165 feet by 55 feet). If there are any unusual obstructions then the owner would be charged at an hourly rate for any heavy machinery used. Unusual obstructions being trees, shrubs and bushes.

The Council then went into Executive Session to discuss salary increases for City Employees.

## COMMISSIONERS' COURT

Commissioners' Court met on July 17, with Albert Postell, Alvin McClure, G.C. Talamantez, J.A. Sheedy III, David Luna and Accountant Jim Faith present.

Charlie Koch met with the Commissioners and discussed the possibility of Kinney County joining the School Board in establishing a Central Appraisal Board. This Board is to be formed because according to State Regulations, by 1982 all evaluations on property by the School, County and City will have to be uniform. Henry Fuentes stated that the estimated cost of establishing a Central Appraisal Board will eventually come to around \$80-90,000. It was stated by Jim Faith that Unvalde County's cost will be \$85,000 and Cliff Belcher stated that the cost for Val Verde County is going to be \$174,000. The taxing agencies have to meet these requirements or else they will not be able to collect taxes. It was also predicted that when the appraisals are re-done for 1982 that Agricultural Usage acreage will go up in appraisal.

Commissioner Sheedy questioned the fact that all this work that was currently being done by the Board of Equalization and funds that were being paid out will be of no effect because everything will have to be done again by

1982.

The Board of Equalization met a 11:25 with some questions as to how it was being run. It was brought to the attention of the Board that according to regulations, it was not only the taxpayers who had to be sworn in, but the appraiser or the tax assessor. Several taxpayers appeared before the Board to protest evaluations but the Board could not do anything because the appraiser was not present to offer testimony. After receiving the Board reconvened with the appraiser present to defend the valuations. A question of whether the state was constitutionally correct in raising the valuations and budget more than 3% in one year was aired. The Commissioners were then advised to get legal

advise from the Taxing Authority in Austin before setting the tax rate. The Board of Equalization then adjourned and the Commissioners' Court reconvened.

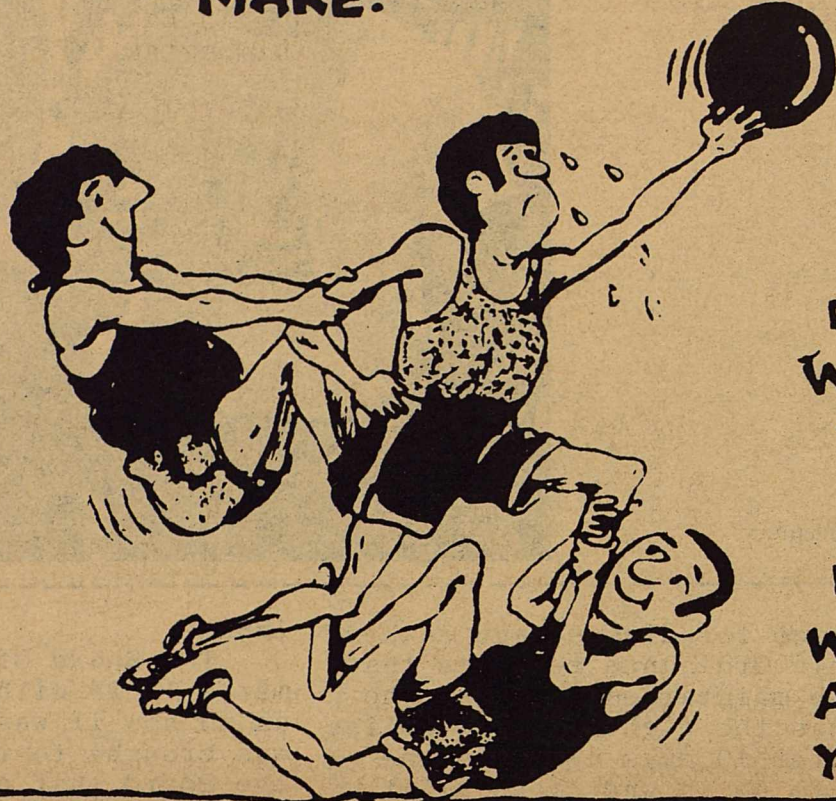
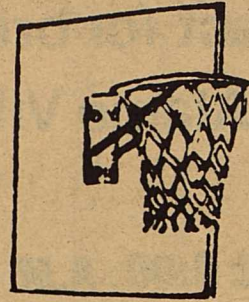
Tully Shahan appeared before the Court to apply for the position of County Attorney. Mr. Shahan stated that he would ask to be paid at the same rate as other county officials and also would require a secretary and office. Mr. Shahan stated that he had experience in applying for Federal Grants, prosecution and the workings of a county government. He also stated that he would not be available to come to work before September 1, because of prior obligations.

Charlie Koch again appeared to get a commitment on whether the County wants to enter into a contract to establish a Central Appraisal District. J.S. Sheedy, III, questioned whether the City would be paying their fair share. David Luna made the motion to enter into the contract with the School District to establish a Central Appraisal District for the year 1982 with all Commissioners agreeing.

Clifton Belcher came to the Court to say that he would be willing to accept a payment of \$1,000 now from the County for additional tax appraisal costs and would wait for the other \$3,000 until the county had collected some tax revenue for the

coming year. This was agreed to by the Commissioners.

The Court then went to work on setting the figures for the Budget for the coming year with almost all Commissioners saying they would need more funds to operate their precincts. It was agreed by the Commissioners to add the cost of a County Attorney his office and secretary with Commissioner Luna questioning if the County was setting this amount for a County Attorney or for Tully Shahan. The Commissioners also had to add extra expenses for bringing the jail to state standards (\$58,000) and also the cost of the alien now in Uvalde Hospital (\$7,000).

Commissioner Luna also said he thought it would be better if the Court to make a donation of \$200 to the Seminole Indian Scout Association so that they could care for their Cemetery instead of the county maintaining it.

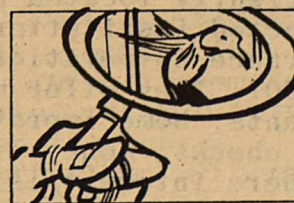

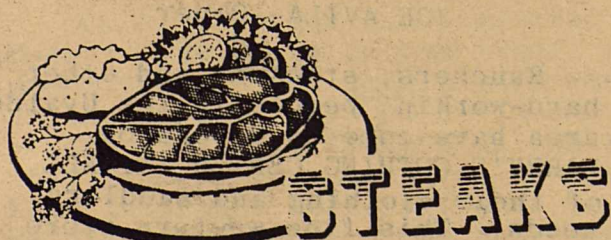
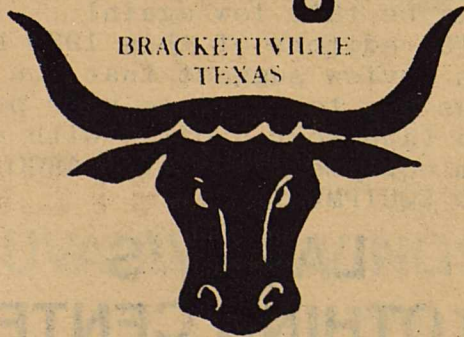

## questions and answers



**Q. A few months ago, I started getting SSI payments. A lady at the social security office told me I'd have to have a periodic redetermination. Does that mean I'm supposed to go back to the social security office every so often?**

**A.** The local social security office will notify you when it is time for your redetermination. A redetermination is simply a review of your case to make sure you are still eligible for SSI and that your payment amount is correct. You may have to visit the office for an interview, but in some instances, the redetermination can be conducted by phone or mail. It's a good idea to keep any checking or savings account statements you get from your bank because you may need them for the redetermination.

**Q. My work as a State employee is covered by social security. Some of my co-workers and I wonder if social security is really a good investment. Couldn't we do better with another insurance or pension plan?**

**A.** Other insurance and pension plans can provide valuable protection, but social security offers some significant advantages. Social security provides disability, survivors, retirement, and health insurance. It protects both you and your family. Social security benefits are tax-free, and your benefit will increase each year if the cost-of-living goes up by 3 percent or more. Also, because social security covers most jobs, its protection moves with you from job to job.

**Q. My doctor has recommended that I have an operation. Before I make up my mind, I'd like to get an opinion from another doctor. Will Medicare pay for a second opinion?**

**A.** Yes. Medicare will help pay for a second opinion in the same way it pays for other services by doctors. In fact, Medicare recommends that you get a second opinion to help you decide about surgery. Ask your doctor to refer you to another doctor. Or, you can call Medicare's Second Opinion Referral Center for the names and phone numbers of doctors in your area who will provide second opinions. 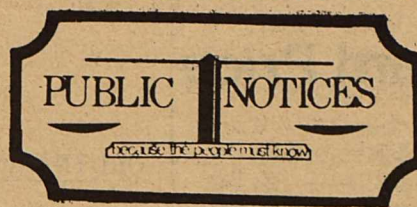

## People Have Responsibility For Reporting

People who receive social security benefits have the important responsibility to report events to the Social Security Administration that could affect payment of those benefits, a social security representative said recently.

Failure to report could mean that a needed check might not arrive on time, or it could result in an overpayment a person can ill afford to repay, the spokesperson said.

Things everyone needs to report are:

- Change of mailing address, even if the person's checks are deposited directly into a checking or savings account.
- Earnings of more than the 1980 annual limit—\$5,000 for people 65 and over and \$3,720 for people under 65.
- If the person goes outside the U.S. for 30 days or more.
- If the person works outside the U.S.

Things disabled people must report:

- Any improvement in condition.
- Any work.
- Receipt of or change in the amount of workers' compensation.

Things dependents or survivors must report:

- Divorce or annulment.
- Marriage.
- Adoption of child.
- Child leaves care of wife, husband, widow, or widower.
- Child nearing 18 is full-time student 18-22.

Someone should report for a beneficiary if:

- A person is unable to manage funds.
- A person getting benefits dies.

More information about these events can be obtained at the nearest social security office. The address and telephone number of the nearest social security office can be found in the telephone directory.

**Q. My wife and I both will be 65 later this year. How soon should we apply for our social security benefits?**

**A.** You should apply for retirement benefits about 2-3 months before you plan to retire. That way, your claim can be processed in time for your payments to start when you stop working. Even if you decide not to retire, you should file an application 2 or 3 months before 65 to make sure you will have full Medicare protection starting at age 65.

ORDINANCE NO. 207

AN ORDINANCE PROHIBITING THE COVERING OF LOTS WITHIN THE CORPORATE LIMITS OF THE CITY OF BRACKETTVILLE WITH WEEDS, HIGH GRASS, BRUSH, TRASH, JUNK, GARBAGE, AND DEBRIS: PROVIDING FOR THE ABATEMENT OF NUISANCE: PROHIBITING THE GROWTH OF WEEDS, GRASS, AND OTHER VEGETATION IN ALLEYS TO A GREATER HEIGHT THAN FIVE INCHES (5"): PROVIDING FOR TEN (10) DAYS NOTICE TO OWNER TO REMOVE: AUTHORIZING REMOVAL BY CITY AND PRESCRIBING A CHARGE AND ASSESSMENT THEREFOR AND ESTABLISHING A LEIN TO SECURE THE EXPENSE OF REMOVAL.

### Section 1. PROHIBITION OF WEEDS, HIGH GRASS, AND DEBRIS

It shall be unlawful for any person, or his agent, owning, renting, or having under his control any lot or premise, whether vacant or in part, with any weeds, high grass, down timer or brush, old logs, decaying vegetable matter, trash or trash piles, junk, scrap, open garbage, filth or debris whatsoever, and same are hereby declared to be public nuisances, a hazard and menace to public health, and fire hazards

### Section 2. NUISANCE: ABATEMENT

The City Manager, Fire Marshal, Fire Chief, Chief of Police, and City Health Officer shall each have the power and duty, when any such situation shall constitute a health or fire hazard, or both, to summarily abate same or have same abated, using City Fireman, or policeman, or City employees.

### Section 3. NOTICE TO REMOVE

It shall be the duty of the City Manager of the City to notify the owner and/or agent of any premises within the City which are grown up in weeds, grass, brush, and other vegetation to a greater height that twelve (12"), to remove such weeds, grass, brush, and other vegetation within ten (10) days. This notice shall be in writing and may be served on the owner and/or agent by handing it to him in person, by certified mail addressed to such owner and/or agent at his post office address, or by publication as many as two (2) times within ten (10) consecutive days if personal service may not be had or his address is unknown. Like notice shall be given for removal of brush, trash, junk, scrap, and debris (Article 4436, R.C.S.).

### Section 4. CITY AUTHORIZED TO REMOVE WEEDS.

Upon the failure of any such owner and/or agent to comply with the notice, as set out in Section 3 hereof or upon the written request and authorization of such owner and/or agent so notified, shall become the responsibility of the City Manager to have such weeds, cut raked, and removed on all property within the City that abuts or adjoins improved property by the employment of City forces, or by an authorized independent contractor. Said high weeds will be cut, raked, and removed to a dept of at least fifty feet (50') inward from all prpoerty lines of said property which adjoins or abuts improved property. (Article 4436, R.C.S.).

### Section 5. CHARGE TO BE LEVIED AND COLLECTED FOR WEED REMOVAL

A charge of \$50.00 for each cutting, raking, and removal of said weeds shall be levied, assessed, and collected against such property each time such cutting, raking, and removal of said weeds shall be performed, where the area is a regular 165'X 55'. In the event that there are unusual obstruction such as trees, shrubs, bushes, brush, excavations, foundations of demolished structures, or any other similar impediment, an additional charge can be levied, assessed, and collected against such premised for the actual additional cost resulting from said obstructions. The charges provided for herein shall be levied, assessed and collected by the City Manager, and if any person shall fail to pay such charges so assessed within thirty (30) days after the proper notice, the City Manager will file, with the County Clerk of Kinney County, Texas, a statement by the Mayor setting out the expenses that the City has incurred pursuant to the provisions of this Section, and the City shall thereby perfect a priviledge lien on the property involved, second only to tax liens for street improvements, to secure the expense to the City, together with ten percent (10%) interest from the date such payment is due. (article 4436, R.C.S.).

### Section 6.

This ordiance shall be effective upon its passage and publication as provided by law.

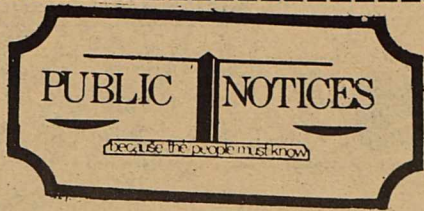

DROUGHT CONTINUES EFFECT ON  
SOUTHWEST AGRICULTURE

UVALDE--The continuing heat wave continues its effect on the region's agricultural production. However, some positive notes creep in amidst otherwise gloomy forecasts, according to Jose G. Pena, Management Economist with the Texas Agricultural Extension Service in Uvalde.

Milo harvesting is nearing its peak. Some dry land farmers report averaging up to 2,500 lbs. per acre while irrigation is producing 4,500 to 5,000 lbs. to the acre. The \$4.60 price per hundred weight is very encouraging. Many farmer expected \$3.80 to \$3.90 per cwt. at planting time. Some observers feel the price may eventually go to \$5.00.

The area's first cotton bale was delivered for ginning early last week. These short seasons varieties, forced to early maturity by intense heat and dry conditions, are expected to produce poorer yields than last season. But overall, the cotton crop outlook appears bright.

Cattle liquidation continues since pastures are dry and sun scalded. Many calves planned for October marketing at 400-500 pounds are being sold now a

at substantially lower weights. The beef cattle market had showed signs of recovery after DES-treated cattle were eliminated from the system. But this liquidation has stabilized the price and the expected increases have not materialized.

Corn yields are also predicted to be lower. The late spring freezes and the May storms had a devastating effect to the young corn plants and now the the heat wave forced early maturity before the full crop was set. Although ears appear fully developed, some endosperms haven't completely matured, so lighter yields are expected. Early surveys show that farmers will average around 75 to 80 bushels per acre as compared to last year's average of over 100 bushels.

The fall vegetable prospect isn't encouraging. The substantial amount of moisture needed to irrigate corn and cotton has left little water to use for fall vegetables.

DROUGHT THREATENS PECAN CROPS

UVALDE--Pecans are currently experiencing serious water shortage problems across the state and particularly in Southwest Texas.

Growth in may young trees has been slowed and a horticulturist with the Texas Agricultural Extension Service warns that mature trees may have short crops or produce smaller than usual nuts this year.

Dr. George R. McEachern says that trees growing in sandy or shallow soil are having the greatest difficulty and irrigation is proving to be essential during this unusually dry year.

"It is improtant to maintain a relatively uniform soil moisture level throughout the growing season from April to October" McEachern stresses. "Early spring, when growth begins, mid-summer, when the nut develops, and early fall, as the kernal develops, are very important irrigation periods for pecan bearing trees."

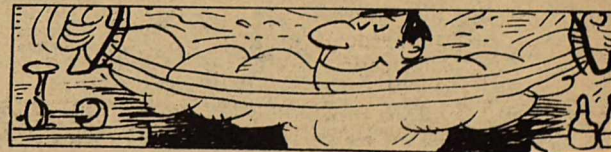
Productive trees, he emphasizes, require a minimum of 32 inches of water per season if they are on good soil.

"Homeowners should apply two inches per day to lawn trees if over two weeks of drought occurs" he says. "This includes most areas of the state. Trees on shallow or sandy soil will need more frequent irrigation. However, homeowners should not allow sprinklers to spray the foliage because it can cause salt burn."

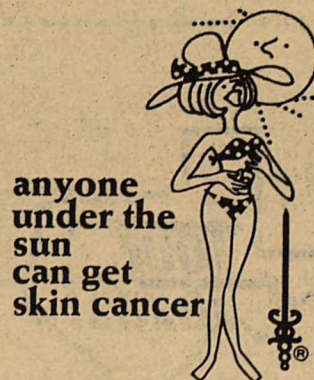
The Texas A&M University horticulturist recommends the following rule of thumb for pecan irrigation: 4-gallons of water per day during July and August for first-year trees, 8-gallons a day for second-year trees, and 16 gallons of water per day for third-year trees. Large trees will use over 100 gallons of water daily during those months.

McEachern says commerical pecan growers in Texas commonly use flood, drip sprinkler or bubble irrigation to supply water to their trees. Some of these methods can be used effectively by homeowners. Consult your county extension agent for more details.

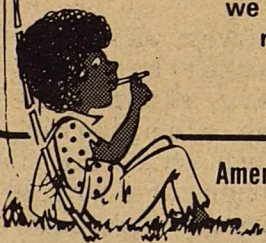

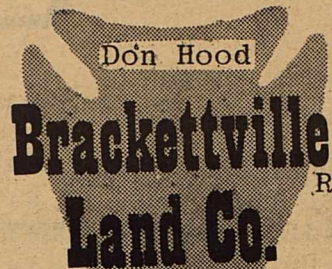
