Westex Bancorp., Inc. is a registered Bank holding company with its principal office in Del Rio. Presently the Del Rio Bank and Trust Company Del Rio, Texas, is the only asset of Westex Bancorp, Inc.





CHLOROPHYTUM--Airplane plant, Ribbon Plant, or Spider Plant.....

A number of plants are in the Chlorophytum species, but the airplane plant is the common variety for a houseplant. All plants in this species family produce clumps of soft arching narrow leaves. Pale yellow stms arch upward through the leaves and bear small white flowers. The small flowers are followed by little plants growing along the stem that gradually weight down the stem. These can be trained upward on hoops or canes, are will naturally droop down around the pot. Airplane plants are commonly available in a varigated form with a cream or white stripe and the solid green

For healthy growth and good color, give your airplane plant bright light. They can tolerate some direct sun in the winter, but position out of direct midday sun, which may scorch the leaves. They grow well in normal room temperatures, but will not thrive in temperatures below 45 degrees.

Water enough to keep the soil moist during the gowing season. In the winter, let the top half inch of the pot dry between waterings. Fertilize regularly, year-round.

## MCBEE APPOINTED

AUSTIN--State Representaive Suasan McBee (D) of Del Rio has been named to the membership of a national legislative committee by Speaker of the House Bill Clayton.

Clayton said he was appointing McBee to the Ethics, Elections and Reapportionment Committee of the Assembly on the Legislature of the National Conference of State Legislatures (NCSL) for a two year term.

The assembly provides a forum for consideration of issues internal to state legislature and state government. In the coming year, the Ethics, Elec-

tions and Reapportionment Committee will continue in reapportionament work in addition to studying the issue of state legislative ethics, including finanacial disclosure, conflict of interest and laws regulating lobbyists. Presidential nomination and election procedures will also be a topic for committee discussion.

"This committee will explore issues within its expertise that it considers national in scope and important to state legislatures. Rep. McBee, as chairman of the House Calendar Committee, lends valuable experience to these endeavors," Clayton said.

Mrs. McBee is serving her fourth term in the Texas House. She was cahir man of the Elections Committee during her last legislative terms

# FORT CLARK DAYS

FORT CLARK DAYS ---- April 4

Each year, during it's annual Fort Clark Days Celebrarion, the gates of Old Fort Clark swing open to the public inviting everyone to help members and residents of Fort Clark Springs, now a private recreation community, to celebrate the establishment of 129 years ago of this historic Indian fort. This year the 5th Annual Fort Clark Days Celebration will be held on Saturday, April 4 from 9 a.m. until midnight.

Now listed on the National Register of Historic Places, Fort Clark is located on the old Chihuahua Trail, midway between Uvalde and Del Rio on U.S. 90, overlooking Brackettville, a thriving City built around the old adobe ghost town that served the hard-working, funseeking troops of Fort Clark for the almost 100 years of its existence as a cavalry post under the command of such as Mackenzie, Bullis, Patton, and Wainwright.

The events of the Fort Clark Days Celebration will begin with a parade of floats, marching groups, bands, antique cars, riding groups, and cavalry invited from Del Rio, Ciudad Acuna, Eagle Pass, Piedras Negras, Uvalde, and other cities, as well as Brackett-ville and Fort Clark Springs. Trophies and ribbons will be awarded for the best parade entries and for the best costumes.

The Fort Clark Day Parade will take place entirely within the Fort Clark Historic District, forming at the old United States Cavalry Stables, proceeding to and encircling the old parade ground, passing in front of the old Officer's Club, the stone two-story officer's houses, the long row of onestory stone barracks, and the two-story barracks now converted into comfortable rustic motels for visiotrs.

From there the parade will continue to the tree-shaded rendezvous grounds beside Las Moras Spring and Las Moras Creek, where Indians, explorers, hunters, trappers, traders, settlers, and gold-seekers bound for California camped under the giant oaks, pecans, and mulberry trees even before Fort Clark was established in 1852. There the 4th Memorial Cavalry, Company K, of Del Rio well engage in maneuvers and skirmish with colorful infantry troops. Charro riders and their feminine counterparts in China Poblana costumes have been invited to demonstrate their riding skills as Mountain men in Buckskins emerge from their tepees to mingle with strolling harmonica players, accordionists, fiddlers, drum corps, and Indian dancers, while women inlong skirts, a nd sun bonnets in sleeve-garters and neck-kerchiefs demonstrate early-day skills of soap-, quilt-, candle-, braided rug-, and knife-making, whittling, leather working, sugar cane pressing with tireless mule patiently plodding around and around in his circle, and artists sketch portraits and scenes. Over all will float the savory aroma of barbecue hiscuits, beans, hominy, coffee, and sugar-and -cinnamon-dusted bunuelos, all cooking over a big open wood fire.

After lunch the center of activities will shirt to the old Guradhouse-Museum where Judge Roy Bean and his trusty marshal will deal summarily with unsuspecting victims accused of horse-stealing and othercrimes, incarcerating them in the old iron-barred prisoner transport cage until they are freed by kind

hearted friends acting as bondsmen. The medicine man in his high silk hat will peddle his maraculous healing water, while garter girls sell their wares from arm, ankle, and knee. The balloon man will deftly transform balloons into dachshunds, rabbits, giraffes, and other animals in the twinkling of an eye, and the old time photographer will turn out sepia-tinted portraits almost as rapidly. A lemonade stand under a canopy beside a gaily decorated surrey, complete with fringe on top, will dispense cooling lemonade and iced tea to all.

Entertaiment by the Canadian Jug Band The Voices of Fort Clark, and others will accopmany the chant of the auction eer, who will dispose of treasures, such as an oil painting by Bud Breen, the famous Western Artist, to the highst bidders.

The nearby famous old stone Commissary building, pictured in many books and cited as one of the finest examples of early military architecture, will house a Sweet Shop, fortune tellers, flea market booths, and the Red Garter Saloon, where soft drinks, beer, hammargers and hot dogs will be available while singers and dancers perform.

A few yards away whirling full skirts a flash of petticoats, Western shirts, cowboy boots, lively music, and the caller's do-si-do and allemande left will make the colorful outdoor square dance. Dinner will be served at candle-lit Las MOras Inn in the old officer Club, followed by a presentation at the Town Hall, the old post theater, of the Fort Clark Follies, featuring music and comedy.

The grand climax of the 5th Annual Fort Clark Days Celebration will be the westerner's version of the easterners' urban block party--the always eagerly anticipated big, big street dance under the star-lit sky and light of street lamps, festive with multicolored streamers and balloons above the dancers moving rhythmically to the strains of nostalgic favorites of the 30's and 40's, with an occasional Cotton-Eyed Joe, schottische, and polka, played and sung by young cowboy-hatted, plaid-shirted, jeans-clad guitarists, fiddlers, drummer, and vocalists above one end of a large oval of tables and

On Sunday, April 5th, a buffet dinner will be served at noon at Las Moras Inn, followed by a tour of Homes in the Historic District, Open House at the Fort Clark Center, flea market booths

in the old Commissary Building, and enteratinemnt and refreshments in the Red Garter Saloon. The old Guardhousemuseum and Sutler's Store will also be open, and visitors may see Lily Langtry, Judge Roy Bean, and perhaps even General Robert E. Lee in their midst.

Visitor may also enjoy a leisurely drive through Pecan Park on the Tour Road, where they may catch glimpses of wild deer, turkey, and javelina. The olympic-size spring fed swimming pool, 100 feet by 300 feet in size, built under mammoth pecan, oak, mulberry, a nd palm trees by General Jonathan Wainwright, provided another unforgettable vista of breathtaking beauty for those who visit this oasis for the 5th Annual Fort Clark Days Celebrarion on April 4th and 5th.



As we enter the third month of the legislative session, activity is increasing. Although we aren't yet spending much time on the floor in formal session, office work and committee responsibilities have meant many long days that are lasting far into the night.

One bill of mine has already passed. It appropriates money to Sul Ross University for repairing structural damage to two of the older buildings on campus, one originally built in 1919!

Bills allowing creation of foreign trade zones at Eagle Pass and Del Rio are also progressing reapidly.

As I have in the past, I am once again sending the House Journals to all the libraries in District 70. So if you want to check on any floor action, ask your local Librarian to let you preuse the journals.

It is such a pleasure to hear from constituents, and I'm hearing a lot these days! Among the issues that seem to be generating a great dael of mail are the Sunday closing law (the Blue Law) and the proposal to allow the United Parcel Service to pick up and deliver packages within the state of Texas.

Many District 70 folks have been in Austin and have come by my office recently. WE've had visitors from Comstock, Quemado, Barksdale, Rocksprings Ozona, Alpine, and Crystal City in addition to Eagle Pass and Del Rio.

So if you call us and hear an unfamiliar

SOCIAL SECURITY NEWS

Miss Elvia F. Fuentes, Manager of the Eagle Pass Social Security Branch Office, has announced that beginning in April the Social Security Representative will visit Brackettville only once a quarter.

Miss Fuentes emphasized that the public will still receive first-class service. Social: Security is as close as your telephone. Anyone who needs assistance on a Medicare matter may call 1-800-442-2620, toll-free. For assistance with any other type of Social Security or Supplemental Security Income question or problem, call 1-800-392-1603, toll-free.

The Socail Security Representative will visit Brackettville from 9:00 am. to 12:00 NOON at the Kinney County Civic Center on April 3, July 10, and October 2,1981.

Miss Fuentes said, "Cutting down on the trips within our service area will save the tax-payers money in the form of government employee's man-hours and mileage. Using the telephone to handle Social Security matters will save the public time in getting to the Center and waiting to be interviewed."

Miss Fuentes also reminds civic groups and organizations that by calling 773-9561 in Eagle Pass a speaker can be provided to address their group on any phase of the Social Security Program.

UPS PROPOSES INCREASE IN SERVICE TO RURAL LOCATIONS

DALLAS-A dramatic increase in package delivery service to the rural areas of Texas would be incommediate result if United Parcel Service were granted the right to pickup and deliver between all points in the state, UPS region manager Joe Dobransky said today.

To gain those rights, UPS must be granted authority by the Texas Rail-oad Commission. However, the Commission has maintained for some years it has no jurdisdiction to grant the type of all-points coverage UPS seeks to offer. Clarification of the Commissions jurisdiction is the subject of two bills currently before the state legislature--H.B.1116 by Rep. Craig Washington (D-Houston) and S.B. 513 by Sen. Chet Brooks (D-Pasadena).

"Many rural communities desperately need direct service, or at least an alternative to the kind of service they're currently getting," Dobransky comments. "Our service is available today to every address in Texas that is reachable by road, but only for packages coming in or going out over state lines."

Even on a "half-service" basis, UPS delivers almost 300,000 packages a day to Texas residents and business and picks up another 150,000. Dobransky estimates over half of the stops made by the company's package vans are in communities of less than 10,000 people. "And thousands of stops a day are made to places that aren't near a town of any size. Places like drilling sites, ranches, souvenir shops, service stations and others off the beaten path are getting direct service each day."

Dobransky added: "It is not unusual for one of our drivers in areas like the West Texas mountains, the Panhandle or the Rio Grande Valley to travel

over 250 miles a day to make less than 50 delivery and pickup stops." UPS offers this service at rates comparable to U.S. Parcel Post.

STATE HIGHWAYS & PUBLIC TRANS-PORTATION NOTES

DEL RIO--The State Department of Highways and Public Transportation conducted a preconstruction conference at the Department's Uvalde Maintenance Warehouse the morning of March 3.

The conference was to discuss traffic control measures, project safety and construction schedule of operations for a seal coat contract project that will incude 8 sections of highways in 4 counties, covering a total of 42.5 miles.

The project in Kinney County will be on US Hwy 90, beginning at the Brackettville West City Limit and extending 16.5 miles to the east.

The purpose of the seal coating is to protect the State's investment in the roadway's base material, by

sealing all cracks in the existing pavement and providing a layer of asphalt waterproofing. The aggregate placed over the asphalt will prevent the asphalt from adhering to the vehic les tires as they pass over the roadway.

The contract work is expected to begin on April 22nd and is to be completed by May 22nd. Traffic will be routed through the work as it is in progress. Supervising Resident Engineer Marc Baxter, in charge of the Department's Uvalde Residency, will supervise the inspection of these projects.
