

BEGONIA.....Begoniaceae.....

The genus Begonia includes more than 2,000 species and hybrids and they are as varied in appearance and habit as these numbers suggest. Some are valued mainly for flowers some for decorative leaves, some for both leaves and flowers. Begonias range in size from tinys, groudhugging creepers to stout stemmed specimens 8-10 feet tall. Yet they all share a number of characteristics. Almost all forms have asymmetrical leaves; the leaves always grow alternately along the stems; and new leaves emerge from stipules (leaf-like sheaths). Many do not require continuous direct sunlight, a fact that makes them particularly suitable for indoor use. Most kinds bear flowers in clusters on short stalks arising from or near leaf axils. There are separate male and female flowers on the same plant, however, each cluster is normally composed of either all male or all female blooms.

Male flowers tend to be the most eye-catching, partly because their petals are often of

different shapes and sizes.
whereas the petals of the female flower are more alike. A
distinctive feature of the female flower is the seed-bearing
ovary which likks like a three
loved appendage immediately behind the petals. Female flowers
although they may slightly fade,
usually last for weeks or even
months, but the male flowers
tend to drop off whithin two
or three days of opening.

RANCHERS HOLD BIG ROUNDUP NEXT WEEK

DEL RIO—The urban cowboy is "out" this week and working cowboy is "in" as hundreds of ranchers from across the U.S. and several countries converge on this festive border city for the International Rancher's Roundup.

It begins Tuesday, August 11, and runs through Thursday at the Civic Center where only chaps and spurs will be missing.

About 125 speakers are scheduled to appear during the week representing 12 prominent ranching states and five countries, quite possibly the largest gathering of this type in the Southwest

Registered participants will received a 435-page cound copy of the proceedings which contains most of the talks presented. Over 1,000 ranchers are expected.

Roundup registration for early arrives begins Monday, August 10, at the Del Rio Ramanda Inn from 3-8 p.m. and resumes at the Civic Center lobby Tuesday at 7:30 a.m.



## Kazen

It may take several years before we know the full effects on the economy of the tax plan approved last week in the House of Representatives, but it is apparent to me that at least a few of the provisions will be of great benefit to Texans.

I supported the President's tax plan on the final vote because by then it was the only surviving bill that included a tax reduction for individuals—and because it incorporated several important provisions that originated in the Ways and Means Committee Bill.

I would have preferred the Ways and Means legislation, which also contained what I considered more equitable tax cuts for individuals and represented a realistic attempt to balance the budget, but this bill was defeated after an intense campaign led by the White House.

Because of the confusion throughout the country over what each bill actually said, it might be helpful to go back a few weeks and see how the legislation developed. The Ways and Means Committee, in an effort to attract more moderate and conservative members, agreed to include a variety of beneficial tax reforms measures long sought by many of

us. This was the case in relief of estate and gift taxes, certain benefits to small businesses and much-needed relief to producers and royalty owners from the Wind fall Profits tax.

In many cases, supporters of the President's tax plan simply added the identical language of the Ways and MEans bill or bid a little higher than Ways and MEans in their own efforts to attract widespread support. Thus, because of the Ways and Means bill, the bill finally approved by the House contained these highly beneficial provisions:

--Among the improvements, the bill reduces the maximum estate and gift tax rate from 70 percent to 50 percent over a 4-year period. More importantly to many people, the so-called "widow's tax" is repealed on the grounds that an individual should be free to pass his entire estate to a surviving spouse without the imposition of any inheritance tax

--Present law provides qualified royalty owners with a credit of up to \$1000 against the Windfall Profits tax. The House bill increases the credit to \$2500 and also reduces the rate for producers on newly discovered oil. Independent production of stripper oil is exempted beginning in 1983.

--As savings incentives, the decuction from gross income for contributions to Individual Retirement Accounts is raised from the lesser of 15 percent of the

annual income or \$1500 to the lesser of 100 percent income or \$2000. The annual diduction limit to a Keogh pension plan is increased from \$7,500 to \$15,000 per year.

## Kinney County LIBRARY

Plans are progressing for showing free family films Tuesday, August 11 at 8 p.m. Rev. Franks of the First Baptist Church of Brackettville has graciously given permission for the flims to be shown on the lawn of the church grounds. Meantime Librarian Corey is making arrangements to procure films that will appeal to all ages. Lion President, Tim Ward, has assured us that the Club's snow cone machine will be at our disposal which means that snow cone refreshments will be available for a minimal charge that evening.

Checks are still coming in from the absentee landholders of Kinney County. The amount taken in from this source has now reached \$1.596. Susan Bunjes also contributed \$500.

The 'Friends' are looking for a stonemason who will volunteer his skill in teaching an apprentice his art on the job; making possible the re-construction of the old Fritter home situated on the site of the new library. If you know of anyone we might contact on this please advise.

A new trial date wstill has not been re-set for the civil action of Allied Fidelity Ins. Co. -vs- Kinney County since the last date of May 11th has come and gone without as much as a hint of a postponement date. Since the counsel for the defense said in his letter to the Plaintiff's counsel in the counter-suit April 10,1981, "If we are ever going to resolve this case, now is the time." it is even more strange. Is it time for the "Friends" to inquire into this in more depth?

There has been good progress on the new library building since our benefit barbeque. The roof and beams are in place and the final square sotnes are being laid.

All "Friends" of the library are reminded of our next meeting Tues. August 11 at 7 p.m. at our usual location in the County courtroom. Several concerns of interest will be on the agenda so we hope to see you

-- Under the present law, homeowners who move, have 18 months to acquire a new home of equal or higher value to avoid tax penalty Because of the high mortgage interest rates and resulting difficulty in accuiring replacement homes, the period is increased to 24 months. The one-time exclusion of up to \$100,000 of gair on the sale of residences for persons 55 and older is increased to \$125,000 beginning in July, 1981.

At this writing, the final version of the tac bill had not been reported by a House-Senate Conference Committee, but there were strong indications that most of the major provisions of the House version would remain in the bill.

In the end, my supportfor the President's tax bill was because of the tax savings and other provisions initiated by the Ways and Means Committee and because, on the final vote, it was a

choice between the President's tax package and no tax cut at

However, in fairness, I must add that sections of the Administrations bill are disturbing I preferred the Ways and Means tratment of indivdual tax cuts, for example, because they were targeted to the middle-income taxpayer and those who earn less than \$50,000 each year. Under the President's plan, 35.1 percent of the individual tax cuts in 1982 would go to 5.6 percent of the population--those making \$50,000 or more. A full 10 percent of the cut would go to 0.2 percent of the taxpayers--those making \$200,000 or more.

At the bottom end of the scale the 41 percent of American taxpayers who make \$15,000 a year or less would get 8.5 percent of the 1982 cut. Under the Ways and Means plan, a \$10,000 wage earner with a family of four would hove seen his taxes cut by \$362. Under the Administation plan, his taxes will be cut by \$52. Two wage earners supporting a family of four on \$25,000 would have had their taxes reduced by \$1,013 instead of \$700

in the Administration plan.

I would also have preferred the "trigger" on the thrid year tax cuts. If the economy perform ed as predicted, the Ways and Means bill would have ocntinued the reduction for the third year. As it is now, the 10 percent ta x cut will be mandatory, regardless of the federal deficit, the rate of inflation or anything else. The problem with this is that some economist already warn of a deficit as high as \$80 billion

A deficit of this magnitude and a movement toward balancing the budget simply do no compute. I continue to believe that the foundation of economic recovery and all of its benefits--including meaningful tax relief, reduc tions in the rate of inflation and escape from spiraling interest rates -- is a sound, balanced budget. Both Congress and the White House must find a way to work toward this end.
