#### RANGELAND WEED SEMINAR SET

LAREDO--A variety of undesirable range weeds infest large areas of South Texas rangeland. These weeds take up space that could be used by grasses and also compete with grasses for sunlight, moisture, and nutrients. Some are poisonous to livestock. When and how to control weeds are decisions a rancher must make in order to maximize his forage production. He must also ask the question, "Will it pay me to initiate a control program?"

These and other topics concerning range weeds and their control will be addressed at a symposium to be held at the Civic Center in Laredo on Wednesday, January 20. This meeting will be sponsored by the Texas Agricultural Extension Service and the Program Building Committees of Webb and Zapata counties.

According to Dr. C. Wayne Hanselka, Extension range specialist, perennial weeds such as goldenweed and threadleaf snakeweed, are difficult to kill using conventional spraying techniques.

"Timing, environmental conditions, chemical vs. mechanical, kind and rate of herbicide, and follow-up management are all very important aspects of a successful control program," Hanselka said. "The economics of initial cost and potential returns must be analyzed before a rancher embarks on such a program."

Hanselka pointed out that this meeting will be designed to inform ranchers of control measures, economics, and ongoing research into range weed control in South Texas. Aerial application of herbicides, current cost-sharing programs, and management following treatment will be discussed. A panel of ranchers discussing their weed control programs will be featured.

"We believe this meeting will provide an educational opportunity and a forum for idea exchange and discussion for ranchers interested in improving their rangelands," Hanselka said.

#### TEXAS CONFEDERATE HEROES DAY

On January 19, Texas Confederate Heroes Day, Texans will be remembering the 90,000 who served from their state in the Civil War. State-wide ceremonies in Austin will begin at 10:30 at the Texas Confederate Museum, 112 E. 11th St.

Keynote speaker will be Dr. Howard Miller, associate professor of

history at the University of Texas at Austin. He will speak on Texas in the Civil War. Mrs. John M. Wilcox, Houston, ex-president general of the United Daughters of the Confederacy will speak on memories of the Civil War veterans.

Many counties around the state will be participating in local ceremonies pilgrimages to Civil War battle sites, graves, monuments, and other sites are being sponsored.

Texans who served in the Union forces will also be honored on this official Heritage Day. Many west Texas and coastal areas were occupied by Federal forces and ceremonies in these areas will commemorate those activities.

This program is sponsored by the Texas Heritage Project of the Texas Historical Foundation and the Texas Division of the United Daughters of the Confederacy.

#### NATURAL FIBERS FASHION REVIEW PLANNED FOR SOUTHWEST FARM SHOW

The 11th annual Natural Fibers Fashion Review is being planned for the 1982 Southwest Farm Show. The fashion contest and show will be held on March 6 in Fort Worth.

The contest is open to any home maker from the Southwest Farm Show states of Texas, Oklahoma, and New Mexico who is involved in agricultural production or an agriculture-related business.

The Fashion Review is designed to promote the use of natural fibers produced in the Southwest and to emphasize excellence in garment construction and fashion in home sewing.

Garments entered in the show must be made of a minimum blend of 50% cotton or 50% wool and/or mohair.

The competition will have four divisions: day wear, evening wear, mother and child, and former grand award winners. The contest provides a showcase for exhibiting designs made from natural fibers.

Prizes will be awarded to first, second, and third place winners in each division. The Grand Award winner will be selected from the winners of the mother and child, day wear, and evening wear divisions.

Sponsors of the event include the Southwest Hardware & Implement Association and Progressive Farmer. The Texas Agricultural Extension Service is coordinating and managing the contest and review.

Entries must be submitted by February 19, 1982. Contest rules and entry blanks may be obtained from Uvalde Extension Service in care of Barbara Charlet.

The Natural Fibers Fashion Review will be presented at 4 p.m. on Saturday, March 6, at the Southwest Farm Show in Fort Worth.

#### MOHAIR INDUSTRY TO CONDUCT A SEMINAR

Mohair industry representatives from South Africa and Turkey will be in Texas and conduct a seminar the night of January 19. This will be held at the Uvalde Fairgrounds, beginning at 7:00 p.m.

Speakers from the seminar will include Dr. Donnie Wentzel, a researcher with the Grootfontein research facility in South Africa, speaking on abortion and mohair fiber development in Angora goats; Dr. Jan van der Westhuysen, assistant manager of the South African Mohair Board, who will discuss increasing reproduction in Angora goats; Mr. Johan Engelbrecht, marketing officer with the South African Mohair Board, will talk about marketing of the South African mohair clip; and Dr. B.C. Yalcin, a geneticist from Ankara, Turkey, will discuss breeding of Angora goats in his country.

The program is designed to provide interested Texas producers with information from these two important Angora countries and is a real opportunity for producers to hear these men, who have excellent backgrounds in their fields.

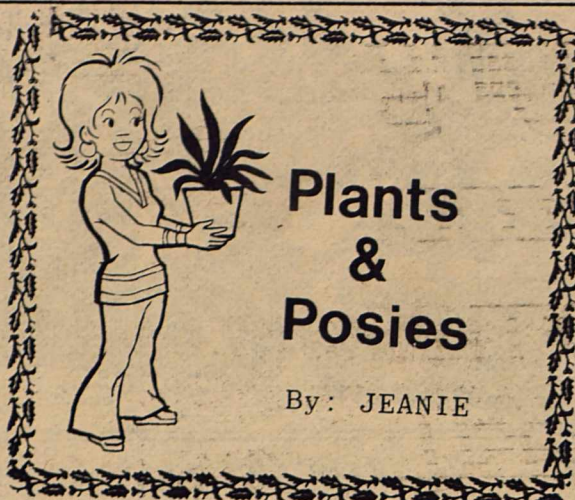

## Plants & Posies

HOYA.....Wax Plant

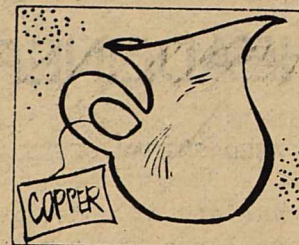
Wax plants are an easy to grow house  
plant tolerant of low temperatures  
and suited to shade. They have attrac-  
tive evergreen foliage and long lasting  
flowers.

Hoya bella has a shrubery habit  
and rarely exceeds 1 foot in height.  
It makdes a nice hanging basker, with  
flowers and branches dangling down.  
The fleshy leaves are spear-shaped,  
and some are spotted with silver mark-  
ings. The white waxy-texture flowers  
are borne in cluster-the centers of  
the flowers are usually shades of red  
or purple.

Blooming is sporadic from spring  
to autumn.

Hoya bella is of Indian origin  
and can tolerate temperatures to 50  
degrees. Hoya carnosa can tolerate  
slight frost if the soil is kept  
slightly dry during wintere. These hoya  
need about 2 years of growing before  
flowering --When ready to bloom, long  
stems are borne and remain bare for  
a long time before leaves form. The  
flower color varies from white to rose  
pink, with usually a darker flower in  
the varigated leaf forms.

During warmer months, water  
freely and mist regularly. In winter,  
if plants are in a cold area, keep soil  
slightly dry. Leaves may curl or turn  
yellow in winter, but new growth resume  
early in spring. If pruning is neces-  
sary, it should be done in spring.

BE IT REMEMBERED that a regular meeting of the Honorable Kinney County Commissioners' Court was begun and holden this the 14th day of December, 1981 at 10:00 A.M. in the Courthouse, Brackettville, Texas, for the purpose duly set out on notice of meeting posted as required by law.

Judge Albert A. Postell called the meeting to order at 10:00 A.M. with the following members present and participating, to-wit:

Dooley, Mr. and Mrs. Charles Shipman, Bill Mills, Miss Sarah Webster; Charolette Corey, Ray Kurtz, Joe Garza, Allen Kreiger, Rosetta Pingnot, Walter Moore, Rose Ann York, Joe York, Jr., Sid Spoonholz;

The Minutes of the November meetings were read and approved.

Judge George Thurmond Requests Assistance for County Auditor

Judge George M. Thurmond met with the Court and said that even though he was aware of the County's financial difficulties he felt that the County Auditor, Elizabeth Deason, needed part time clerical help in her office. Judge Postell said that due to the County's financial situation, he would share his secretary, Maria Gomez, with the auditor. Judge Postell said this arrangement was satisfactory with his secretary to work mornings with the auditor and in his office in afternoons. Judge Postell also stated that he had a high school student working two hours per day in the auditors' office on a federally funded program and with this arrangement saw no need to have assistant auditor appointed. Judge Postell asked if the Court had any questions regarding extra help in the auditor's office. Commissioner Sheedy stated that a County Auditor had been appointed to relieve the Clerk's office of a work overload and it now seemed that there were more problems with several offices being overworked and he found it difficult to understand the situation.

### LIBRARY LOTS

Judge Postell reported that no bids had been received by the Court on the two lots advertised for sale for use and benefit of the library. The Clerk was instructed to re-advertise the two lots in Lorange Addition with bids to be opened January 11, 1981, at 10:30A.M.

### LIBRARY INSURANCE BIDS

Judge Albert A. Postell reported that he had received one bid from Kreiger Insurance Agency for quotation on insurance for new library as follows:

Dear Judge:

In response to your request for bids to provide insurance on the new Public Library building, we submit the following:  
1) For an annual premium of \$795.00 Fire & Lightning, Extended Coverage and Vandalism & Malicious Mischief Insurance in the amount of \$150,000.00 with an 80% coinsurance clause, and \$100.00 deductible on all Extended Coverage losses. This building cannot receive an additional fire rate credit until it is physically occupied as a public library.  
2) For an annual premium of \$482.00 Glass Breakage from any cause, with a \$50.00 deductible. This premium can be reduced to 201.00 with a cumulative deductible of \$201.00. This deductible is applied until \$201.00 is exhausted, and all losses are paid in full there after.

You will note that the Vandalism & Malicious Mischief Peril in quote numbered 1, does not include glass breakage.

The Court decided the bid of Kreiger Insurance and since there is no way of knowing when the building will be occupied by the library, Commissioner David G. Luna moved that the County insure the Library Building with Kreiger Insurance Agency on a sixty day basis for glass breakage insurance, and instructed the Clerk to re-advertise for insurance bids when the building was occupied as a public library. Commissioner Tim Ward duly seconded the motion which passed with the following vote: Ayes: David G. Luna, Tim Ward, and Alvin S. McClure. Nays: John Amos Sheedy, III.

#### ROTARY CLUB REQUESTS USE CIVIC CENTER

Mr. Frank Finamore requested free use of the Civic Center for dance to be held on February 27, 1982 as a fund raising event for the Boy Scouts of America with the Brackettville Rotary Club sponsoring the local Boy Scouts.

Commissioner John Amos Sheedy, III moved that the Court allow the Rotary Club to have free use of the civic center on February 27, 1982 except for \$75.00 fee paid toward electrical bill since all proceeds were to go for the use and benefit the Boys Scouts of America. Commissioner Alvin S. McClure duly seconded the motion passed unanimously.

#### RESIGNATION OF LIBRARIAN

Judge Postell read the following letter to the Court:

Dear Sirs:

Please accept this as my resignation as librarian of the Kinney Co. Library. It has been a privilege and pleasure to serve in this capacity and I wish to thank the Court for many past kindnesses and splendid cooperation.

May I recommend Charolette Corey for appointment in my place. She is very capable and very conscientious and quite aggressive and I know the Library will be in good hands.

Mrs. Golemon had wanted me to continue until we move into the new building but that is rather indefinite and not fair to Mrs. Corey who is doing all the work now.

I talked with Mrs. Golemon's daughter last night, and she said Mrs. Golemon would be unable to return to Brackettville before next spring due to poor health. She also said Mrs. Golemon wishes to resign from the Library Board and would like for me to be appointed to fill her unexpired term.

A Commissioners Court has a great responsibility and I feel you are fulfilling that responsibility conscientiously and well.

Thank you again for your many kindnesses and considerations to the Library which I know will continue into the future.

Attorney Shahan suggested that the Court pass a resolution in appreciation of Miss Sauer's many years of service to county and library and publish in newspaper.

Commissioner Tim Ward moved that the Court pass a resolution thanking Miss Sauer for her years of dedicated service to the County and Library and accept her letter of resignation as Kinney County Librarian. Commissioner John Amos Sheedy, III duly seconded the motion which passed unanimously.

Judge Postell said no action would be taken until Mrs. Golemon resigns from the Board of Directors for

the Kinney County Library and at that time the Court would appoint Miss Sauer to complete Mrs. Golemon's term.  
CHAROLETTE COREY APPOINTED KINNEY COUNTY LIBRARIAN

Commissioner John Amos Sheedy III moved that the Court appoint Charolette E. Corey as Kinney County Librarian to fill the vacancy created by Miss Else Sauer's resignation. Commissioner Tim Ward duly seconded the motion which passed unanimously. Mrs. Corey's bond and oath as County Librarian to be filed with the Clerk and recorded in the official bond records.

#### RE-DISTRICTING ORDER OF NOVEMBER 30, 1981 RESCINDED

Commissioner David G. Luna moved that the order re-districting Kinney County's Commissioner, Election,

Constable and Justice precincts according to the 1980 Federal Census at the November 30, 1981, Special Meeting of Commissioners' Court be rescinded due to the fact that re-districting order was passed at a special meeting rather than a regular meeting of the Commissioners' Court. Commissioner John Amos Sheedy, III duly seconded the motion which passed unanimously.

#### BILL ADAMS-COUNTY INSURANCE

Mr. Bill Adams presented Philadelphia Life's Hospital Cash Program Insurance to the Commissioners' Court which would pay the employee \$40.00 per day while in the hospital. Mr. Adams said that he could enroll Kinney County employees if there were at least ten interested in this policy.

Commissioner David G. Luna moved that the \$6.60 Kinney County paid toward employees Cancer Plan Insurance Plan Insurance could go toward premium on Philadelphia Life's Policy if the employee chose or remain on the Family Cancer Plan Ins. policy, that it was strictly up to the individual which policy to be selected, or if the employee wanted to have a premium deducted from payroll for Philadelphia Life Ins. Co. policy. Commissioner John Amos Sheedy, III duly seconded the motion with the understanding that the county would only pay \$6.60 for the employee on only one of the policies. The motion passed unanimously.

#### BLASA FLORES--INSURANCE ADMINISTRATOR

Carlotta DeLaRosa, County Treasurer, reported that he office was too busy to continue handling and administering the County's insurance program and would like all insurance claim removed from her office. Mrs. DeLaRosa said she would continue taking care of the billing for all insurance. Mr. Shahan said that his secretary, Blasa Flores, was agreeable to handling the county's insurance claims if Mr. Adams would properly train her and the Court would allow more postage for mailing all claims.

#### LIBRARY INSURANCE

Mr. Allen H. Kreiger met with the Court and reported that his quote was for an unoccupied building and that once it was occupied the premium would be lowered but suggested that the Court take temporary 60 day policy on glass breakage and builders risk insurance. Commissioner John Amos Sheedy III moved that the court insure the new library building with a builder's risk policy for \$150,000 to cover fire, vandalism & malicious mischief and glass breakage for sixty days with Kreiger Insurance Agency. Commissioner Alvin S. McClure duly seconded the motion which passed with the following vote: Ayes: John Amos Sheedy, III, Alvin S. McClure, and Tim Ward; Nays: David G. Luna.

Meeting Recessed until 1:30 P.M.  
1:30 P.M. Court reconvened for public hearing on the re-districting proposal for Kinney County.

The court considered the County's Re-districting Plan, consisting of four maps and field notes. Letters from the Kinney County Democratic Party Chairman, Fort Clark Springs Association Community Council President, and City of Brackettville by W.M. Thurber, City Manager.

Indicating approval of the County's re-districting plan were filed with the Court and made a part of these minutes. It was stated that there would be no changes of polling places, the population and registered voters were equalized as to Minorities and Anglos within the 10% variance according to the 1980 Federal Census figures. The new precinct lines establish Commissioner, Constable, Justice of Peace and Election Precincts which share identical boundaries.

Commissioner David G. Luna, moved that the Court adopt a resolution setting out the new precincts lines, re-districting population to equalize Minority and Anglo population without diluting Minority voting strength in a fair and equitable manner for each Commissioner, Justice of the Peace, Constable, and Election Precincts according to the 1980 Federal Census figures for Kinney County, Texas, with field notes and maps to be filed in the County Clerks' office and submitted to the Justice Department for approval. Commissioner Alvin S. McClure duly seconded the motion which passed unanimously.

#### ORDER TO AMEND BUDGET RESCINDED

Commissioner David G. Luna moved that the order to amend the budget to cover the additional costs of cleaning the County Cemetery which passed November 16, 1981 be rescinded since Lateral Road Runds could not be used for items other than road maintenance or road right-of-way. Commissioner Tim Ward duly seconded the motion which passed unanimously.

Commissioner David G. Luna moved that some workers cleaning the cemetery, parks, and county property be paid with funds budgeted in the General Fund and transfer funds from the Roads and Bridge Fund to the General Fund for the balance needed for salaries of said workers and that be transferred from Road and Bridge Fund to replace funds used to pay said workers from the Lateral Road Fund. County Attorney Shahan recommended that the Commissioners' plan ahead and consult with the Auditor before approving expenditures and operate within the budget. Commissioner John Amos Sheedy, III duly seconded the motion which passed with the following vote: Ayes: David G. Luna, John Amos Sheedy, III, and Tim Ward. Abstaining: Alvin S. McClure  
PAYMENT OF PART TIME JAILER

Commissioner Tim Ward reported that while Sheriff Bailey and Deputy Slubar were out of town attending a seminar. Jailer Juarez hired Lydia Martinez to work as a part time jailer until their return and that there were no funds budgeted for an additional jailer. The Court pointed out that funds had been budgeted for part time jailers in the Sheriff's budget and Miss Martinez should be paid from these funds.  
TREASURER & AUDITOR SALARIES

Commissioner David G. Luna reported that an oversite had been made in not equalizing the salaries of County Treasurer and County Auditor when the current budget was approved and Commissioner Lanu moved that the County Treasurer's salary be increased to the amount of the County Auditor's salary

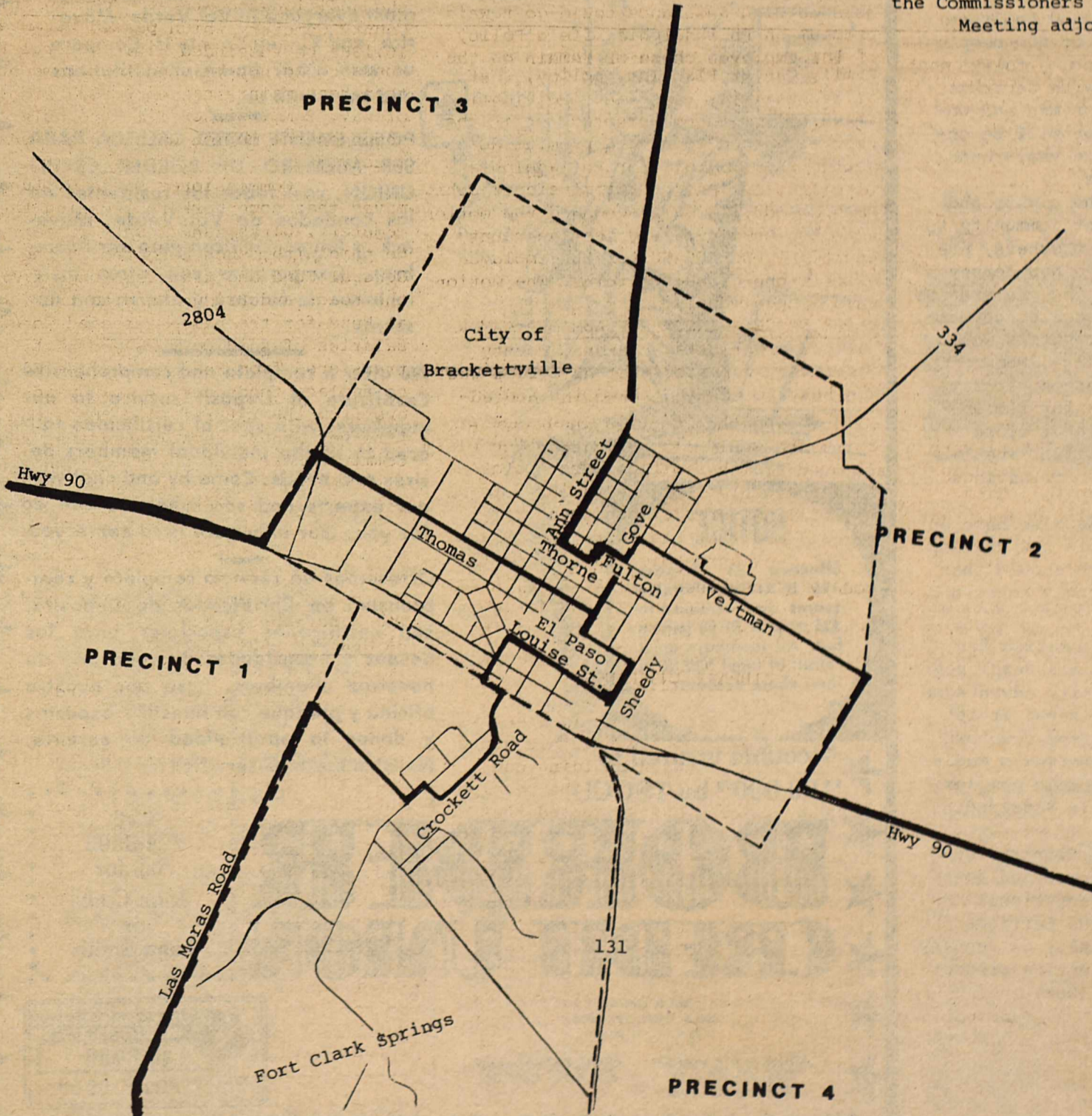

with a budget amendment to cover said increase. Commissioner Tim Ward duly seconded the motion. The Clerk was instructed to add increase of County Treasurers' salary to the January 1982 agenda and past same for ten days prior to meeting to meet requirements of salary increases with the action retroactive to December, 1981. The motion passed unanimously.

**MR. TOM NEILSON-COMPTROLLER'S OFFICE**

The Court thanked Mr. Tom Neilson for attending Commissioners' Court and assisting Kinney County with the proper procedure for accounting and expenditures of budgeted funds.

Mr. Neilson offered these suggestion for improved fiscal operations of the County: (1) Stay within budget; (2) Auditor to keep account of expenditures in ledger; (3) Do not make expenditure if funds not budgeted or if emergency then amend budget first and then expend funds; (4) Any official should have purchase order signed by County Judge and Auditor before making purchase unless the item is over \$3,000 then the Court must advertise for bids and salaries need not have purchase order if funds are budgeted and available.

**NOVEMBER 1981 BILLS & REPORTS**

Commissioner David F. Luna moved that all bills incurred by Kinney County for the month of November, 1981 be paid as presented and that all reports of County Officials be approved as presented. Commissioner Tim Ward duly seconded the motion which passed unanimously.

JUDGE Postell reported that Mr. Quinton Etzel had called and reported that there would be a meeting on Wednesday, December 16, 1981 to work on a settlement with the bonding company on the library lawsuit, and asked that the Commissioners attend. Meeting adjourned.



**\$100 MILLION RETIREMENT COMMUNITY TO BE FIRST OF ITS KIND IN TEXAS**

HOUSTON--A \$100 million development under construction here by US Homes Corp. will be the state's first fully planned retirement community, it was announced by officials for the home-building giant.

CountryPlace, a community unique in offering a complete recreational-oriented lifestyle geared toward senior citizens, is under way on 600 acres of countryside 13 miles southwest of downtown Houston off State Highway 288. Deed restrictions require at least one member of the household to be 50 or older and allow children under 18 to visit for periods of no more than 30 days a year.

Ray Woodruff, president of the Southwest Houston Division of US Home Corp., said during the announcement, "While there are other retirement housing centers in Texas, there is no other development with the total recreational community concept of CountryPlace."

When complete, the development will have 1,079 detached single-family homes and 454 townhouses built around a \$4 million central complex of sports and leisure facilities. Homes and townhouses will be priced from \$50,000 up.

At the heart of CountryPlace will be a seven-acre lake stocked for fishing. Winding throughout the community will be an 18-hole golf course and a jogging and bicycle path. Other outdoor recreational facilities will include lighted tennis courts, swimming pool, and shuffleboard.

The Carriage House, a 12,000 square foot luxury clubhouse, will house a reading library, TV room, spacious lounge, game room, ceramics workshop, catering kitchen, and ballroom that can accommodate up to 500 people. The center also will feature fully equipped exercise room with separate saunas and whirlpools for men and women. A full-time director will be on-site to plan and organize year-round activities for residents.

CountryPlace is the eighth and newest complete retirement community to be built by US Homes. The others, are in Florida, Maryland, and New Jersey. Extensive research into the preferences of homeowners in those earlier communities determined what amenities would be provided at CountryPlace, Woodruff said. Among the extras are a separate parking and storage area for recreational vehicles, extra-large closets in most floor plans, and full insulation and gas appliances for savings on utility bills.

Woodruff noted, "We also have only two entrances into this new development because our research showed that senior citizens are strongly concerned about security."

US Home selected the location for CountryPlace because of its rural setting convenient to big city advantages important to senior citizens. It is situated just 13 miles from downtown Houston and 10 miles from Texas Medical Center and the Astrodome complex. The nearest small town is Pearland, seven miles away.

The first phase of CountryPlace--consisting of model homes and townhouses and all of the recreational facilities, including the Carriage House--will open officially on January 30. Completion of the entire project is scheduled for early 1988.



- (4) An AGGRAVATED ASSAULT is committed every 13 minutes
- (5) A BURGLARY is committed every 2 minutes
- (6) A THEFT is committed every 71 seconds
- (7) A MOTOR VEHICLE THEFT is committed every 7 minutes.

These statistics were compiled from data submitted to the Texas Department of Public Safety Uniform Crime Reporting Bureau by 730 Texas Sheriffs and Chiefs of Police whose jurisdictions represent 92.4% of the State's

One major crime was committed in Texas every 36 seconds during the first six months of this year. This is an increase of 3.3 percent over the same period last year. Murder was the one crime to decrease---down 2.1 percent. Reported burglaries showed the largest increase---up 8.2 percent.

Other statistics show:  
 ----Larceny-theft made-up over one-half of the crimes reported.  
 ----In rural areas 40 percent of the reported crimes were burglaries, as opposed to burglaries comprising only 30 percent of urban crime.  
 ----Motor vehicle theft occurs twice as frequently in counties with a population over 100,000.  
 ----The rape per person in cities under 2,500 is nearly as high as in cities over 100,000.  
 ----3,941 offenses of arson were reported with resulting property damage very near \$50 million.  
 ----Law enforcement agencies continue to be the most successful in clearing or solving a greater percentage of murders (75%) than any other crime. The least success is with burglaries (15%).

**Capture Tennis Action With High-Speed Film**

When an activity is this popular, it stands to reason that sooner or later you are going to be taking pictures of it, which means polishing up your techniques for stopping action.

To begin with you need a camera with a shutter speed of at least 1/500 second. This, combined with a fast film such as Kodacolor 400 film or Kodak Ektachrome 400 film, should be able to stop all but the fastest action. It is also an excellent shutter speed to use with a telephoto lens.

For tennis, where you want to be close to the action without getting in the way, a telephoto lens is almost a must. High-speed film allows you to use a

Action moving directly toward—or away from—the camera is the easiest to stop. For action going past you, you have an alternative using a somewhat slower shutter speed, say 1/250 second, pan with the action. This will result in a blurred background with the subject in focus. This technique can add a sense of motion and excitement to the picture.

A motorized film advance is not a necessity but can be very useful if you want a quick series of pictures to show the complete stroke.

Choosing the angle and deciding when to shoot are, of course, up to you. You are still the most important factor in determining whether your pictures are good or great.

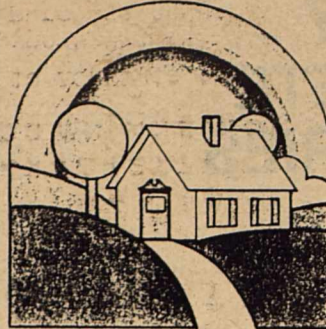
