### CHAMBER OF COMMERCE BANQUET



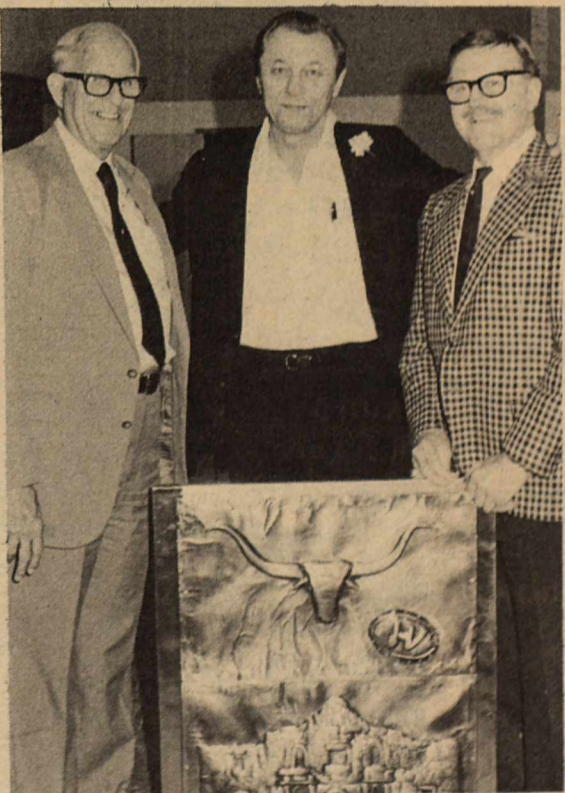
Judy Loos was presented Woman of the Year Award by outgoing President of the Chamber of Commerce, Happy Shahan.

**SENATOR BILL SIMS**

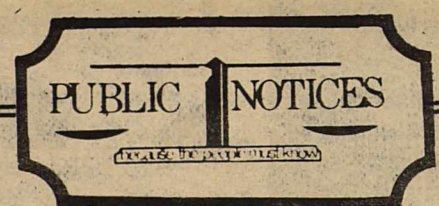
Senator Bill Sims of San

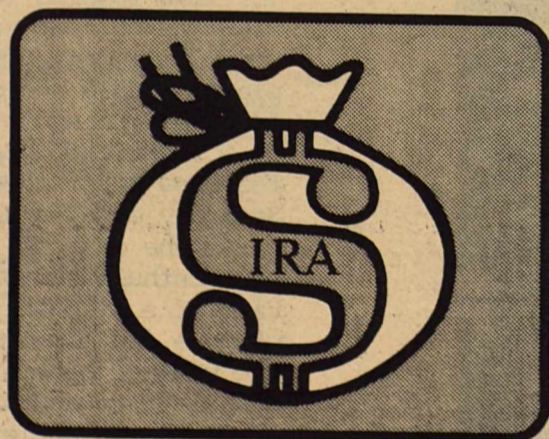

# SHERIFF'S CORNER

CONGRATULATIONS to Judy Loos and Bill Riley on receiving the WOMAN of the YEAR and MAN of the YEAR respectively.

A live, World War II vintage, had grenade was found in the old Ft. Clark dump last week. Jewel Robinson, her brother Dan, and her mother Ms. Essie Coker were looking for old antique bottles near the old dump when the grenade was discovered. Ms. Robinson contacted this officer and the area was immediately secured with the cooperation of FT. Clark Security Officers.

A Bomb Disposal Unit from Corpus Christi was notified and dispatched to the site at my request and the grenade was placed in a sealed container and removed. The Seargent in charge of the operation advised that we were lucky that no injuries or possibly even death occurred as the grenade was unstable due to its rusty condition.

Should any of you happen to discover any suspicious objects that might contain explosives, please contact the Sheriff's Office as soon as possible. Old grenades, blasting caps, etc. are very unstable and we certainly do not want any of our citizens injured or killed from handling objects of this sort.

Garland Hinesly, a salesman at FT. Clark, reported the theft of his automobile last week. The description of the vehicle and suspect has been entered into the TCIC and NCIC computers. A warrant has been issued for the suspect and we hope to recover the vehicle soon. When captured, the suspect will be returned to Kinney County to stand trial.

I will now continue the report on the Rabies Control Act of 1981.

The Act further provides that the owners of dogs and cats shall have these pets vaccinated against rabies by the time they are four months old and at regular intervals thereafter as prescribed by rule of the board.

The Act also authorizes the city and county governments to enact ordinances and/or adopt rules to require the registration of each dog and cat found within the respective jurisdiction of the city or county.

The board, if rabies is known to exist in the area, may declare an area "quarantined". The area quarantine shall remain in effect for 180 days following the last case of rabies diagnosed in a dog or cat, or other animal species responsible for the quarantine.

The Act further provides a penalty for failure to quarantine an animal or present an animal for quarantine when ordered to do so by the board. This penalty is classified as a Class C misdemeanor which provides a fine of up to \$200. upon conviction. Further

penalties are provided for violation of the area quarantine, and dog and cat registration requirements, violation of dog and cat restraint requirements, and violation of requirement to vaccinate a dog or cat.

This Act was approved by the Legislature of the State of Texas on May 26, 1981 and went into effect on January 1, 1982.

As I said when I started this report, the objective of the report was to make you aware of the options available to the city and county. The law is there if the respective governments want to use it. The City of Brackettville has already taken steps in this direction by passing ordinances requiring that dogs and cats be vaccinated. They have a quarantine pen that has been approved by the State Board of Health and it has been used several times to quarantine animals that have bitten humans. I would like to see the City and the County work together on this Act for the protection of our citizens. None of us wants an outbreak of rabies to occur in our community such as the one that happened in Laredo a couple of years back. We need to take steps to control the stray dog problem in our community and see that all pets are vaccinated against rabies BEFORE such an outbreak occurs.

## BLUEBONNET TRAIL

The 22nd annual Highland Lakes Bluebonnet Trail is set for April 9-10 and April 16-17. The Trail winds its way through the Hill Country communities of Marble Falls, Kingsland, Llano, Buchanan Dam, Burnet, and Lampasas where the bluebonnets are sure to be in full bloom.

The map of the Trail is provided by the Highland Lakes Tourist Association so that the lover of bluebonnets will know where the best areas are for viewing. In each of the Bluebonnet Trail communities, a special local arts and crafts fair has been prepared as an added attraction to the natural beauty of the Texas State Flower.

The best way to enjoy the Bluebonnet Trail is to plan a leisurely drive through any parts of the trail, stopping to enjoy the scenery, the points of interest, and the arts and crafts fair. Texans littered their roadsides more than ever in 1981-82 and it cost more than 17million of their tax dollars to pick the trash up, according to the State Department of Highways and Public Transportation (DHT)

DHT Engineer-Director Mark Goode said, "The dollars spent to pick up litter, 35 percent more than a year earlier, come from the same budget that must also be used to repair potholes, mend guard rails and other necessary maintenance activities."

Statistics compiled by DHT's Safety and Maintenance Operations Division show that Houston far outpace other metropolitan areas in trash pick-up costs. Compared to the \$6.9 million spent by the department's Houston district, \$1.9 million was spent in the Dallas district while San Antonio and Fort Worth districts used \$1.2 and \$1.1 millions respectively

The 1981-82 trash pick-up total is two-thirds more than was spent in 1979-80 when the state-wide cost reached \$10 million for the first time. During 1980-81, DHT spent \$12.2 million.

The department's entire maintenance budget for 1981-82 was \$308,098,210.

**4-HERS FOOD SHOW**

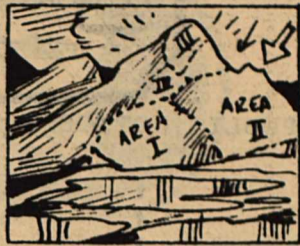
