### NEWS FROM SWTJC

Like or not, it's almost time to tackle the annual income tax problem again, and there's help available in a special short course at Southwest Texas Junior College that begins Monday, February 6.

Taught by local accountant Sheman Mumme, the class will meet all four Mondays in February from 6 to 9:30 p.m. in one room of the Wagner Building on the SWTJC campus.

Cost for the Course will be approximately \$20.00, according to SWTJC business administration division chairperson Adolph Gottschalk.

"The course will cover the fundamentals and other considerations of income tax preparation", Gottschalk said. "Mr. Mumme will also discuss the latest tax reforms rules and regulations".

In addition to the different versions of Form 1040 and its supporting schedules, concepts that will be explained include depreciation, capital gains and losses, self-employment, employment taxes, small businesses and farming.

"Mr. Mumme will also concentrate on the particular schedules and problems of student interest," Gottschalk explained.

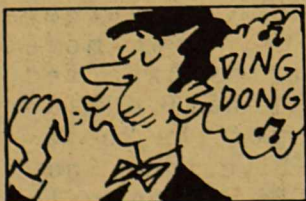
**SEE YOUR DOCTOR**

### Author of "Delta Force" to hold Autograph Party

B. Dalton Bookseller at Plaza Del Sol Mall in Del Rio is planning an autograph party on Saturday, February 4, 1984 from 1:00 to 3:00 pm. They will be host to Col. Charles A. Beckwith (USA Ret.) who has written the book "Delta Force: The U.S. Counter Terrorist Unit and Iran Hostage Mission."

Charles Beckwith, you'll recall, was the ground commander who unhesitatingly aborted the Iranian-hostage rescue mission, told the country why, and held his head. What we didn't know was that Beckwith had worked and fought for nearly 20 years to get his elite counter-terrorist unit, Delta Force, into operation and then to train it for what was to be its historic baptism-of-fire.

In 1952 he joined the US Army Infantry with a second lieutenant commission.

In the years that followed he became known as a maverick and one of the Army's finest combat commanders. He served 16 months in Korea as a platoon leader and company commander and in numerous capacities with the Special Forces. In 1962 he participated in an officers exchange program with the British Special Air Service (SAS). On his first tour of duty in Viet Nam he was awarded the Silver Star for gallantry for his rescue of the surrounded Special Forces camp at Plie Me. Later in this tour, he was severely wounded and spent many months recovering in an Army Hospital.

Following his recovery, he took command of the Army Infantry School's Florida Ranger Camp at Elgin Air Force Base. In 1967 he volunteered again for duty in South Viet Nam where he served with 101st Airborne Division. He left there in 1968, and was stationed in Hawaii until 1973 when he volunteered for an assignment to the Joint Casualty Resolution Center in Thailand to conduct casualty recovery operations throughout Southeast Asia. He then returned to Fort Bragg, North Carolina as commandant of the U.S. Special Forces School.

In 1976, Colonel Beckwith was asked by the Department of the Army to develop a military unit to combat international terrorism. It was then that he organized Delta Force and recruited and trained the operators of this elite, super-secret unit. In 1979 Delta Force became a national asset under the direct control of the Secretary of Defense and the President of the United States.

On April 24, 1980 Colonel Beckwith led Delta Force into Iran in an effort to rescue the 52 American hostages being held in Tehran. When three helicopter being used in the mission developed mechanical problems and were unable to proceed, Colonel Beckwith made the decision to abort the mission.

Thanks to superior ghosting, there's flavor, color, drama, and conviction in this forthright first-person history-engrossing and eye-opening even (or especially) for those with reservations about special ops or the rescue mission.

B. Dalton welcomes Beckwith to Del Rio and invites Brackettville residents to come over and have a cup of coffee and chat with him.

This week's column is dedicated to the memory of Richard Latham, the U.S. Customs Officer who was kidnapped and brutally murdered last Friday, January 27, 1984.

Our deepest sympathy goes out to his brother, Bob Latham, a U.S. Border Patrol Agent stationed here in Brackettville, and to the other surviving members of his family.

Brutal violence and murder directed towards peace officers and other law abiding citizens of our society seems to be the trend by the criminal element these days. Some of the most brutal and violent assaults in our area over the past year or so have been at the hands of Mexican Nationals in our country either illegally or holding "Resident Alien" cards issued by the U.S. Government.

Several San Antonio policemen have been violently assaulted by this particular element over the past few years. Clyde Hobbs, Chief Deputy with the Uvalde County Sheriff's Department was brutally murdered last year by a gang of criminals, some of which were Mexican Nationals. Mrs. Adams living on the Burr Ranch just south of Kinney County was shot by an illegal alien in her front yard while holding her infant grandchild in her arms. U.S. Border Patrol Agents are often assaulted by illegal aliens and now a good, hardworking law enforcement officer has been kidnapped and murdered while in the line of duty.

I have one question. When are we going to stop and say "Enough is enough!"?

Sure, I believe in civil rights and due process of law. I personally do not know any peace officers who do not, but we have rights too. I received many calls from concerned citizens and law enforcement officers from various parts of the state while the search for Richard Latham and his abductors was being conducted. One caller asked a very sincere question. She wanted

to know if criminals had declared "Open Season" on peace officers. In my opinion and the opinion of many of my fellow officers this seems to be the case.

Most of us believe in homes, fair and impartial law enforcement, but in my opinion, our court systems have gone too far in favor of civil rights for criminals. We in law enforcement are waging a constant war against crime and the peace officer on the street is the front line soldier who has to do all the dirty work. We are the ones down in the mud and the blood. We do not have the privilege of showing up for work calm, cool, and collected with clean pressed suits and air conditioning with coffee breaks and someone with a gavel to call for order. If you don't believe that, ask the families of Clyde Hobbs and Richard Latham, both who have brothers living and working in Brackettville. Ask Mrs. Adams who was shot in her front yard and was so terrified that she has been unable to return to the ranch she called home. Talk to "Ford" Dodson whose house was burglarized this past year. Ask the others whose homes have been vandalized, burglarized, and burned. Ask the women who are terrified to stay alone in their ranch homes at night or for that matter during the day.

The courts should stand for honesty and civil rights, but the rights of law abiding citizens and honest, hardworking, dedicated peace officers should take precedent over the rights of the vicious, brutal criminals roaming about the country.

I am proud to have known men like Clyde Hobbs and Richard Latham and I am proud of the brotherhood that binds peace officers together in a bond so strong that when one is lost we feel we have lost a brother. I don't want to continue to lose good friends and good officers to the brutal criminals and killers. I think the time has come to take a harder stand against violent criminal. The place punishment in the courts.

Farewell, Richard, and God Bless.

The holder of season tickets will be given the opportunity to choose the performance night and seat one week before tickets for each show go on sale to the public.



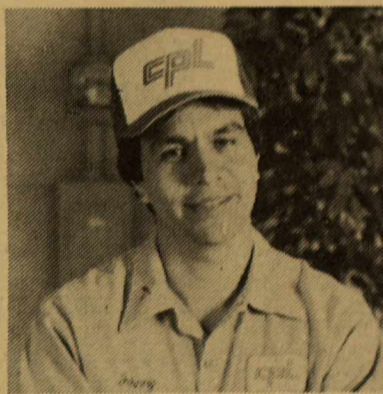
