**CITY NEWS

The City Council, representing all citizens of the City, passed and approved for submission to the Texas Department of Community Affairs a request for a \$82,600 grant to replace the present ground storage tank in the Utility Department Water System.

In conjunction with the Grant Request the Council committed \$22,500 of utility department facility maintenance funds to renovate the 1928 elevated storage tank.

This request generated and approved at two public hearings prior to Council finalization, along with the ongoing replacement of old worn out fire plugs, the replacement of water lines behind the football field, and valve replacements throughout the City, is but a part of the overall goal of updating and improving the water system.

The Mayor with concurrence of all members of the Council called a special meeting to discuss police department and

Corporation Court operations and organization. It has been recommended the Council consider consolidating the City Department with the Sheriff's office. The meeting held Thursday evening, June 7, was set primarily to consider the possibility, coordination and cooperation with City/County government and to set up public hearings to generate and evaluate citizen input.

A cooperative Fire Department Support Contract was finalized with Fort Clark Springs and the City thus ensuring financial support for insurance and equipment for the Brackettville Volunteer Fire Department, Emergency Ambulance Service and Police Reserve Support.

The Contracts and Working Agreements with the City and Fort Clark Springs Association and Municipal Utility District is a prime example of how we can and should work together for the benefit of the entire community.

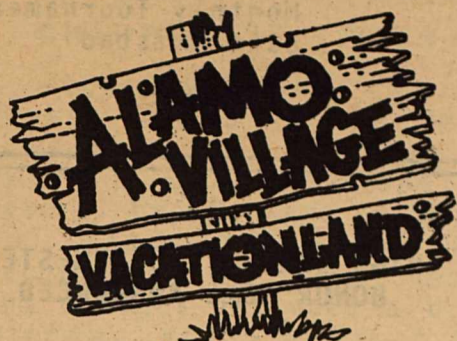


side to choose from. There will also be an offering of the best open and bred heifers available. It will be an exciting sale in front of the "Alamo" replica.

**GARDNER FEATURED ARTIST AT
 TEXAS LONGHORN SALE
 OF THE CENTURY**

Dave Gardner, foreman for the Texas A & M Experimental Ranch at Spofford, cast his first bronze in 1976. It was titled "First Go," a sculpture of a cowboy with saddle and bridle in hand ready for his first bronc of the day. Gardner's bronze art has stemmed from an active interest in Western Art. After losing the tips of three fingers, his interest became a pastime during recuperation. His skills became even more adept during other recuperation periods resulting from being drug by a horse and rolled on by yet another. Themes for the sculptures stem from many of the artist's personal experiences while ranching. Dave, a graduate of New Mexico State University, has been at the Experimental Ranch for five years.

A bronze model of Dave's, "Law West of the Pecos," has been on display at the First National Bank of Uvalde. His works are also in England, Brazil, Paraguay, and Australia, as well as in most states of the U. S. A. The artist and his bronzes will be at the "Texas Longhorn Sale of the Century," on Saturday, June 16th, at Alamo Village on the Shahan HV Ranches.

Bud Breen, Western and Indian artist, will also be at the sale, along with reknowned Markos artists. Bud has spent his time in the West working on ranches until the late 50's,

when he decided to devote all his time to his painting. He started painting at an early age. Now married to Naikai, a Cherokee Indian, he lives in the West, thinks Indian and paints Americana.

Breen's paintings are in such homes as John Wayne's, Rex Allen, Slim Pickins, Roy Rogers, Tom T. Hall, and at the Washington Redskins office in D.C., as well as many others.

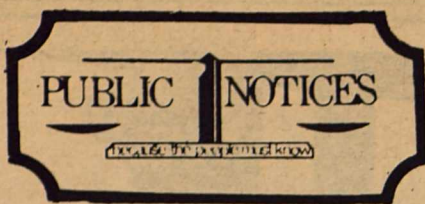
Most of the Western art on display will have a hint of familiarity to many. While viewing the displays, the artists will be on hand to talk about their works.

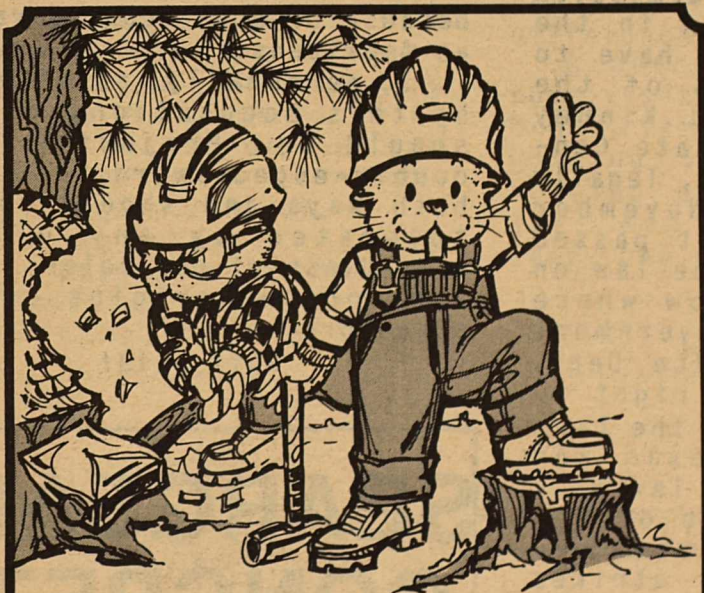

THE SHERIFF'S CORNER

On the General Election ballot in November, 1983, a State Constitutional Amendment was overwhelmingly passed throughout the State, with a 4 - 1 margin in Kinney County. The amendment allows counties to make adjustments in the number of Justices of the Peace and Constables. If passed, the law was to become effective on January 1, 1984. The amendment passed and was put into effect on January 1, 1984.

Kinney County, with a population of less than 18,000, was allowed to chose the option for counties of this size, to choose between one (1) and not more than four (4) Justices of the Peace and Constables. The Commissioner's Court, after careful consideration, passed a Resolution to return to one (1) Justice of the Peace and one (1) Constable to serve County-wide.

The Democratic Chairperson, after consulting with legal advisors, added to the ballot, on a county wide basis, the names of those candidates seeking the respective offices of Justice of the Peace and Constable. The Democratic Primary, held on May 5, 1984, gave YOU, the voters of Kinney County, the opportunity to make your vote for the various candidates. The failure of the candidates for either of the offices to obtain a 51% vote margin during the primary forced the top two of each race into a run-off election held on June 2. Again, YOU, the voters of Kinney County, cast your votes. By majority vote, a single Democratic candidate for each position was chosen. By law and your vote, they won their place on

the ballot of the General Election to be held in November, 1984.

Why, you may ask, am I going over known points of law? Recently, the Commissioners of Kinney County, the County Judge, and the Democratic Party Chairperson of Kinney County were named in a lawsuit charging them with 'racial discrimination' and 'civil rights' violations. The suit has been filed by a disgruntled Justice of the Peace who chose NOT to run on a county wide basis, as provided by law, and a county employee, who was fired from her job for insubordination and lying to her superior. The allegations in the suit specifically charge that those named have violated the civil rights of this Justice of the Peace and discriminated against him racially because, he claims, a Hispanic cannot win a county wide election in Kinney County!

Well, naturally, 'Big Brother', in the form of the U. S. Justice Department came to the rescue and tells Kinney County to "Hold on! This election may not be valid!" "You didn't get OUR permission to hold the election in the first place!" All I have to say is: The voters of the State of Texas and Kinney County voted on a State Constitutional Amendment, legally on the ballot in November 1983. This Amendment passed state wide and became law on January 1, 1984. Now where does the federal government and the U. S. Justice Dept. think they have the right to step in and overrule the laws of the State of Texas and Kinney County, made law by a large majority vote of the voters of the state and county? Big Brother strikes again!

Now, as to the allegations that no Hispanic can win a county wide election in Kinney County. Consider this: our County Treasurer is Hispanic and has won two county-wide

elections. The recent Justice of the Peace election shows, by the election of a Hispanic, that the allegations are false. There are Hispanics on the City Council, The Commissioner's Court, and the School Board. In my humble opinion, the people of Kinney County have shown that we elect our officials primarily because of their qualifications. Racial prejudice of any kind has no place in our society nor our community! I am proud to believe that the people of Kinney County are not influenced in our selection of officials by the color of his or her skin, sex accent, or ethnic origin.

The lawsuit in question is not only against those specifically named, but against ALL of us who live and vote in Kinney County. We are being charged with racial discrimination and civil rights violations by one dissatisfied office holder who has decided that the majority DOES NOT rule and one ex-county employee who refused to recognize the responsibilities of her position. Both parties want special consideration because of their race, not because of equal consideration as Americans.

I, personally, am offended by this accusation, as you should be. Prejudice is a double-edged sword that cuts both ways and should not be tolerated by any of us, regardless of our color, race, sex, or the origins of our ancestors.

Nuff said!

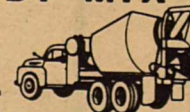

GARCIA ATTENDS SCIENCE SYMPOSIUM AT U.T.

Andrea Gracia of Brackettville High School was selected to attend the 24th Annual Texas Energy Science Symposium for outstanding high school students at the University of Texas at Austin, June 5-8, according to Bill Cranford, CPL local manager in Del Rio.

Andrea is the daughter of Mr. and Mrs. Eloy Garcia of Brackettville. She was accompanied by Dorothy Oliver, science teacher at Brackett High School.

Central Power and Light Company, a member of the Texas Atomic Energy Research Foundation is joining with the university in putting on the symposium and sponsoring 52 students and teachers from South Texas.

Some 500 outstanding science students and their teachers from throughout the state are selected by their schools to attend the four day meeting. Scientists and engineers for industry and education discussed nuclear physics, aerospace engineering, solar energy and related topics.

Participants spent two afternoons touring science laboratories at UT, including those where experiments sponsored by the foundation are being carried on in thermonuclear (fusion) research.

The Texas Atomic Energy Research Foundation is made-up of 10 investor-owned electric utility companies in Texas,

including CPL. The foundation was created in 1957 for the advancement of knowledge of energy, particularly nuclear energy, through scientific and educational activities. Its research efforts are presently directed towards controlling fusion reactions through programs being carried out at the University of Texas at Austin laboratories, with the ultimate goal of using energy from nuclear fusion for the generation of electricity.

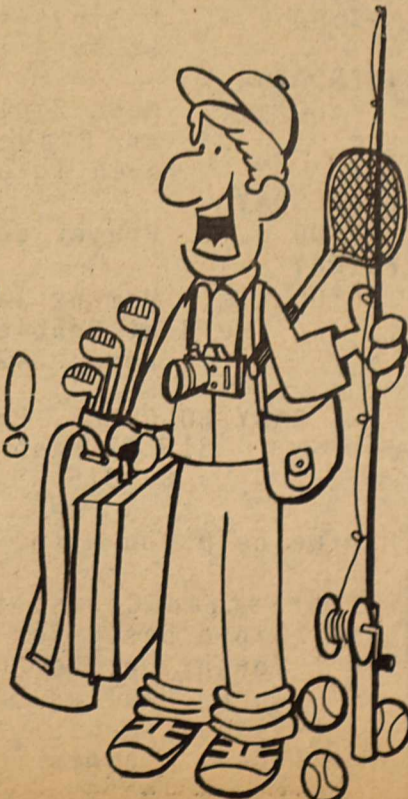
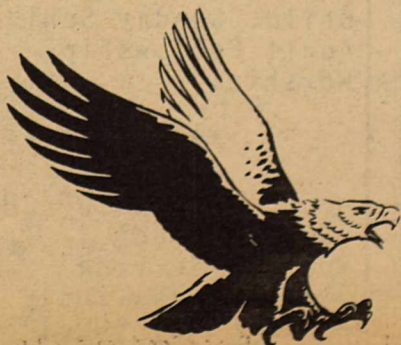
