
CATTLE RAISERS ANNOUNCE CHANGES IN FIELD INSPECTORS

Texas and Southwestern Cattle Raisers Association has appointed R. H. Butch Thompson, 35, formerly of Kingsville, Texas, to serve as field inspector for TSCRA District 29 in Southwest Texas, effective immediately, says Don C. King, TSCRA secretary-general manager in Fort Worth. He also announced the relocation of two other field inspectors to East Texas and the Houston area.

Inspector Thompson, who has served as a field security supervisor for King Ranch for five of the last 11 years, will work with cattlemen in Uvalde, Real, Edwards, Val Verde, Kinney, Zavala, Frio, Dimmit and Maverick counties. He will be headquartered in Uvalde and will supervise the brand inspection activities within his district.

Thompson, a Tyler, Texas native, was raised in New London, Texas, and complettd high school at Kingsville. He attended Texas A & I University at Kingsville before serving three years with the Kingsville Police Department. He completed the rank of Sergeant before joining King Ranch, King said. In his capacity at King Ranch, Thompson worked in conjunction with TSCRA field inspectors on numerous occasions.

"I feel like we're extremely fortunate to have the opportunity to recruit a man of Thompson's livestock background and experience as a peace officer into the field inspector force. His many

TSCRA, a 107-year-old
cattlemen's organization, employs 32 field inspectors, all certified peace officers carrying special Texas Ranger commissions, to assist cattlemen and conduct livestock theft investigations. In 1983, these inspectors, working with state and local law enforcement agencies, developed 150 theft cases, primarily dealing with cattle, and recovered or accounted for nearly 3,000 head of livestock and miscellaneous ranch property



DROUGHT CONDITIONS FOR RANCHERS

UVALDE - While a drought is both stressful and traumatic for livestock producers, it also gives ranchers an opportunity to evaluate and update their managerial

practices.

"Once the drought has set in and cow numbers are considerably cut, a rancher can reappraise his entire ranch operation," says Dr. Tom R. Troxel, livestock specialist with the Texas Agricultural Extension Service, headquart-ered at Uvalde. "The rancher can then ask himself, 'What can be done to improve the overall efficiency of the ranch and provide some flexibility to reduce the effect of the next dry period.'"

Many ranchers have already sold 25% to 75% of their herds since the dry weather started last fall. Ranchers have also indicated that they will want to see if it will rain in May and June before selling more

of the herd.

Dr. Troxel reminds that lactating cows have high nutritional requirements, and if the nutrition is not present due to drought, both the cow and calf will suffer. One option is to wear and sell the calf early in an attempt to maintain the condition of the cow. He points out that many 200-pound calves are now going to market.

With the culling of cows, a rancher could very easily move from a year-round calving season to a spring and/or fall

calving season. "A ranch could keep cows that calve at a certain time of year or when it rains again buy replacements that will calve at the same time of year, said Dr. Troxel.

Many times it is very difficult to control a breeding season due to the large size of some pastures. Once livestock have been removed from a large pasture, the rancher may want to consider cross fencing the large pasture into three or four smaller pastures. Therefore, a rotational grazing system could be initiated which may help during the next dry period.

"Eliminating non-breeding and late calving cows through pregnancy determination can increase profitability regardless of rainfall level,"

adds Dr. Troxel.

Lightweight calves are those generally born late in the season or are those born from poor milking cows. Pregnancy determination can also eliminate the late calves, and ranchers can then eliminate the cows with poor

milk production. Another management practice which should be included is a good herd health plan, Troxel recommends. This includes all necessary vaccinations, including calfhood vaccination against brucellosis. Heifer calves should be vaccinated with a reduced Strain 19 vaccine between 4 - 12 months of age, with accredited state or federal veterinarians required to vaccinate the. heifers.

The certified free herd program is another consideration for ranchers, particularly those who sell breeding stock. The number of certified free herds in Texas has increased from 675 in 1983 to 1307 or more so far this year. To be classified as certified brucellosis free. a herd (all cattle older than six months) must successfully pass two negative blood tests 10 to 14 months apart. In addition, the herds must be recertified annually, Troxel reminds.

"In the semi-arid Southwest, 6 out of 10 years are below normal rainfall," adds Dr. Troxel. "Cattlemen need to stock their ranches with those six years in mind." Generally, according to long standing statistics, only two "normal" years fall within the 10-year span, while two other years are usually high rainfall years resulting hurricanes.

Flexibility is the key word during the extra high rainfall years, as well as times of drought. When high rainfall results in an over-abundance of grass, ranchers may want to

consider keeping their own stockers or buying some to utilize the extra grass, the

specialist adds.

Flexibility has become important as cow/calf operators face rising feed costs and dwindling income. A rancher must consider all possible alternatives for making the ranch as economically efficient as possible. "Although drought is extremely difficult to predict, it does provide an opportunity for ranchers to regroup their thoughts and consider changes in managerial practices," adds Dr. Troxel. "This regrouping of managerial practices will serve the rancher to their advantage when the next dry cycle occurs."

SAD NEWS FOR CHOCOLATE HOUNDS

Chocolate has been blamed for many things over the years from obesity to acne, from hyperactivity to infertility, and now pet death.

In a report from the Texas Veterinary Medical Diagnostic Laboratory (TVMDL) published in a recent Texas Veterinary Medical Journal, chocolate was reported to be the cause of death in a Springer Spaniel dog. The dog died in seizures one day after eating two pounds of chocolate chips.

The ingredient in chocolate toxic to dogs is theobromine, a caffeine-related stimulant. The stimulant is cleared from the blood at a much slower

rate in dogs than in man. Agitation and loss of bladder control can be symptoms of theobromine poisoning in dogs when seen after they have eaten a large amount of chocolate .

Also reported by TVMDL is the toxicity associated with ingestion of excessive amounts of raw or cooked onions in

dogs.

Veterinarians caution pet owners to avoid feeding onions and chocolate treats to dogs, and to keep chocolate in a safe place as a dog's sweet tooth can be just as powerful as any "chocoholic's".

PUBLIC UTILITY COMMISSION SETS LOCAL HEARINGS

The staff of the Public Utility Commission of Texas sets out next Monday on the first of seven local hearings across Texas to hear what residential and business telephone customers think about local measured service (LMS).

Monday's hearing will be in Houston. Other hearings are scheduled in San Antonio, Dallas, El Paso, Amarillo,

Odessa, and Harlingen.
The local hearing for the Brackettville area will be in El Paso on Friday, July 6. The hearing will take place at the City Council Chambers, 2 Civic

Center Plaza, 2 to 5 p.m. and 6:30 to 8 p.m.

Local measured service is proposed by Southwestern Bell Telephone Company as an alternative to standard flat rate local service. Monthly flat rate service allows an unlimited number of local calls for a set rate permonth. The El Paso current

flat rate is \$9.10. Local measured service, under the proposal, would have a monthly rate which is 75% of the current local flat rate service. No usage is included in the monthly rate. Each outgoing call would be billed by a method similar to long distance call billing and would be based on the 1) time of day; 2) number of minutes of the call; and 3) distance of the call. Discounts would apply to calls made during specified times in late evenings and on weekends and holidays. Distance of calls based on minutes of use would fall into one of three mileage catagories from 0 to 31 or more miles. Initial minute charges and additional minute charges would be set for each of the mileage catagories.

Bell also proposed converting their present measured rate, with a few changes, to a lifeline rate available only

to individuals 65 years and over who have incomes at or below poverty levels. The lifeline rate would be \$5.00 per month including 25 local calls. Each additional call would be eight cents. The time of day, distance of the call or number of minutes of the call would not be measured for lifeline service.

LMS and lifeline service would be available only in Bell areas served by the electronic central office equipment capable of measuring the elements of each service. The services could not be provided in areas served by older central office equipment.

PUC Hearings Examiner Sheila Bailey will conduct the hearings in each city. Consumers planning to present comments at the meetings do not need to register prior to the meeting. Sign up sheets will be available at the meeting location at the start

Representatives from PUC's General Counsel Division, Consumer Affairs Office and Public Information Office will be attending the local hearings also. In addition, Chairman Al Erwin will attend the San Antonio hearing. Commissioner Peggy Rosson will attend the El Paso hearing. Commissioner Phil Ricketts will attend the Amarillo hearing.

Examiner Bailey set the hearing on the merits of Bell's request for 9 a.m., September 24. Testimony and recommendations of participants in the case will be available mid-September before the hearing begins. Partici-

pants are Office of Public Council, U. S. Telephone, MCI, Consumers Union/Texas ACORN/LULAC, City of El Paso, Texas Municipal League and Texas Association of Cellular Communications.







THE SHERIFF'S CORNER

by Norman H. Hooten, Sheriff

Several months ago I made you aware of a proposal by the U.S. Marshal's Service to Kinney County to build a County Jail Annex. It was to be used primarily for the detention of pre-trial, low risk, minimum security federal prisoners until they could be brought to trial in federal court. These prisoners were to be mainly illegal aliens and/or smugglers of illegal aliens.

This week's column will be to re-cap the progress of that original proposal and bring you up-to-date on the developments as they stand

today.

After we received the original proposal, an in-depth study by the Kinney County Commissioner's Court was made into the many aspects of such an undertaking, by financial and cost & planning experts. After careful study and analysis, the decision was made that the cost and long term debt necessary for such a facility would not be in the best interest of the taxpayers of Kinney County.

Shortly thereafter, we received a proposal from Operational Support Services, a Houston based company in the business of building and operating private enterprise detention facilities. The proposal was to allow them to enter into negotiations with

the U.S. Marshal's Service and the Immigration and Naturalization Service in an attempt secure contract commitments on numbers of prisoners to be detained in such a facility, should one be built. Representatives of Operational Support Services further offered substantial percentages of the gross income to be paid direct to the County through the Sheriff's Department should the proposal and commitments be accepted and the Detention Center be erected in Kinney County. The reason for this offer of percentages of gross is that, by law, the U.S. Marshal's Service cannot contract with private enterprise for the detention of their prisoners and all contract agreements must be handled through the Sheriff of a county where the prisoners are to be detained.

The construction, operation, and maintenance of the proposed facility would be at NO cost to Kinney County. The compensation received by Kinney County through the Sheriff's Department was estimated to range from \$250,000.00 to \$600,000.00 per year. The amount depends on the size of the facility and the number of prisoners detained within the facility.

Now, I am no financial wizard, but to me this seemed to be a good way for the county to become more financially stable and be able to ease the burden on the taxpayers of this county with NO cost to the county and NO risk on monies invested. Naturally there were some opponents to the proposal, and although I was surprised at the radical opposition demonstrated by some, I still respected their rights to express their feelings on this matter.

I have tried to present the facts to the people as we have progressed with the proposal. There has never been a final agreement made and the proposal was simply that - a proposal under serious consideration. No final action will be taken without input from the citizens and taxpayers of

Kinney County.

For your information, as of this date, it appears that due to the reluctance on the part of the U.S. Marshal's service and the Immigration and Naturalization Service to agree to contract for specified minimum numbers of prisoners to be detained in the proposed Detention Center, the chances of any final proposal by Operational Support Services to build such a facility have just about been killed. I, for one, am disappointed because the income from prisoner care fees from a Detention Center in Kinney County would have been a tremendous boost to the economy in the forms of jobs for our people and a substantial cash flow direct to the Kinney County General-Fund in addition to an increased tax base on the buildings and property.


At any rate, NO final decision has been made as of this date by neither Operational Support Services nor Kinney County. I just wanted to bring you up-to-date on the matter and will, as promised, keep you advised on any further developments.
