The answer is no - there is no law against picking our State Flower. However, there are laws against criminal trespass - so make sure you're not on private property when you stop to take your annual kids-in-the-bluebonnets pho-

There are laws against damaging or destroying rights-of-way and government property - - so pick a few flowers, but don't dig up clumps of them and don't drive your vehicle

into the midst of them. Remember, Mother Nature and in many cases, your fellow Texans, scattered wildflower seeds along medians and roadways so that everyone could enjoy spring flowers.

For the safety of yourself and others, as well as to limit your ticketability:

There are laws against impeding traffic - - so be careful about slowing down to enjoy the view. Pick areas with light traffic conditions for stopping.

Signal before leaving or entering the roadway.

Park off of the roadway (off of improved shoulders), parallel to the

# Gail FFA Judging Teams - Tough Enough



## Texas State Police Olympics Garza County Sheriff's Department

On June 5th-9th, Deputies Bobby Dean, Mo Herridge and Sheriff Kenny Radke will compete in the Texas State Police Olympics. Held annually at different Texas locations, this competition will be held on South Padre Island. Each year, thousands of law enforcement officers from throughout the state compete in hundreds of events, including basic self-defense, track and field, bowling, power lifting, golf, "Iron Cop", K-9 events and many more.

Last year Garza County Sheriff's Department Team of Mo Herridge, Cliff Laws and Kenny Radke competed well bringing home 4 medals, (3 gold, 1 bronze), and a 4th. place. According to Herridge, that is quite an accomplishment for a small team from a department. compete against big city departments like Houston and Dallas, and some of them send a hundred or more people to compete."

Herridge explained that they competed well because they worked hard. "This year, Kenny and I are bowling about 3-4 hours a week, and Bobby and I are lifting about 10 hours a week. We're putting a lot of time, effort and money

into doing this."

According to Herridge, it will cost around \$2000 for them to compete in the State Police Olympics this year. "We don't know exactly, because we don't know what the entry fees for individual events will be just yet. Plus, there will be the cost of any special equipment we are required to have to compete." He also explained that the cost to cover competing in the National Police Olympics, for those who qualify, is not included.

This year's team isn't competing in the K-9 events, but next year's will. "The department is getting a law enforcement dog this year, but we won't have him very long before the Olympics," said Herridge. "But, next year we'll be ready. Deputy (Memo) Ortiz will be handling the



#### 1995 ARP PROGRAM SIGNUP

The signup for the 1995 Acreage Reduction Program (ARP) ends APRIL 28, 1995. For 1995, the ACR (setaside) requirement for all crops in Borden County is zero. This does not mean that you can plant all the acres that you want. Each participating crop will have a maximum planted acreage. Advance payments may be requested at the time of signup. All other signatures must be received in this office by May 12, 1995.

## SIGNUP AUTHORITY FOR SPOUSES

A husband and wife can sign documents on behalf of each other for CFSA and CCC programs in which either has an interest, unless written notification denying a spouse this authority has been provided to the county office. Spouses cannot sign on behalf of each other for powers of attorney (ASCS 211 or ASCS 211-1). Spouses April 28 must have a power of attorney on file or sign personally for WRP easements, CRP easements, or claim settlements.

## FALL SEEDED CROP CERTIFICATION

Friday, April 28, 1995, is the final date to certify all fall seeded crops (wheat, oats, barley, rye, triticale) regardless of the use. Producers must certify all fall seeded crops for any of the following: a). Small grains intended as RC&D grain for harvest. b) Small grains as cover crops on acres that will be used as ACR or CU, including volunteer stands, and small grain cover already shredded or hayed. c). Small grains for grazing. d). Zero acreage report if you have a base for wheat, oats or barley and the crop isn't planted for harvest.

#### MEASUREMENT SERVICE

You may request for this office to measure small grains for harvest, CU with a small grain cover, or small grain grazed out, for a nominal fee. This request must be made and paid for prior to April 28, 1995.

#### SMALL GRAINS LEFT STANDING

Producers choosing not to destroy their small grain cover have until April 18, 1995 to file a request to leave the crop standing and undisturbed. All acreage of small grains for cover must have a \$10.00 fee filed if you wish to leave it standing.

#### LIVESTOCK FEED

Borden County has been approved for the livestock feed program. This period will run for 90 days, if conditions warrant. Applications for the new feeding period are being accepted now for producers who have suffered at least a 40 percent feed loss and derive at least 10 percent of their gross annual income from the sale of livestock, feed grains, and CRP annual rental payments. Eligibility for feed assistance begins when the application is signed.

## NEW RULE FOR FAILED ACRES FOR 1995

For 1995, if wheat is failed it must be appraised. If the wheat is appraised over 4 bushels per acre, it will not be considered failed. It will be a low yield, and if you plant another crop, such as cotton, on the failed acres they will be considered cotton and not ghost acres. If the wheat crop is appraised at 4.0 bushels per acre or less, it may be approved as failed. The producer would be eligible to (1) plant a "ghost" crop on the acres, and (2) designate the acres as a failed crop for deficiency payment.

## **Big Country** among best in Texas

SWEETWATER -- The Big Country Resource Conservation and Development area has turned yesterday's news into environmental excellence today.

The Big Country RC&D, headquartered here, has been recognized as one of 62 finalists for Award Governor's for Environmental Excellence in conjunction with "Clean Texas 2000."

> Finalist were chosen

from more than 350 applicants across the state - from as small as Shamrock and Panhandle to as large as Houston.

The RC&D was selected for its use of recycled newspaper pellets on farmland. The field work, in conjunction with Auburn University research, spread the pellets cropland in Mitchell, Scurry and Garza counties.

Jimmy Apel, executive director of the RC&D, said the pellets helped prevent erosion of the land. Also, plots treated with the pellets -- in comparison with untreated -- showed higher yields.

From the 62 finalists, 12 winners will be recognized by Gov. George W. Bush at an awards ceremony in Austin on May
