AMERICAN CANCER SOCIETY VOLUNTEERS

American Cancer Society volunteers from 10 counties, including 3 from Kinney County, attended the 1985 Crusade Kickoff for ACS District 27 in Uvalde on Saturday, March 31st.

LaWanda & Norman Butler and Enemencia Starzel of Fort Clark and Brackettville represented the Kinney Unit of the ACS at the kickoff which featured the theme, "WE ARE WINNING". The annual meeting serves as the first official function of the crusade -- the educational and fund - raising drive sponsored by the ACS volunteers each spring.

The 1985 goal for District 27 was announced as 90,600, which includes the Kinney County Unit goal of 2,200.

According to LaWanda Butler, service and rehabilitation chairman, these funds will be used to continue the society's three fold attack on cancer through research, education and patient services. The American Cancer Society is second only to the federal government's National Institute as a source of cancer research funds.

In Texas alone, more than \$6 million is currently invested by the ACS in 12 major hospitals and research

institutions throughout the state.

And all of these funds were raised by volunteers, added Butler.

The ACS also emphasizes the educational aspect of its drive, according to Butler. Our focus for this year's crusade will be the prevention and early detection of colon and rectum cancer, she added.

A highly curable form of cancer if detected early, Butler said colon and rectum cancer will be the feature of a pamphlet called, "Your Colorectal Health Check" reviewed by volunteers door to door at as many homes as possible during April. April has been designated as Cancer Control Month.

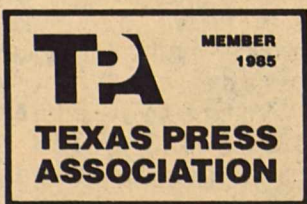

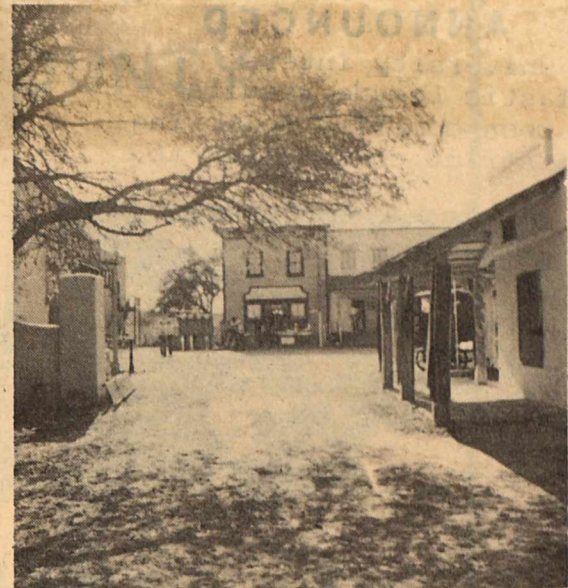
Everyone attending the Cavalry Days celebration is encouraged to dress in the period of the 1870's.

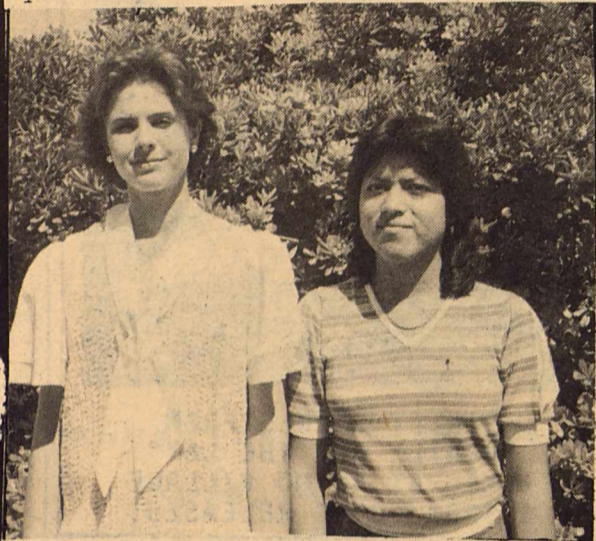

Twenty years ago an old time Texas Ranger by the name of Frank Mills told me that he had lived long enough and had been involved with law enforcement work long enough to know that pro-law enforcement legislation and anti law enforcement legislation swings like the pendulum of an old Grandfather Clock.

He thought at that time, twenty years ago, that the pendulum had been swinging in the favor of the crooks and outlaws long enough and that it would start swinging back in favor of the law

enforcement officers and the good law abiding people they protect and serve. Well, if our Frank were still alive today I am sure he would be disappointed to see that the pendulum has not yet swung back in the direction he was hoping for.

We receive new Supreme Court decisions almost daily that further restrict peace officers in the performance of their duties. We seldom ever receive news of a new law or even a decision by that great court or any other court backing up the peace officers enforcing existing laws.

It is very frustrating to spend hours of hard work trying to catch a ring of burglars or other criminals only to see them tried, convicted, and then released on probation. The hours, days, and often weeks of painstaking law enforcement work, paying strict attention to the paperwork so that you don't lose your case on a "technicality", seem to be wasted when the convicted criminal gives you that over the shoulder smirk as he walks out the courthouse door. As you watch him go you know that sometime in the very near future he will commit another crime, most likely of a similar nature as the one for which he was just convicted and released.

In my opinion there are serious flaws in today's trend toward probation for criminal

violators who are convicted in court for their crimes. This includes juveniles as well as adult offenders. An extremely large percentage of convicted offenders, both adult and juvenile, who receive probated sentences are soon rearrested again.

An example of this was recently proven out by a research team funded by the National Institute of Justice.

In this project the researchers tracked over a 40 month period 1,672 men convicted of felonies and sentenced to probation. Of that total, 1,087 (65%) were soon again arrested; 853 (51%)

were convicted, and 568 (34%) ended up in jail or prison. Of those convicted, about one third were placed back on probation.

The repeaters "tended to commit burglary, theft and robbery, the crimes most threatening to public safety," the report said. Those crimes accounted for 75% of the new charges filed against the probationers.

Although property crimes predominated, the analysis showed that 18% of the 1,672 were convicted of serious crimes following rearrest.

The study, which is the first systematic attempt to

examine the effectiveness of probation as a punishment for adult felons, comes at a time when the nation's probation programs are under unprecedented strain. "Probation has become the predominant sentencing alternative across the country," the report said. The courts impose this sanction in 60 to 80% of ALL criminal convictions.

I have not done an in depth study of our local adult and juvenile probation program, but I can say that a very large percentage of both adults and juveniles who receive probated sentences are re arrested on similar charges before their probation period is up.

I don't have the answer to the problem, and there are many smarter brains than mine at work to come up with a solution, but as my memory serves me I can recall the fact that when I was a child I was sure as hell less likely to commit some misdeed when I knew that I was going to get my britches dusted when I got caught than I was if I thought I could get by with a warning. Something to think about.

WHAT IS A TAX RENDITION?

This public service message from the State Property Tax Board, local taxing authorities and this newspaper explains the process.

A rendition is a report a taxpayer makes which lists the taxable property he owned or managed and controlled on January 1, 1985. A rendition also gives a taxpayer the opportunity to record his own opinion of what the value of his property should be.

Not every taxpayer has to file a rendition, but there are important reasons why a taxpayer may wish to do so.

Renditions must be filed: (1) for all tangible personal property used to produce income; or (2) on any other taxable property if required by the chief appraiser.

Renditions may be filed by any taxpayer who wishes to preserve certain valuable rights.

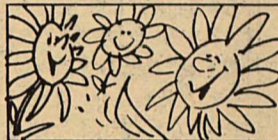
Even if you aren't required to prepare and file a rendition on your property, there are several good reasons why you should do so:

- *By filing a rendition, you have placed on record your own opinion of your property's value.*
- *You create a responsibility on the part of the chief appraiser and the appraisal review board to notify you if they intend to increase the value of your property by any amount over the value you rendered. Further, you have the right to protest to the appraisal review board either the increase in value or any other decision affecting the taxability of your property.*
- *You place your correct mailing address on record, thus ensuring receipt of tax bills. If your tax bill goes to an old or wrong address, you may be liable for penalty and interest if your taxes are paid late.*

Besides a rendition, you may also file a special form called a "report of decreased value," if the value of your property decreased during the preceding tax year for any reason other than normal depreciation. The appraisal office will inspect the property to verify any reported change in appraised value and its cause.

You should file renditions and other property reports with the county appraisal district office any time from January 1 through April 30. The appraisal district has rendition forms available for various types of property, as well as other property report forms.

Your appraisal district can also give you a free copy of the *Taxpayers' Rights, Remedies, Responsibilities!* pamphlet which explains exemptions, appeal rights, and other details of the local property tax system in Texas. Or contact the State Property Tax Board in Austin.

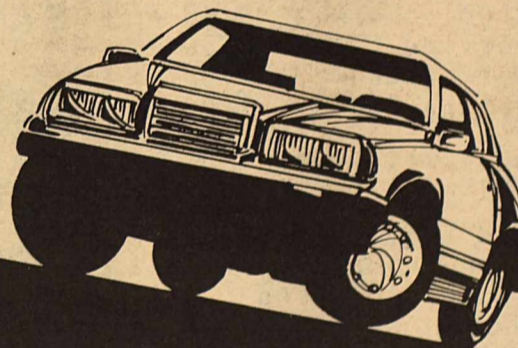
