

HOLIDAY FATALITY

A tragic one car accident July 4th left one on Brackettville youth dead and three injured. The accident occured at approx. 10:00 p.m. on a curve in Ft. Clark when a jeep driven by Jarrett Wayne Rogers, 15, of Ft. Clark lost control of the vehicle on a curve, near the golf course. The vehicle went off the road, slid sideways and then overturned at least one and one-half times, throwing all four occupants out onto the roadway.

Keith Corder, 16, was pronounced dead at the scene by Justice of the Peace Louis Starzel, from massive head injuries. Clinton Hobbs, 16, Henry Schwandner, 16, and Jarrett Rogers, 15, were transported to Val Verde Memorial Hospital for further treatment of their injuries. They were attended to at the scene by members of the Kinney County Volunteer Ambulance crew. Hobbs and Schwandner were admitted to the hospital for further treatment and observation. Rogers was treated and released.

Our most sincere, heartfelt sympathy is extended to the family of Keith at this time of sorrow and loss.

The Kinney County Volunteer Ambulance crew must be praised for their fast, professional response to not

only this accident, but all the other accidents and incidents requiring their services. These people give freely of their time on a non-paid voluntary basis for the sick and injured people of Kinney County and receive very little recognition for their efforts. I know I always breathe a little easier when I am at the scene of an accident with badly injured people scattered about and see the KC Ambulance and attendants coming. I know they are well trained professionals who can take charge of the care and treatment of the sick and injured until they can be transported to a clinic or hospital.

I have asked to be put on the agenda of the next meeting of the Ft. Clark Springs Board of Directors on Saturday, July 20th. At that time, I intend to discuss with the board members the increase in lawenforcement and public safety problems within the confines of Ft. Clark. Although we are limited by law as to action we can take, particularly on traffic cases, there are alternatives that can be and should be considered.

Like it or not, Ft. Clark has grown beyond being a quiet, semi-retirement community, into a small town, bringing with that growth, increased problems, disturbances, and criminal activity experienced by other towns and villages. We must take whatever legal action we can at this time to gain control of the situation for the safety and well being of the residents of Ft. Clark. To do this we will need the

support of not only the leaders of Ft. Clark, but the residents as well. We cannot do it alone.







General Telephone Company of the Southwest in accordance with the Public Utility Regulatory Act and the Rules of the Public Utility Commission of Texas gives notice of its intent to implement new exchange access rates for the provision of shared tenant and tenant resale services.

These proposed rates are applicable to customers of General Telephone Company of the Southwest, excluding hotel/motel customers, who provide local exchange telephone service of General Telephone Company of the Southwest to their tenants or patrons on a resale or shared use basis. This resale or sharing arrangement is normally provided utilizing a customer-provided PABX or other similar stored control switch capable of common control processing or other features commonly associated with a PABX "Smart" switch.

These proposed rates are designed to recover costs on a usage basis for local exchange telephone service access and are identical to General Telephone's "Optional Measured Service" rates. The monthly access rate will be \$28.95 per trunk line and the usage rates

As this is a new service offering, we are unable to determine the number of customers who may be affected. Currently, there are no known prospective customers. Until any customer utilizes this new offering, there will be no effect on the revenues of the telephone company, and in any event, the telephone company does not expect revenues to be affected by more than 21/2 percent. These proposed rates, where applicable, will provide tariffed local exchange access to customers who then will provide shared or resale services to

These proposed rates have been suspended by the Public Utility Commission of Texas and will become effective as proposed or modified by order of the Commission on a date to be determined by the commission.

The proposed rate schedule is on file with the Commission for public inspection and is also available at any business office of General Telephone Company of the Southwest.



C.P. & L. PROPOSES RATE HIKE

Central Power and Light Co. is asking the cities it serves and the Public Utility Commission of Texas for a \$122 million increase in its base rates. This would increase the cost of electric service approximately 14 percent. The change is not expected to appear on customers' bills until after March 1986, almost four years since CPL's last rate increase.

At present the company has the lowest rates of all investor-owned electricgenerating utilities in Texas. The requested increase would put CPL in the mid-range, based on the Public Utility Commission's monthly rate

survey for June.
"The in increase is necessary to recover the costs of providing service to our customers," said Bob Range, CPL's executive vice president and chief financial officer. "All of our non-fuel operating expenses, including operating, maintenance and taxes, have gone up over 30 percent in the last three years. Our present rates are based on 1981 costs and do not reflect those increases. The rate change is also needed to ensure successful completion of our current construction program. This program is vital to the future well-being of the people we serve in South Texas.

The major portion of that construction program is the South Texas Project muclear generating station. CPL is participating in STP to help meet future electrical demands of its service area. The company has more than 500,000 customer accounts, which is ten percent higher than 1981.

"Completion of STP will give us more capacity to serve our customers. It also will provide fuel diversity, and with a fuel which is much cheaper than gas or coal," Range said.

Unit 1 of STP, now 81.9 percent complete, is scheduled to go into service in June 1987. Unit 2, 54.2 percent complete, is scheduled for June 1989.

Range noted that customers do not pay for the actual materials and labor on a plant or other facility until it is in use. The portion of the increase which

will be applied to STP will be used only to pay some of the interest and other carrying costs on the money used to finance construction. This business procedure reduces the amount of money CPL must raise. It also helps keep down the final cost of the plant.

The overall effect of the rate increase will be tempered by two fuel cost decreases since February. The decreases, which amount to a 10 percent drop in energy cost to customers, are the result of CPL purchasing fuel at lower costs and passing the savings on to customers.

A residential customer using 1,000 kilowatt hours a month is now paying \$70.94. Under the proposed rate the customer would pay \$83.02 for the summer use and \$77.96 from. November through March.

A. The leaves on the Alstroemeria, also known as Inca or Peruvian Lily, often yellow and die before the flowers do. You can help prevent this by removing the lower leaves and using a cut flower preservative.

Alstroemeria which come from South America, are relatively new to the florist industry. They should be kept cool, especially at night and removed from both heat sources and drafts.

Two very popular types of Alstroemeria are the pink "butterfly" type and the "Orchid". There are three basic color groups of this lovely flower ... red, pink and yellow, with intermediate shades also available in apricot, sal-
