FIRE ON THE MOUNTAIN CLOGGERS TO PERFORM

The Old Quarry Society for the Performing Arts will present the Fire on the Mountain Cloggers on August 10, 1985, 8:30 p.m., at the Old Quarry Amphitheatre, Ft. Clark Springs.

Direct from an appreance at the 14th Annual Texas Folklife Festival, the Fire on the Mountain Cloggers will perform traditional as well as precision clogging by combining intricate footwork with lively bluegrass music.

A historical presentation on the background of the clog dance includes everything from Cherokee Indian war whoops to Irish step dancing to the English Lancaster clog. Fiddle music recorded by Linda Carolan's late grandfather adds authenticity to Irish and buck dancing sections of the story. Buck dancing, which is closely related to clogging in its origin, provides the audience with a taste of fancy footwork.

Under the direction of Rusty and Linda Carolan, th group performs annually at the Texas Folklife Festival, Night in Old San Antonio and other fiesta events, Wurstfest, San Antonio Livestock Show and Rodeo, plus 125-130 other Future bookings events. include an eight day tour in Venezuela with performances in Valencia and Caracas, Maracaibo.

The Carolans will be among instructors featured at a National Clogging Convention in Louisville, Kentucky in November 1985.

Dvorak has found that many of the events associated with tumor growth resemble those of ordinary wound healing.

"The wound that will not heal" — an old description of cancer — may prove to be a quite literal description.

Dvorak's basic idea is to cut the "lifeline" of the tumor and starve it to death. "This approach is quite different from any currently employed," he

Cook to retain vitamins with a small amount of liquid over a high temperature for a short time by steaming, boiling or stirfrying, suggest the experts at the Food Marketing Institute. Rather than fried or in a salad with mayonnaise, potatoes can be boiled or baked for optimum nutritional value.





NOTICE OF PROPOSED RATE INCREASE BY C.P. & L.

Central Power and Light Co. is distributing postcards this week (July 29- Aug. 2) discussing the effects of its proposed rate increase on customers. This direct notification is required by the Public Utility Commission of Texas.

The postcards provide a close look at the CPL rate case. Important figures in the rate case are highlighted, showing the date CPL filed its rate increase, the proposed effective date for the new rates, and the dollar and percentage amount comparing

the proposed 1986 revenues with actual 1984 revenues.

The proposed increase to base rates will generate additional revenues of approximately \$122 million for CPL-- an increase of about 14 percent over revenues produced by current rates. Therates currently in effect reflect two decreases in the fuel portion of the bill. CPL passed those fuel cost savings on to its customers in January 1985.

Compared to the revenues that were produced by rates in effect during 1984, before CPL lowered the fuel protion of its bill, the increase is only about \$10 million, or about one percent higher.

The proposed effective date for the rate increase listed on the postcard is August 13, 1985. Under PUC guidelines, new rates go into effect no sooner than 35 days after filing. Traditionally, however, the PUC suspends new rates for an additional 120 days. Based on other rate cases, CPL estimates March 1986 as the earliest possible date new rates will be implemented.







District Court was held on July 29th and again on July 31st in Kinney County and several cases, both civil and criminal were heard by District Judge George Thurmond.

A 15 year old Brackettville youth charged with Aggravated Assault and Robbery had his day in court on July 29th. He and another youth were suspects in the May 5th assault and robbery of Salvador Hernandez, 59, of Brackettville. The youths allegedly attacked Mr. Hernandez in the alley behind the Gateway Cafe at approx. 8:30 p.m. as he was walking home. During the assault Hernandez was brutally beaten and cut on the hands with a knife. His injuries have caused him months of pain and several weeks in the hospital for treatment of his injuries, including a severe shoulder separation.

Due to the way the law is designed to protect juveniles, the trial was not technically a criminal proceeding, but was considered a civil process. At any rate, a jury was selected and the presentation to the court and jury lasted two days. After retiring for deliberation, the jury returned a guilty verdict. Sentencing will come later this month. The 15 year old could be remanded to the custody of the Texas Youth Commission (TYC) until his 18th birthday. The other youth charged in the crime was released into the curstody of relatives living out of town several weeks ago.

It is frustrating to see how our laws have changed over the years. Now a days, sometimes seems that the criminals of our society have more rights and protection under the law than do the law abiding citizens. Those with criminal intentions have no restrictions or technical points to consider before going through with their crime. And most of them are aware that they will most likely receive a probated sentence even if they are caught and finally convicted.

Consider the case of a 14 year old San Antonio youth who raped, then cut the throat of his adult female victim, a year or so back. Because he is 14 years old, he cannot be tried as an adult and will most likely be released from TYC on his 18th birthday, and his criminal record will be sealed forever.

Furthermore our laws seem to have developed to the point where the ability to pay determines the number of convictions and punishment. Those who have the financial resources to hire high priced attorneys are far less likely to go to prison for their crimes than those who have to rely on court appointed attorneys who are not really interested in the case and have "plea bargains" on their minds for a quick disposal of the case in question. Oh well, even at it's worst, our system is still the best in the world.

Another case heard before Judge Thurmond that involved DWI violation of probation of Benjamin Tovar, 27, previously

of Brackettville.
Tovar recently was tried before Judge Thurmond and received a 3 year sentence in the Texas Department of Corrections (TDC) for a felony DWI conviction and subsequent revocation of his probation. His attorney filed a motion for a new trial which was denied by Judge Thurmond on July 31st. Tovar is being held in the county jail in lieu of \$10,000 bond awaiting the necessary paperwork to transfer him to IDC.

There was a big turn-out for the benefit BBQ and dance held at the swim park on Ft. Clark last Saturday. The benefit was held for Danielle Blum, the 9 year old daughter of Chuck and Carole Blum, who was struck down by a car last month as she crossed Hwy. 90 , from the Ft. Clark entrance gate. I talked with Chuck and he advised that Danielle is improving slowly and hopes are high that that she will recover soon. It is heartwarming to see our community, friends and neighbors, respond to a common cause such as this and put aside personal and political differences and rally to the aid of one of our own.



Tips To Protect Your Videocassette

Dust, heat, moisture and impact constantly threaten sensitive videotape. Exposure to any of these elements can alter the tape's sensitive magnetic qualities and can hurt the viewing quality of your tapes or erase them completely. Worse yet, poor quality tapes can damage your video recorder. Protect your videocassettes and VCR by following these simple guidelines.

- Keep videocassettes out of direct sunlight and away from water, dust and dirt.
- Because a videotape is easily susceptible to damage, it needs all the protective help it can get. The videocassette shell is intended to be a permanent cover for the delicate videotape. Under no circumstances should the user pry open this protective plastic covering.
- Keep your VCR in top shape to prevent tape damage. Your video dealer will be happy to show you how to



Your videotapes may last longer and play better if you heed these helpful hints.

properly clean and maintain your VCR.

- Take up any slack in the videotape before playing. Just turn the hubs in a clockwise direction until you feel the tension.
- Don't leave the videocassette in the VCR. Remove it when you stop watching it to prevent stretching, slack and wrinkling of the videotape.
- Don't use flimsy paper or cardboard sleeves for storage. They offer virtually no protection against dust or moisture. Always store your

videocassettes in a rugged, sealed case made for the purpose, such as Amaray's Video-Bank*.

- If the videocassettes have been stored in a place cooler or warmer than the viewing area, allow them to sit and acclimate to room temperature for at least 30 minutes before playing to prevent tape damage from condensation.
- Find a cool, dry, dustfree spot for storing your videocassettes.
- Stand them on end, with the empty hub above the loaded hub. This keeps the tape from warping.
- Magnetic fields can erase a videotape. Store videocassettes away from electronic equipment like TVs or stereo speakers.
- Play every tape twice a year to keep even seldomviewed videocassettes in top form. This prevents permanent damage from an uneven rewind and keeps layers of the tape from sticking together.




