

You can't lose your right to vote just by moving, but you do have to be properly registered in your new community to be able to



Anyone who moves should look into registration requirements to keep his right to vote in his new community.

Most likely, your right to vote in your new hometown depends on the date of your move and the state's specific residency requirements. You may find you have not lived in the new state long enough to exercise your right to vote. If so, you can inquire about voting by absentee ballot through the state where you previously lived. Keep in mind there are deadlines for requesting an absentee bal-

TEXANS RATE DOCTORS UP-TO-DATE AND ETHICAL

Texans think doctors are usually up-to-date on the latest advances in medicine, but that they keep patients waiting too long for their appointment, according to a survey conducted for the Texas Medical Association.

The survey also reveals that most Texans believe the professional liability situation has reached crisis proportions and that the tort system needs reform. These and other findings are featured in the January issue of the official TMA journal, Texas Medicine.

Doctors also were rated as having very high or high ethical standards by 58 percent of the respondents. Nine out of ten said it is important to have a personal physician. These findings come from a survey conducted in July by V. Lance Tarrance & Associates, Houston. "We feel we can better serve patients by knowing what they like and dislike about their doctor, according to Dr. Joel Reed, Houston, chairman of the TMA Council on Communication. "That's why we asked that this survey be done."

While 58 percent of Texans said doctors keep them waiting too long, a nearly equal number think doctors to a genuine interest in them and are up-to-date on medical advances.

The article points out that Tarrant, Bexar, and Dallas county folks and those 55 and older have consistently favorable opinions about doctors. Persons with a family income of more than \$50,000 a year are slightly more negative about physicians than the average Texan.

On the broader issue of health care, 76 percent agree government should provide better health care for the poor and elderly. Increased confidence in medicines shown by the 94 percent who said medical science now routinely saves many people who would have died five or 10 years ago.

Seventy-five percent of Texans are keenly aware of the growing crisis with malpractice suits and awards in this country. More respondents said persons are not usually justified when they sue doctors, but are looking for an easy way to

make money. The amount awarded to patients by juries in malpractice suits is usually too much, said 44 percent of the respondents. More than half said there should be a limit on the amount of money that can be awarded to someone suing a doctor.

The telephone survey included 700 adults 18 years of age and older in Texas.

SEXUAL REHABILITATION KEY TO RECOVERY AFTER PELVIC CANCER TREATMENT

Education and counseling can have a great impact on a patient's motivation to resume sexual activity after pelvic cancer therapy, according to Texas Medicine, the official journal of the Texas Medical Association.

The article in the journal's January issue states that treatment of pelvic tumors often hinder a persons ability to function sexually because the tumors are close to the genital area. Authors Andrew C. von Eschenbach, MD and Leslie R. Schover, PhD, need intensive sex therapy. Instead, information on waterbased lubricants, penile implants, hormone therapy, and other appropriate facts can help patients cope with the stress of cancer treatment.

The authors state that education and counseling often can clear up any myths about cancer that mey deter patients from resuming sexual activity. Contrary to what some patients may think, cancer cannot be spread through sexual contact.

Other areas of discussion between patient and physician should include advice on how to resume sexual activity in a non-pressured way, and explanation how cancer therapy will affect sexual desire, arousal, and orgam, and information on treatments, such as hormone therapy. According to the article, patients with a history of marital conflict or individual psychological problems may need to be referred to a mental health professional for moreintensive evaluation early in the cancer treatment process.

FOSTER PARENTING ORIENTATION
OFFERED

Persons interested in becoming foster parents are invited to orientation meeting on Thursday, Jan 23, 7 p.m., at the San Felipe Neighborhood Facility, 200 Bridge St. in Del Rio.

The Texas Department of Human Services trains and certifies foster families to provide temporary homes for children who have been abused or neglected. the goal of the program is to return the children home to a safer environment.

Foster parents may be single, married (at least two years), working couples, military, or retirees. No minimum income is required and financial assistance is provided to defray expenses.

Darrell ZumMallen, Foster Home Development Worker for Val Verde, Maverick, and Kinney counties, said the number of foster homes in the area has not kept up with the rising number of children needing placement in the past year.

"We have only 4 foster fa ilies in Del Rio, 2 in Eagle Pass, and 1 in Brackettville. This is not nearly enough to meet our needs," ZumMallen said.



### DIET CHECKLIST

Are you thinking about going on a diet? Before you spend your money for a particular diet book, class or plan, here are some questions to ask:

Is the effectiveness of the program well-documented or is it based on testimonials by "successful" clients.

Does the program make sensational claims that you can "eat all you want," or "lose ten pounds over night"? If so, what's the scientific evidence for these claims.

Is the program supervised by qualified personnel, such as a medical doctor or registered dietitian?

Does the program focus on diet alone, or does it also include behavior and lifestyle modification for permanent weight control? Does the staff have any expertise in these areas.

Are the diets nutritionally balanced to include foods from the major food groups of protein foods like meat, poultry and fish; fruits and vegetables; dairy products; grains and cereals?

Does the program suggest unreasonably rapid weight loss over a short period of time?

Does the program require the purchase of special foods, devices, supplements, books or other extras, and can the purchase be justified?

## AGRICULTURE JOINS IN FOOD AND FITNESS CAMPAIGN

For asecond year the U.S. Department of Agriculture (USDA) is sponsoring a "Food and Fitness" campaign which extends clear into Kinney, LaSalle and Zavala Counties.

"Some people have trouble seeing the connection between agriculture and diet and fitness," say county Extension agent Sylvia Baker.

"But the health and wellbeing of the American public is largely determined by the nutrition provided from our agricultural products," she explains.

What people choose to eat -


or not to eat - has an important influence on the market for various commodities. And their food choices are often influenced by fad diets and misinformation about the nutritional value, health effects or safety of particular foods, says the home economist.

Also, the more scientists have studied nutrution and weight problems, the clearer it becomes that food is only half the story, remarks Baker. Maintaining a healthful weight is a matter of balancing the calories you take in from food against the energy expended through exercise.

Baker notes that Agriculture Secretary John Block recently announced the theme of the 1986 USDA campaign as "Food and Fitness: An Every Day Event."

In Texas, the Extension Service is carrying out this program to provide the public with realiable information about the total food system - production, consumption, nutrition and exercise, she notes.

The holidays are finnally over and hunting season is closed once again so maybe things will slow down and get back to normal for awhile.

All in all things went smoothly as far as law enforcement problems were concerned. We had the usual rise in numbers of DWI cases, Public Intoxication arrests and civil disturbaces that always come with the holiday and hunting seasons each year.

Game Warden, Bill Lindeman advised me that he had filed 23 cases in J.P. Court this hunting season, most of the cases filed were night hunting cases. The violators paid stiff fines assessed by the respective J.P.'s involved.

Criminal Mischief cases on Fort Clark have increased dramatically over the past few months and though we have increased patrol time on the Fort we have not as yet been able to obtain sufficient evidence that will enable us

to make an arrest. The primary target of the vandals seem to be attacks on vehicles such as tire slashings, broken windows, hood ornaments, etc. Lee Herron has been the victim of several attacks on his property near the old parade ground and Genell Hobbs had two tires slashed on her vehicle as well as a tire cover slashed. The damage in that case amounted to over \$200.00. Tires on seven golf carts were slashed during the same incident which occured on the night of Jan 5th. Also on the same night two golf carts were pushed into Las Moras Creek by vandals and damage was done to a house under

Clark Security and citizens watching out for their neighbors we will eventually get a break in this costly, unnecessary crime spree and be able to make arrests. Be assured that when the break does come the violators will be prosecuted to the fullest extent of the law. It is time that the offenders involved have to pay for their crimes against the law-abiding citizens of our

Those of you who live on Ft. Clark are asked to watch out for suspicious persons in areas where they should not be and to make reports of these sightings to Ft. /Clark Security and/or the Sheriff's Department as soon as possible. With all of us working together we will eventually be able to put these vicious vandals out of business.

Burglars hit two locations in Brackettville on successive nights. The first burglary occured at the Memories Lounge on Hwy. 90, Sunday night, Jan 5th. The burglar entered the building by breaking out a window of the front door and crawling through the opening. Several cases of beer and a German Beer Mug were taken in the crime. The incident was investigated by Chief of Police Jim Lindeman and myself on Monday, and a suspect, Juan Martinez, 31, of Brackettville, has been arrested in the case and is in jail at the time of this writing awaiting trial.

### U.S. POSTAL SERVICE

OATMEAL CAKE WITH COCONUT-PECAN TOPPING (Makes 13x9-inch cake)

- 1 1/2 cups liquid Carnation nonfat dry milk 1 cup quick oats
- 1 cup firmly packed brown sugar
- 1 cup granulated sugar 1/3 cup softened butter
- 1 1/3 cups flour
- 1 teaspoon baking soda
- 1 teaspoon cinnamon 1/2 teaspoon nutmeg Coconut-Pecan Topping

Combine liquid nonfat milk and oats; let stand 20 minutes. Cream sugars and butter in large mixing bowl. Add eggs one at a time; beat well after each. Combine flour, baking soda, cinnamon, and nutmeg. Add dry mixture and oats mixture alternately to creamed mixture; beat well. Pour into buttered 13 x 9 x 2-inch baking pan. Bake in moderate oven (350 $^{\circ}$  F.) 30 to 35 minutes or until

toothpick inserted in center comes out clean. Cool 10 minutes. Spread warm cake with Coconut-Pecan Topping while still in pan. Broil 5 inches from heat, 1 to 2 minutes or until bubbly and brown. Cool in pan. Cover with foil for transporting.

Coconut-Pecan Topping: Combine 1 cup firmly packed brown sugar, 1/3 cup butter, and 2 tablespoons water in small saucepan; heat until butter is melted. Stir in 1 cup chopped pecans and 1 cup flake coconut.


