An aching back has been called the great American pain because so many people are affected each year. Backaches are one of the most common causes of work days lost through illness, says the Texas Medical Association.
The vast majority of backaches are often called "non-specific" because they have no obvious causes. There are allso no obvious, easy cures. Most non-specific backaches are probably due to a strained ligament that causes surrounding muscles to go into painful spasm. Some people, however, tend to develop back pain when they are under stress, just as other people commonly develop tension headaches.
Although a non-specific backache is often very painful, there is virtually no risk of complications. Such backaches generally heal without treatment, but unfortunately they also tend to recur.
There are several things you can do to protect your back and lessen your chances of backache. When lifting heavy objects, keep your back straight; bend your knees and let your legs do the work. Avoid high heels; they force your stance into an unnatural position that strains your back. Select a firm, highbacked chair whenever you sit and use a cushion to support the small of your back. Sleep on a fairly hard bed and use a relatively flat pillow or none at all. If you are overweight, try to lose weight. It strains your back to carry extra weight.
If you do get a backache, there are measures you can take to ease pain and speed healing. Take simple painkillers such as aspirin or aspirin substitutes as instructed on the package. Apply heat to the painful area to ease discomfort. Lie flat on your back for as long as you can on a bed with a fairly hard mattress. It may help to put a pillow under your knees.
If your backache persists for more than three or four days despite these measures, consult your physician.

## THE BARON DEURBROUCQ

Fredell Lack, the brilliant violinist who will be heard on Saturday, Feb 15 at the Grand Opera House, plays one of the most famous Stradivarius violins in the world, the Baron Deurbroucq, named after the Prussian nobleman who one owned it.

The artist, who has been acclaimed as "a violinist of the first rank" (Salzburger Nachrichten) chose the Baron Deurbroucq blindfolded from among half a dozen other instruments. After playing a few notes, Miss Lack knew that this was "her" violin. When the blindfold was removed, she was told that she had chosen one of the most famous of all Strads.

The violin, which dates from 1727, was made when Antonio Stradivari was eight-three years old, almost at the end of his long life, and his violins are said to have become more perfect as he grew older. The Baron Deurbroucq, one of the large instruments typical of this later period, has a purity and warmth of tone that modern violin-makers have never been able to equal.

In the past two centuries, the instrument has passed through the hands of several celebrated European violinists. When Miss Lack first played it, it had been locked in a vault in Boston for almost thirty years - yet it was in perfect condition.

Miss Lack's husband jokingly refers to the violin as "her child by a previous marriage".

Care for the instrument is, in fact, an important part of Miss Lack's work routine. She has her own ingenious methods of keeping the instrument in good playing condition despite frequent changes of climate which considerably affects an instrument as sensitive as this one.

When Miss Lack's concert tours take her to regions which are extremely hot and dry, she always travels with half an apple tucked in her violin case. The apple imparts the necessary moisture to the instrument. In very damp regions, Miss Lack leaves the violin case open in a closet overnight with the electric bulb burning.

In the Baron Deurbroucq, a great artist has found a great instrument. When she draws her 150 year old Tourte bow across the violin strings, the result is music of unsurpassed purity, vibrancy, color, and beauty.

## HEALTHY HEARTS MAKE GOOD

 VALENTINE PRESENTSHeart-shaped cards are a traditional way to "I love you" on Valentine's Day. The Texas Medical Association suggests that ensuring the health of human hearts is another lasting way to say the same thing.

Preventing heart disease through good health habits, recognizing the early signals of a heart attack, and learning cardiopulmonary resuscitation, or CPR, are three ways you can affect your own and other's health.

Good health habits for preventing heart disease include not smoking, watching your blood pressure and getting relatively high in unsaturated fats. Other risk factors you can control are diabetes, and excess weight. A program of regular exercise and avoiding severe stress when possible also can be protective.

Knowing the early signals of a heart attack and how to help a possible heart attack victim are important. The most common symptom experienced by heart attack victims is chest pain; but this can differ among individuals. Most often the pain is in the midchest sometimes it radiates to the neck or left shoulder or goes down the left arm. Victims often experience weakness and
shortness ot breath.
patient acutely ill with a heart attack will appear pale and cool, but may be sweating profusely.

If someone around you experiences heart attack symptoms, you can best help-possible save a life--if you know several things: 1) the fastest route to a hospital equipped to $r_{1}$ andle heart attack emergencies; 2) how to do CPR; and 3) how quickly to call a doctor, the hospital and/or an ambulance.

CPR is a technique that can keep a heart attack victim alive until an ambulance and medical treatment available. It can be learned in only two or three hours and requires only minimal practife thereafter. In your own area, you can find out where CPR instruction is available through your local American Red Cross chapter

This week's column will be devoted primarily to bringing you up to date on the increase in felony auto-theft in Kinney County and the fact that the "Guatamalan Connection" is still in operation along our border and our larger cities. This large scale international auto-theft ring is costing the citizens of Texas hundreds of thousands of dollars annually in stolen automobiles and insurance coverage. Auto theft is on the increase in ourcounty with five reported since Jan 1, 1986. A list of the stolen automobiles and their estimated value is shown below.

Vehicle \#1 - a 1970 ford pickup registered to S.L Vincent of Spofford, this vehicle, valued at $\$ 1,100.00$ was taken on Jan 1, 1986 from the carport at the Vincent residence in Spofford. It was entered into the TCIC computer and was recovered abandoned neaar Belton in Bell County on Jan 8, 1986.

Vehicle \#2 - a 1979 ford pickup owned by Clyde Earwood of Del Rio, Tx was stolen from his ranch in northwest Kinney County on Jan 27, 1986. The vehicle, valued at $\$ 1,000.00$ was recovered abandoned near Bastrop on Jan 28, 1986.

Vehicle \#3-a 1982 Ford pickup owned by Domingo Villarreal of Brackettville was stolen from the parking lot of the Stop $N$ Shop Grocery the night of Jan 11, 1986 The pickup, valued at $\$ 5,000.00$ was recovered that same night on Hwy. 90 near the county line west of town. The suspect, an 18 year old illegal alien, was arrested at the scene.

Vehicle \#4 - a hunting jeep owned by hunters from Houston was stolen from the Pat Rose Ranch in northern Kinney County the week of Feb 3 , 1986. It was valued at over $\$ 1,500.00$ and was recovered abandoned in heayy brush several miles away near a highway.

Vehicle \#5 - a 1982 Chevrolet 4 -wheel drive pickup was stolen from the pinon Ranch in northern Kinney County on Feb 6, 1986. This vehicle, valued at over
$\$ 1,500.00$ has not been recovered at t fetmeof thits

The five vehicles shown above are valued at over $\$ 10,000.00$ and though four of the five have been recovered, the owners of the recovered vehicles still had to shell out cash money for wrecker fees and expenses related to returning the vehicles to Kinney county. All five vehicles are believed to have been stolen by illegal aliens passsing through our county. If this trend continues we will set an all time record for stolen automobiles in Kinney County before the year is out. This is certainlya record we do not want to have. There is no way that the Sheriff's Department or any other law enforcement agency can prevent this type crime under the present circumstances. My suggestion to car owners is to take the keys from your vehicle every time you leave it. Lock the doors and park it in a well lighted area. If you are going to leave your vehicle unattended for several days in an unprotected area, remove the battery. Until our government takes the necessary steps to control and/or stop the tremendous flow of illegal aliens into our country (and don't hold your breath for that) the problem of felony crimes will continue to increase. Who bears the primary cost of those crimes, you and I, the tax-paying public and citizens of the United States.
The arrest of a 62 year old Mexican National driving a stolen vehicle in the early morning hours of Feb 4, 1986, has caused further investigation into the 1984 "Guatamalan Connection" autotheft cases. The man was arrested by this officer after we received a report from the Uvalde Police Department that the stolen vehicle had been sighted leaving Uvalde towards Brackettville on Highway 90. The vehicle, a 1985 Toyota pickup valued at over $\$ 15,000.00$ was recovered and returned to the owners. The suspect remains in the county jail in lieu of a $\$ 5,000.00$ bond. His case will be presented to the Kinney County Grand Jury on Feb 13, 1986.
