An international barbecue cookoff will draw expert cooks from throughout the country with a petting zoo and horse racing to be offered at the fairgrounds.

A carnival will be held at the fairgrounds to entertain the young at heart with two full days of entertainment planned at the three stages that will be in continual operation.

DUDLEY HARRISON STATE REPRESENTATIVE FILES BILL

Austin--State Representative Dudley Harrisoon, D-Sanderson, played a big role in the recent special sessions of the legislature. As a member of the Appropriations Committee, he was able to guard against cuts in the Agriculture Department and to keep Sul Ross cuts down to a minimum. Representative Harrison also filed and passed H.B. 81, a bill to raise the state highway speed limits, and he was appointed to serve on the Joint Committee on Liability Insurance and Tort Law and Procedure by the Speaker of the House.

While the average cut in Higher Education was 10.7%, Representative Harrison fought to keep Sul Ross's appropriations intact. Sul Ross loss only 3.1% of it's appropriated funds for fiscal

year 1987.

Representative Harrison attended the Conference Committee meetings in order to keep close tabs on the cuts in the Agriculture Department, of which he is Chairman for Budget and Oversight for the Agriculture and Livestock Committee. The U.S. Congress will soon be passing a bill to allow states to raise their speed limits to 65 miles per hour in some rural areas. thanks Texas, Representative Harrison, will automatically raise the speed limit when Congress enacts this bill.

SHERIFF'S CORNER NORMAN HOOTEN

This week's column will be primarily a summary of the activities of the Sheriff's Department for the past fiscal year ±1985-862 which ended on September 30th. I will summarize crimes reported versus crimes cleared by arrest, value of stolen property versus value of stolen property recovered, and give a brief breakdown on income received by the Sheriff's Department for prisoner care fees and the cost of feeding the prisoners. Total operational costs are not available at this time as I will have to wait until the annual audit is complete before these cost are tabulated.

NOTE; It is believed by investigators that all stolen autos were taken by illegal aliens. This belief is caused by evidence at the scenes of the crimes and the Method of Operation used by the car thieves and the fact that most of the stolen cars were recovered abandoned in the interior of Texas on highways commonly used by illegal aliens. Of the four vehicles that have not been recovered as of this date, one has been located in Mexico and we have not been able to breach trhe tangled web of red tape caused by Mexican authorites. The otherthree unrecovered vehicles have not been located.

I recently compiled a report for the U.S. Border Patrol on crimes committed in Kinney County since January 1, 1985 that have been directly linked to illegal aliens. In this report it was determined that 41 crimes were involved with a

total value of stolen or damaged property being \$132,506.95. There was a total of \$84,325.00 recovered and only fact that illegal aliens are pouring through our county in such high numbers and are very mobile. They are also extremely hard to identify and most have no prior records in the U.S. or Texas thereby having no identification files on hand with various law enforcement agencies. They hit and run, usually leaving little evidence with which to trace them. As the records show, crim in our county caused by illegal aliens is very expensive and approx. 90% of all fewlong crimes being committed in our county at this time are being committed by illegal aliens.

I was recently approached by Mr. and Mrs. Dick Lamb, Safety Coordinators with the National Child Safety Council, they presented a program designed

to make parents and children more aware of safety precautions that can be taken to protect our kids. program will be primarily for children from kindergarden through the 6th grade. Handouts and other material will be provided to children of those ages later this year as soon as the printing is completed. I will coordinate this with school officials. This program would not have been possible without the generous donations of the following citizens and businesses: First State Bank of Brackettville, B & S Grocery, C & L Minimax, Burger & Shake, Alamo Village, The News-Post, Frontier Gallery, Sagebrush Shoppe, Southwestern Communications, Dennis Slubar, Ft. Clark Springs, Kinney

County Land Company, and Rio Grande Electric Coop.

We should all be thankfull these citizens have shown their desire to join with me in a program that will better educate our youngsters in safety habits and information that may prevent injury, death, or heartache later on.

The Kinney County Sheriff's Department took in a total of \$197,708.00 in prisoner care fees through the county jail for FY 85-86, the breakdown is as follows: Bureau of Prisons, \$142,828.00, US Marshalls, \$48,244.00, US

Border Patrol, \$6,636.00.

There were 28,199 meals served prisoners at the jail at an average cost of 95 cents per meal. I had predicted that we would take in \$204,000.00 in prisoner care fees for FY 85-86 and we would have made it had we not cut down on prisoners during the month of February in order to paint the jail interior and do other repairs.

other repairs. The FY 86-87 budget for the Sheriff's Department and County Jail, including salaries has been set at \$199,553.34. We have estimated an income generated by prisoner care fees at \$200,000.00. This means that the Sheriff's Department and County Jail is self supported without placing a burden on the taxpayers of this county. Therefore the county can use funds generated by taxes and other sources for other projects.








Activity Center Dedication

Teenagers And Nutrition

BRIDGING THE GAP

American teenagers find themselves coping daily with the trials of growing up, doing well in school and merely being accepted by their peers. Small wonder, then, that good nutrition is very low on their list of priorities.

Nutritional deficiency in teens has become prevalent enough to cause concern among health professionals. The statistics speak for themselves; as much as one-third of the teenage population is not getting enough of at least two nutrients such as vitamins A, B6, calcium and iron in their diets.

Teenagers' nutritional needs increase between the ages of 11 and 20. Teenage boys experience a rapid growth spurt during this time, increasing their need for certain nutrients. For teenage girls, the onset of menarche changes nutritional needs, especially

for calcium and iron.

Often, these increased needs aren't met. Studies show that as many as one-third of adolescent girls are on weight-reducing diets at any given time, and that many of these diets contain improper amounts of protein and other essential nutrients. When they are not trying to lose weight, teen-



agers' diets often include high-calorie/low-nutrient-density foods such as desserts, sugared sodas, fats and oils, that are also nutritionally deficient.

Drug and alcohol abuse can also contribute to nutritional deficiency in teens. Most teenagers know about the dangers of addiction and overdose; what they may not know is that drugs, cigarettes and alcohol interfere with the body's nutrient absorption.

Health professionals recommend teenagers get more exercise (since today's teenagers are much more sedentary than in the past) and develop increased awareness of the daily nutritional needs of a healthy, growing body. A balanced vitamin/mineral supplement may also be a wise consideration to make sure that requirements for vitamins and minerals are met.

SOUTH TEXAS REGIONAL BLOOD BANK

Brackett High School will sponsor a blood drive Tuesday, October 14 from 2 to 6 p.m. The community is urged to join high school students in giving blood to help patients in neighboring south Texas hospitals.

All types of blood are needed, but type 0 blood donors are especially in demand at this time. Type 0 is the most common blood, and is therefore used the most for treating hospital patients.

Blood collected in Brackettville is taken to the South Texas Regional Blood Bank in San Antonio for extensive testing and processing. It is then returned to communtiy hospitals as needed for patients.

The Brackett High School blood drive will be held in the home economics cottage from 2 to 6 p.m. Donors should be between the ages of 18 and 66, in good general health, and weigh at least 110 pounds (17-year-olds may also donate with written parental consent).
