

COURTHOUSE CLOCK - HISTORICAL MARKER?

Plans may be underway to make the Couthouse clock more accessable to the public.

Due to the age and the history of the clock, David Blair, who has repaired and set the timepiece for the past 8 1/2 years, would like to place it in the National Register as an Historical Marker. In order for this to be accomplished, the clock must be made easily accessable to the public.

Blair, who has been working on clocks for 25 years, does not get

paid for the work he performs on the County clock. He is, however, able to write articles about the clock in the National Clock and Watch Collectors Association Eulletin which has over 106,000 members in the United States. Many members of this association may visit Brackettville in order to see our historical clock.

Another clock of the same design is placed in Fort Davis. It was positioned just one month and ten days after ours in 1910.

TO ALL INTERESTED AGENCIES, GROUPS AND PERSONS:

On or about February 2, 1987, the above named City will request the Texas Department of Community Affairs to release Federal Funds under Title I of the Housing and Community Development Act of 1974, as amended, for the following project:

Project Name: Elevated Storage Tank.

Contract Number: SF06211

The Subject Project is located entirely within the City of Brackettville, Texas. The grant funds are proposed to be used to replace the existing 75,000 gallon elevated water storage tank with a new tank of same capacity. The existing legs will be retained and will be sand blasted and painted. No additional storage capacity will be created.

FINDING OF NO SIGNIFICANT IMPACT

It has been determined that such request for release of funds will not constitute an action significantly affecting the quality of the human environment and accordingly the above named City has decided not to prepare an Environmental Impact Statement under the National Environmental Policy Act of 1969.

The reasons for such decision not to prepare such a Statement are as follows: (a) There will be no increase of storage capacity; (b) No new site will be involved as the new tank will replace the old tank at the same location and using the same supporting legs; (c) construction will be of short duration only; (d) no additional visual or altered conditions affecting the environment will occur; (e) the ambient environment of the city and the immediate area of the project will not be altered.

An Environmental Review Record respecting this project has been made by the above named City which documents the environmental review of the project and fully sets forth the reasons why such statement is not required. This Environmental Review Record is on file in the office of the City Manager located within the City Hall. Such documents are available for public examination and copying, upon request between the hours of 9:00 a.m. and 4:00 p.m. weekdays.

Public Comments on Findings

All interested agencies, groups and persons disagreeing with this decision are invited to submit written comments for consideration by the City to the City Manager on or before January 18, 1987. All such comments so received will be considered and the City will not request the release of Federal Funds or take any administrative action on the within project prior to the date specified in the preceding sentence.

Release of Funds

The City of Brackettville will undertake the project described above with Texas Community Development Program funds from the Texas Department of Community Affairs (TDCA) under Title I of the Housing and Community Development Act of 1974, as amended. The City of Brackettville is certifying to the Texas Department of Community Affairs that The City of Brackettville and Mayor William Mendeke in his official capacity as Mayor of the City, consent to accept the jurisdiction of the Federal Courts if any action is brought to enforce responsibilities in relation to environmental assessments, decision making, and action; and that these responsibilities have been satisfied. The legal effect of the certification is that, upon its approval, The City of Brackettville may use the Texas Community Development Program funds, and the Texas Department of Community Affairs will have satisfied its responsibilities under the National Environmental Policy Act of 1969 and 24 CFR Part 58.

OBJECTIONS TO STATE RELEASE OF FUNDS

The Texas Department of Community Affairs will accept an objection to its approval only if it is on one of the following bases: (a) that the certification was not in fact executed by the chief executive officer of the Contractor approved by TDCA; or (b) that the Contractor's environmental review file for the project indicated omission of a required decision, finding or step applicable to the project in the environmental review process. Objections must be prepared and submitted in accordance with the required procedure (2 4 CFR 58) and may be addressed to the Texas Department of Community Affairs, Community Development and Housing Division, P.O. Box 13166, Capitol Station, Austin, Texas 78711.

Objections to the release of funds on bases other than those stated above will not be considered by the Texas Department of Community Affairs. No Objection received after February 5, 1987 will be considered by the Texas Department of Community Affairs.



Once again the bugle echoes in the mountains around Ft. Davis, but it is peaceful and green in the misty dew.

There was a time when the valley was not so peaceful, when over the Pasos de Rosas came only the soldiers and pioneers on their way to California or Chihuahua, Mexico. Then the hills echoed to the war whoops of the Comanche and the Apache. Some travelers did not reach their destination, but perished in the mountains and canyons at the hands of the Indians. The Spanish Trail was marked by the burned wagons and bones bleaching in the sun.

Following the Mexican War of 1846-47 when the vast territory of New Mexico, Arizona and California was added to the United States, and Texas had joined the union, gold was discovered in California. People started to migrate to the gold fields, and an important part of the southern route was the San Antonio-El Paso road, hundreds of wagon trains began to travel this trail.

George H. Giddings obtained the mail contract and started the first stagecoach service in 1853. James Birch with his famous "Jackass Mail", took over the service in 1857 and two years later the Butterfield Overland Mail began to run between St. Louis and San Francisco.

From the west, the Mescalero Apaches from New Mexico crossed this trail on their raids. From the east the Comanche War Trail crossed the road at Comanche Springs, which became the site of Fort Stockton, now Fort Stockton, Texas.

By 1854 the situation was so desperate the military in San Antonio was compelled to build a fort in west texas to protect the travelers on the southern route. In October, 1854, Major General Persofor Smith made a trip along the trail and selected a site near Creek in the mountains. The new fort was named Fort Davis in honor of Secretary of war Jefferson Davis, who later became President of Confederacy.

Six companies of the 8th U.S. soldiers to their death. Later he Infantry under the command of Lt. tried to lead others to the scene of the battle but was never able to build and occupy the Fort. do so.

Seawell wasn't at all pleased with

the location, because of the boulders surrounding the fort, any attackers could be upon the garrison before being seen, and Col. Seawell felt the fort should be more favorably located. But orders were orders, and sixty pineslab buildings were erected in a way up and down the canyon. In the future the Col. hoped to build a more organized post near the mouth of the canyon and more in the open.

Within the seven years of Col. Seawells command, he did build six stone barracks across the mouth of the canyon. But the officers were still quartered in the ramshackle log huts and the supplies were kept in falling down warehouses roofed with canvas or thatched with grass.

The 8th Infantry, on foot or muleback, were supposed to escort the mail and freight wagons through the territory. What little contact they had with the raiding Indians was un-important because the soldiers were always just too late.

Sometimes the Cavalry used the Fort as a base for various expeditions against the Indians. New forts were built along the trail namely, Hudson, Lancaster, Stockton and Quitman.

In 1857 to 1860, camels were imported and tested on the desert at and near Fort Davis, but the project was abandoned due to the rocky ground. The eamels learned to step on the cactus and crush them, but the rocks cut up their feet. Some of the herd were turned loose to roam, and in the late 1890's they were still sighted in the vicinity.

The Indian problem was still large, but because of the start of the Civil War and the secession of Texas, the dept. commander Gen. David E. Twiggs, ordered the forts along the Spanish Trail abandoned.

In June, 1861, the Confederate Troops occupied the closed forts, and seemed to have friendly relations with the Apaches until August, 1861. At this time Chief Nickolas turned against the Confederates and stole some horses and cattle from the corrals in Fort Davis. Lt. Rueben E. Mays, took thirteen men and started in pursuit of the marauders. The Apaches led the soldiers deep into the Big Bend country, where in a canyon Chief Nickolas had 80 to 100 warriors hidden on both sides of the trail. The only survivor was a Mexican guide in the employ of the soldiers. And to this day, some believe he was used to lead the Later he soldiers to their death. tried to lead others to the scene of the battle but was never able to

Somewhere in that rugged country, thirteen soldiers and their officer lay with their sabers rusting in the sun and rain.

In the spring of 1862, garrisons of the west Texas Forts accompanied the retreating Confederate Army back to San Antonio and the forts were again abandoned. Fort Davis was further wrecked by the Apaches and lay deserted for five years. In 1867, under the command of Lt. Col. Wesley Merritt, a famous Cavalry general of the Civil War, and the fort was manned by four troops of the 9th U.S. Cavalry, a colored regiment. Only then was the fort to look and be like Col. Seawell had dreamed. The first buildings were built of stone but due to the lack of funds, the last were built of adobe and the project was again delayed. The Indian problem was finally whipped in the 1880's and fifty structures were built and occupied by twelve companies of both Infantry and Cavalry troops.

* HOPPIN' JOHN

2 cans blackeye peas (heated)
1 cup chopped ham
1 cup finely chopped onion
1/2 tsp. hot pepper sauce
2 tblsp. oil
1/2 tsp. salt
3 cups steamed rice

Saute ham, onions, hot pepper sauce in oil over moderate heat for 3-5 mins., stirring frequently until onions are soft but not yet browned. Combine blackeye peas, ham

mixture and rice; then heat. Garnish with thin slices of ham and serve with mustard greens and hushpuppies.

* HUSH PUPPIES

1 cup yellow cornmeal

1 cup white cornmeal

1 1/2 cups flour

1 tsp. baking powder

1 1/2 tsp. salt

1 tblsp. melted butter

1 1/4 cup extra fine chopped onion

Add to this mixture 1 beaten egg and enough milk (about 2/3 cup) to make soft dough, but stiff enough to form a tablespoon size ball. Cook in deep oil at 375-400 degrees until deep brown in color (4-5 mins.)

CADETS TO PERFORM AT UVALDE'S OPERA HOUSE

The Texas A&M Singing Cadets will perform on stage at Uvalde's Grand Opera House on Thursday, January 15, 1987 at 8:00 p.m. This will be the second appearance in Uvalde for the all-male glee club who have appeared in every major city in Texas. Their last performance at the Grand Opera House was completely sold out.

In recent years, the widely acclaimed choral group directed by Robert L. Boone has won approval in Bay City, Midland, Orange, Gainsville, Beaumont, San Angelo, Gonzales, Jasper, Lake Jackson, Stephenville, El Campo, Refugio, Vernon, Kingsville, and other towns.

State boundaries, however, do not hinder the Cadets. They've "said it with music" in Louisiana, Arkansas, and Chicago, Illinois. The latter was before a national convention of hospital administrators.

The Singing Cadets appeared in the White House by presidential invitation in 1971. In 1974, a summer "Ambassadors for Friendship" tour took the glee club on a three-week, 3,100-mile swing along the Danube River, through the Carapathian Mountains to the Black Sea Coast in Romania. In the summer of 1983 the Cadets traveled

to Mexico to compete in an International Music Festival.

The Singing Cadets have taken the "Voice of Aggieland" to national television and joined other groups in special performances. Most recently they teamed with the Houston Symphony for one of the most unique performances in their storied history.

Recordings have been released by the Singing Cadets, with more on the way. They have appeared on a commercially-released single, backing Sergio Franchi in "No Man Is An Island." The television camera has also focused on the group many times. They have appeared with Franchi on the Ed Sullivan show and performed on the Mike Douglas Show. The Texas A&M Cadets made seven appearances on the nationally televised Miss Teenage America Pageant.



Archeologists won't find much at the city dump

I had always figured that archeologists a thousand years from now, if there are archeologists a thousand years from now, would be able to piece together an accurate picture of our society rather easily, simply by locating the city dump and excavating.

I no longer believe that. At least it won't be an easy

Nothing halfway usable gets buried at our city dump.

Recently, after agonizing over each item, I loaded up a small trailer with an accumulation of treasures there just no longer was room to store. It was not yet 9 a.m. on a Sunday morning when I backed up to a machine-made gulch at the dump.

A salvage crew in Day-Glo vests was already on hand

And they were not fooled by the topping of tree branches camouflaging the load. By the time I had finished flinging the limbs into the ravine, two men were on hand to inspect the other items.

It had been hard enough to decide to turn loose of all that good stuff. Seeing others standing ready to grab it up was almost enough to make me head back home with it

First to go was a carpetsweeper that wasn't broken but had never picked up anything in it's life. This was the kind without a motor. You just pushed it back and forth and it was supposed to, but didn't, clean up the mess on the carpet.

One of the orange-vested men actually broke into a trot getting back to his pickup with it.

The other guy, meanwhile, was methodically making a little pile of his salvage.

Using the trash can carrier with no wheels as container, he stacked in the plastic wall decoration of five Oriental girls playing samisens, a light that used to hang over the dining room table until a fire and a non-retracting retractor caused its replacement, a lawn chair with no webbing on the seat, and a lawn edger with a burned-out motor.

But both men ignored a perfectly good couch frame that only needed upholstering, new plywood up to four feet square and several heavy timbers with only a few barnacles on them. I was to learn later they probably came back for these things, too.

Who are these people who pick over your trash, making you wonder how you could have been stupid enough to throw such good things away?

Well, they are people who think they can recycle it, sell it

Cefe Valenzuela, superintendent of the Corpus Christi Sanitation Division, said the city started letting bids out on the salvage rights about six years ago because many persons thought that casual salvagers were city employees who shouldn't be doing that type work on city time.

And, believe it or not, a contractor pays the city \$280 a month for these scavenging rights, and then has to hire people to sift through the debris.

Lonnie Dearman who oversees operations at Corpus Christi Greenwood fill and the Westside fill said wood, bedding, usable tires and fixable items go to a couple of men who take them to Mexico. Metals of all kinds go to local scrap metal yards.

"Americans are the most wasteful people in the world," Dearman said. "If you don't believe it, just work at a landfill for awhile.

We throw away perfectly good things, he said, like a lawnmower that only needed a new spark plug.

So now I don't know where the future archeologists will finally run our artifacts to earth. As long as the things are recognizable, it seems they are likely to get used again in some fashion.

It may just be that an archeologist himself will still be trying to get my old carpetsweeper to work in the year 2986.



Brad's Car Care

Check tire pressure periodically. All you need to check this with is a tire pressure gauge. You can use the one on the service station air hose, but these are notoriously innacurate. You'll find the correct pressures either in your owner's manual or on a sticker found on the glove compartment door, gas cap door or inside the doorjamb. Check the pressures with the tires cold. Heat causes the air pressure inside the tire to increase several pounds. Recommended tire pressures are always given for cold tires. If you live in a part of the country that has cold winters, it's a good idea to check your tire pressure when the weather starts to get cold.

To check tire pressure, remove the valve stem cap and firmly press the gauge on the valve stem. You'll hear a slight hiss of escaping air when applying and removing the gauge. If the pressure is low, add air until it reaches the correct pressure. Never let air out of warm tires to bring them down to the proper cold pressures. Many new cars have radial-ply tires which look slightly underinflated, but don't go by looks.

DRUNK DRIVERS ADD RISK TO HOLIDAYS

Getting into the spirit of the season by drinking too much alcohol can have deadly consequences, particularly if the drinker tries to drive.

The National Highway Traffic Administration, Safety Drunk National sponsored and Drugged Driver Awareness Week December 14-20, estimates nearly half the deaths on America's highways involve alcohol. In 1984, for example, more than 23,500 persons in the U.S. died in crashes in which alcohol was a factor.

"Alcohol is a drug," said Dr. Bernstein, Texas "And like Commissioner of Health. any other drug that slows reflexes, limits coordination, or dulls responses, liquor bottles should bear labels that say: "Don't Drive When Taking This Medication."

To stay alert and sober when drinking, most persons should limit their alcohol consumption to two drinks or beers within a two-hour period. Consuming three or four drinks within two hours will cause a drinker's decision-making driving skills to be diminished markedly. More than four drinks or beers consumed in two house will drinkers to have enough cause alcohol in their bloodstreams to be drunk.

It takes about an hour for each ounch-and-a-half of liquor or 12ounce beer to be metabolized.

Eating foods rich in protein and carbohydrates can help slow the absorption of alcohol into the bloodstream, but food will not keep someone from getting drunk. will coffee or cold showers.

Hosts can help guests avoid drinking too much by refilling glasses at a slower rate, having plenty of food available, and

offering a variety of non-alcoholic beverages.

Because new laws have made hosts, restaurants, and drinking establishments liable for the actions of their inebriated guests or customers, many communities are arranging taxi service to transport persons unable to drive safely.

Dr. Bernstein also recommends a "designated driver" plan, in which person in a group volunteers drink and to assumes responsibility to drive the others home.

More than 8,000 persons in the U.S. between the ages of 16 and 24 were killed in alcohol-related crashed in 1985. Of these, more than 6,200 were in accidents in which the driver was intoxicated. Statistics show that alcoholrelated fatal crashes are about three times greater at night than during the day.

"If we can stop people from drinking and driving, we can prevent many needless deaths," Dr. Bernstein said.

Home Hints

FOILED AGAIN — If you're like most people, you usually wind up with small, odd pieces of aluminum foil you just hate to waste. Take these and roll and wind them into long strips until the thickness of about two pencils. Shape in an "S" and use in a pan to rest meat on when you're grilling it so it won't sit in the fat. They can be used time and again, washed in the dishwasher, made into any shape, size or length. It saves scrubbing the grill and is perfect for grilling steaks, lamb chops, etc. Tammy N., Cherry Hill, N.J.

SOFTENER TIP — When I got my clothes dryer, I found myself with a lot of liquid fabric softener I no longer had any use for since I enjoy the fabric softener sheets much better. I decided to experiment and make my own. This is the result: put a small amount (about ½ oz.) of the liquid into a pint of water. Dip an old bath cloth that has been cut into squares in the solution and squeeze it out. Put the cloth in the dryer and dry, then toss it into dryer loads. It works very well for towels and sheets.
