

SHERIFF'S CORNER Norman Hooten Sheriff

Writing this column every week sometimes seems to become a heavy load. I have to have my copy ready for deadline so the editor has time to get it into print and often I will be involved in a criminal investigation (or 2 or 3) or some other matter during that particular time and have to put in some extra time and late hours to get everything done.

And, in spite of what some folks might tend to believe, I try to shoot straight from the hip, without bias or prejudice, in reporting to you some of the activities that the Sheriff's Department has been involved in during the preceding week. I started this column over 6 years ago and made a promise then that I would try to keep you informed of criminal activities, investigations, and other related matters under my jurisdiction, and I sometimes receive criticism, both good and bad, for my efforts. Sometimes the load becomes such that I have considered discontinuing the column, but then again I feel that you, the taxpaying, voting public of this community and this county, have the right to be kept informed of what is going on in your community and the general activities of your Sheriff Sheriff's and the Department so I keep plugging along in my own peculiar way trying to keep you informed. The choice is yours, if you don't like what you read in "The Sheriff's Corner", then turn the page and read something else, or if you do read it and want to voice your opinion about an error I might have made or about something I might have reported on, let me hear from you and if indeed an error has been made I will attempt to correct it, or explain to the best of my ability why a certain report was or was not made.

Speaking of errors, I was informed that I made one last week when giving credit to those that provided the outstanding service at the Ft. Clark Restuarant for the meeting of the Southwest Texas Law Enforcement Officers Association. I thought I was doing a good thing in recognizing the efforts of those involved, but through an honest mistake I indicated that Joy

Ralston was manager restaurant and thanked her and her staff for the service and good food. Well, I have been informed that Jean Kohler is the manager of the restaurant and I failed to mention her name in the credits. I assure all those responsible that I intended no slight to anyone and to all those responsible, I again extend my thanks and gratitude for a job well done. Hope this satisfies everyone!

The "anonymous letter" to the editor a couple of weeks back seemed to touch a nerve or two judging from the response in last week's paper. Personally I think this is good for the community, gets people stirred up and thinking.

Ironically, the general theme of the letter (local minors in possession of and/or consuming alcohol) came home to roost with so e of our local youths and their parents the night of Friday, February 27th and again the night of Saturday, February 28th. In the first incident we received a complaint through Ft. Security of a loud party going on in one of the motel rooms. Upon investigation it was determined that a beer party was in progress attended by several local young people, all of them under the legal drinking age being from 15 to 20 years old. We handled the situation the way we usually do by confiscating the alcohol (in this case a keg of beer), and taking the names, ages, and home phone numbers of all those involved and then calling their parents.

In the second incident on

Saturday night, the local minors involved weren't quite as lucky. A Texas Liquor Control Board Agent from Del Rio apprehended several youths consuming alcohol (beer) on the premises of a local business that has an off-premise beer and wine license. (This means that though the business can legally sell beer or wine, the beer or wine cannot legally be consumed on the property, ie; a grocery store, _ etc.) The youths involved received citations issued by the LCB Agent and will have to appear before the Justice of the Peace and will most likely have to pay fines for the violations.

As usual, the incidents sparked response from the parents of those involved, both positive and negative, though I am pleased to report that the positive responses far outnumbered the negative. And I want to say this on behalf of the young people involved, with the

exception of only one, ALL of them extremely well-mannered, were polite, and respectful towards the peace officers handling the think incidents. I this demonstrates that even though they were in violation of the state liquor laws, the training and guidance they must have received at home carried them through what must have been a frustrating embarrassing situation.

I will repeat what I told several concerned parents: We, and I am for the Sheriff's speaking Department only, are not, and will not be, involved in a witch hunt for minors in possession of and/or consuming alcohol. We will, however, investigate each and every complaint or report we receive about this matter and each case will be handled to the best of our ability and judgement based on the merits of each case. I still firmly believe that the ultimate responsibility for the control of the actions of our local young people lies with the parents, NOT



In the shaping of Texas after San Jacinto, the rangers were organized into a force during the Texas Revolution. Seldom numbering more than five hundred men, they were both lawmen and soldiers on the frontier.

One of them was "Bigfoot Wallace" descendant of Scottish Highlanders, born in Lerington, Rockridge County, Virginia. Wallace stood 6 ft. 2 in. in his moccasins, weighed two hundred pounds and lived and breathed the Ranger Spirit. Bigfoot and his fellow rangers were the enemy of lawbreakers. Wallace was called "Bigfoot" because of his boxcar feet and some say he could have been named Bigfoot because of confusion with a well known Indian who was also called Bigfoot.

In one incident Wallace tracked down a particular renowned horse thief named Antonio Corao and using the usual remedy for horse thievery executed him on the spot. Sometime later in a San Antonio cantina, a mean looking hombre burst into the Cantina and announced he was a friend of Corao and was hunting for the dirty so and so who killed his friend. Whereupon Wallace drew his Bowie knife and roared that he aimed to kill all Corao's friends too. The avenging hunter outlaw took one good look at Bigfoot and his Bowie knife and immediately left town.

Wallace fought in Meir under Hays Co. of Rangers and was a private in Co. K, C.S.A. When Bigfoot, Neighbors and other Texans were captured and taken to Mexico as prisoners another incident of interest occured. Every morning Neighbors, Bigfoot and four other companions were hitched by their prisoners to a cart and escorted to the city market to produce supplies for the day.

The "off lead man" of this six man team seemed unable to resist playing a practical joke upon their simple minded guards. So one morning when they were driven into the market, and were passing the stall of a very old Mexican woman, whose peculiarly fantastic costume, and shriveled haggard face gave her more the appearance of a fiend than a human being. As soon as the off

leader caught a glimpse of this hideous old woman, he cast a wink back at his comrades. Suddenly he raised his head and snorting like a horse, started off in a trot, sheering around her, gradually turning his head in imitation of a horse who shuns a suspicious looking object.

The whole team ran a mile before the astonished guard could head them off. The "leaders" claimed they were frightened at the sight of the old woman. The officers were asked if they themselves had been frightened. On the return trip the leaders were led by the soldiers around the old hag. The Mexican officers told their superiors that the Texans were not so brave after all.

Bigfoot drove for the "Jackass Express" on the southern route and had many experiences with the Lipans and others.

He died Jan. 7, 1899 and was buried in the Divine, Texas Cemetery. Shortly after his remains were moved to the State Cemetery in Austin.

FISH STOCKING PROGRAM OFFERED

Well it's that time of year, Spring. It's time for new lambs, kid goats, baby calves, and the fish stocking program. Yes, the West Nucces-Las Moras Soil and Water Conservation District is offering its fish stocking program again this year.

The local district will be taking orders for fish from now until close of business April 18, 1987. Fish will be delivered beginning at 10:00 a.m. Wednesday, April 29, 1987, at the Kinney County Civic Center. Order blanks for the fish are available by calling (512) 563-2414 or by coming by the Soil Conservation Service office upstairs at the Courthouse in

Brackettville. Also look at local stores for order blanks, some


stores will have them.

The district was pleased last year to be able to offer this service to the local land-owners and operators. To say the least it worked better than we hoped and many people asked if we would do it again. This program has allowed ranchers to get just the fish or

forage fish they need and have the fish delivered to them.

Fish offered this year include channel catfish 4-6 inches, channel catfish 6-8 inches, largemouth bass 1-2 inches, bluegill sunfish 1-3 inches and fathead minnows. The minimum order is 50 of one species of fish or 1 pound of minnows. For further information you can pick up an order blank or call the local Soil Conservation Service office.

This year the district will have something new. We have invited the fellows of Aquaculture Enterprises, commercial fish hatchery to come and talk about managing a farm pond for fish, fish stocking, and just about anything related to the subject of fish. This fish seminar will be April 8, 1987 at 1:00 p.m., at the Kinney County Civic Center. It is open to the public and anyone who wants to know more about fish and their management is invited to A slide show will be attend. presented and questions answered. Be sure and mark it on your calender and plan to attend.

This process is necessary in order to receive reimbursement for each lunch under the United States Department of Agriculture School Lunch and Breakfast Program. All lunches served in any public school

lunch program are eligible for reimbursement through this program when guidelines are met.

Annual Sonora Experiment Station Ram Test Field Day



OF HIGH RISK DONATIONS

A confidential system where donors indicate that their blood should be used only for laboratory studies has proved effective in reducing the incidence of high risk donor blood entering the blood supply, according to the February issue of Texas Medicine.

The safety of the nation's blood supply became a critical issue when it was discovered that acquired immune deficiency (AIDS) could be transmitted by blood transfusion. In 1983, concern about this disease led to AIDS blood donor screening recommendations from the Food and Drug Administration. The Gulf Coast Regional Blood Center, Houston, the site of this confidential system, implemented the FDA recommendations immediately. However, in 1984, it upon the FDA expanded recommendations and began requiring donors to apply a pressuresensitive bar-coded label to a donor card that indicates whether the donor's blood should be used "for laboratory studies only" or "for transfusion". The blood center believed the risk of contracting AIDS through blood transfusion could be further reduced by going beyond the FDA

recommendations and eliminating donations from persons at high risk for AIDS, according to the official journal of the Texas Medical Association.

"The hypothesis depended on the confidentiality of the system developed to protect individual rights," according to authors Bill T. Teague, Pablo J. Fortes, John Drury, and Ronald Phillips. All of the authors are with the Gulf Regional Blood Center.

The blood center tests all donations, regardless of designation, for the HTLV-111 antibody. From the period of June 1 through November 1985, the center found that .19 percent of the "for transfusion" donations were repeatedly reactive to the AIDS antibody testing. Only .07 percent were positive for the Western blot test which generally is accepted as a reliable test to confirm the presence of the antibody.


"The extremely low number of "for transfusion" donors who test repeatable positive for the HTLV-111 antibody suggest that these donors are, in fact, very low risk and/or did not feel they were at high risk at the time of donation," according to the authors.

SUL ROSS PROFESSOR PUBLISHES ARTICLE

Dr. Donald Smith, Professor of Education at the Uvalde Area Study Center, had his article, "The Christian Assessment Scales: Christian Self-Perception," published in the fall volume of the Journal of Psychology and Christianity. The article examines the Christian Life Assessment Scales as an instrument for counselors and researchers to use in measuring personality traits. One hundred twenty eight subjects were used in the research for the project. Each took the CLAS and the results, said Smith, indicated that significant differences were found among the five major groups of subjects.

The CLAS requires those taking it to sort descriptions of characteristics of individuals into different categories from "least like me" to "most like me," and into a separate sort category of how they perceived God would want them to be. From the research,

ARSON FIRES INCREASE IN TEXAS

The crime of arson apparently is becoming more profitable in Texas. The number of set fires increased 31.5 percent in the first six months of 1986, compared with the same period in 1985, according to statistics recently compiled through the Texas Fire Incident Reporting System (TEXFIRS).

TEXFIRS is an automated system operated by The State Board of Insurance, State Fire Marshal's Office, to document the number, nature and causes of fires in Texas. Three hundred and ten fire departments protecting 71 percent of the state population report fires to the system.

During the first six months of 1986, fire departments reported a total of 9,045 incendiary of suspicious fires which resulted in at least 11 fatalities, 53 injuries and an estimated \$39.2 million in property loss.

The amount of property loss decreased 12 percent from the same period for 1985, but injuries increased 17.8 percent and fatalities increased 22.2 percent. The dollar loss from these fires amounted to 22 percent of the total dollar loss from all fires.

"Incendiary" or "suspicious" were among the top five fire causes in every major building category. Residential properties were hit the hardest by arsonists during the first six months of 1986. More than 1,400 incendiary/suspicious residential fires resulted in 39 injuries, 10 fatalities and \$19.7 million in property damage.

Fires caused by children playing with fire increased 44.8 percent in the first half of 1986, to more than 1,800. They resulted in 49 injuries, six fatalities and \$3.7 million in property loss.

Statistics from the TEXFIRS are made available to the public in an effort to decrease the number and severity of fires through increased public awareness of fire problems, said State Board of Insurance Chairman Lyndon L. Olson, Jr.

-- LANDSCAPING FOR ENERGY CONSERVATION --

Texans spend millions of dollars every year beautifying their homes with trees, shrubs, vines and With proper planning, flowers. many of those dollars can be recovered through reduced utility bills. Studies have shown that shading walls from direct sunlight in the summer can reduce wall surface temperatures by as much as 29 degrees. This can make a big difference in the cost of air conditioning the home. And while it may take many years for trees and hedges to mature, certain vines planted now may be trained on trellises to provide relief from the heat, and from high utility bills, this summer.

When planting trees, homeowners

should also consider the potential for saving on heating bills in the winter. For the east, west, and especially the south side of the house, choose trees that will lose their leaves in the fall, allowing the sun to strike walls and windows. The sun is too often ignored as a source of free light and heat on cold days. On the north side of the house, plant evergreen trees and bushes that can act as windbreaks, diverting blasts of cold air away from doors and windows.

From Section 22.10, Texas Penal Code:

LEAVING A CHILD IN A VEHICLE.

(a) A person commits an offense if he, or she, intentionally or knowingly leaves a child in a motor vehicle for longer than 5 minutes, knowing the child is: (1) younger than 7 years of age; and (2) not attended by an individual in the vehicle who is 14 years of age or older. (b) An offense under this section is a Class C Misdemeanor.

I have much to say to this law. As a caring father, I am appalled to see children, some still infants, left in cars at local businesses. If a child is taken somewhere, why not take them inside? Or still, leave them at home with an adult or older juvenile (babysitter). And with hot weather coming, leaving a child

unattended in a car can be fatal.

I am reminded of a time while I was an SP in the Air Force, when I happened on such a situation at the store. base The outside temperature was 95 degrees, and even with the windows cracked, the temperature in the car reached about 125. We did not have time to look for the parents, as the child was already showing signs of the heat getting to him, so we shattered a window, and took the child out. When the mother arrived, she was more concerned about the broken window, insisting that we would have to pay for it. We didn't, but she did...in more ways than one.

If these types of circumstances arise, it will be more than a Class C Misdemeanor. The State of Texas may pursue the matter as a criminal case. And I applaud it.

Also, in the case of child restraint, the law is that if the child is under 2 years old, they must be in a child safety seat; and if 2-4 years old, must be seatbelted in, REGARDLESS of where they are sitting in the car. I don't hesitate to issue citations on this offense. It doesn't matter if the parents don't like it, or agree with this law, or what may happen to the current seatbelt law. I don't think that the part of the law concerning children will ever be repealed. And it shouldn't. Not only are the children safer, but there is less distraction to the driver, and the children are more controlled.

But I'm not preaching; just giving friendly, concerned advice, one loving parent to another.

Smith found five groupings ranging from those in which the two sorts were not very different to those for whom the differences in the sorts was quite significant. Smith warned that care should be taken not to overgeneralize the results of the study. While the five groups existed, the implications of the differences between the groups was not clear, and further study was needed to show the scales could be used in effective counseling programs.

Smith, a member of the faculty at Sul Ross State University since 1974, earned his Bachelor of Science and Master of Education from the University of Illinois, and his Ed.D. from Illinois State University. He has also served in the Center as acting Dean and as Chair of the Program Area of Teacher Education.

Dear Editor:

It seems "Anonymous" struck a nerve.

Several things strike me as interesting. In the first place I agree with every word that was said. In the second place I noticed that Wanda Schwandner did not dispute a single factual statement.

Come now Wanda, I grew up just down Washita River from where you lived in Oklahoma. True, Oklahoma was "dry", but home brew and bootleg liquor were readily available and the legal "3.2" beer was as much alcoholic as some of the "lite" beers today. The boys gathered behind the barn or in the parks and sneaked their drinking. There were the "barn" dances where some of the adults got drunk.

The big difference was that mom and dad didn't use alcoholic beverages and didn't encourage their young people to. Certainly there were people who used these things but they were in the small minority and by no means had approval of the general public.

I've seen through the hamburger stand window, and in the halls what goes on among teen agers at the Civic Center dances. Just because the parents sit at a table and drink and the young sit at another table and drink doesn't mean it is right or good for the teens to drink. One does not have to attend one of these dances to "check out my neighbors nor my neighbors actions" but I saw alcohol abuse by teen agers without looking for it.

I agree with anonymous, "these are all kids we know and love. They are our "good kids. " I'd rather my kids be --- having a couple of beers than out thieving, vandalizing, using drugs ---" is a cop out. There is no legitimate reason for doing either one. Now at least your sons can know their mother gives tacit approval to their violating the law and drinking beer.

I do not agree that the community has a responsibility to furnish activities for the young people. The parents have the major responsibility. There are many many more things for young people to do today than there has ever been.

Certainly our youth needs support but only for those things that are right, legal and helpful. To close our eyes to reality and give even acquiescence to harmful practices is no real help for youth.

There is no greater way to help youth than to lead the way in worship of God and faithfulness to Him by support of the Church. For all the hoop-la there is still no greater source of character building.

And as for peer pressure - each youth is going to be either a leader or a follower: I'd rather mine be leaders by peer pressure for the right, than followers.

The week of March 8-14 is Older Worker Week in Texas. We encourage other employers to hire an Older Texan during this week. Nutrition and Aging Program in the past 11 years has hired 10 Older Te.ans. This has been made possible through The Senior Texans Employment Program. Headstart has also had the priviledge to work with Senior Citizens provided by STEP.

The names of people previously employed by STEP are, Teresa Luna, Hannah Daniels, now deceased, Victoria Martinez, Maria Sandoval, Lucy Williams, Virginia Cruz and Consuelo Castillo. Current employees are Agnes Vondy, Eluteria Garcia and Juanita Rivas.

Next week a proclamation will be signed honoring our STEP employees and urge other agencies to recognize our Older Worker in our community.

Labor provided by STEP has enabled many rural communities to start, operate and complete various local programs which would not have been possible without the assistance of the STEP workers. Due to the eroding tax base present in rural communities and school districts, projects such as major repair to community buildings, schools, renovation of parks or development of human service

programs must be forgotten because tax dollars have not been available to undertake the responsibility. With STEP workers leading the way, many communities are able to implement new social programs and capital programs with enrolees carrying the primary responsibility.

Additionally, the communities benefit because of the increased number of workers in day care centers, schools, hospitals, senior centers, beautification projects, transportation program drivers and nutrition programs for the elderly. By increasing and upgrading the number and quality of workers in these areas, programs are refined and can increase or expand services to more needy individuals in the service area.

The rural community economy has benefited by STEP workers earning their dollars in the community and spending their wages locally. STEP wages represent a significant impact on rural areas when local dollars are earned and spent at home. The Senior Texans Employment Program has become a source of pride to the enrolees, while local project sponsors have developed a renewed feeling about the ability, productivity and resourcefulness of older Texans.


In addition to the general care and operation of the library, the librarian teaches library skills to the elementary students on a regular weekly basis and to the high school students upon the request of the teacher or student.


